Plans, and pictures, etc. of the site and the site walk in which the above named people participated, were displayed and discussed. But it was decided not to pursue looking into the project further without more guidance from the developer, Elliot Chamberlain of Chamberlain Homes.

2. Pond cleanup off ET - OOB trail near School St. (Echo Ave.)

Rich Litwin, an abutter to a pond that is off of ET - OOB trail near School St. had a complaint about the use of the area. Young people congregate there and have loud parties and throw things into the pond. The mosquitoes are also very bad. It needs to be cleaned up.

1. Mark Koenigs suggested that the summer police bicycle cops patrol the area sporadically. He will talk to the PD.

Peter Hornby suggested playing opera music as a deterrent to the young people.

Is Town maintenance of this pond a responsibility under the state MS4 requirements? Mark Koenigs will add this to the ET - OOB trail DPW to-do list.

OOB Chamber of Commerce booklet mention of the Eastern Trail noted.
