"Our municipal family lost a dear friend and associate on June 23, 2008 with the passing of Carole Ann Kingsbury who served citizens of our community as the Licensing Coordinator since August 21, 2000. She inspired us in life and throughout her illness showed a spirit of optimism and trust. We are delighted to have with us this evening Carol's mother, Francis Dakin; her brother, Robert; her son's Daniel Kingsbury and his wife, Nancy Kingsbury, Nancy's two sons, Kyser and Nick Richard; and Carols son' Stephen and his friend, Debra Penney. Born in Farmington, Maine in 1944, most of her growing up years were spent in Dixfield, Maine where she lived with her parents, Frances M. Dakin, who is with us here this evening, and Francis E. Dakin. Her father predeceased her in 1993. She had two brothers, Ronald and Robert, of whom she spoke often; and a sister, Kathryn Claire who predeceased her in 1950. Assistant Town Manager Reid read the following into the record from Town Attorney Chris Vaniotis. "There is no provision in the contract for early termination by either party. Ecomaine's explanation for that is that given the volatility in the market for recyclables, they are relying on the seven year commitment(and possibly three year extension) to recover their costs. The contract could be terminated early by mutual agreement, but not unilaterally. In addition, section 409.16 of the OOB Charter authorizes the Council, with certain limitations, to sell surplus property of the town. I do not think that section applies to the recycling program. The Town is not 'selling' property; it is providing a service to its residents by collecting and disposing of waste materials."

Councilor Dayton thanked John Bird and the entire recycling committee for their work and passed out recycle posters and Frisbees made from recycled materials.

Code Enforcement Officer Mike Nugent stated 2007 feasibility study funds are being used for the present station study. Councilor MacDonald stated this study will produce information needed to inform voters prior to a police station referendum possibly this November. Chief Kelley stated the rescue billing fund, with an annual income of approximately \$350,000, can be used to pay for the new police station. A two million dollar bond would require an approximate annual payment of \$193,000 so the rescue billing fund is adequate to pay for the new station without raising property taxes.

Discussion continued re: possible timing of construction, possible bond vote, maximizing use of local contractors and location of new station.
