TABLED ITEM COMMENTARY NUMBER 5545

Discussion with Action: Amend Chapter 2, Division 8 – Ballpark Commission – Section 2-401.

This item was tabled at the last meeting and brought forward again for approval.

TOWN MANAGER: He explained why this action was necessary based on the fact that the Ballpark Commission cannot do everything and therefore there is the need to have volunteers accept responsibilities and as such be "commission's agents for carrying out the Commission's responsibilities. There is this slight adjustment to the prior wording. This is the recommendation of the Town Attorney. It should not be unexpected for this document to come up for adjustment as the Ballpark activities grow. He reiterated that the challenge of the busy schedule of the Commissioners necessitated the need to ask other qualified volunteers to accept responsibilities that needed to be indicated in the Ballpark Commission Ordinance in the area of "commission's agents." During the discussion the question was also discussed about the need to hire individuals to care for the fields next year in line with the number of events that are already scheduled

Councilor O'Neill alluded to the insurance issue, again asking why the Town insurance would be used for OOB365 events and not for all events. This he said would afford everyone the same opportunity to use the Town insurance rather than just one group. The Town Manager explained that the OOB365 group now has their own insurance. Councilor O'Neill then suggested that a perhaps a workshop on special event permits and in particular the insurance issue be a consideration in the coming weeks. Councilor Bolduc said that she saw no need for such a workshop for obviously the issue has corrected itself. Councilor Tousignant said he hadn't seen the Special Event permits but he was reminded that they were being sent via email from the Town Clerk's office. The Town Manager explained that the one time that the Town insurance was especially used was during the Balloon Festival which was definitely a combined event by both OOB 365 and the Town and the extent and magnitude of the event justified the use of the Town's insurance and some participation by departments. The Chair again indicated that the OOB365 group's mission was to bring events to the Town during the fall, winter and spring seasons. When the question was asked by Councilor Dayton and Councilor O'Neill about the cost for town involvement the Town Manager indicated that those type of records and figures have not been kept. He indicated it would be mostly involvement by public works, police and fire.

Explanation for the reasoning for it was provided on several occasions by the Town Manager. Sec. 2-401. Authority to appoint agents. The Commission may, with the consent of the Town Manager and the vote of the Town Council, designate one or more of its the members or other volunteers to serve as the commission's agents for carrying out the commission's responsibilities. Such agents may not, however, bind the town to any contractual or financial commitments unless expressly authorized to do so by the town council. (Ord. of 3-16-2010, § 7)
