GOOD AND WELFARE:

GINGER MCMULLIN: I am a member of the Old Orchard Beach Conservation Commission and on behalf of Andrea Berlin, Chairperson of the Conservation Commission, to announce that on Thursday evening, June 26, 2008 at 7:00 p.m. in the Town Council Chamber, a presentation will be given by the Maine Department of Inland Fisheries on Wildlife's Beginnings with the Habitat Program. The purpose of this program is to aid Town's in conservation planning by providing information and a collection of maps showing plant and animal habitats of statewide and national significance found in the Town. Additional maps showing public and private conservation lands, watersheds and wetlands will also be included. This very informative program is open to the public. Further information can be held through the office of the Assistant Town Manager at 207-934-5714, extension 226.

COUNCILOR MACDONALD: I am inviting any citizen that would like to come in and discuss anything that is going on in the community and any concerns that they might have.

COUNCILOR DAYTON: I would like to remind everyone that this is recycling week and that you can even recycle plastic and they will be made into Frisbees.

CHAIRMAN LONG: The City of Saco has held a number of open meetings dealing with their desire to development Saco Bay. The State in its judgments established a process to determine if development of the bay would be detrimental to the affected communities as well as to the revenues generated for the State by the current uses of Saco Bay. Currently the City of Saco prefers to have a regional developmental agreement to management development on the bay. The City also contends that their agreement with Spartan Bay is still valid. Protecting the bay is the highest priority and therefore should be considered first. A regional

plan reduces our ability to protect our primary asset, the beach. The approach presently in place does not reflect an understanding of the environment of Saco Bay. The moratorium takes affect July 18, 2008 and the State expects to be informed of our progress in January 2009. The state rejected the plan proposed by Saco. If the Tow Council wishes to have a workshop on Saco Bay and forms a committee then we ought to act on that proposal.

COUNCILOR FRENETTE: I would like to volunteer my services to go to these meetings and would ask the Town Manager and the Planner to attend but we need to know what is going on and if any other councilors wish to attend that would be fine. I want to support the position of George Hogan and see what is being planned for our position in the bay.

CHAIRMAN LONG: I would like to point out that the Chairman does not establish the schedule for the Town Manager nor his staff – the Town Manager is responsible for that. I would also point out that in earlier May Councilors were informed in over 25 e-mails were updated on the issues involved and ahead of us. So I encourage people to get involved as my interest is specifically that of the town. The Town Manager has indicated we are involved.

COUNCILOR FRENETTE: That may be true but our presence is necessary and I want to support George Hogan. If we are not there it looks like we do not have an important investment in this.

CHAIRMAN LONG: What is happening in Saco is that they are trying to establish a Management Agreement prior to the moratorium. Saco desires to receive a Spartan Bay lease payment and without a management agreement that is not likely to happen. They don't own the land and don't have the right to lease it and I am interested in Old Orchard Beach. If they think this is such a good idea they should do this in Saco at Ferry Beach.

COUNCILOR O'NEILL: There are a lot of concerned citizens and I do think they should be involved and I think we would be wise to consider the committee and we could put the Town Manager on that.

COUNCILOR FRENETTE: I agree it would be good to have citizens. I think they are more interested in Saco than Biddeford or Old Orchard but we need to keep ourselves involved.

CHAIRMAN LONG: If we signed on to a management agreement we would lose our rights to the bay. I would suggest

COUNCILOR DAYTON: Is this a citizen group? If we are going to appoint someone we need to do it before the 15th meeting. We can't do anything tonight. This is good and welfare.

COUNCILOR O'NEILL: Yes that is the case.

CHAIRMAN LONG: Can I have a motion to adjourn?
