NEW BUSINESS:

3097 Discussion with Action: Amend the Code of Ordinances, Article IV, Town Beach, regulating motorized vehicles on the beach.

CHAIRMAN LONG: The Code of Ordinances, Article IV, Town Beach unlike the situation in many towns on the Maine coast, the beach in Old Orchard is Town-owned property, having been acquired by the Town in 1935, and the Town is very protective of what is clearly its most valuable asset. For that reason, the Town does not allow any motorized vehicles on the beach. Section 42-201 of the Town Code states: "no motorized or vehicular traffic of any kind may enter or use the beach for any purpose, with the exception of public safety vehicles and the town's public works vehicles, designated for public safety or beach cleaning purposes." That ordinance has been in effect since 1961.

That ordinance, representing the policy of the Town for nearly 50 years, precludes the operation of amphibious vehicles over the Town beach. Consideration of any changes to this ordinance is important to the protection of our beach.

PHIL DENNISON: I would appreciate the Council approving this agenda items to protect the beach which is our most precious resource.

ED REA: I am the Executive Director of Ocean Park Association and I support this Ordinance change.

MARC GUIMONT: I support this change in the protection of our beaches and the economic welfare of our municipality.

COUNCILOR FRENETTE: I support the addition of the word <u>amphibious vehicles</u> to the Ordinance but I do not agree with the verbiage at the end of the Ordinance - This paragraph (h) does not permit, and the Town Council may not approve under this paragraph, the use of the town beach or adjacent tidewaters by amphibious vehicles – because I believe that takes away the power of another Council. COUNCILOR O'NEILL: I would really like to know what prompted this whole issue as that has not been explained to us. It was Captain Russell Shaw who provided duck boat years ago. Our ordinance was fine the way it was and I did not see any reason to change and still would ask why this has come to the front.

CHAIRMAN LONG: It arose because of the Spartan Bay issue and the request from a Massachusetts business owner to have a duck boat with access across our beach.

COUNCILOR FRENETTE: Then I agree with the addition of the words amphibious vehicles but I move that the other section be removed.

COUNCILOR MACDONALD: I agree with Councilor Frenette for the wording of amphibious vehicles but not the other section.

MOTION: Councilor Dayton motioned and Councilor Frenette seconded to Amend the Code or Ordinances, Article IV, Town Beach, regulating motorized vehicles on the beach to add the words amphibious vehicles but delete the wording – This paragraph (h) does not permit, and the Town Council may not approve under this paragraph, the use of the town beach or adjacent tidewaters by amphibious vehicles/

VOTE: Unanimous.

NOTICE OF PUBLIC HEARING MUNICIPAL OFFICERS OF THE TOWN OF OLD ORCHARD BEACH

The Municipal Officers of the Town of Old Orchard Beach, Maine hereby give Public Notice that there will be a Public Hearing held at the Town Hall, Council Chambers, on February 19, 2008 at 7:00 p.m. to consider the following:

AMENDMENT TO CHAPTER 42, ARTICLE IV, DIVISION 2 OF THE OLD ORCHARD BEACH CODE PROHIBITING THE USE OF AMPHIBIOUS VEHICLES ON THE TOWN BEACH AND IN ADJACENT TIDEWATERS

Be it hereby ordained, by the Town Council of the Town of Old Orchard Beach, Maine, in Town Council assembled, that Chapter 42, Article IV, Division 2 of the Old Orchard Beach Code is amended as follows:

The definition of "water toy" in Section 42-141 is amended by adding the underscored language shown below:

Water toy means any motorized craft, vehicle, conveyance or device for carrying or transporting persons in or on the water, including but not limited to jet skis, powerboats, <u>amphibious vehicles</u> and rafts or other flotation devices pushed by, pulled behind or towed by a motorized boat.

Section 42-144, paragraph (h) is amended by adding the underscored language shown below:

This section shall not apply to a marina; a passenger transportation service, such as excursion boats, charter boats, water taxis or water shuttles; or a waterborne amusement ride, which is: (i) operated at, to, from or adjacent to the pier; (ii)

operated pursuant to an annual license issued by the town council under article II of chapter 18; and (iii) operated only in areas approved by the town council and marked off by buoys, ropes, floats or other devices designed to keep swimmers and bathers from entering the operations area. The town council may approve such an operation only upon finding that it will not create a hazard to the public health, safety or welfare by endangering swimmers, distracting lifeguards from the performance of their duties, contributing to noise or water pollution or otherwise interfering with the public's use and enjoyment of the town beach and adjacent tidewaters, and the town council may impose conditions to ensure compliance with such findings. This paragraph (h) does not permit, and the Town Council may not approve under this paragraph, the use of the town beach or adjacent tidewaters by amphibious vehicles.

Notwithstanding the provisions of Title 1, section 302 of the Maine Revised Statutes, this amendment shall affect proceedings pending at the time of its passage.

3098 Discussion with Action: Set a Public Hearing Date of March 18, 2008 to Amend the Provision of Police Protection at Chem-Free Establishments – Chapter 6, Article IV, Section 6-157(6).

CHAIRMAN LONG: This is a public safety issue in which the Administration supports the recommendation of the Chief of Police.

TOWN OF OLD ORCHARD BEACH CONCERNING THE PROVISION OF POLICE PROTECTION AT CHEM-FREE ESTABLISHMENTS

WHEREAS, Chapter 6, Article IV of the Old Orchard Beach Code regulates the conduct of so-called "chem-free" dances; and

WHEREAS, Section 6-157(6) of the Code requires the person operating a chem-free dance to provide police protection; and

WHEREAS, the intent of the Council is that such police protection must be provided by an officer of the Old Orchard Beach Police Department, unless the Police Department, because of its own staffing needs, cannot make an Old Orchard Beach Police Officer available; and

WHEREAS, it is important for public safety to have an Old Orchard Beach Police Officer with arrest powers present at a chem-free dance whenever possible, and the use of another police officer a private security officer should be allowed only in circumstances where there is no Old Orchard Beach Police Officer available; and

WHEREAS, that intent is not clearly expressed in the current language of Section 6-157(6); and

WHEREAS, the Council finds that chem-free dances are occurring on a regular basis and it is therefore necessary to correct the existing ordinance language immediately; and

WHEREAS, the Council finds that these circumstances constitute an emergency within the meaning of Section 410.1 of the Old Orchard Beach Town Charter;

NOW, THEREFORE, be it hereby ordained by the Town Council of the Town of Old Orchard Beach, Maine, in Town Council assembled, that paragraph (6) of Section 6-157 of the Old Orchard Beach Code is amended by deleting the language in strikeover type and adding the underscored language as shown below: (6) The person operating the chem-free dance shall provide police protection on the property during the chem-free dance and during the one-half hour periods preceding and following the chem-free dance at that person's expense. The police protection shall be an officer of the Old Orchard Beach Police Department, unless the Old Orchard Beach Police Department cannot provide an officer, in which case the police protection may be another police officer or a security officer approved in advance by the Chief of the Old Orchard Beach Police Department. One officer is required. The person operating the chemfree dance may elect to employ additional officers.

- MOTION: Councilor Frenette motioned and Councilor MacDonald seconded to Set a Public Hearing Date of March 18, 2008 to Amend the Provision of Police Protection at Chem-Free Establishments – Chapter 6, Article IV, Section 6-157(6)."

CHAIRMAN LONG: The Assistant Town Manager has served as the Interim Town Manager in the absence of the appointment of a new Town Manager.

COUNCILOR FRENETTE: Not that I have to justify to anyone on the council nor to the general public that Louise Reid has done an excellent job acting as interim town manager but if you have dealt with the previous town manager you will know that she really has acted as the Town Manager for a long time. In my opinion \$4,000 is not enough.

COUNCILOR DAYTON: I want to thank you, Louise, for being so responsive in the number of conversations that we have had regarding financial management, personnel, purchasing issues, and other difficult items and I have appreciate her professionalism and her willingness to listen.

COUNCILOR MACDONALD: I am the new councilor and Louise has been extremely supportive and helpful to me, more so than any others sitting upper here and I hope it continues. CHAIRMAN LONG: Louise, I appreciate your tolerating me.

COUNCILOR O'NEILL: I would also like to express my appreciation for the administration that Louise has provided in the absence of a town manager and for that matter during the past four years. I don't feel the \$4,000 is enough and you can't put a price on what she has done for us but I would ask that we authorize an additional \$1,000 and make it \$5,000 from Account Number 20102-50101 – Department Head Salary Expense, with a balance of \$18,438.00.

- MOTION: Councilor O'Neill motioned and Councilor Frenette seconded to Authorize the payment of \$5,000 to Acting Town Manager V. Louise Reid to come from Account Number 20102-50101 – Department Head Salary Expense, with a balance of \$18,438.00.

COUNCILOR DAYTON: I would suggest we tack on a well deserved vacation.

CHAIRMAN LONG: (Laugh) Not just yet. Louise, you are really awesome.

4001 Discussion with Action: Approve Town Manager Agreement (Probationary) with Stephen Gunty, effective March 3, 2008.

CHAIRMAN LONG: We are pleased to announce our desire to hire Steve Gunty as the new Town Manager, effective March 3, 2008. The Old Orchard Beach Town Council will appoint Stephen J. Gunty as Town Manager, effective March 3, 2008 at their Regular Town Council Meeting. Mr. Gunty lives in Ellsworth, Maine and has for 23 ½ years served in positions in city management, Labor Relations/Human Resources/Finance, and Economic Development. He has shown the ability to maintain positive Board relationships and establish active intergovernmental, business and community partnerships to accomplish goals and the Town Council felt he had the talent to maintain a neutral position on issues and move forward goals in the best interest of the municipality. He has served in Waukesha, Wisconsin as the Director of Administrative Services and as the Human Resource Director; City Administrator in Sparta, Wisconsin; Economic Development Director in Calumet City, Illinois and City Administrator in Ellsworth Maine. In all his positions he has been known to foster intergovernmental relations, being very project oriented and fiscally responsible in both capital, operational and quality enhancement initiatives. The Gunty's have two children, ages eleven and thirteen.

MOTION: Councilor Frenette motioned and Councilor O'Neill seconded to Approve Town Manager Agreement (Probationary) with Stephen Gunty, effective March 3, 2008.

VOTE: Unanimous.

4002 Discussion with Action: Approve the Appointment of Stephen Gunty as Town Manager, effective March 3, 2008.

COUNCILOR DAYTON: I would like the public this was a rigorous process –significant number of candidates - 41 candidates – we interviewed eight and we have had many meetings

during the past two months. I appreciate all the good work that my fellow councilors have done and I look forward to the next six months working with our new town manager.

COUNCILOR FRENETTE: I want it to be a lot longer than six months.

COUNCILOR MACDONALD: I also welcome the new town manager. I had wished and recommended that the public and the Chamber of Commerce become more active in the process of finding a town manager but the other council members did not agree and that is alright. I welcome the new town manager and look forward to working together.

CHAIRMAN LONG: Mr. Gunty, please step forward. (Mr. Gunty signs the probationary agreement.) Does the Town Manager wish to comment?

TOWN MANAGER STEPHEN GUNTY: I would, yes. I appreciate the opportunity to serve the citizens of OOB and to work with this fine Town Council. I have had a little time to get to know them in some fashion and I look forward to calling this Town my own and working with them in continuing in a great direction. I look forward to being part of solutions to town issues, in working with this fine group of department heads and employees, and a continued association with Louise Reid who has been extremely helpful in bringing me current on many issues. And once again, thank you.

CHAIRMAN LONG: The Town Manager is scheduled to meet with the Department Heads tomorrow and Louise has already provided him with about 15 pounds, 6 ounces of material.

MOTION: Councilor Frenette motioned and Councilor O'Neill seconded to Approve the Appointment of Stephen Gunty as Town Manager, effective March 3, 2008.

VOTE: Unanimous.

4003 Discussion with Action: Appoint V. Louise Reid as Secretary to the Town Council, effective March 5, 2008.

CHAIRMAN LONG: Our special thanks to Gary Lamb, Planner, who was willing to offer his assistance during these interim arrangements as the Secretary to the Town Council. Both the Council and the Acting Town Manager express their appreciation to Gary.

COUNCILOR FRENETTE: I would also like to thank Gary Lamb for stepping up to the plate and offering to do this in the interim.

ASSISTANT TOWN MANAGER: I have sincerely appreciated the willingness of Gary Lamb to help in this regard but also for the other excellent counsel he has provided me during this period along with an outstanding group of department heads and employees.

The Town of Old Orchard Beach wishes to hire a consultant to conduct an Implementation Assessment of the Old Orchard Beach Comprehensive Plan, which was approved by OOB voters and the State Planning Office in 1993. The consultant will compare the 1993 Comprehensive Plan with the 2008 OOB Zoning Ordinances and write a report outlining the specifics of how well the Plan has or has not been implemented. This report will be used to inform the Town Council and planning staff and help prioritize and plan for a full Comprehensive Plan update.
