The Assistant Town Manager wishes to indicate to Council that The Bag Company does not make draw string bags and this is the type of bag that has proved very acceptable in our previous experience here in Old Orchard Beach. In addition the weight of the bag provided by Phoenix Recycling is the strength that is acceptable to our use. The Assistant Town Manager made calls to all six references provided by Phoenix Recycling and found that all those interviewed were pleased with not only the quality of the bag but the service provided by the company and the staff. One of the references, Joseph Lambert, purchases 20 million bags for the Boston area and recommended with great satisfaction the Phoenix Recycling Company. The Bag Company did not provide a listing of references.

In addition to the acceptable price a contract extension/price escalator/de-escalator clause is provided to us by the company. This has been part of the reference check and the escalator/de-escalator clause has been economically attractive to the references because it has de-escalated more than escalating re the cost of products.

TOWN MANAGER: The request for the leasing of space at The Grand Victorian Hotel Condominium is being presented to the Council this evening. This is for the Police sub station which will provide to the citizens and tourists a place located in the center of the community from which to operate during the summer months.

COUNCILOR O'NEILL: I wish to state that I am not supporting this. We have major issues already with our fire and police public safety facility and are questioning whether we need to rebuild or build new so I believe that we are placing the cart before the horse. I didn't support it when it was first raised and I also feel that we did not follow through on the purchasing policy of the Municipality when we considered this and for those two reasons I do not support this and will vote against it. I appreciate the work put into it but I cannot support it at this time.

COUNCILOR LONG: I also do not support this. We have been talking about comprehensive planning and this is premature to do this at this time. We need to look at the public safety issues at a comprehensive planning level. I don't think it is a good way to do business. I will not support this.

COUNCILOR FRENETTE: I support this. We have talked about this need for years but it has always not been affordable. It is affordable now. We need this in the downtown area and I believe that this is an opportunity that we cannot afford to miss. If a year or so down the road we find it does not meet our needs or fit into our planning we can address it at that time. I don't think we can afford not to try it.

COUNCILOR LONG: Again, I state that Public Works has done a great job and our Public Safety staff and Chief John Glass who is the Emergency Management Director have provided an unbelievably excellent service to the community.

COUNCILOR DAYTON: I met with the Public Works Director today and reviewed some of the plans that she has put in place and I appreciate the work she is doing and believe we are going in the right direction.

MOTION: Councilor O'Neill motioned and Councilor Frenette seconded to establish an Emergency Account – FEMA Disaster Relief – Other Improvements Capital, Account Number 31131/50556, in the amount of \$200,000, until such a time as FEMA funds cover the cost of damage related issues.
