COUNCILOR FRENETTE: We wish to invite all citizens to Memorial Park during the visit to our community of the Viet Nam Moving Wall. Opening Ceremonies are Friday, May 25, 2007 at 3:00 p.m. with the attendance of several State and Local officials and the Governor of the State of Maine, John Baldacci. Other ceremonies will be held on Saturday, Sunday and Monday evenings at 6:00 p.m. This is an enormously important event for our community and an opportunity to recognize the ultimate sacrifice given by so many. Our thanks to Jason Webber, Nance Kelley, Nikki Dupliese and Peg Smith for the enormous amount of time and commitment put into the arrangements and to all those who have donated so generously of time, efforts and funds.

COUNCILOR DAYTON: Clean up day this past weekend was very successful and to all the community organizers throughout the municipality as well as members of the Public Works Department, our sincere thanks for your commitment to getting our community ready after the series of storms. It is this type of united efforts that makes our municipality special and to each of you the Council and the administration expresses our deep appreciation. The Assistant Town Manager met this week with teachers of the fifth grade at Loranger School to receive an update on Junior Achievement Day of Sharing. NEW BUSINESS:

2040 Discussion with Action: Presentation of Phase 4 of the Veteran's Memorial by Andrea Berlin, Chairman of the Memorial Park Committee, and Richardson & Associates.

CHAIRMAN KLINE: I will introduce Jason Webber, Recreation Director, and Andrea Berlin who will introduce the guest speaker this evening.

JASON WEBBER: Wish to express Richard & Associates, Andrea Berlin and the Memorial Park Committee for all their hard work and say that it is a pleasure to work with them.

RICHARDSON & ASSOCIATES: The memorial park committee approved Richardson and Associates designs for phase 4, [The Veteran's Memorial District] at the Friday April 26th meeting. While working with them over the winter they also showed us a preliminary plan for phase 5 that was well received. While we contracted Richardson and Associates to develop plans for phases 4 & 5, we asked them to focus on phase 4 so we can get this approved by council and into a presentation packet

showing design watercolor sketches and construction costs prior to Memorial Day. I urge you to make a decision on approving this plan tonight in order to have these documents ready for Memorial Day. This presentation also gives our community members and anyone who is visiting over the Memorial weekend an opportunity to view the presentation by Richardson on channel 3. We plan to have a few packets made ahead of the wall coming Memorial Day weekend enabling an immediate mailing to anyone who expresses serious interest. Todd Richardson and his firm have offered to volunteer their time in layout and set up of the wall when it arrives before Memorial Weekend. In addition they have offered to prepare presentation panels that will be weather resistant and Jason is preparing to locate these where visitors will easily view them. We will have a card for visitors to take after viewing the design should they want to become involved. It will have a brief history of the overall project, color designs like the presentation board that was in town hall and contact information. The size of the card has yet to be determined. I thought the size of a standard wedding invitation would be appropriate. In light of the bad press that the Veteran's Administration received this year, our community will be proud when they see what Richardson and Associates has prepared honoring those who have served this country. It is outstanding; sophisticated while being integrated into the existing park we have all worked so hard in the past developing. We held workshops with both of our communities Veteran's groups. Todd Richardson prepared a questionnaire ahead of these presentations for the Veterans asking them to share their words and feelings about the wars they served in. Richardson had a surprising number of responses immediately and continuing several weeks after the workshops were held. They left additional questionnaires for members that were not in attendance. These veterans that took part in the questionnaires will have their words displayed on walls that are integrated into the design, making this very personal for us as a community while allowing anyone who visits the ability to connect to this place we are creating. I am very interested in the material that this wall will be constructed of. I don't want them to rust. Some of the veterans felt that they shouldn't rust as well. The walls will be illuminated at night, which will evoke an added layer to the emotional experience that a visitor to the park might miss during the active recreational hours. In addition the lighting will be an added security feature. Both veterans groups gave permission for the WWII monument to be moved if necessary. They trusted that it would be placed appropriately. They saw the same preliminary design work that Todd Richardson presented to you earlier this winter. I think everyone will be happy with how we sought to make individual areas dedicated to each war. This was one of the requests coming out of the design charretes we help a year ago.

Process Review/Update: After initial Town Council Presentation – team brought design concept to Veteran's groups. There was a very positive response from both VFW and American Legion Groups. There was emphasis on a creating a place to teach and honor. Further charge from Committee to consider individual spaces for conflict memorials/reflection. Design revisions reviewed by committee and in public forum for approval. Look to Memorial Day/Visiting Vietnam Veterans Wall events as opportunity to share proposal with the whole community. He then discussed the amended schematic design. He discussed the Gateway and Ceremonial Plaza which contained a major light wall which contained the area name and donor list. United States, Military Branch, POW/MIA flags located together with Gathering Bench and Dais area for ceremonies – adjacent to great lawn for major events. WWI and WWII Existing Memorials flank path entering Commemorative Area – emphasizing historical community memorial. Continued discussion was on the Memory Walk Path. This has

heavy-duty brushed stainless steel panels with punch-cut quotations, set in concrete footings emphasizing durability. Fiber-Optic lighting glows between panels and makes words shine – can be maintained from edges of panels. The Landform Ridge at 2.5 feet height creates sense of holding space while retaining safety sightlines and accessibility. The Landform Lookout includes retaining light well cuts in landform increase visibility from top to path and up lights in grove of trees creates glow in space, rather than outlining path. The Reflecting Pool – reflecting space has a lookout area mad more intimate – sized for small group and individual reflection, while plaza below hosts major events/commemorations; water table and bench sited sliding past each other to welcome and draw visitors into the space; and deciduous grove creates backdrop to space, and entrance hall. The Memorial Wall includes individual small plazas for reflection peel off of park path leading to memorial area; and materials – pavers granite bench, single sentinel trees – refer to central memorial space palette. The artist-designed memorial posts grace each space and recall qualities and history of individual conflicts. Finally the next steps are to have boards on display at Moving Wall during the Memorial Day Weekend; Marketing booklet is in development; and supporter discussion events to be planned.

CHAIRMAN KLINE: I express my appreciation to all concerned in making this a possibility.

COUNCILOR LONG: I appreciate all who have been concerned. I know there is a force behind this and that is Nance Kelley. This is for those who served rather than the war event itself. I appreciate how the Committee listened to the suggestions and formulated them.

MOTION: Councilor O'Neill motioned and Councilor Frenette seconded to approve the Plan presented on Phase 4 of the Veteran's Memorial project.

VOTE: Unanimous.

\$8,000 to replace the vehicle currently assigned to the lifeguards. This vehicle is a 1988 Chevrolet Truck which was confiscated by the Old Orchard Beach Police Department in a drug arrest. It is in poor condition and it is no longer feasible to put money into it and will not pass the State Motor Vehicle Inspection. The lifeguards use the vehicle to transport flags, signs, rescue boards, emergency medical and rescue gear and is also used as a response vehicle to the scene of any water related emergency. The vehicle which will be purchased is a used 1998 Chevrolet 4x4 pickup with extended cab (desirable to carry gear) and having new tires. The vehicle will better suit the needs of the lifeguards and is in great condition at a reasonable price.
