**Introduction to new Conservation Commission Members:**

It was announced that Jayne Flaherty resigned on April 7, 2009; Linda Newell on July 21, 2009; and Steve Bergeron on September 1, 2009. Appreciation was expressed for their service on the Conservation Commission.

State and Old Orchard Beach Charter - This was presented to each of those in attendance.

Title 30-A, Section 3261. Conservation commissions

Unless otherwise provided under their home rule authority, municipalities may establish conservation commissions as provided in this section. [1987, c. 737, Pt. A, §2 (NEW); 1987, c. 737, Pt. C, §106 (NEW); 1989, c. 6, (AMD); 1989, c. 9, §2 (AMD); 1989, c. 104, Pt. C, §§8, 10 (AMD).]

**1. Appointment of commissioners.** The municipal officers may appoint at least 3, but not more than 7, conservation commissioners. Members shall initially be appointed for terms of one, 2 and 3 years, such that the terms of approximately 1/3 of the members will expire each year. Their successors shall be appointed for terms of 3 years each. Members shall serve until the appointment of their successors.

The commission may recommend to the municipal officers that associate members be appointed to assist the commission as the commission requires. Associate members are nonvoting members. Their terms of office shall be for one, 2 or 3 years.

## OLD ORCHARD BEACH TOWN CHARTER AS OF 09/22/2009

Sec. 903. Conservation Commission.

There shall be a Conservation Commission composed of five (5) members, and two (2) Alternates who shall be appointed by the Council. Members of the Conservation Commission shall serve staggered three (3) year terms under 30-A M.R.S.A. § 3261 and shall serve until a successor has been appointed and qualified. The Conservation Commission shall be responsible for the care and superintendence of the public parks and shall have such powers and perform such duties as are provided by the laws of the State of Maine and the ordinances duly adopted by the Council, including the powers and duties of tree wardens. The Conservation Commission shall have the power to form subcommittees and/or advisory boa

## Memorial Park End of Summer Report

Andrea Berlin reported the park is the best it has ever looked. A lot of funds were saved by utilizing volunteer labor. One DPW summer employee has done a very good job and in in a good position to work in the park next year which will be a big help. We are ending the season with about 30,000 dollars which hopefully will be enough to start up the park next spring

**Donations from Rotary:** Drinking Fountain

Kiosk

Andrea reported that the Rotary Club has approved a donation for a drinking fountain in the park near the rest rooms and that the Memorial Park Subcommittee has won a donation grant for a public kiosk to be placed near the parking lot. This will be for public notices and events but not for general advertising. Council will see this on their next Council agenda.

**Security Camera** 

Andrea made mention of the need for more security in the Park. More vandalism has occurred this week.

**Pe'tanque Courts** 

This is game that is of interest to some members of the community. Once enough funds are rasied, we hope to place the courts to the side of the gazebo.

**Natural Resource Open Space Inventory** 

John Bird reported that the Environmental Subcommittee is in the process of conducting an open space inventory for the purpose of inclusion in the updating of the Comprehensive plan.

**Dune Grass** 

The health of the Dune Gras is of primary concern to the Conservation Commission. The newest member, Randy Sears has two masters in Marine Biology and Ocean Sciences. He is very interested in seeing that the Dunes are protected. The Environmental subcommittee is looking forward to working on the boardwalk project.

**Blueberry Plain** 

John reported that there was a problem in the blue berry fields. Members of the CC met with DEP on the issue. John reported that the plains are in good shape. The public seems to be self policing and staying of the trails with motor bikes etc. However, no cars should go there. The CC wants the bolders placed at the front of the plains as they once were. Alternative Energy

Jean LeClerc provided a very exciting presentation on the proposed wind study program for Old Orchard Beach. He explained that a grant was available through Efficiency Maine to put an anemometer tower up for 1 year to capture wind speed data. The hope is to place the wind tower next to the school so that the students can use this as a learning tool. He anticipates a small cost (approx. 100 dollars) to cover the liability insurance of the tower.

After hearing the presentation the Council was in full support of moving forward with this project.

In the discussion phase many of those attending participated in the areas of interest noted above. Impressive work has been done in the Ballpark which was highlighted in the information provided by the Ballpark Working Group. It had completed its initial mission which was delineated in the April 14 Improvement plan and the formation is being done of a structured administrative group which would alleviate cited concerns over the ability to conduct more aggressive fundraising, oversight of decisions affecting the Ballpark Rehabilitation and its future plans and the need for a more diverse representation of interest. Those who participated were acknowledged for their work in moving these objectives forward. Mention of the previous studies done on the ballpark and the desire to reestablish interest in the formation of a group to look to continue use of this vital piece of property. In the previous study that was done there was a good effort put forward and the onward progress of a new committee is vital to moving forward.

Impressive talk also included whether wind power is appropriate and feasible for the Town. The desire is there to move forward on this study as well and the formation of a Wind Power Master Plan. This would permit the identification of areas within the Town that are most appropriate for wind power developed based on community impacts (sound, visual, shadows, etc.). There are costs relative to this study and that is something to be considered in the future. The suggested collaboration with the schools brought great acknowledgement.

Tom LeChance wowed the Committee with an update on what has been done not only on funding but on interests that have been made known for uses within the Ballpark. He reported on the fund balance of \$22,661.79 including the payment of materials to Deering Lumber, ABC Supply (Roofing), Lowes, Winding Brook Turf, Irrigation Doctor, Ray's Trucking, Pierre Bouthiller, Lakeview Lumber, Michelles Carpetry, B&S Security and Pro-Turf. Donations he reported on were in the amount of \$16,114 and many still contribute to the ongoing work that is being done. He spoke of the need for equipment with a projected maintenance budget of \$39,350.54.

Enormous support was expressed by Lucien Huot who sang the praises for the work that was being done by volunteers at the Ballpark. He expressed his appreciation and his great enthusiasm for the continued growth of development in the Ballpark. The Chair expressed appreciation for all those who had come out and for those who made presentation and for making this a productive workshop.
