## REPORT OF SUPERVISOR OF SCHOOLS.

---

*To the Citizens of Old Orchard:*

As I present my second report of our schools, I desire to acknowledge my thanks to Divine Providence, by which our teachers and scholars have been sustained in health, sufficient to attend to their school duties.

I think our average attendance would be materially increased if the parents had more interest in the education of their children. It is a sad state of things when parents will allow their children to remain away from school, day after day, and spend the most important part of their lives in ignorance and idleness. We have one hundred and fifty-five scholars in this town at present who draw school money; and one hundred who attend school. Some few attend school in other towns, and in some cases this may be necessary. But as far as possible our scholars should be kept in our own schools until they have passed through all our studies. I would call the attention of the truant officer to those children who are always found upon the streets and never in the school room, that his power may be felt when parents can no longer control.

Our teachers of last year are still with us. Mr. Fling in the high school is doing his work faithfully and efficiently, as the results show in the examination of his scholars each term. A class in Latin has been formed during the last term, which I think adds to the interest of the school and is full of promise. Miss Fling is one of our best grammar school teachers. She has a thorough knowledge of all the branches taught in such a school, and this with her excellent discipline must insure her constant success. Miss Mayberry, in the primary department,

has a most trying, as well as important position; and I have been pleased of late to observe some improvement in discipline and instruction.

I desire to renew my request of last year, in regard to the accommodations and sanitary condition of our school rooms. If we cannot move our school house to a more beautiful and healthy location, I recommend that the town build suitable water-closets, and furnish proper sewerage and drainage as soon as possible, for the above named improvements are woefully neglected. You are also aware that we have no suitable building for our primary school; therefore, the welfare of our children demands that such accommodations be provided at an early day; and I advise that a house for said purpose be erected, near where the school is now held.

I find it my duty to call your attention to the new law, which makes it the duty of every town to furnish all text books necessary to be used in our schools, at public expense. I have considered the matter with much care, in order to give you a basis upon which to act at your next town meeting; for the money must be available for the purchase of said books, such as we need, as soon as next August, at which time the law takes effect. The Supervisor or Committee have a legal right to replace by others, such books as have been in use five years or longer. Those which have not been so long in use can only be changed by a vote of the town. I have assumed that such books as are now in use and can be used for the next year or two, will be retained without extra cost to the town. I therefore recommend that you raise at least two hundred and fifty dollars for this purpose.

WARRANT FOR  
ANNUAL TOWN MEETING,

MARCH 3d, 1890.

To P. C. Harley, Constable of the Town of Old Orchard, in the  
County of York, Greeting:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of said Town of Old Orchard, qualified by law to vote in town affairs, to assemble at Porter's Hall in said Town, on Monday, the third day of March, A. D., 1890, at 10 o'clock in the forenoon, then and there to act upon the following articles, to wit:

1st—To choose a moderator to preside at said meeting.

2nd—To choose all necessary town officers for the year ensuing.

3rd—To hear and act upon the report of the town officers and all standing and special committees.

4th—To see what action the town will take in relation to pay of town officers.

5th—To see if the town will vote to raise a sum of money not exceeding six hundred dollars, for building the county road from Saco line to Ocean Park.

6th—To see what sum of money the town will raise, 1st, for common schools; 2nd, free high school; 3rd, making and repairing highways and bridges; 4th, support of poor; 5th, pay of town officers; 6th, maintaining street lights and electric lights; 7th, contingent expenses; 8th, sanitary expenses; 9th, interest on loan for highways; 10th, reducing debt.

7th—To see what sum of money the town will vote to raise to pay collector's commissions, abatements and discounts.

8th—To see what compensation the town will vote to pay the Collector for collecting taxes for all moneys actually collected.

9th—To see if the town will vote when the taxes shall be committed to the Collector for collection, and what discount shall be allowed on both town and special, if paid within a given date, and charge interest thereon thereafter.

10th—To see if the town will authorize the Selectmen and Treasurer to hire money in anticipation of taxes and not exceed the same.

11th—To see if the town will authorize the Selectmen and Treasurer to issue town notes, to pay those which fall due the present year.

12th—To see if the town will authorize the school agent to employ the school teachers.

13th—To see if the town will authorize the assessors to make such abatements as they think reasonable.

14th—To see if the town will vote to set out and replace such shade trees as the Selectmen deem expedient, not to exceed the sum of 5 per cent. of the amount appropriated for highways.

15th—To see if the town will vote to accept so much of Ocean Avenue as extends from Seaside Avenue to the sea wall as per W. S. Dennett's plan of lands of Old Orchard Beach association.

16th—To see if the town will vote to accept the extension of Central Park Avenue, commencing at Washington Avenue, running five hundred (500) feet southeast towards the Boston & Maine R. R. as per plan of E. C. Staples.

17th—To see if the town will vote to authorize and direct the School Supervisor to make such changes in school books now in use in the town as he may deem expedient.

18th—To see what sum of money the town will raise for the purchase of school text books.

19th—To see what action the town will take and what sum of money the town will raise to maintain police force; construct and maintain sidewalks; to maintain fire department; for hydrant rental; for interest on debt incurred in fire department, sewers and loan. All within the limits set out in section four of the Act of Incorporation of the town of Old Orchard, to be a separate tax, to be assessed and collected as provided in said Act.

20th—To see if the town will vote to maintain a hydrant on the proposed extension of the Old Orchard Water Co. on the Milliken's Mill road as per petition, within the limits set out in section four of the Act of Incorporation of the town of Old Orchard, to be a separate tax to be assessed and collected as provided in said Act.

21st—To see if the town will vote to raise three hundred dollars (\$300) for building and repairing sewers, within the limits set out in section four of the Act of Incorporation of the town of Old Orchard, to be a separate tax to be assessed and collected as provided in said Act.

22nd—To see if the town will vote to build a sewer, beginning at or near the Highland House, (Union Avenue,) extending from thence down Union Avenue to First street, thence through First street to Atlantic Avenue, within the limits set out in section four of the Act of Incorporation of the town of Old Orchard, to be a separate tax to be assessed and collected as provided in said Act.

23rd—To see if the town will authorize the Selectmen to make a loan for the purpose named in article twenty-second.

24th—To see what action the town will take to extend the fire alarm service within the limits set out in section four of the Act of Incorporation of the town of Old Orchard, to be a separate tax to be assessed and collected as provided in said Act.

25th—To see what action the town will take in regard to closing the places of business on Sundays.

26th—To see what action the town will take in regard to regulating excursions coming into the town on Sundays.

The Selectmen hereby give notice that they will be in session at the ante room of Odd Fellows' Hall, on the morning of election from 8 to 10 o'clock, for the purpose of revising and correcting the check list.
