## SCHOOL REPORT.

---

To the Citizens of Old Orchard:

In this, my third annual report of the schools of Old Orchard, I am pleased to state that the progress along all lines has been satisfactory. No radical changes have been made in the courses of study or in the methods of handling the pupils. Rather, we have been pursuing an even course, increasing the efficiency of the work, watching developments and laying the basis for further changes which we believe will work toward better training for pupils in all grades.

### COMMON SCHOOLS.

During the summer, several changes were made in the Primary School building, which have added to the comfort of teachers and pupils by eliminating the bad sanitary conditions which have existed for a long time.

We have introduced into the language studies, a new series of text-books which, by using a more natural method of teaching, will produce better results in grammar, spelling and the use of correct speech. The Harvey's Essentials of Arithmetic, which were introduced during the previous year, have been extended to all the schools.

During the last Spring term, we also attempted for the first time, some slight training in handwork in the elementary schools. This work proved its value from the start, not only in the fine quality of work done, but also in the interest which it aroused among the pupils. The exhibition of the work which was held during the term was a source of pride to parents and friends and of gratification to those who trained the pupils in the work.

## HIGH SCHOOL.

Last June, after looking over the work accomplished during the previous year, we felt that some changes in the curriculum were absolutely necessary in order to save some of our pupils from merely drifting. We found that we had too much of the abstract and too little of the concrete. To remedy this, we introduced Biology. We also introduced Commercial Arithmetic as a foundation for a business course. Through such studies as these, the student learns by doing and gains the value of doing. We also introduced medieval and modern European history, as a connecting link to make our course in history complete. Within the last few weeks, we also introduced a course in Literature to fill an undesirable gap in our training in English.

I have included with this report an outline of curriculum in the high school as at present organized. We believe that since this course not only allows a pupil to prepare for college, but also offers great advantages for the non-college pupil, this is as good a course as could be arranged in a two-teacher high school.

## RECOMMENDATIONS.

During the coming year, we wish to aim toward greater unity in the education of the pupil. We feel that the greatest fault in our present system is the gap between high school and elementary school and our first recommendation this year is to so change the studies in the two upper grades of the grammar school and the first grade of the high school as to make the high school more attractive to the pupil and to make his entrance into that school easier and more natural.

To do this, we would suggest that the seventh and eighth grades be taken from under the supervision of the grammar school and put under the supervision of the high school. By this system, it would be possible for the pupils in these grades and the pupils in the first grade of the high school to have certain courses in common. This group of grammar school and high school pupils would become an intermediate or junior group. This would change the traditional "jump" from grammar school to high school to an easy and natural step. It would also accustom the pupil

in the higher grades of the grammar school to the system of elective courses and to the freer methods of school room conduct which are so valuable in increasing his self-restraint. We would also suggest that a new teacher be added to the teaching force, if only as a part time teacher. This together with the additional room which would be available for common use between the three upper classes of the high school and the junior group, would make it possible to introduce some such needed courses in handwork which would be open to members of the junior group. If the additional teacher was required by the junior group for only a part of her time, she could be used for additional work in the lower and primary grades, spoken of below. By this system, we believe that more pupils will be saved for high school education and thus better equipped for life.

As a second recommendation, I urge with all the earnestness within me, that something be done to improve the educational facilities in our Primary Department, along lines as suggested in my report of last year.

The years in the primary school are the most critical of the child's life. Not only is this the period in which the memory and imitative powers are trained the most easily, but of more importance still, it is the period when habits are formed that will go far towards the child's equipment for future usefulness.

Our needs along lines of school equipment will depend largely upon the action taken on the above recommendations.

In closing, I wish to especially commend the faithful services of our janitor, Mr. E. E. Googins, who at all times has labored to keep our school buildings in a first-class sanitary condition.

During the year, I have received great help from the school committee, teachers, officers of the town and citizens. I desire to thank all for their kindness, consideration and support.

## WARRANT.

---

To Howard N. Robinson, Constable of the Town of Old Orchard, in the County of York:                    GREETING:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of said town of Old Orchard, qualified to vote in town affairs, to assemble at the Town House in said town, on Monday the 5th day of March, A. D. 1917, at 10 o'clock in the forenoon, then and there to act upon the following articles, to wit:

1st. To choose a moderator to preside at said meeting.

2nd. To choose all necessary town officers for the ensuing year.

3rd. To hear and act upon the reports of the town officers and all special and standing committees.

4th. To see what action the town will take in relation to pay of town officers.

5th. To see what sums of money the town will raise: 1st, for common schools; 2nd, for free high school; 3rd, for free text books; 4th, for making and repairing highways and bridges; 5th, for the support of poor; 6th, for the pay of town officers; 7th, maintaining street lights and electric lights; 8th, for contingent expenses; 9th, for sanitary expenses; 10th, for town interest; 11th, for repairing school-houses; 12th, for the public library; 13th, for heating, lighting and care of town property; 14th, for moth nests.

6th. To see what sum of money the town will vote to raise to pay collector's commission, abatements and discounts.

7th. To see what compensation the town will vote to pay the collector for collecting taxes for all moneys actually collected.

8th. To see if the town will vote when the taxes shall be committed to the collector for collection and what discount, if any, shall be allowed on both town and special taxes, if paid within a given date, and what rate of interest, if any, will be charged thereon, thereafter.

9th. To see if the town will authorize the Selectmen and Treasurer to hire money in anticipation of taxes and not exceed the same.

10th. To see if the town will authorize the Selectmen and Treasurer to issue town notes to pay those, if any, which fall due the present year.

11th. To see if the town will authorize the Assessors to make such abatements as they think reasonable.

12th. To see what amount of money, if any, the town will raise to be applied on the town debt.

13th. To see what action the town will take and what sums of money the town will raise to maintain a police force; to construct and maintain sidewalks; to construct and maintain sewers and drains; to maintain fire department; to maintain town team; for hydrant rental; for interest on debt incurred in fire department, sewers and loans, all within the limits set out in Section IV, of the act of incorporation of the town of Old Orchard, to be a separate tax, to be assessed and collected as provided in said act.

14th. To see if the town will vote "yes" or "no" on the question of appropriating and raising money necessary to entitle the town to State aid as provided in Sec. 20 of Chap. 130 of the Public Laws of 1913.

15th. To see if the town will raise and appropriate the sum of \$732.00 for the improvement of the section of State Aid road as outlined in the report of the State Highway Commission, in addition to the amounts regularly raised for the care of ways, highways and bridges, the above amount

being the maximum which the town is allowed to raise under the provisions of Section 19 of Chapter 130 of the Public Laws of 1913.

16th. To see if the town will vote to designate and set apart a definite sum of money from the regular appropriations for sidewalks, for the purpose of maintaining and constructing highways and sidewalks in that part of Old Orchard known as Ocean Park, and what sum it will so set apart for each purpose.

17th. To see if the town will vote to instruct the municipal officers in regard to the expenditure of the \$3,000 appropriated by the State for the town of Old Orchard.

18th. To see if the town will vote to appropriate a sum of money sufficient to pay for the services of a school physician as required by Chapter 73 of the Public Laws of 1909.

19th. To see what sum the town will vote to appropriate for the purpose of cleaning beach during the summer season.

20th. To see if the town will vote to provide extra lighting on the sea wall during the summer months, and how much it will appropriate therefor.

21st. To see what action the town will take in regard to extra lighting of streets during the summer months and how much it will appropriate therefor.

22nd. To see if the town will vote to authorize the Selectmen to appoint a Building Inspector in conformity with Sec. 25, Chapter 40 of the Public Laws of 1915.

23rd. To see if the town will vote to celebrate Old Home Week, and if so, to raise a committee of arrangements, and how much it will appropriate therefor.

24th. To see if the town will vote to grade and gravel Hampton Ave. from Surf St. to Sea Side Ave., and how much it will appropriate therefor.

25th. To see if the town will vote to continue lighting sign on Old Orchard St., and how much it will appropriate therefor.



26th. To see if the town will vote to establish a hydrant on Tunis Ave., and how much it will appropriate therefor.

27th. To see if the town will vote to paint the Town Hall, and how much it will appropriate therefor.

28th. To see what action the town will take in regard to gravelling the Beach end of Union Ave., and how much it will appropriate therefor.

29th. To see if the town will vote to purchase a steam road roller, and how much it will appropriate therefor.

30th. To see if the town will vote to grade and gravel Surf Side Ave., and how much it will appropriate therefor.

31st. To see if the town will vote to grade and gravel Sea View Ave. from Central Ave. to Hillside Ave., and how much it will appropriate therefor.

32nd. To see if the town will vote to extend sewer on Fern Park Ave. to Elizabeth Cottage, and how much it will appropriate therefor.

33rd. To see if the town will vote to grade and gravel First St. from Union Ave., to Atlantic Ave., and how much it will appropriate therefor.

34th. To see if the town will vote to grade and gravel Sea Forth Ave., and how much it will appropriate therefor.

35th. To see if the town will vote to establish a hydrant on Portland Road near property of H. T. Googins, and how much it will appropriate therefor.

36th. To see if the town will vote to establish a hydrant on East Grand Ave., at corner of Sea Forth Ave., and how much it will appropriate therefor.

37th. To see if the town will vote to grade and gravel 15th St., from Union to Saco Aves., and how much it will appropriate therefor.

38th. To see if the town will vote to appropriate a sum of money for the beautifying of grounds around the Town Hall.

39th. To see if the town will vote to establish a hydrant at the corner of Woodland and Hillside Avenues, and how much it will appropriate therefor.

40th. To see if the town will vote to grade and gravel Flint Street, and if so, to appropriate the sum of \$200 therefor.

41st. To see if the town will vote to accept the proposition of the B. & M. Railroad in regard to location of public toilet on Railroad Park.

42nd. To see if the town will vote to construct a public toilet on Railroad Park and how much it will appropriate therefor.

43rd. To see if the town will vote to straighten, grade and gravel Cascade Road, and how much it will appropriate therefor.

44th. To see if the town will vote to grade and gravel Temple Ave. from Goose Fair Brook (Saco line) to tracks of the B. & M. Railroad.

45th. To see if the town will vote to establish signs at the four inlet streets from the State highway, and how much it will appropriate therefor.

46th. To see if the town will vote to construct cement walks on the following streets: On southeast side of Fourth St. from Colby Ave. to Randall Ave.; on northwest side of 15th St. from Union Ave. to Saco Ave.; on northeast side of Union Ave. from 3rd St. northwesterly; on southwest side of Beach St. from Grand Ave. to beach; on east Grand Ave. from Walnut St. northeasterly; on southeast side of Grand Ave. from end of walk already constructed, northeasterly to Tioga Ave.; on east Grand Ave. on southeast side from end of walk, northeasterly, 500 feet; on northeast side of Brown St. from Grand Ave. to the beach.; on northeast side of Trainor St. from Grand Ave. to the beach.

47th. To see if the town will vote to establish the following electric lights: Seven summer and one permanent light at Ocean Park, in such location as may be designated

by the Ocean Park Association; one permanent light on Evergreen Ave., at foot of 9th St.; one summer light on Fern Park Ave., above Ivy Ave.; one permanent light in Park Ave. near Mrs. Perry's; one permanent light on corner of Wesley and 11th Sts.; one permanent light on Portland Ave. at trotting park, and how much it will appropriate therefor.

48th. To see if the town will vote to purchase a pair of horses for the town team and how much it will appropriate therefor.

49th. To see if the town will vote to authorize the Selectmen to issue bonds in the sum of \$10,000 in lieu of those maturing in 1917.

50th. To see if the town will vote to accept Forest Ave. from Union Ave. to Sea View Ave., as laid out by the Selectmen.

51st. To see if the town will vote to accept Sea View Ave., from Forest Ave. to Somerset Ave., as laid out by the Selectmen.

52nd. To see if the town will vote to grade and gravel Ancona Ave., from First St. to the beach, and how much it will appropriate therefor.

53rd. To see if the town will vote to grade and gravel Tioga Ave., from Grand Ave. to Surf St., and how much it will appropriate therefor.

To act upon any other business that may legally come before said meeting.

The Selectmen hereby give notice that they will be in session at the Town Hall for the purpose of revising and correcting the voting list, on the morning of election from 8 to 10 o'clock.
