## Board of Health Report

By alert inspection of streets and back yards, that they may be free from all nuisances, by guarding carefully the handling of all food consumed by the people, by enforcing quarantine with those taken with contagious disease, so as to check the spread of any troublesome epidemic, and by giving close attention to all plumbing done throughout the town, to see that it is done according to the requirements of the State law, the Board seeks to maintain the best possible sanitary conditions all over the town.

Throughout the year the Board has done its best to respond to all complaints from householders and others in regard to unsanitary conditions and nuisances, and have given vigilant inspection, setting them right so far as possible.

Garbage has been well taken care of by the men contracting for it, except that there were many complaints from the Ocean Park section during the first half of the season. It is gratifying to note that the metal container for garbage, required by law, has come into very general use by householders.

The Board has been vigilant in the inspection of food in groceries, fruit stands and eating places, requiring the screening of all rooms where food is served. Grocers and fruit sellers have been required to keep all goods, displayed outside their stores, 18 inches up from the sidewalk, out of the way of stray cats and dogs,

Through its Health Officer the Board has issued health certificates to 750 (seven hundred and fifty) persons handling the food of the Town. Upwards of 50 persons brought health certificates from other towns, so that we had approximately 800 food handlers in town during the summer.

The Health Officer reports the following contagious disease cases during the year:

Measles, 5 cases.
German Measles, 9 cases.
Whooping Cough, 2 cases.
Chicken Pox, 7 cases.
Tuberculosis, 1 case.
Syphilis, 1 case.

In connection with the above the Health Officer has made 54 calls on school children sent home and reported by the teachers as possible cases of contagious disease.

#### **PLUMBING**

This is the first year that the Board of Health has given attention to the matter of plumbing. When the new plumbing laws came into force last spring it was difficult to know just how to apply them. However, after due consideration by the Town Officials, it seemed best to adopt the new State Code as a whole. This new Code, with two sections meeting further requirements of the State laws, make up what constitutes the Plumbing Ordinances of the Town of Old Orchard.

These Ordinances were published in due form, and approved by Supreme Judicial Court Justice Dunn. They were also placed on file with the Town Clerk of Old Orchard.

Under these ordinances, the Board has issued 48 plumbing permits, and made 58 plumbing inspections. For this clerical work and the inspections no appropriation was made at our last Annual Meeting. This matter, as well as the licensing of plumbers, ought to receive attention at our next annual meeting, March 5th, 1928.

### School Report

To the Board of Education and the Citizens of Old Orchard:

Any modern plan of education aims to prepare the pupil to fit into an increasingly complex social situation. To teach the child to think as well as to memorize; to form correct habits and attitudes toward society, citizenship and work; at all times to consider your child as an individual and to preserve and strengthen the aptitudes and abilities with which heredity has endowed him; these and other educational endeavors have been reflected in these reports and our classrooms.

In the administration of this program, it has been like wise our aim always to study the existing plan scientifically and from time to time to suggest changes,—sometimes an addition and sometimes the dropping of some feature which has not proved its usefulness. Education is dynamic. The aims remain much the same but the materials and methods differ as the social situation changes.

Finally, always remembering that the schools depend on public taxation, it has been our aim to make the best possible use of all facilities and of the particular abilities of the members of the teaching staff.

#### Enrollment and Attendance

It is gratifying to note that efforts along the lines indicated above have resulted in increasing the holding power of the schools, so that more pupils are now going out into adult citizenship with a greater general education. This may be seen from a comparison of the school enrollment in 1927 and 1917:

The gain in grades 1-6 represents the growth in the school population; the gain in the upper grades represents the greater holding power of the schools. Perhaps this is the more significant because it was just ten years ago that we began to shape our organization along the lines of the junior-senior high school plan.

While considering this enrollment it may be worth while to give a word to the question of attendance and tardiness of the pupils.

Regularity of attendance and punctuality are obviously necessary if a pupil is to gain the greatest benefit from school attendance.

This does not mean that a pupil or his parents should make an idol of perfect attendance to be attained regardless of the physical condition of the child. The parent should carefully consider the health of the child and if he is not in suitable physical condition to attend as for instance in very inclement weather, consideration of his health should come first. On the other hand, nothing other than physical condition or a real emergency should be permitted to break into regularity of attendance.

There is rarely a good cause for tardiness. Pupils should be expected to take all the precautions that any reasonably careful person would take to be on time. They should take into account each day the possible causes of delay and aim to overcome them. Except in very few situations is the so called "excuse" for tardiness other than an "alibi," reflecting that the pupil,—or sometimes his parents,—have been careless. All parents are urged during the coming months to cooperate with the school authorities in obtaining a better record for punctuality on the part of the pupils.

#### Academic Adjustment

One special effort now going on is intensification of the work in language in both the elementary and the high schools. An experimental special course in English to correct the deficiences of various pupils in the high school is being

tried. If it proves valuable, it will probably lead to further intensification along similar lines in other subjects.

#### Health

In connection with home economics, a new course has been organized in home nursing. In conducting this course the teacher has had the enthusiastic cooperation of Miss Edna Avery and Miss I. C. Johansen of the York County Public Health Service.

The home economics department has also provided a hot dish during noon recess for pupils' lunches.

The usual health examinations have been conducted by Dr. Pepper and Dr. Brown in cooperation with Miss Johansen.

Throughout the year, Mr. Armstrong, as a member of both the Board of Health and the Board of Education, has greatly assisted and encouraged the development of our health program.

Our accomplishments and aims along health lines will be more fully discussed in the appended reports of Principal Jewett, Dr. Brown and Miss Johansen.

#### Athletics

It is gratifying that a committee has been appointed to consider the possibility of erecting a building which will provide suitable quarters for indoor athletics for the pupils. It is earnestly hoped that a favorable report will be presented and favorably acted upon at the Annual Meeting. May we again affirm our belief that such a building would probably be self-supporting in the summer, thus providing facilities without cost during the school year?

#### Community Service

Believing that community service training is of great importance, we are happy to note that all grades of the Old Orchard schools belong to the Junior Red Cross and that many of our boys belong to the local Scout Troop. The fact that W. Warren Harmon and Clyde R. L. Snow, former

members of the Board of Education, and Principal Frank H. Jewett are associated with the scout organization, has greatly stimulated scout work among the boys in our upper grades.

Thrift Encouragement

Since February 4, 1924, our schools have had a School Bank conducted by pupils of the high school in co-operation with Miss Donaldson of the Saco & Biddeford Savings Institution. During this time the pupils of the Old Orchard schools have made a total deposit of \$2,731.09.

#### Staff

It will be remembered that the schools opened in September, 1926, with six new teachers in a total staff of eleven. It is gratifying to note that these new teachers have consistently shown the efficiency, cooperative attitude, and professional spirit which mark our teachers. Last September we were fortunate in having only two changes. We were sorry to lose the departing teachers but the experienced teachers who were obtained to take their places are proving of the type we are glad to place in charge of our children.

It is also fitting to specially commend Mr. Bernard, the janitor, for his efficiency in keeping the school buildings in good condition and for his cooperative attitude in his contacts with the entire staff.

#### Equipment

A new fence has added materially to the appearance of the school center. New desks of the modern movable type have been placed in the freshman room of the high school. A new "slide" has been added to the playground. This was purchased through the efforts of the school. Two pianos, one temporarily loaned and the other being provided through the efforts of the teachers, have been added to the equipment of the elementary school. These have been of inestimable value in the advancement of the musical program. Through the generosity of Dr. Pepper, a bed has been added to the equipment of the health room.

#### **Finances**

Again this year it has been possible to conduct the schools with a balance at the end of the year, due to unexpected opportunities for economy and increased state allowances. Perhaps it should again be noted, however, that because a business board has been able to make unexpected savings, it should not be penalized by any reduction in the carefully estimated requests for the coming year.

#### Recommendations

As in recent reports, the major recommendation for the year is that manual training be added to the elemenary and high school programs. By manual training we do not mean an intensive trade course in mechanics. It should be rather a course giving the boy a background valuable at home or in industry; a "try-out" course in which the boy may determine whether he is fitted for mechanical pursuits; a course in which he can put into practice and see a motive for many of the things he learns in academic subjects, giving an incentive for better work in the whole school program and, above all, a course which will develop neatness, accuracy, self-reliance, and a proper regard for order and concentration.

Thus, subject to the approval of definite plans by the Board of Education, it is respectfully recommended:

- 1. That a cement floor be laid in the basement of the elementary school building.
- 2. That part of the space so provided be set off as a special room for manual training.
- 3. That funds be provided for the purchase of minimum equipment for these courses.
- 4. That arrangements be made for the employment of a whole or part time instructor to teach these courses.

In closing I wish to express my appreciation of the courteous and cooperative manner in which the members of the Board of Education and the teaching staff have considered and assisted in the various developments during the year.

#### To the Superintendent of Schools:

The registration for the fall term in the last four years of our Junior-Senior High School was 56. Five years ago the registration for the same four grades was 29. By this you will see that the growth in the high school has been nearly 100 per cent in the last five years. What is true of the high school is also true to a great extent of the lower grades. Our attendance for the past year has maintained a good average. I wish to call the matter of tardiness to your attention. I believe this should be given serious consideration by the parents and that an effort should be made to keep the number of instances as low as possible.

This year we instituted a custom of posting the names of the students whose rank fell in one of three honor divisions, namely:

Our health program which has been one of the important factors in our school life for the past seven years has been carried on this year as usual. We have had both dental and medical inspections. In addition we have had the very able assistance of Miss Johansen, the York County Nurse, in doing special work with the pupils. Under her direction each pupil has been weighed and measured and given sight and hearing tests. After the examinations are completed suggestions for needed corrections are made and a considerable amount of follow-up work carried on. The course in Home Nursing, which has been under the direction of Miss Johansen, has been a very valuable one to the girls.

During the past year the elementary school department gave a play and entertainment from which they realized about seventy dollars. This sum was used to purchase a slide for the play ground equipment. Last fall a piano was purchased for use in the elementary building. This has already been partly paid for by money raised by the school. Both the teachers and myself appreciate the splendid spirit of cooperation and helpfulness given by the parents and citizens in supporting these outside activities.

Much time this year has been devoted to solving individual problems. We have endeavored to fit our course of study to meet the greatest needs of the largest number of pupils.

The one outstanding need in our school is a course in manual training for the boys. I sincerely hope some course may be taken up soon that will meet this need if only in a small way.

In closing let me state that the loyal support and hearty cooperation which you, the Superintending School Committee, parents and citizens have accorded us as your teachers is deeply appreciated.

#### REPORT OF THE NURSING WORK

To the Superintendent of Schools:

The annual inspection for the school this year was made January 4, 1928. Dr. Pepper made inspection of the throats at that time, the nurse accompanying him. Dr. Brown gave the dental inspection. The following report includes their clinical findings as well as the other inspection, such as testing eyes and ears and weighing and measuring done by the nurse:

The number inspected this year was 205. There were 39 who had abnormal throat conditions, 4 had defective hearing, 68 needed immediate dental care, 24 had defective vision. There were 16 corrections of abnormal throat condi-

tions, 12 of the teeth and 5 of the eyes. Four children were found to have suspicious lung conditions. Twenty-eight were more than 10 per cent under and 9 were more than 20 per cent over the average weight for height and age. Red tags were given to all pupils who were either more than 10 per cent underweight or more than 20 per cent overweight. Green tags were given to those who were between 7 and 10 per cent under and 15 and 20 per cent over, and white tags to those who were nearly or exactly the average weight.

Health talks have been given in every room, also posture drills to promote better sitting, standing and walking positions.

To encourage the pupils to be 100 per cent physically, a contest is promoted by the Maine Public Health Association in which a "Six-point" Button is given to the children who are 100 per cent throughout the year. Already we are glad to report 22 who, if they continue in the same condition, will in May, Child Health Month, secure this button. We hope that others will join them as they get corrections made thus becoming 100 per cent. The enthusiasm for health seems to be great among the children and we hope many more will be "Six-point" children.

In cooperation with the teacher in the Department of Home Economics, classes in Home Nursing with demonstration have been given to a small group of girls in the High Although the class started with only six, one of School. whom moved away, there is scarcely a week but there are as many as 10 to 14 present for at least a part of the time, or as long as their other classes will permit. The girls seem to A health room has been fitted up be very much interested. in the new building and the classes are held there except These classes have when it becomes necessary to use heat. been held, one each week covering two periods, since October, when demonstrations began, and will close in February. The five pupils, who are officially enrolled, are eligible to a certificate from the National American Red Cross by whom

the course is directed and with the County Nurse as Red Cross Instructor. Altogether the nurse has spent four whole days at the school besides the class instruction and miscellaneous visits to schools and several other places, as well as many home visits.

A Health Talk was given in cooperation with the State Department of Health by Dr. G. H. Coombs, Director of Communicable Disease Division. This talk was given to the boys and girls of the Junior High and High schools in segregated groups.

A Health Talk was given to the Women's Club by the Nurse, about 20 being present.

The school program for this year in the Maine Public Health Association is to promote as many "Six-point" children as possible. A "Six-point" child is one who measures up to the minimum standards as indicated by physical inspection of the following points:

- 1. Vision—Child should be able to read a line marked 20 at a distance of 20 feet or have glasses fitted properly.
- 2. Child should hear whispered voice at a distance of 20 feet.
- 3. Child should have teeth that are reasonably clean and no unfilled cavities in them.
- 4. Child has no symptoms of trouble with throat or nasal obstruction and is not a mouth breather.
- 5. Child does not weigh more than 10 per cent under the average or more than 20 per cent over the average for height and age.
- 6. Child has excellent posture in sitting, walking and standing.

We ask your cooperation in helping your town to have as many "Six-point" children as possible. A healthy child is the town's greatest asset.

# DENTAL EXAMINER'S REPORT TO SUPERINTENDENT OF SCHOOLS

I herewith tender my report as Dental Inspector for the Old Orchard Schools for year 1927-1928.

The inspection this year convinced me that the parents of Old Orchard, who realize the importance of the healthy, clean mouth, in the preserva ion of good health, its necessity for perfect physical development and mental attainment are giving the mouths of their children thoughtful consideration and care.

Of the two hundred and seven children examined by me thirty two had their teeth without a cavity, twelve of them had one cavity each, twenty one had two cavities each and fourteen had three each.

Thus seventy-nine of the two hundred and seven were in very excellent condition and with very small amount of attention may be considered perfect dentally.

If I could but complete my report thus, but one hundred and twenty-two of these children had from four to fourteen cavities each and six had from fourteen to seventeen cavities while many of these children had one or more alveolar abscesses.

Every alveolar abscess discharges pus directly into the bloodstream or into the mouth and thus poisons the bloodstream by the digestive tract.

May I ask is it right to spend your public money for the mental development of your children and to neglect the physical well-being of these same children?

# Town Warrant

# March 5, 1928

To Frederick H. Googins, Constable of the Town of Old Orchard, in the County of York:

# Greeting:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of said Town of Old Orchard, qualified to vote in town affairs, to assemble at the Town Hall in said town, on Monday, the 5th day of March, A. D. 1928 at 9 o'clock in the forenoon, then and there to act upon the following articles, to wit:

1st. To choose a moderator to preside at said meeting.

2nd. To choose all necessary town officers for the ensuing year.

3rd. To hear and act upon the reports of the town officers and all special and standing committees.

4th. To see what action the town will take in relation to pay of town officers.

5th. To see what sums of money the town will raise. 1st, for common schools. 2nd, for free high school. 3rd, for free text books. 4th, for making and repairing highways and bridges. 5th, for the support of poor. 6th, for the pay of town officers. 7th, maintaining street lights. 8th, for contingent expenses. 9th, for sanitary expenses. 10th, for town interest. 11th, for repairing schoolhouses. 12th, for fhe public library. 13th, for heating, lighting and care of town property. 14th, for moth nests. 15th, State road patrol. 16th, public toilet. 17th, school supplies. 18th, for transportation of high school scholars. 19th, for advertising. 20th, for payment of serial bonds. 21st, for tarvia. 22nd, schoolhouse maintenance.

- 6th. To see what compensation the town will vote to pay the collector for collecting taxes for all monies actually collected.
- 7th. To see what sum of money the town will vote to raise to pay collector's commission and abatements.
- 8th. To see if the town will vote when the taxes shall be committed to the collector for collection and what rate of interest, if any, will be charged thereon, thereafter.
- 9th. To see if the town will authorize the Selectmen and Treasurer to hire money in anticipation of taxes.
- 10th. To see if the town will authorize the Selectmen and Treasurer to issue town notes to pay those, if any, which fall due the present year.
- 11th. To see if the town will authorize the Assessors to make such abatements as they think reasonable.
- 12th. To see what action the town will take and what sum of money, if any, the town will raise to maintain one or more regular patrolmen.
- 13th. To see what action the town will take and what sums of money the town will raise to maintain a police force; to construct and maintain sidewalks; to construct and maintain sewers and drains; to maintain fire department; to maintain town team; for hydrant rental; for liquidating Serial Bonds; for interest on debt incurred in the fire department, sewers and loans, all within the limits set out in Section IV, of the act of incorporation of the town of Old Orchard, to be a separate tax, to be assessed and collected as provided in said act.
- 14th. To see if the town will vote "yes" or "no" on the question of appropriating and raising money necessary to entitle the town to State Aid as provided in Section 20 of Chapter 130, of the Public Laws of 1913.
- 15th. To see if the town will raise and appropriate the sum of \$1,333 or the sum of \$6,665 for the improvement of the section of State Aid road as outlined in the report of the

State Highway Commission, in addition to the amounts regularly raised for the care of ways, highways and bridges, the amount being the maximum which the town is allowed to raise under the provisions of Section 19 of Chapter 130 of the Public Laws of 1913.

.16th. To see if the town will vote to appropriate a sum of money separate from and in addition to the regular highway appropriation for the purchase of Tarvia, or any other dust laying or road saving material and what sum they will so appropriate.

17th. To see if the town will vote to appropriate a sum of money sufficient to pay for the services of a school physician as required by Chapter 73 of the Public Laws of 1909.

18th. To see what action the town will take and what sum of money they will vote to raise for the purpose of keeping clean or free from paper and other waste matter, Surf Street, Old Orchard Street, and East and West Grand Avenues, or those parts of East and West Grand Avenues contiguous to the congested center of the town, during the summer months.

19th. To see what streets or parts of streets the town will vote to lay dust during the summer months, and what part of the cost thereof, if any, shall be assessed against the property thereon, as provided by law.

20th. To see if the town will vote to raise the sum of \$200, or such sum as is deemed necessary, to purchase oil and apply the same for the extermination of mosquitoes.

21st. To see if the town will vote to instruct the Selectmen to appoint a building inspector for the ensuing year and determine his compensation.

22nd. To see what action the town will take in regard to permitting peddling or the taking of pictures by transient photographers, or any other business or the use of automobiles, motorcycles, aeroplanes and other fast-moving vehicles on Surf street during the so-called Beach season.

23rd. To see if the town will authorize the Selectmen to employ special officers to act as life-guards from July 1 to Labor Day, and what sum they will appropriate therefor.

24th. To see what action the town will vote to take in regard to the operation of the Public Toilet.

# Street Lights

To see if the Town will vote to locate the following 25th. lights, as petitioned for by various persons: Four months light on Circuit Avenue; all lights in Fern Park, so called, be made four months lights, on Walnut Avenue between B. & M. Railroad and Davis Camps; strings of lights on Saco Avenue from Washington Avenue to Union Avenue; yearly light. corner of Brisson and East Grand Avenue; summer light on corner of 15th street and Wesley Avenue changed to yearly light; four months light on Randall Avenue, corner 10th Street; four months light on Temple Avenue, near Sea View Cottage; four months light at foot of Oceana Avenue; four months light at foot of Ancona Avenue; four months light at foot of Tioga Avenue; four months light at foot of Porter Road: four months light at foot of Blaine Road; four months light at corner of Lake and Forest Avenue; four months light at corner of Somerset and Lake Avenue; yearly light at corner of Seaview Avenue and North Street; yearly light at corner of Myrtle Avenue and Saco Road; yearly light corner of St. John Street and Saco Avenue; four months light at the corner of Winona Avenue and 9th Street; yearly light at or near the Boyden House; four months light at corner of Randall Avenue and 11th Street.

# Hydrants

26th. To see if the Town will vote to locate the following hydrants: One at the corner of Bluff Avenue and Seaview Avenue; one at the corner of West Grand Avenue and Odena Avenue, and relocate and move hydrant on Saco Avenue adjoining property of Clarence Cousens, and appropriate a sum of money therefor.

# Sidewalks

27th. To see if the Town will vote to construct cement sidewalks on the following named steeets and avenues as petitioned for by various persons. On the westerly side of of Evergreen avenue from 11th street to 15th street, on south westerly side of Cedar avenue from present termini to 1st street; on south easterly side of Grand avenue from Tunis avenue to Reggio avenue; on westerly side of Summitt street from present termini northerly 120 feet, on north easterly side of School street, northerly from present termini about 40 feet; on the easterly side of Walnut avenue from Davis Camps southerly 100 feet; on southerly side of Ancona avenue from Grand avenue to Second street; repair walk at or near corner of Old Orchard street and Depot square; on Cottage avenue from Saco avenue to Ivy avenue; on westerly side of Adelaide road from present termini to residence of S. Leverson; on westerly side of Ocean avenue from West Grand avenue to Seaside avenue.

28th. To see if the Town will vote to reimburse Mrs. Alden Ricker of Saco for cost of walk laid at her expense on Myrtle avenue in 1925, amounting to \$132.79, and appropriate a sum of money therefor.

31st. To see if the Town will vote to authorize the Selectmen to prepare a Booklet for the town for advertising purposes, expense of same to be taken from the advertising fund.

32nd. To see if the town will vote to raise money to provide for the services of a public health nurse, or take any action thereon, and what sum they will so raise.

33rd. To see if the Town will vote to rebuild bridge on Seventh street; construct bridge at termini of Colby avenue, and widen Temple avenue from Grand avenue to 9th street, and appropriate a sum of money therefor.

34th. To see if the Town will vote to add Aldine terrace, Cleaves street, First street, Highland avenue, Saunders avenue and Westland avenue to the list of streets on which Tarvia is to be applied.

### Sewers

35th. To see if the Town will vote to construct a sewer on Forest avenue from Seaview avenue to Union avenue, and rebuild in whole or in part the line of sewer on Heath street so called; relay sewer on Union avenue from Grand avenue to Surf street; relay sewer on Atlantic avenue from 1st street to residence of W. G. Harmon; extend sewer on Fern Park avenue, on Morrison street, on 16th street from junction of 15th street to Maplewood avenue; relay sewer on Fountain avenue; also water drain on Fountain avenue; and raise and appropriate a sum of money therefor.

- 36th. To see if the Town will appoint a committee to consider the sewage situation at Ocean Park, in connection with the Ocean Park Association and the New England Baptist Conference and report its findings at the next regular Town Meeting.
- 37th. To see what action the Town will take and what sum of money they will appropriate to take care of the surface water on East and West Grand avenues.
- 38th. To see if the Town will vote to appropriate the sum of \$1,000 or such sum as would be necessary to be used to keep the gutters of our streets free from grass and other accumulations.
- 39th. To see if the Town will vote to purchase a ten-ton Tractor and Snow Plow for the use of clearing our main highways of snow, and what sum of money they will appropriate therefor.
- 40th. To see if the Town will vote to rescind the vote taken at a Special Town Meeting held on Thursday evening, January 5th, 1928, under Article 4 of a warrant issued for that date, wherein it was voted to discontinue so much of Surf street lying contiguous to land of James P. Rundle.
- 41st. To see if the Town will vote to discontinue that portion of Surf street lying contiguous to land of Charles W. Usen.
- 42nd. To see if the Town will vote to employ two policemen or women, or one of each, to patrol the beach during the summer months, and what sum of money they will appropriate therefor.
- 43rd. To see if the Town will vote to close the easterly termini of Mullen avenue, except to foot travel, or allow the same to be done by others.
- 44th. To see if the Town will vote to adopt Roberts' Rules of Order as a standard for parliamentary proceedure in all Town meetings.

45th. To see if the Town will vote to appoint a committee of three or more persons to investigate the advisability of purchasing or obtaining control of the present Old Orchard Pier property, and if found advisable after report of findings, to present a resolve in the next Legislature, asking that the Town of Orchard be given the right to make such purchase, with regulations therefor.

46th. To see if the Town will vote to prohibit all persons from taking sand from Surf street or the beach, without a written permit from the Board of Selectmen, said permit to be granted in consideration of 50 cents for each load so taken, or such sum as may be agreed upon by vote.

47th. To see if the Town will vote to instruct the selectmen to pay for the cost of lighting the advertising signs now located on the Cascade road and the Ocean Park road from the Advertising Fund, if there be any, and if not, from any monies that may be in the Contingent Fund.

48th. To see if the Town will vote to replace all lights now located on East and West Grand avenues and Union avenue, including summer stringer lights, so called, with ornamental lights, such as are now located on Old Orchard street, except that the lamps or bulbs shall be of 600 candle power; and also to place additional yearly lights on Saco road, Ocean Park road and easterly and westerly ends of Grand avenue, and in such other localities as are thought best by the Selectmen and Light committee, up to the sum of fifteen hundred dollars, the same to be secured without additional expense to the Town on account of a tentative plan of reduction in rates by the Cumberland County Power & Light Company.

49th. To see if the Town will vote to exempt from taxation in whole, or in part, the property of the Home for Aged People Association for the year 1928.

50th. To see if the Town will vote to raise and appropriate a sum of money for the purpose of repairing Union

avenue, by constructing cement or tarvia gutter, or otherwise, to take care of the surface water on said avenue, particularly that part of said avenue between 3rd street and 1st street.

51st. To see if the Town will vote to procure 50 settees, more or less, to be placed on Surf street, for the use of our summer guests, and raise and appropriate a sum of money therefor.

52nd. To see if the Town will adopt by vote the following Plumbing Ordinances as drawn up by the Board of Health, in accordance with the rules of the State Board of Health, and approved by Justice Dunn of the Supreme Court, as a part of the By-Laws of the Town of Old Orchard:

Plumbing Ordinances of the Town of Old Orchard

Section 1. The plumbing laws of the Town of Old Orchard shall be the Code of Rules and Regulations of the State Board of Health, as approved by the Public Health Council, December 29th, 1925, and May 13th, 1926, and in effect on and after June 1st, 1926. All plumbing done within the Town of Old Orchard, and all materials therefor shall conform to said Code of Rules and Regulations.

Section 2. All plumbing work shall be done under the direction of a practical plumber, and no plumbing work on soil, waste, or sewage pipes, except for light repairs, shall be started without a permit from the Board of Health. Applicants for such permits shall state in writing the nature of the proposed plumbing in detail.

Section 3. All plumbing work done shall be subject to the inspection of the Board of Health, who shall, plumbing inspector, appoint when necessary. duties shall be to inspect all plumbing for whose which is in process granted, permits are which of construction, alteration, or repair, and shall perform such other appropriate duties as are required. But no inspector

shall approve his own work, or work of any person by whom he is employed, or who is employed by or with him. For this work the Board shall, when necessary, appoint an additional inspector, one who has the qualifications of a regular inspector, who shall act in case of absence or inability of the regular inspector. The compensation of plumbing inspector shall be determined by the Board of Health, subject to the approval of the Selectmen.

Section 4. No person, firm, or corporation, shall do plumbing work in the Town of Old Orchard without a Licence from the Selectmen. License fee shall be \$1, (one dollar), and said license shall be good for one year from date of issue.

Section 5. The Schedule for plumbing permits and inspections shall be as follows: For permit not to exceed six connections, \$2.00. For permit for more than six connections, \$2.00. plus 25 cents for each additional connection above six. Said fees shall be paid to the plumbing inspector at the time of filing plans, specifications, and application for plumbing permit, and shall be turned into the treasury of the town.

Section 6. Whoever violates any provision of the proceding sections, or any order or regulation made thereunder, shall be punished by a fine of not less than ten or more than one hundred dollars for each offence. Municipal and police courts and trial justices shall have jurisdiction of all offences under this act.

53rd. To see if the Town will vote to raise and appropriate a sum of money sufficient to construct a drain or otherwise take care of the surface water accumulating on Sea Cliff avenue.

54th. To see what action the Town will take in regard to closing to public travel, except on foot, the lower termini of Brown street.

55th. To see what action the Town will take in regard to petitioning the State Legislature to change the name of

the Town from Old Orchard to Old Orchard Beach.

56th. To see if the Town will vote to reimburse George Letourneau for money expended for cement walk on Kinney avenue, adjoining his property, and appropriate a sum of money therefor.

57th. To see what action the town will take in regard to raising or otherwise providing for the sum of \$17,000 in settlement with the City of Saco for its claim for damages occasioned by the new line established between the Town of Old Orchard and the City of Saco by the 83rd Legislature, House bill 230.

58th. To transact any other business that may legally come before said meeting.

The polls will be open at 9.00 o'clock A. M., and will remain open until 1.00 o'clock P. M.

The Selectmen will be in session at the Town Hall, Thursday, Friday and Saturday afternoons, from 2.00 to 5.00 o'clock P. M., March 1st, 2nd and 3rd, 1928, for the purpose of correcting the voting list.
