## School Report

---

### REPORT OF SUPERINTENDENT OF SCHOOLS To the Board of Education and Citizens of Old Orchard Beach:

Old Orchard Beach is facing a crisis in the question of its school buildings. If the progress which has been made in the improvement of program, in obtaining and retaining a high class school staff, and in the building of school morale is to be maintained, the community must face at once the need for a new high school building and start action for securing it.

For several years Old Orchard Beach has faced this need. From time to time it has taken some excellent steps to relieve the situation. When it erected an elementary school building in 1924 it solved,—except for the lack of adequate playground space,—the housing demands for the first six grades. It is also gratifying that this was done in a way which will fit into any new developments.

At considerable expense from time to time it has also removed some of the difficulties in the old high school building. However, we have reached a point now where there is no solution of the problem of adequate housing for the six junior—senior high school grades other than in the erection of a new plant.

In those six grades we have about one hundred pupils. For their instruction an excellent staff has been employed. The advantages of the six-year high school and a modern program of studies came easily to Old Orchard Beach owing to the centralization of its school plant and good transportation facilities. The work of



our pupils and graduates has been satisfactory. But at what loss of effort! How much wider range of opportunity and better achievement would be possible if teachers and pupils were not hampered at every turn by the inadequacy of the school plant!

It is not too much to say that the present building is unhealthy. It is evident that it is grossly inadequate to meet the demands which a modern program makes on it. It contains three regular classrooms, only two of which are in any way up to standard. One very small room has to be used for such widely varied activities as typewriting and chemistry. You can imagine the inadequacy of the room for the proper equipment for either,—to say nothing of both,—of these subjects. Another small room offers the only opportunity for home economics in all its branches,—and this has to be used in addition for the intensive work of preparing the school lunches.

Can you imagine a high school aiming at a Class A program of education with neither gymnasium nor auditorium? Yet this is another handicap under which we are trying to attain high ideals.

That our school has been able to attain a high standard of achievement has been due to the excellence of the staff and the earnestness of the pupils. In no other town in this vicinity are teachers or pupils forced to contend with such obstacles as ours. We cannot hope to expand our program further; we are sending good dollars after poor ones in repair and maintenance bills; our children of the future will suffer from serious handicap if we do not face the crisis and take action.

In a time of depression, it is the duty of all governmental departments to be as economical as possible. But this does not apply to capital outlay. The time is favorable for low costs of building; the work will be a

help in working out of the depression centering around unemployment.

Just what shall be done should be decided by the Board of Education and the citizens of the community. My personal suggestion would be to obtain a new site for the six year high school, erect a new, adequate building which will meet the demands of a modern program and provide for reasonable increase in enrollment & then raze the old high school building thus providing the necessary playground space to make our present plant for the first six grades satisfactory. But whether this or some other plan should be followed is for you to decide. My interest is that something be done before we find ourselves paying for our neglect in handicaps placed on our boys and girls.

### Our High School

Our high school, as opposed to our high school building, is in most healthy and efficient condition. You are urged to read carefully the report of Principal Hamlen which gives in detail an outline of the work and excellent achievements of this department. Of particular interest in the field of academic development have been the establishment of a course in debating and plans for establishing a branch in the National Honor Society.

### The Health Program

The report of the school nurse is also well worth careful study. The system of self inspection, by pupils to detect unhealthy or unclean conditions, the building inspection, the weighing and measuring program, the standardization of health records, vaccination, the successful work with underweight pupils, the extensive program of dental prevention and correction, and the home nursing instruction are all matters for commend-

ation. Dr. Foss, the dentist, Mrs. Foss the school nurse, and Miss Bean the home economics instructor have been untiring in their efforts and for their conscientious interest the community should be profoundly grateful.

Dr. Jones and Dr. Willard of Saco have contributed largely to the success of this program. For the splendid backing and financial assistance given to this program by local Parent Teachers Association we are especially grateful.

#### School Savings

We have now had school savings, a habit forming instruction in thrift, for a little over seven years. During that time the deposits of our pupils have been nearly \$4,000.

#### Our Graduates

We receive excellent reports regarding our graduates in college and normal school. It is also a source of pleasure that one of our graduates has been selected as a teacher in the newly organized and splendidly equipped junior-senior high school in Falmouth.

It is also pleasant to note that Mrs. Dolley, who has accomplished so much in the development of our musical program, has been chosen choral director of the Maine Federation of Musical Clubs.

#### Buildings and Supplies

During the past year the elementary school building has been painted on the outside. New modern equipment for both buildings has been purchased. Our Janitor has kept the elementary building in excellent condition, and has earnestly endeavored to maintain proper standards of cleanliness in the old high school building.

The classes have been provided with an adequate supply of textbooks and teaching materials, including

the so-called "work books," which are especially valuable for adapting the work to the individual pupil. It is hoped that during the next year a greater use of these aids may be possible.

#### A Valuable Extension

While realizing that in times of financial stress, extensions must sometimes be deferred, I wish to again call to your attention the desirability of extending our facilities by the establishment of an evening school and of a vacation school.

I believe that the vacation school is so important and would be such a good investment that it should not be dismissed even this year. A school providing for pupils in grades five through nine, under a system of individual instruction, would remedy weaknesses discovered during the regular school year, and prepare for more rapid promotion, and render a real and needed service. Such a school would also offer a valuable service to summer residents whose children need special study to prepare for their work in the fall in their home schools. This would increase the popularity of Old Orchard Beach a summer home. Such a school could be conducted in the elementary school building, three hours each morning, five mornings each week for six weeks. Of course attendance at this school would be optional with the parents of the pupils. Communities which have started such classes have found that the demand is greater than the beginning facilities will meet.

In closing I wish to express my appreciation to the Board of Education for their interest and attention to the work of the schools. To the staff I also owe the deepest gratitude for their splendid consideration and their willingness to give freely of their time

and effort in order that the schools may the better serve the community.

#### TO THE SUPERINTENDING SCHOOL COMMITTEE

The first half of the school year of 1930-1931 has proved to be one of steady progress for the Junior-Senior High School. The enrollment for the five upper grades is approximately the same as last year. The transfer of the Seventh Grade from the Grammar to the High School has added a large number this year. The use of the three larger rooms as home rooms has adjusted the matter of seating. The presence of that grade has made it possible to organize the school upon the full Junior-Senior High basis. The departmental work of the upper grades has been extended to the seventh grade. In addition to regular courses in English, Science, and Junior High Mathematics, there is offered this year a course in Social Science which is a combination of geography, history and civics, adapted to the lower junior high grades. Because all instruction in the six grades is given by the same group of instructors, the younger pupils are becoming adjusted and will not find the change from the grammar grades to the high school an abrupt one.

Attendance has kept up the high average of the past. Few pupils have been detained at home by illness. Full credit should be given to the School Nurse, Mrs. Foss, for her untiring efforts in giving physical examinations. To Mrs. Foss and Miss Bean our instructor in Home Economics should go the credit for getting the splendid cooperation of the Parent-Teachers

Association in supplying milk and hot lunches to the under nourished. The dental examinations and free dental cleanings given by Dr. Foss and the dental hygienist have also assisted greatly in the above record.

The pupils have been maintaining a good scholastic record. The honor roll for the first term of 1930-1931 included 19 pupils. This average accords with the general scholastic standards of other schools. The Terman Intelligence Tests are to be given to the entire school, during the winter term. It will be interesting and helpful to compare our record with that of the thousands who have already taken these tests. Doubtless the result will be satisfactory. To further encourage scholarship in the school, plans are now under way for the establishment of a local chapter of the National Honor Society for Secondary Schools. Membership in this chapter means to the high school student the same thing that membership in the Phi Beta Kappa does to the college student. There are a few outstanding students this year who are worthy of this honor.

The special departmental work has been very encouraging this year. This includes work done along three very different lines. First, I wish to commend the Manual Training Department for its splendid result. Under the capable management of Mr. Roberts the foundation work of last year has been expanded and continued this year. New machines have been added to the equipment which have assisted in turning out better work. The experience gained from the projects of this department is proving invaluable to the boys. Any money expended to this end will pay ample dividends.

A second special department, that of Home Economics is under the splendid management of Miss Phyllis Bean. Through the cooperation of Mrs. Foss this work has been enlarged. The tables used in this de-

partment have been recovered. Some additional equipment has been added. Other things could also be well utilized. The work of Miss Bean in supplying hot lunches at noon and in furnishing milk for undernourished pupils has already been referred to. I am convinced that any outlay in this work will be amply repaid.

Finally the efforts of the school in furnishing the rudiments of business training deserve mention. True, there is only a beginning along this line. The school from lack of space and scarcity of instructors is offering only typewriting and bookkeeping. One new typewriter and a guaranteed rebuilt machine now make seven for the use of the students. The results in speed and efficiency for both beginners and advanced pupils is very satisfactory. In these things as in all the schedule the instructors and students are working to capacity. Miss Porter in addition to her works as instructor of English, capably handles the two classes in typewriting. Miss Brown, besides serving as instructor in Science and Mathematics takes good care of the bookkeeping instruction.

We have been fortunate for some years past in having the services of Mrs. Helen Dolley in the music instruction of our schools. In chorus and part singing there has been splendid work done. There are now two music clubs connected with the Junior-Senior High, whose monthly meetings are a part of the regular weekly music periods. The programs are arranged by the students under the supervision of the faculty sponsor, Miss Porter. These are varied, instructive, and helpful. For the development of a knowledge of the best music and a sense of music appreciation these weekly periods are certainly worth while.

I wish to express my appreciation of the cooperation and loyal service of every member of the faculty.

They have not failed to give unstintingly of time and effort to make the school a success. Each has a six periods a day, except two with seven. In addition all extra curricular activity is sponsored by some faculty member. It has been a pleasure to work with such teachers.

As a final recommendation, I would suggest the housing of the Junior-Senior High in new quarters. The need of a new High School Building has been so frequently discussed in previous reports that there is danger of repetition. There are two conditions that will bear referring to again. These are overcrowding and an unsafe chimney. Ninety five or a hundred pupils within such small quarters is not conducive to the smoothest operation of the school, especially where there must be considerable passing up and down the stairways.

The old chimney presents a constant hazard. There has already been one occasion this year to call upon the services of the fire department to put out a fire in the chimney. Fortunately, the blaze was discovered in time and there was no damage caused. There have been, however, similar occurrences in past years. Under the present circumstances no one can tell when disaster may come. Fire drills among the pupils will do much to avert a panic and the loss of life, if fire should break out during the school sessions. Fire in the old structure will surely mean some confusion and, possibly, loss of school time. It may mean the loss of the Grammar School Building or the loss of life. Surely either of these would be a much greater loss than that of the old building itself.

It is well to consider the matter of the new building from all angles and to act for the best interests of the town in the future as well as the present. The



teachers are now cheerfully using whatever facilities the town has provided to continue the school in the Class A. group of the state public high schools. Feeling that there is no better time than the present, I am convinced it would be a splendid investment in developing the lives and characters of our boys and girls, the town's future citizens for the town of Old Orchard Beach to erect and equip a modern high school building.

TO THE SUPERINTENDENT OF SCHOOLS AND  
BOARD OF EDUCATION, OLD ORCHARD  
BEACH, MAINE.

I hereby submit the following brief resume of the work done in Public School Music in Old Orchard Beach, Me.

Our text books are the Progressive Music Books with an accompanying Teachers' Manual outlining the work from month to month.

These books are in use in the schools of Portland, Biddeford, Saco and other nearby towns. We are following the Manual quite closely and I note that pupils coming in from any of the other mentioned towns are never ahead of us in their work.

For the first time this year we have the first six grades separately with such satisfactory results as to surely justify this arrangement.

The children in Grade 1 in addition to their regular work outlined are learning to sing and recognize by ear the tonic chord; also to recognize it on the staff in any key.

Following this in the Second grade, we review the Tonic Chord, write it on the staff in any key and for

the first time this year second grade children are learning the intervals of thirds and fourths to recognize by ear and from the staff.

Third Grade pupils review the interval drill of previous grades adding fifths and sight reading of songs involving these problems; also simple diatonic progressions. Time problems of simple two, three and four beat measures are explained and learned by rhythmic scanning. This is the first third grade that has ever been in a class by themselves and are accomplishing much more accordingly.

Grade four reviews all previous theory, tone work etc., and begin more difficult time problems key signatures, sharp and flat chromatics, sight reading etc. We hope to begin two-part work before the year is over which we have not had time for in previous years with two grades together.

The fifth grade is getting well underway with two part singing; also reviewing all previous theory, tone and time problems. This term we begin study of the Natural and Harmonic Minors in scale and songs.

Grade six is small but seem much interested in modulation to nearby keys at present. Later we take the scale construction in Major and Minors, reviewing previous theory etc. Usually we begin three part music in this grade but it is rather hard to carry on unless the parts are very well balanced.

The Senior and Junior High School classes are very interesting this year with some exceptionally good voices. Most of our work here is in sight reading, interpretation, music appreciation which seems to be progressing very satisfactorily.

Our Music Clubs, High School Glee Club, Ponselle Club of the Jr. High and Nora Archibald Smith Club of the grades are all members of the Maine Federation of Music Clubs and seem much interested in their

work.

Our accomplishments in Music Appreciation, Rhythm Bands etc. are limited by lack of good phonographs; however they are not neglected in any of the schools.

I wish to express my very sincere appreciation to our Supt. of Schools, the Board of Education and to each and every teacher for their fine co-operation without which such satisfactory results could not have been accomplished.

#### REPORT TO NURSING SERVICE IN THE SCHOOLS

At the opening of schools all pupils in the elementary school were inspected for symptoms of communicable disease and pediculosis (lice). No evidence of either condition was found, with the exception of two children who had received care for nits.

Inspection of the Building, Toilets, and Water facilities was made and it was recommended that screens be put on the windows of the toilets.

A system of Daily Inspection of pupils by the pupils under the Supervision of the Teacher was organized to stimulate interest in personal cleanliness.

All pupils were weighed and measured. A study of the individual development and growth over a period of three years was made and the pupil classified according to the degree of under-weight.

Extremely under-weight children requiring lunches, rest periods, and a limited school time were given immediate attention.

Revised health records as suggested by the State

Department were made out which necessitated interviewing each pupil to check up the history of previous illness, tendency to disease habits, and immunization. In this also, children were classified as to their defects, the need of home visiting or parent consultation.

### VACCINATION

45 Pupils were vaccinated by Dr. L. A. Jones at the school and received daily dressings or home visits by the nurse as necessary.

### DENTAL WORK

Permission slips were sent out to be signed by the parents, and preparations made for a Dental Hygiene program. 147 children were examined by Dr. A. W. Foss D. M. D. (gratis) in order to extend the privilege of mouth hygiene to the upper grades. 112 children received dental prophylaxis or cleaning by the Maine Dental Hygienist Miss Newhall, and 21 by the dentist. 142 children were in need of dental attention, that is requiring filling or extraction of teeth.

Dental defects for 1930 were 7 defects per child. The previous year 8 defects per child, showing a decrease of 1 defect per child since the beginning of dental hygiene program.

Dental corrections are now available to the school children at a minimum cost or free as the case indicates.

Miss Newhall conducted a Health entertainment during her time here, the proceeds of which were turned to the Milk Fund.

### PHYSICAL EXAMINATIONS

220 children were examined by Dr. L. E. Willard. All pupils who were previously inspected by the nurse and found to have one or more defects other than teeth or any tendency to hereditary or contact disease were

grouped as to family, the parents notified and asked to be present while the doctor gave a thorough stripped to waist examination. Advice and recommendations were given the parents present by the physician.

Notices of all defects were sent to parents by the nurse or in urgent cases the homes visited.

Chest cases taken to Children's Hospital re-examined given tuberculin test 1-100 and 1-1000, positive re-action cases X-rayed. 75 visits have been made to homes of school children.

#### SEVEN POINT HEALTH

As an incentive to overcome defects the Seven Point Health awards (under the direction of Miss Abbie Buck Maine Public Health Association) are being issued. Approximately 50 pupils will be eligible having had all their defects corrected.

#### UNDER-WEIGHTS

65 pupils were under-weight at the beginning of the school term. These have been weighed once each month. 40 are receiving lunches either by their own finances or through the Parent Teacher Association Milk Fund.

To date the under-weights are reduced to one half

the number entirely eliminating the 15 and 20 per cent class and reducing the 10 per cent class to 6.

#### HOME NURSING INSTRUCTION

One 80 minute period each week in Home Nursing has been given in co-operation with the domestic arts department (in charge of Miss Bean) in the High School. 11 students of this elective course are taught Bed Making, Bathing and Care of Sick, Care of Feeding of Infants, Pre-School and School Children, and preparation and application of plasters poultices, and various home remedies which may be recommended by a physician. First aid is also included in this course.

No record has been kept of the number of pupils receiving emergency care or minor dressings and treatments. Time analysis shows an average of 3 and 1/2 hours per day are spent in school work.

DANA E. HUNTINGTON

Died at the Eye and Ear Infirmary, Portland, Me., August 21, 1930. Born at Henniker, N. H., and at the time of his death was 72 years and 8 months old. He was the son of Franklin T. and Lavina G. Huntington, his boyhood days having been spent on the farm of his parents. On reaching manhood he became interested in the affairs of his native Town and State. Served as Road Commissioner, Selectman, was an Assessor and Overseer of the Poor in the Town of Hillsboro, N. H., and served his district in the State Legislature. Later removed to Wisconsin and there for some years engaged in the hotel business. Returning East became identified with the lumbering industry and for many years held important positions with large lumber operating companies in Maine. Became a resident of Old Orchard Beach about 14 years ago. First took over the management of the Revere House and later the Vermont Hotel. His love of public service never lagging, he was elected Road Commissioner of Old Orchard Beach in 1923 and he was re-elected to that office each succeeding year to and including 1930, up to his death.

In the demise of Dana E. Huntington, Old Orchard Beach lost an outstanding citizen, whose tireless energy and constructive thought unsparingly devoted to this his adopted town, of which he was exceedingly proud, have brought results which will remain a monument to his memory. His Christian character and human sympathies endeared him to all who knew him.

Nurse service has been extended to 93 families and a total of 605 visits have been made. Beside care has been rendered to Maternity, New Born, Medical and Surgical Cases.

Instructions in Health and Demonstrations have been given in many homes including: Teaching the care of Infants and Children, preparing of Formulas, Diets, and Treatments.

Instruction and Demonstration in the care of Invalids, Aged and Sick.

Much time has been devoted to investigation to Social Service and Family Problems.

1-3 of the nurse's time is spent in the schools. A detail report is submitted under the Board of Education

A Nursing Committee has been organized having a representative of each group who are in any way connected with Welfare Work in Old Orchard. The duties of this committee are to advise and supervise all nurse activities and problems.

Standing orders governing the extent and type of Nursing Care of Patients as directed by the National Public Health Association have been prepared, presented and approved by the physicians.

A time analysis has been made for a period of three months, and is now ready to be submitted to the National Headquarters as well as to the Local Committee.

# WARRANT

MARCH 2, 1931.

To Irving C. Lyon, Constable of the Town of Old Orchard Beach, in the County of York:

Greeting:—

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of said Town of Old Orchard Beach qualified to vote in town affairs, to assemble at the Town Hall in said town, on Monday, the 2nd day of March, A. D. 1931, at 9 o'clock in the forenoon, then and there to act upon the following articles, to wit:

- 1st. To choose a moderator to preside at said meeting.
- 2nd. To choose all necessary town officers for the ensuing year.
- 3rd. To hear and act upon the reports of the town officers and all special and standing committees.
- 4th. To see what action the town will take in relation to pay of town officers.
- 5th. To see what sums of money the town will vote to raise. 1st, common schools. 2nd, for free high school. 3rd, for free text books. 4th, for making and repairing highways and bridges. 5th, for the support of poor. 6th, for the pay of town officers. 7th, maintaining street lights. 8th, for contingent expenses. 9th, for sanitary expenses. 10th, for town interest. 11th, for repairing school houses. 12th, for the public library. 13th, for heating, lighting and care of town



property. 14th, for moth nests. 15th, State road patrol. 16th, public toilet. 17th, school supplies. 18th, for transportation of high school scholars. 19th, for advertising. 20th, for payment of serial bonds. 21st, for tarvia. 22nd, schoolhouse maintenance. 23rd, maintenance of third class highways. 24th, nursing service. 25th, cleaning streets and Beach.

6th. To see if the town will vote "That the Collector of Taxes shall hereafter be paid an annual salary of \$1,000.00 payable the last day of each month, in installments of \$83.33 1-3 each, that the office of said Collector shall be maintained in the Town Building during the months of July, August, September and October of each year, with office hours daily (except Sunday) from 9 to 12 A. M. and 2 to 5 P. M., during which time the duly elected Collector of Taxes shall be in personal attendance.

7th. To see if the Town will vote that the Collector of Taxes shall hereafter be paid a Commission of 7 mills on the dollar on all taxes actually collected. That the office of said Collector shall be maintained in the Town Building during the months of July, August, September and October of each year, with office hours, daily (except Sunday and legal holidays) from 9 A. M. to 12 noon and 2 to 5 P. M., during which hours the duly elected Tax Collector shall be in personal attendance.

8th. To see what sum of money the town will vote to raise to pay collector's commission and abatements.

9th. To see if the town will vote when the taxes shall be committed to the collector for collection and what rate of interest, if any, will be charged thereon, thereafter.

10th. To see if the town will authorize the Selectmen and Treasurer to hire money in anticipation of taxes.

11th. To see if the town will authorize the Selectmen and Treasurer to issue town notes to pay those, if any, which fall due the present year.

12th. To see if the town will authorize the Assessors to make such abatements as they think reasonable.

13th. To see what action the town will take and what sum of money, if any, the town will raise to maintain one or more regular patrolmen.

14th. To see what action the town will take and what sums of money the town will raise to maintain a police force; to construct and maintain sidewalks; to construct and maintain sewers and drains; to maintain fire department; to maintain town team or truck and driver; for hydrant rental; for liquidating Serial Bonds; for interest on debt incurred in the fire department, sewers and loans, all within the limits set out in Section IV, of the act of incorporation of the town of Old Orchard, to be a separate tax, to be assessed and collected as provided in said act.

15th. To see if the town will vote "yes" or "no" on the question of appropriating and raising money necessary to entitle the town to State Aid as provided in Section 26 of Chapter 28, of the Public Laws of 1930.

16th. To see if the town will raise and appropriate the sum of \$1,466.00 or the sum of \$7,330.00 for the improvement of the section of State Aid road as outlined in the report of the State Highway Commission, in addition to the amounts regularly raised for the care of ways, highways and bridges, the amount being the

maximum which the town is allowed to raise under the provisions of Section 19 of Chapter 28 of the Public Laws of 1930, or under the provisions of Section 22, Chapter 28, of the Revised Statuts of 1930.

17th. To see if the town will vote to appropriate a sum of money sufficient to pay for the services of a school physician required by Chapter 19 of the Public Laws of 1930.

18th. To see what action the town will take and what sum of money they will vote to raise for the purpose of keeping clean or free from paper and other waste matter, Surf Street, Old Orchard Street, and East and West Grand Avenues, or those parts of East and West Grand Avenues contiguous to the congested center of the town, during the summer months.

19th. To see what streets or parts of streets the town will vote to lay dust during the summer months, and what part of the cost thereof, if any, shall be assessed against the property thereon, as provided by law.

20th. To see if the town will vote to raise the sum of \$200, or such sum as is deemed necessary, to purchase oil and apply the same for the extermination of mosquitoes.

21st. To see if the town will vote to instruct the Selectmen to appoint a building inspector for the ensuing year and determine his compensation.

22nd. To see what action the town will take in regard to permitting peddling or the taking of pictures by transient photographers, or any other business or the use of automobiles, motorcycles, aeroplanes and other fast-moving vehicles on Surf street during the

by transient photographers, or any other business; or so-called Beach season; and provide extra seats for the Beach, and other places about town for the use of our summer guests, using any money necessary therefor from the Contingent fund.

23th. To see if the town will authorize the Selectmen to employ special officers to act as life-guards from July 1 to Labor Day, and what sum they will appropriate therefor.

24th. To see what sum of money the town will vote to grant and raise to be expended and used for advertising the natural resources, advantages and attractions of the State of Maine.

25th. To see if the town will vote to appoint a Committee of 5 or 7 persons to revise and amend its By-Laws, said Committee to report at a Special Town Meeting not later than May 15th, 1931.

26th. To see if the town will vote to dispose of its team, and purchase in place thereof a truck and blade for use in snow removal and other purposes, and what sum of money it will raise therefor.

27th. To see what action the town will vote to take in regard to the payment of the Davis lot note, and the Special Road employment note, said notes being for \$5000 each.

28th. To see if the town will vote to assess the abutters for one-half the cost of all sidewalks hereafter constructed or such other proportion as may be agreed upon.

29th. To see if the town will vote to raise a sum of money for the purpose of rebuilding and that part of Washington Avenue as was by vote, relocated and

widened, and to pay land damages therefor.

30th. To see if the town will vote to raise money to provide for the services of a public health nurse, or take any action thereon, and what sum they will so raise.

31st. To see if the town will vote to exempt from taxation, in whole or in part, the property of the Home for Aged People Ass'n for the year 1931.

32nd. To see if the town will vote to build a retaining wall on N. W. side of Washington Ave., where land was taken and street widened, and appropriate money therefor.

33rd. To see if the town will appropriate a sum of money sufficient to install a heating plant in the Fire Station, and provide for other needed requirements therefor; \$1,000.00 estimated cost.

34th. To see if the town will vote to make a park of the lower end of Old Orchard Street and appropriate a sum of money for the purchase of seats, band stand and other needed requirements, called for by the change from present situation.

35th. To see if the town will vote to purchase additional danger signals for Third Class Highway near Milliken's Mill on Portland Road, and what sum it will appropriate.

36th. To see if the town will vote to instruct the Selectmen to have blue prints made of all sewer lines now laid and also all additional lines as they are constructed, using any monies necessary therefor from the Contingent Fund.

37th. To see if the town will vote to reimburse The Maine Investment Co., the sum of \$600; being for

money paid the town toward construction of Sewer on Carll Avenue and part of Wesley Boulevard in 1921.

38th. To see if the town will vote to refund to Lila I. Barnes the sum of \$42.92 for money paid to the town for taxes in error for the year 1917 to 1929.

39th. To see if the town will vote to raise and appropriate the sum of \$4472.87 said to be the town's share of the expense incurred in rebuilding and widening the Railroad Abutment on the Cascade Road.

40th. To see if the town will rebuild bridge over brook on West Grand Ave., Westerly of Ocean Park line, and what sum of money it will appropriate therefor.

41st. To see if the town will vote to instruct the contemplated By Law Committee to formulate and present a By Law governing and restricting the building of one-night camps in accordance with the Public laws of 1930, Chapter 5.

42nd. To see if the town will vote to instruct the Selectmen to pay from any monies in the Contingent Fund, the sum of \$50 to the C. Fayette Staples Post of the American Legion, for the care and decoration of Soldiers Graves.

43rd. To see if the town will vote to buy the so called Pine Cottage property on Portland Ave., consisting of seven acres more or less, the same to be used for school and playground purposes, and if the vote is favorable will appoint as a purchasing Committee, a joint Committee consisting of the Board of Selectmen, Town Treasurer and Superintending School Committee and how said purchase money shall be raised, whether by note or bond, and if by bond for what term and at

what rate and amount.

44th. To see if the town will vote to authorize the Selectmen to locate a Hydrant on Saco Road at or near the residence of Walter H. Green, and appropriate a sum of money therefor.

### Streets

45th. To see if the Town will vote to grade and gravel the following named streets or parts of streets and avenues as petitioned for by various persons: Ocean Avenue from Somerset to Forest Avenue; Pavia Avenue; Glenwood Lane; Miles Avenue; Wesley Boulevard; Hoffman Street Extension; Surfside Avenue near Ladd Avenue; Grade and gravel the lower end of Ocean Avenue; Park Avenue from Hillside to Bluff Avenue; Winona Avenue from Seaside Avenue to Sea Wall; widen, and grade and gravel W. Grand Avenue from Randall Avenue to Old Salt Road; grade and gravel St. John Street; Winona Avenue from 4th Street to 7th Street; Colby Avenue from 4th Street to 9th Street; Tunis Ave., from E. on Park Avenue between Hillside and Bluff Avenue; 3 yearly lights on Carll Avenue; 4 months light on Randall Avenue near old pumping Station; yearly light at Corner of Grove Street and Ivy Avenue; yearly ornamental light at corner of East Grand Avenue and York Street; on School Street near Legion Bldg.; 2 additional lights on Smithwheel Road; yearly light on Old Salt Road near residence of Mr. Severance; yearly light, corner of Tenth Street and Randall Ave.; locate yearly light on Cliff Avenue at Junction of Private Way, and what sum of money it will appropriate therefor.

50th. To see if the town will vote to accept Parcher Avenue as laid out by the Selectmen.

51st. To see if the town will vote to accept Glenwood Lane as laid out by the Selectmen.

52nd. To see if the town will vote to accept Fifth Street as laid out by the Selectmen.

53rd. To see if the town will vote to accept Wesley Boulevard as laid out by the Selectmen.

54th. To see if the town will vote to accept Hoffman Street extension as laid out by the Selectmen. To see if the town will vote to accept Pavia Avenue as laid out by the Selectmen.

55th. To see if the town will vote to have the tax collector maintain his office in the Town Building from the first day of July to the first day of March, 1932, and said tax collector, to collect all taxes including the automobile excise tax.

56th. To see if the town will vote to have the method of book-keeping recommended by the State

Auditor installed for use in Old Orchard Beach, and to have the town books audited at least twice in each year by a certified public accountant.

57th. To see what action the town will vote to take to drain Summitt Street and what sum of money it will appropriate therefor.

58th. To see if the town will vote to limit the pay of any Town Official incapacitated for duty, to 30 days, unless the Town is under moral or legal obligation.

59th. To see if the town will vote to instruct the Road Commissioner to remove the width of two blocks of cement sidewalk extending into the Street on the North Easterly side of Old Orchard Street, between Milliken Street, and the Boston & Maine Railroad; and to see what sum of money the town will vote to raise and appropriate for the same.

60th. To transact any other business that may legally come before said meeting.

The polls will be open at 9.00 o'clock A. M., and will remain open until 1.00 o'clock P. M.

The Selectmen will be in session at the Town Hall Thursday, Friday and Saturday afternoons, from 2.00 to 5.00 o'clock P. M., February 26, 27 and 28, 1931, for the purpose of correcting the voting list.
