REPORT OF THE SELECTMEN OF  
OLD ORCHARD BEACH, ME.

To the tax-payers and citizens of Old Orchard Beach:

It is our duty as Selectmen to make a report of all receipts and expenditures for the financial year which closed December 31, 1931. We have two things in mind regarding this report; first, to give you facts and second, to give them to you in a form that can be readily understood. We hope that in your consideration of each department you will be able to form some idea of the funds necessary for its proper administration. We hope you will come into the Annual Town Meeting with constructive ideas as to more efficient methods of carrying on the work of each department.

The financial problems of 1931 have been of unusual difficulty. In the Poor Department the appropriation was far from adequate in a time of unemployment and financial depression.

The constantly increasing amount of tin cans and waste paper is greatly raising the cost of carrying on the work of the sanitary and street cleaning departments. The heavy seas of the summer of 1931 were beyond our control but they served to increase the cost of our life saving department.

The payment of the note on the new fire apparatus forced up the expenditures in that department and there is another of like amount to be met in 1932.

The appropriation under Town Interest provided only for the interest due on Bonds. Nothing was provided for the payment of interest on notes.

The School Department shows a substantial balance which by State regulation must be carried on into next year. The cost of Industrial Education is always heavy.

The cost of the work on Washington Ave. was much less than estimated.

The receipts in the Contingent Department were especially gratifying as they not only covered an unusually large expenditure but also nearly wiped out all overdrafts in other departments.

With a good balance in the banks, a possible resource of \$19,000 in uncollected taxes, the payment of the excise taxes held over into 1932, we hope to meet the current expenses up to the time of the Annual meeting without any great increase in the notes payable account.

In closing may we say that we heartily agree with the judgment of the accountants that it was unwise to cut the tax rate this year. We believe it would have been better financial policy to have maintained the tax rate of the preceding year and to have applied any surplus on our interest bearing debts.

## THE OLD ORCHARD BOARD OF HEALTH

The Board of Health has been on the alert during the year endeavoring to maintain the highest sanitary conditions possible. We have had no serious epidemics, and are fortunate in having fewer cases of communicable diseases in our midst than they have had in some of our neighboring towns and cities. With the cooperation of parents in the case of their children we have held within reasonable control the cases of chicken pox and measles that have developed, keeping the pupils out of school as little as possible.

In this connection we make mention of the splendid work done by our Town Nurse, Mrs. Foss, in caring for the sick among the children as well as the grown-ups in town.

During the first week in August the Board took vigorous action in ridding the town of the so called Gipsy nuisance. We ought to have a town By-law to prevent these lawless itinerants from coming here. It is not a happy condition when our summer people must watch their clothes lines and look with suspicion on persons who come stealthily into their back yards.

The Board feels that it accomplished something in getting vile smelling pigs outside the thickly settled portion of the town. Nuisance like this must be abated if we are to keep up with the times. The tax-payers, as well as the law, call for a clean and spotless town. and this is what the Board of Health is striving for.

The handling of dry and wet waste is one of our major problems, and now that so many have installed oil heaters the dry waste has increased in quantity. This means a call for a larger appropriation for the Sanitary Department.

During the busy part of the summer season the Board heard many complaints from different parts of the town where the waste was not taken care of promptly, but we take this as a sign that the householders are anxious to cooperate in keeping the town in a well kept up condition, and we as a Board pledge you, the tax-payers, that we are vigilant, and render you the very best service possible.

## School Report

### REPORT OF SUPERINTENDENT OF SCHOOLS

To the Honorable School Committee, Board of Selectmen, and Citizens of the Town of Old Orchard Beach,

Ladies and Gentlemen:—

It becomes, at this time, my obvious duty to submit for your consideration my first annual report.

Let me assure you, in the beginning, that any judgments expressed in this report are, for the most part, mere opinions. I have, as yet, had insufficient time to study many of the most important problems connected with your schools. There are, however, some pertinent aspects which I wish to bring to your attention. The superintendent is only your executive officer. The electorate is, by virtue of our form of government, the body to decide upon the future policies of your schools, and it is through instruction given to your superintending school committee that legislation becomes established custom. This report is cognizant of these extensions and limitations of procedure. Therefore, factual presentations of trends and movements in your schools are intended to indicate feasible and judicial goals which an informed voter would need. The data presented by the superintendent and immediate handling of the town warrant as related to schools.



diately following is, therefore, given by him as an interpreter, not an advocate. The decision must be yours with attendant results and responsibilities.

### Enrollment

The study of the school enrollment is exceedingly interesting. There has been a steady and consistent growth in the school population for a decade. There is scarcely a grade in the past ten years that does not have an increased registration year by year the entire period. The statistical study begins with the year 1919.

In that year all the elementary grades were taught in combination grades. The 1st and 2nd grades were taught in one room by one teacher, likewise the 3rd and 4th, the 5th and 6th, and the 7th and 8th shared rooms and teachers as indicated. The entire eight grades thus required only four teachers. The teaching load was not particularly heavy with these combination grades as indicated by registration and attendance at the time this study begins.

In 1919 the number registered in the combination 7th and 8th grades (and this is significant) was 29 pupils with an average attendance of 25 pupils. So rapidly did these grades expand that in 1927, or just eight years later, the 8th grade was established separately with 24 pupils and an average attendance of 20 pupils, while the 7th grade had a registration of 22 pupils and an average attendance of 20.3. These grades, therefore, nearly doubled in this period of eight years.

The growth trend in your schools will get confirmation from a continuation of our comparative method applied to the remaining elementary grades.

The 5th and 6th grades have a surprising growth. In 1919 they were cared for in one room and taught by one teacher with only 21 pupils registered and with an average attendance of only 17.7 pupils. However, in 1925 the 6th grade alone had 27 pupils or more than

the number of the combination grade only six years before. When the 6th grade was given a separate room and teacher, the 5th grade had 21 registrants. Thus both the 5th and 6th grade had sufficient pupils for a teaching unit, with an average attendance better in 1925 with the double enrollment than in 1919.

In 1919 grades 1 and 2 were a combination grade, but growth compelled them to be separated in 1922. Grade 1 had more pupils than did the combined grades 1 and 2 in 1919.

The 3rd and 4th grades existed as a combination grade (with the exception of one year 1925) until within the past two years when they had to be housed separately. The 3rd grade has 34 pupils and the 4th has 24 pupils.

The elementary school, judging by this study, will be growing larger since there is scarcely a class as small in the following fall as was enrolled the previous June over a period of years. The elementary building has nearly a capacity enrollment.

In the immediate future the enlarged classes seeking entrance to the Junior High School will create undue congestion at that building. This judgment would seem justified when you consider that the enrollment of the 9th, 10th, 11th and 12th grades in 1929 was 24 pupils and at the present time is 53 pupils.

In former years it was expected that the Old Orchard Beach schools would be large in the early Fall and late Spring and that the Winter enrollment would materially decrease. The Florida financial collapse curtailed the great migration to the south. The school population seems stabilized at this time with a growing population.

The present enrollment of the high school is far too large for both the Junior and Senior grades. The incoming 7th grade next Fall will further increase the need of the high school space. The adjustment and

correlation of the curriculum will not easily admit the taking of one of these grades out of the building, and housing them separately, on account of the integration of subjects.

I notice that repeatedly and over a period of years your attention has been called to the need of a modern plant and equipment for your high school. This outlay, at this time, unless figures showing great saving at this time, that nothing should be attempted in the way of a new building unless it can be creditably done and with ample space for a modern-day program. I should hesitate, personally, to sponsor great initial outlay, at this time, unless figures showing great saving in building materials and aiding in general employment could be so established that an enlightened public demand would entirely justify the proposal.

A second proposal has been set forth to the superintending school committee in the nature of a compromise of a temporary nature. If the small classes of the 11th and 12th grades could be given a contact with a larger school, say, Thornton Academy, as a contract school, it would be a decided aid in widening the experiences of these young people and especially for those members who are going on to college. The scientific and library equipment of the Academy ranks exceedingly high. Thus the congestion could be temporarily relieved, and time could be taken in deciding on a building program. The present situation has been a gradual growth and final disposal of the problem is hereby presented for your deliberation.

#### Repair of School Property

Your attention is now directed to the growing needs of your school plant in the matter of repairs. The elementary school is, on the whole, in good general upkeep. However, it seems desirable to give considerable attention to the inside of the building. The walls and wood-work should be taken care of this

summer. The steam plant of this building is not giving satisfactory results. Considerable outlay has already been expended on this plant and it is hoped that a greater portion of the difficulty has been located.

#### Lights at the Elementary School

The lighting circuit at this building was hitched up with the power machinery of the Manual Training Department and was found to be unsafe. This fall it was found advisable to have the lighting circuit for the power machinery lead into the building in such a way as to insure safety and, at the same time, give the school the advantage of a power rate. The present arrangement has passed the Insurance Underwriter's specifications for safety.

#### Manual Training Department

The Manual Training department is housed in the elementary school building. This is far from ideal. The matter of discipline alone becomes a problem. The more serious problem, however, is the noise which the power machinery makes when in operation. This is an unavoidable noise and is a disturbing factor to the teaching of little children when it is more or less continuous throughout the school year. It may be said that this is the best arrangement possible with the available school space as now provided in either building.

#### High School Building

In the preceding Town Reports, I have noticed certain recommendations to which, I wish to add my approval and urge your careful attention, as a problem needing decision. It appears that for some years past, the school authorities have, through the report of your superintendent, Mr. B. F. Heald, called your attention to the dangerous fire hazard occasioned by the defective chimney at the high school, which has frequently

been the cause for much alarm. The burning out of this chimney is well known to all. The Superintending School Committee has attempted to reduce this fire hazard by installing an oil heater. This may or may not be adequate protection. I would give it as my opinion that the only adequate solution of this fire hazard is the rebuilding of the old chimney. It is, therefore, recommended that this be considered when the appropriations are made for this year. In a building with inflammable stairways, with no outside fire escapes, this recommendation might seem of prime importance since the safety of your children is probably your first concern.

#### Transportation

There is every likelihood that in the near future transportation of your children will become a much different problem from what it is today. You are aware of the effort that is reported to have been made by the electric railroad to discontinue service for a part or the whole of the year. If such a contingency should arise, the solution would, of course, be automotive transportation.

There are growing regulations of state wide scope being insisted upon in connection with the transportation of public school children, which in the near future must more and more apply to local conditions. There is the question of comfort. The new state law provides that any child transported must be transported in comfort. This is interpreted to mean comfortable seating space with either an enclosed conveyance or with adequate wraps.

There is another rather important observation on transportation. At the present time many towns in the State of Maine have found it advisable to carry insurance absolving town officials and school authorities alike from entangling law suits, if serious accidents

should occur to school driven buses. There are sufficient upper-court rulings in other states to make it seem wise for Maine school authorities to carry insurance. This has been done this year in the Old Orchard Beach transportation and should be made a permanent policy of the schools.

Old Orchard Beach becomes a part of School Union No. 7.

Old Orchard Beach schools by request of the School Committee were added to the Saco, Dayton and North Kennebunkport Union this fall. There were certain desirable internal changes that, thereupon, became apparent. I will enumerate a few of these which should meet with your approval and hearty support.

First, it seemed best that a uniform type of book-keeping should be adopted by all the towns in the Union. This the Superintending School Committee adopted.

Second, a voucher system was then adopted so that no school bill can originate except through the Superintendent's office or on an order from the chairman of the School Committee, and then, only with a properly signed triplicate serial order. There are, therefore, only two responsible persons handling orders drawn against the school accounts, namely, the Superintendent and the chairman of the School Committee. There are, of course, bills of large size which involve larger specialized undertakings which are authorized by the direct vote of the committee at some regular meeting, and even then, orders will usually be authorized on order blanks. This will make for accuracy and reliability of results.

A third regulation which it would seem would make for efficiency is the duplicate bill system. This requires that each bill, which passes the committee, shall have a duplicate filed in the Superintendent's office. Moreover, in order for a bill to have passage, it

must first be stamped by a dated superintending school committee stamp and signed by two members. This gives the legal approval of the bill on a certified date over the signature of the members passing the bill. The Superintending School Committee very enthusiastically adopted this method and it will be in force on all school accounts henceforth.

The Superintending School Committee have recommended that the Maintenance Account, hereafter, be designated, Maintenance, Light, Power, Water, Insurance and Rent. This would be one account but would carry items whereby the citizens could readily check up any single item, year by year, if they so desired.

The accounts which receive state subsidy should each carry the full expense connected with their department and the balance should be carried forward each year. This is a state requirement.

The Manual Training and Domestic Science departments are, therefore, submitted in that fashion in this report.

### Educational Report

The elementary grades are approaching a fine standard of achievement. My observation is, as yet, fragmentary and inadequate, but as such, is wholly satisfactory. The teachers are happy in their work and have an enthusiasm which should go a long way to provide that atmosphere of good-will in which your children can work and grow to best advantage. I wish to bear witness to this cooperation and urge that it be fundamental in all our professional relationships.

The High School Building has in the past had the principal's room on the upper floor. In order that the supervisory details of administering the high school program might be improved, the school committee had the seats in the principal's room transferred to the

larger of the two down stairs rooms.

There were four new teachers who came into this department this year. Three of them had had no previous experience in public school teaching. They have, however given of their best and have gained both in command of themselves and in handling of their subjects.

A strong measure of personal support has been given to all those agencies which I thought would make for future character and proficiency in the lives of your young people. It is hoped that constructive consideration may be given to the major recommendations of this report.

#### REPORT OF THE HIGH SCHOOL PRINCIPAL

To the Superintendent and Superintending School Committee.

The school year during 1931 has proved to be one of adjustment and change and yet of certain advancement. The first change came in getting the Seventh Grade, which had formerly been in the Grammar School Building, accustomed to the routine and discipline of the High School. The aim of your faculty has been to unify the work of the six grades now under our charge. By this I mean having a teacher responsible, in so far as it is humanly possible, for one or two subjects throughout the grades. As a result, we now have one of the few unified junior senior high schools in the state.

Since my last report Mr. Lyseth, the State Agent for High Schools has visited the school and had every opportunity to inspect the equipment and work of it.



During his visit he expressed pleasure at the class room work. He couldn't express the same approval of the building and equipment. He offered two constructive criticisms. The first was that the bookcases containing the school library be located in a more accessible place. Consequently, during the summer vacation a bookroom was constructed at very small expense and the library was moved to occupy the position of the former book shelves. This arrangement is liked and is being used more widely than the former. The second suggestion was to the effect that the typewriters should not be located in the science room. A readjustment has placed them in one of the larger home rooms and has given more room for expansion in this department.

Attendance upon school sessions has steadily improved throughout the year. Some cases of truancy have been detected, and dealt with. Tardiness has been the worst misdemeanor in attendance, but has now been decreased to only excusable cases. Absence has been for sickness or with parents' consent.

The scholarship of the school has been steadily improving. The honor roll for the fall term of 1930 included the names of nineteen pupils, the same roll for the fall term 1931 includes twenty-four pupils. During the Spring Term of 1931 the Terman Intelligence Test B was given to all the pupils of the Junior-Senior High School. The results were comparable with those from other schools who have taken the same test. During the next few weeks the Stanford Achievement Tests in different subjects will be given to the school. Later in the year, if conditions warrant it arrangements will be made for the school to take part in a series of competitive tests for general scholarship sponsored by and furnished by the University of Me. In every way the school is keeping scholarship as its chief objective and is encouraging advancement in it

The special departmental work deserves mention. There are four distinct types of work offered in addition to academic subjects. First, I wish to mention the Manual Training Department. Thanks to the cooperation of the townspeople, through their school board, there is now an equipment the equal of any small school in the state. The fall term of 1931 has seen Mr. West capably carrying on in Manual Training, together with a class in Ancient History and the coaching of the boy's basket ball team. He has proved efficient and his pupils are learning much that will be valuable to them.

The Home Economics Department has been well managed through the year of 1931. Mrs. Aikins, the present instructor has accomplished much with her students and has added to the equipment. I would advise the reading of her report for more complete details of what she has done.

The Commercial Department has been relocated, expanded, and improved this year. By placing tables for the typewriters in one of the two largest rooms more space has been obtained. Two new typewriters have been added and the seven old ones reconditioned. They are all used to capacity by three divisions of pupils. Bookkeeping has been one of the regular subjects in this department. This year Shorthand has been added and much interest and appreciation has been shown by nearly all the students in the department. Because of lack of time during school hours two extra periods a week are voluntarily given to this subject by the instructor. Miss Gailey, the present instructor is thoroughly qualified for the work and is fully accredited by the state department.

Instruction is offered in Music throughout all grades of the Old Orchard schools. Mrs. Dolley has

continued the splendid work of past years. There are two organized Music Clubs in the Junior-Senior High School which hold regular monthly meetings. Programs for these have been arranged by the students under the supervision of Miss Galley for the Junior Club, and of Mr. Dolloff for the Senior-Club. Through the encouragement of the latter an orchestra is being started which may eventually become a regular school activity.

Athletic activities have developed in two sports, basketball and baseball, during 1931. Under the able coaching of Miss McIntire the girls produced a championship team in basketball. They won eleven straight games and the cup in the Central York County League. So far this winter they have won all their league games, and will doubtless win a second cup or trophy. If that be so they will receive an invitation to a state small schools' tournament at Livermore Falls. The boys likewise have had a team which has made a creditable showing for the first season. During this school year under the capable coaching of Mr. West they have improved and are winning a good proportion of their games. Last spring a baseball team was started and the boys did well for the first season. The school appreciates the interest of the townspeople and welcomes their support in these outside activities.

Every teacher of the Junior-Senior High School should be commended for their cooperation and eager, loyal service. They have given unsparingly of time and effort to produce the good results achieved. Each has a teaching load of, at least, six periods a day. In addition every extra curricular activity is sponsored, coached, or supervised by some member of the faculty. They helped gladly with their classes during the first evening session ever held in Old Orchard. They are

a group of teachers of which any town may well be proud. It is a pleasure to work with them.

In conclusion, I wish to express my appreciation of the hearty support given by Superintendent Hull, and each member of the school board.

Superintendent H. C. Hull; I hereby have the honor of presenting a brief report of the Home Economics Department of Old Orchard Beach High School.

In our work thus far this year we are following the State outline in so far as it is practical. As only two years of Home Economic work is outlined in the State Course of Study, and we are offering it to all four years of high school, we are having to modify the course to meet this condition.

Early in January with the cooperation of the Parent-Teacher Association we started the Hot Lunches. Thus far we have averaged twelve students per day in the first six grades. The planning, marketing, preparing and serving of the School Lunch is giving the Freshmen Class of five an unusually fine problem. Accurate accounts are kept each week. As the duties of the girls rotate from week to week they gain experience in each branch of work, and take great pride in shouldering their own special responsibility.

A nurse once said "Every person should eat at least one hot food at each meal summer and winter", therefore you can understand why we would like to have every child that stays at noon during cold cold weather a Hot Lunch Child.

It is our aim to make the Home Making Courses of such a practical nature that they may function in the

homes of the girls to-day, as well as in the future.  
 "The greatness of America lies in the American home."

We feel that we are greatly handicapped in our limited quarters and with our inadequate equipment. We are especially in need of a safer and more modern cooking device.

I wish to thank you Mr. Hull, for your cooperation, and for your assistance in obtaining more modern text books, and thru you to thank the members of the School Committee for their interest and cooperation, and our chairman Mrs. Gilpatrick, for obtaining for us the many little things needed in running our department efficiently.

I am pleased to submit the following report of the Music Department of our public schools:

Last year's report covered quite fully the work in music as outlined in the Progressive Method used in grades one to seven. This has been followed as usual this year until this winter term when we are introducing the Music Hour series in grades five and six. These books are published by the same house as the Progressive Method on similar principles, but incorporate more advanced methods and contain much valuable material. Music forms; music appreciation notes and suggestions; biographies; measurement tests; glossaries etc., are included in the accompanying Teachers' Manual for each grade, which will prove most helpful to both teacher and pupil. We hope to

gradually supply each grade with these in order to obtain the best results.

Perhaps the most outstanding feature of our school life this year was the presentation of a fine Steinert piano to the first grade room by Mrs. Belle Godard in memory of her little daughter Katherine, who was a member of this class last year until her untimely death in June. A piano was greatly needed in this room for use with rote songs, musical games etc. and is bringing much pleasure to all the children.

The Junior Music Clubs of the grades and High Schools were all represented at the Junior Rally Day in Portland last May which the Maine Federation of Music Clubs sponsored. An unusually fine program was rendered, the All-State Junior Chorus being a specially delightful feature.

Washington anniversary programs are now in preparation in all the schools to be given as part of the school curriculum, or in public preparation.

We are most fortunate this year in having two accomplished musicians, Miss Gailey and Mr. Dolloff of the High School faculty who are generously assisting in all the musical activities of the Junior-Senior High School.

May I here express to them, also to our principal, Mr. Hamlen and to the teachers of the grades, my very sincere appreciation of their co-operation and assistance without which the very satisfactory progress of the year could not have been achieved.

I also wish to thank our Superintendent of Schools and members of the Board of Education for your hearty support and interest in my work.

REPORT OF INDUSTRIAL ARTS DEPARTMENT  
FOR YEAR 1931-1932

I hereby submit the following report of the Industrial Arts Department of the Old Orchard Beach High School. Owing to larger classes it made it necessary to add a few tools to the wonderful equipment that the shop boasts. The following are the tools that were added: 5 Stanley Jack Planes, 6 Lloyd Knives, 1 Expansive bit, 5 Nail Sets, 3 Awls, 1 Pair Pliers, 2 16-oz. hammers, 2 Sets Drills 1-16"—1-4" Inc., 1 Electric Glue Pot, 5-5' cabinet clamps and an assortment of finishing materials including: Nails, brads, screws, sandpaper, shellac, stain and Duco paint.

The interest is very high this year with many useful and ornamental articles being made. I have used different lumber this year some that was more in a cabinet class. The boys have appreciated the fact that they could use Oak, Gunwood, Cedar, Whitewood and Maple along with White Pine.

Telephone desks and chairs, Writing desks, Smoking stands, Gun case, Floor lamps, costumers, clocks, chests and many smaller articles comprise the list made in shop the first half year. These articles are being stained walnut, oak, and mahogany while some are being left natural.

I hope to give the boys a few fundamentals of electric wiring and also some mechanical drawing. There is no equipment for mechanical drawing but we can build our own boards, T-squares and angles in shop.

## SCHOOL NURSING

Herewith is submitted the first report of nursing service for complete year under full time community service.

Routine inspection of school buildings, toilets, water facilities have been made.

Inspection of all pupils in Class room, follow up visits to homes, Class room inspection and Health Instruction as itemized in 1930 report.

375 pupils were weighed, measured and inspected by nurse, a study of their growth and development made.

253 pupils were given physical examination by Dr. L. E. Willard, school physician the following defects and corrections recorded:—

215 pupils were examined by the school dentist, Dr. A. W. Foss. The mouths of the children show splendid results from the continuous mouth hygiene program which has been carried on for several years.

60 pupils were placed on the Dental Honor Roll at the first examination. That is 1-3 of the pupils in the Elementary building have their teeth in perfect condition all the year.



The average cavities per child for 1931 is 5 plus showing a decrease over the previous year (1930 7 plus 1929, 8 plus).

135 received dental prophylaxis or cleaning.

37 Extractions were done in the school building.

2 pupils had inflamed gums caused by need of dental cleaning.

74 Seven Point health pupils.

Emergency dressings of minor injuries, or first aid rendered when necessary. 11 major cases of accident or illness were referred to Dr. H. A. Randall in some of these splinting, strapping or X-ray were necessary.

17 pupils were vaccinated by Dr A. L. Jones under the annual immunization program of the Board of Health. Daily dressings were done at the school or home as necessary.

Milk lunches and Hot lunch were served as in the previous year, sponsored and financed by the Parent Teacher Association.

A Pre-school clinic was held in co-operation with President Hoover's Child Health Conference at the school in May. Financed by the Local Branch American Red Cross. 15 children received Physical and Dental examinations and had their teeth cleaned.

# WARRANT

## MARCH 7th., 1932

To Lewis M. Fowler, Constable of the Town of Old Orchard Beach, in the County York:

Greeting:—

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of said Town of Old Orchard Beach qualified to vote in said town, on Monday, the 7th day of March, A. D. 1932 at 9 o'clock in the forenoon, then and there to act upon the following articles, to wit:

1st. To choose a moderator to preside at said meeting.

2nd. To choose all necessary town officers for the ensuing year.

3rd. To hear and act upon the reports of the town officers and all special and standing committees.

4th. To see what action the town will take in relation to the pay of town officers.

5th. To see what sums of money the town will vote to raise. 1st, common schools. 2nd, for free high school. 3rd, for free text books. 4th, for making and repairing highways and bridges. 5th, for support of poor. 6th, for the pay of town officers. 7th, for maintaining street lights. 8th, for contingent expenses. 9th, for sanitary expenses. 10th, for town interest. 11th, for repairing schoolhouses. 12th, for the public library. 13th, for heating, lighting, and care of town property. 14th, for moth nests. 15th, for State aid road patrol. 16th, public toilet. 17th, for school supplies. 18th, for transportation of High School pupils. 19th, for advertizing. 20th, for payment of serial bonds. 21st, for road oil. 22nd, schoolhouse maintainance. 23rd, for maintainance of third class highways, 24th, nursing service. 25th, cleaning streets and beach. 26th, for Domestic Arts. 27th, for Manual Training. 28th. for

school physician, as acquired by law.

6th. To see what sum of money the town will vote to raise to pay collector's commission and abatements.

7th. To see if the town will vote when the taxes shall be committed to the collector for collection and what rate of interest, if any, will be charged thereon, thereafter.

8th. To see if the town will authorize the issue of notes in anticipation of taxes pursuant to s. 83 of ch. 5 of the Revised Statutes 1930 that the treasurer with the approval of the selectmen is hereby authorized to issue and negotiate notes of the town to the amount which shall not exceed in the aggregate outstanding at any one time, one hundred twenty five thousand dollars for temporary loans to be paid during the current year by taxes.

9th. To see if the town will authorize the Selectmen and Treasurer to issue town notes to pay those, if any, which fall due the present year.

10th. To see if the town will authorize the assessors to make such abatements as they think reasonable.

11th. To see what action the town will take and what sum of money, if any, the town will raise to maintain one or more regular patrolmen.

12th. To see what action the town will take and what sums of money the town will raise to maintain a police force; to construct and maintain sidewalks; to construct and maintain sewers and drains; to maintain fire department; to maintain town truck and driver; for hydrant rental; for liquidating Serial Bonds; for interest on debt incurred in the fire department, sewers and loans, all within the limits set out in Section IV, of the act of incorporation of the town of Old Orchard, to be a separate tax, to be assessed and collected as provided in said act.

13th. To see if the town will vote "yes or "no" on the question of appropriating and raising money necessary to entitle the town to State Aid as provided in Section 20 of Chapter 28, of the Public Laws of 1930.

14th. To see if the town will raise and appropriate the sum of \$1,466.00 or the sum of \$7,330.00 for the improvement of the section of the State Aid road as outlined in the report of the State Highway Commission, in addition to the amounts regularly raised for the care of ways, highways and bridges, the amount being the maximum which the town is allowed to raise under the provisions of Section 19 of Chapter 28 of the Public Laws of 1930, or under the provisions of Section 22, Chapter 28, of the Revised Statutes of 1930.

15th. To see what streets or parts of streets the town will vote to lay dust during the summer months, what the sum of money they will appropriate for the same.

16th. To see what action the town will take in regard to permitting peddling or the taking of pictures by transient photographers, or any other business or use of automobiles, motorcycles, aeroplanes and other fast moving vehicles on Surf Street during the so called Beach Season; and to provide seats for the Beach, and other places about town for the use of our summer guests, using any money necessary therefor from the contingent fund.

17th. To see if the town will authorize the selectmen to employ special officers as life-guards from July 1st to Labor Day, and what sum they will appropriate therefor.

18th. To see what sum of money the town will vote to grant and raise to be expended and used for advertising the natural resources, advantages and attractions of the State of Maine.

19th. To see if the town will vote to purchase a truck and plow for use in snow removal and other purposes, and what sum of money it will raise therefor.

20th. To see what action the town will take in regard to the payment of its outstanding notes.

21st. To see if the town will vote to raise money to provide for the services of a public health nurse, or take any action thereon, and what sum they will raise.

22nd. To see if the town will vote to exempt from taxation, in whole or in part, the property of the Home for Aged People Ass'n for the year 1932.

23rd. To see if the town will vote to instruct the Selectmen to pay from any monies in the contingent fund, the sum of \$50.00 to the C. Fayette Staples Post American Legion, for the care and decoration of Soldiers' Graves.

24th. To see if the town will authorize the Superintending School Committee to transfer two grades of the High School to Thornton Academy as tuition pupils for the next school year in order to relieve the serious overcrowding of our local school buildings; and to pay the tuition and transportation charges for the same from the appropriations for High School.

25th. To see if the town will vote to authorize the Selectmen to have the Town Books audited for the years 1925, 1926, 1927, 1928, 1929, the audit to be made by the State Auditors.

26th. To see if the town will authorize the issuance of \$45,000 of the bonds of town to bear interest at the rate of  $4\frac{1}{2}\%$  per annum, and as to whether said bonds shall be term bonds or serial bonds, and if serial bonds, to determine the amount of such serial bonds to mature annually. The proceeds from the sale of said bonds to be applied to the payment of the notes of the town now due or which may become due during the current year.

27th. To see if the town will vote to instruct the treasurer to execute quit-claim deeds of any parcel of property purchased by the town for taxes in former years, in all cases where tax deeds have been delivered to the town, to any person who will pay to the town as the consideration for such quit-claim deeds, the amount of the tax due thereon, including all expense of the sale and interest thereon at the rate fixed by law.

28th. To see if the town will appropriate the sum of \$800.00 for the purpose of erecting in that part of the town building adjoining the jail, on the ground floor, facing Post Office Square, quarters for the poli-

ce department, to include a courtroom, breaking an entrance from the proposed quarters through the wall into the jail, thereby placing the entire court and police department with jail in one section of the building, and taking these departments from that part of the town building where they now are, leaving that space available for other town purposes.

29th. To see if the town will vote to purchase a 2 ton tractor and plow for use in clearing the snow from the sidewalks and other purposes and what sum of money they will appropriate therefor; all within the limits set out in Sec. IV, of the act of incorporation of the town of Old Orchard, to be a separate tax to be assessed and collected as provided in said act.

30th. To see if the town will vote to authorize the Selectmen of the town to open Brown St. from E. Grand Ave. to the Boston & Maine R. R.; this space to be used for public parking purposes.

#### SEWERS AND DRAINS

31st. To see if the Town will vote to construct the following lines of Sewers. And under what conditions if any.

On west Grand Ave., from Colby Ave., to Casco Ave. On a part of Anconia, Winona, Oceanna, and Casco Aves.

Extend Storm Sewer on West Grand Ave., to Fourth Ave. Extend Sewer on Surf St., to and on Odena Ave.

Construct Storm Sewer pocket on 11th st.

Relay Brook Culvert on First St. And what sum of money if any they will appropriate therefor.

#### HYDRANTS

32nd. To see if the town will vote to locate a hydrant on West Grand Ave., at or near the location of the Old Salt Road and what sum of money they will appropriate therefor.



## STREET LIGHTS

33rd. To see if the town will vote the following named electric lights.
