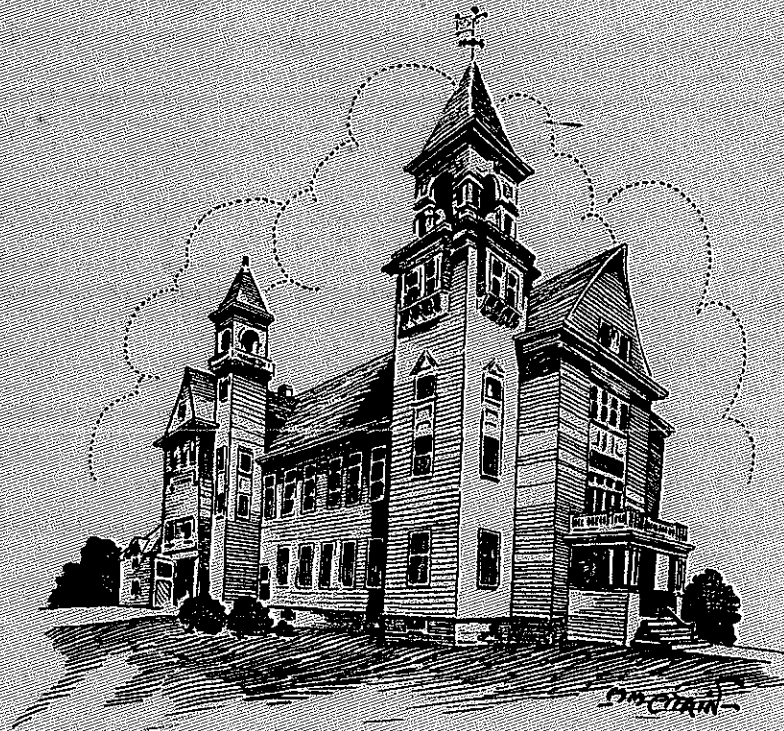
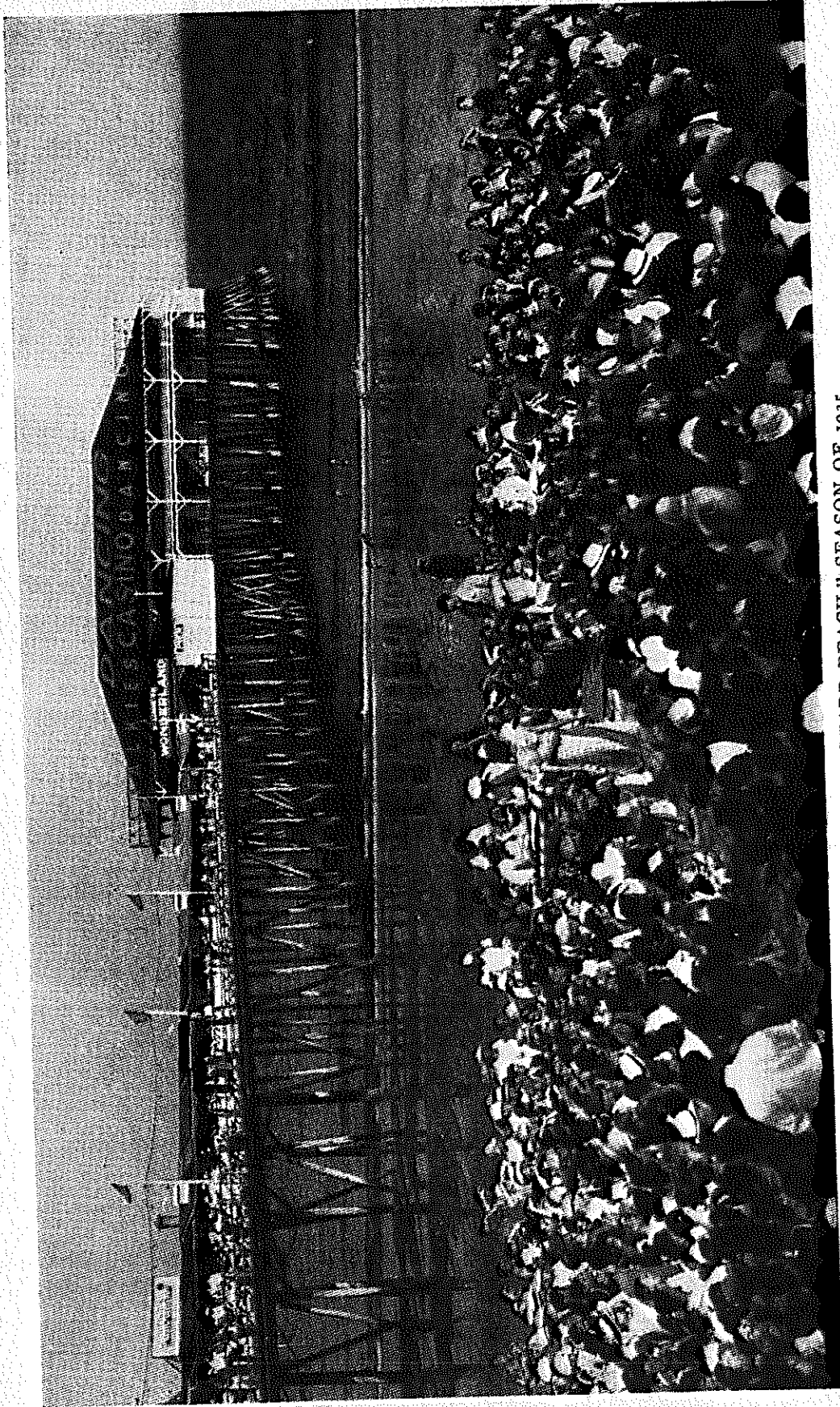

I herewith submit my report of the Police Department for the fiscal year ending December 31, 1935, for your consideration.

In view of the many emergencies which arose during the past year our department was maintained within it's appropriation and shows an unexpended balance.

During the period that the summer schedule was in effect there were but two cases of breaking and entering, which I believe is a record and further proves the value of systematic patrolling. One of our great problems is the prevention of car thefts, we lost several during the summer but every one was recovered.

Much interest was shown in the police school during the spring session and it's results certainly warrants it's continuance. I want to thank our instructor, Dr. Malone for his untiring efforts in the school for which he received no salary.

I recommend the continuance of two year-round night patrolmen and there is great need of a year-round day man. I earnestly hope the town will, this year, install a signalling system which is of such vital importance to the department.

I want to thank the many citizens who have recognized the progress made in our department the last few years for their kind comments.

Never has there been a year of any more harmonious working in our department than in 1935. I wish to extend my most sincere appreciation to the entire personnel for the manner in which they executed their duties and also to the Board of Selectmen for their loyal support and fine co-operation.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

To the Honorable School Committee, Board of Selectmen,
and Citizens of Old Orchard Beach:

Ladies and Gentlemen:

This past year has been a year of many problems but withal progress has been substantial and pronounced from every educational aspect.

It is apparent at this time that the very limited space for expansion in both the Elementary School and the High School can find no adequate solution until a new building is provided. This is generally recognized by the public at large. The reasons for the conviction will become apparent with increasing clarity as you analyze the enrollment now in your schools.

A Study of Enrollment

The tendency of increasing teacher-load on the elementary level has been apparent for some years. Several grades of the Elementary School are now too large for the best intellectual progress. In 1919 all elementary grades were housed and taught in combination grades. The 1st and 2nd grades were taught in one room by one teacher, likewise, the 3rd and 4th, 5th and 6th, 7th and 8th were combination grades. The entire elementary staff only required four teachers. Today all grades in the elementary building are nearing, or have exceeded, the 40 pupil enrollment mark at this time.

Your attention is called to a detailed study of the enrollment as it was reported September 25. On September 25th grade one had 16 girls, 26 boys, making a total of 42; grade two, 12 girls, 30 boys, total 42; grade three, 15 girls, 24 boys, total 39; fourth grade, 16 girls, 21 boys, total 37; fifth grade, 21 girls, 17 boys, total 38; sixth grade, 16 girls, 24 boys, total 40.

This makes a total enrollment for the first six grades of 238 pupils. The boys predominate over half the enrollment by a margin of 46. Promotion problems are at once apparent to any one who thinks carefully on these facts as presented in the above enrollment. Some of the grades are so out of balance in the disproportionate number of

boys and girls enrolled, that, on first visiting them, they seem like a boys' school.

A detailed study of the enrollment of the Junior, Senior High School is no less significant than the statistics presented for the Elementary School. The seventh grade enrolled 17 girls, 22 boys, or a total of 39; the eighth grade enrolled 18 girls, 22 boys, total 40; ninth grade enrolled 13 girls, 8 boys, total 21; Sophomores enrolled 9 girls, 10 boys, total 19; Juniors enrolled 5 girls, 14 boys, total 19; Seniors enrolled 8 girls, 3 boys, total 11. The respective enrollment of each of the four years of the Senior High School is, relatively small, as compared with the Elementary School. However, these large Elementary Grades are going forward to the High School in a continuous stream.

There are only eleven pupils to be graduated from the High School this spring. Only these eleven places will be available next fall, while nearly forty will be seeking entrance. This brings us to grips with the present needs that will eventually confront school officials on the opening of school next fall.

It seems likely next fall that classes must be established at the Town Hall, or some other equally undesirable place with all the disadvantages of broken control, increased teacher staff, and many other cumbersome arrangements. It is equally plain that each class established apart from the main school must be supplied with seats, desks, and supplies of all kinds.

Many parents feel that any make-shift plans, as indicated above, will be unfair to their children. The Old Orchard Electorate must face the needs of your school fairly for the congestion is crucial.

In passing I should like to call your attention to the fact that where the lower grades near the forty mark of enrollment, the lower quartile of that group will need more individual help than can be given to them if they are to be kept up to grade. The first grade is case in point. In the first grade this fall, it became apparent that one teacher could not possibly care for the enrollment, consequently on November 25, this grade was given an extra teacher. The elementary building was designed to carry a teacher-load

of thirty-five pupils per room. There is no room that does not now exceed that quota. The seasonal exodus has of late years afforded little appreciable relief to the schools from this tendency to over flow its normal school space. The elementary school is already outgrown.

From the foregoing tabulations, it seems perfectly plain that the High School will greatly increase with each succeeding graduation. Each promotion henceforth will tend to greatly increase the Senior High School enrollment. Industry will not be able to absorb the children who should remain in school. The relative holding power of the Senior High School should be greatly increased by curricular betterments and offerings for the non-collegiate minded. It would seem, therefore, that it is increasingly the obligation of the public to afford educational opportunities to meet the need of the growing stream of youth who can not drop out of school for productive work, but who, perforce, must remain in school whatever the limitations. The other alternative for this non-collegiate group, is for them to drop out of education into enforced idleness with all the vast liability of rapid deterioration.

Your attention is invited to a brief summary of the extra curricular activities of the High School. The organized student class activities are as follows; Boys' Basket Ball Club coached by Mr. Marshall; Girls' Basket Ball Club coached by Miss Moore; Athletic Association, President, Arthur Baily; Old Orchard News Club, Editor-in-chief, Bessie Margone; Senior Class President, Arthur Baily; Faculty Advisor, Principal Herbert Bean; Junior Class President, Leslie Whittmore; Faculty Advisor, Elmer Marshall; Sophomore Class President, Edmund Muller; Faculty Advisor, Harold Higgins. The Music Clubs have their special plans and take their place in the school activities. The organization and the team work in the administration of these extra curricula activities is highly commendable. They are co-ordinated by the Principal, Mr. Bean.

There is entire co-operation on the part of the staff and the student body. In spite of the crowded conditions at the High School I feel that distinct progress has been made. The grade of work being accomplished, the accuracy of ac-

counting, the fullness of data available, the filing system and check-ups, the general discipline, the diversified interests of the student today are satisfactory. These outward evidences of progress, I am happy to inform you, can be seen for yourself if you but accept the invitation of the Superintending School Committee to visit your schools and make an appraisal from your own observations.

The seasonal decorations of the Elementary School of Old Orchard lead in the colorfulness and general attractions the schools of this Union. Teachers meetings have had 100% attendance except for excused illness. These meetings have been instructional and have helped to unify the class room work. My supervisory calls are kept by calendar date by each teacher in the proper place in the State Register. This is part of the data required by Statute. Last year 434 calls were made and listed by date.

Repairs

The repairs of the schools this year have been under the jurisdiction of Mr. Kennett. The school repairs have been carried through in a thoroughly business like fashion.

Your school buildings are in a fairly good state of up keep. The outside surfaces of both buildings will need paint this present year. A considerable vibration of the upper floor of the Main Room at the High School has been noticeable this fall. It was also noticed that this floor was somewhat out of plumb. This has been remedied by a truss supported by pillars being installed extending through the center of the room below. This truss greatly strengthens the floor and does away with all vibration

Gongs, both inside and out, were installed at the Elementary building. These aid in calling the schools together and dismissing them, as well as in case of fire drills where pupils need to be handled in a group.

Transportation

The frequent criticism regarding the various modes of transportation of public school pupils has had full consideration by your Superintending School Committee. The fact that the Boston & Maine busses are not timed to accommodate or correlate with the school day is a matter that is not within the jurisdiction of the Committee.

Mr. John Crowley made some necessary changes in his conveyance that has been accepted, this year, as quite satisfactory by the families served. If and when a new building for the High School pupils is assured, transportation of the public school pupils will become an acute problem. Transportation of the public school pupils should be timed, if possible, to best accommodate the school day and schedule.

One of the pertinent suggestions is that a bus commodious enough to accommodate all pupils, operated under a three year contract, with an established schedule, under the direct control of the School Committee, would likely be more satisfactory than the present arrangement without adding additional expense. This is a matter which the Superintending School Committee wish to refer to you for solution at the proper time.

The usual statistical data is appended to the report and will be found informative.

In conclusion, I wish to join with the Superintending School Committee in expressing our belief that your schools have made commendable progress within the year and that many progressive and encouraging signs point the way to the future.

32 School and 3 Pre-School children were vaccinated by Dr. Paul S. Hill, Jr., under the annual immunization program of the Board of Health. The usual routine of after care wherever necessary.

The annual Pre-School Clinic was held in May in cooperation with National Child Health Program, financed by the Local Branch American Red Cross. 49 children were examined by Dr. L. E. Willard, defects were as follows:

10 classes in Home Nursing were held in co-operation with Domestic Arts Department (Mrs. Aitkins in charge) Students are taught bed-making, bathing and care of Sick, care and feeding of Infants, Pre-school and school children, administration of medicine and treatment such as may be recommended by a physician. The use of practical and improvised equipment in the sick room. The work of the students and the use of equipment was displayed at the School Exhibit. Scrap books compiled by these students were submitted to National Headquarters American Red Cross, Washington, D. C., and several of them have been placed on exhibit there.

A survey of crippled children has been made and reports submitted to State Department of Health, Augusta.

Milk and Hot Lunches, served by Domestic Arts Department and financed by P. T. Ass'n as in previous years.

Again we have had a full school year free from epidemic of any kind.

I wish to express my appreciation to the Superintendent and Superintending School Committee, teachers, parents and organizations, for their support and co-operation in carry on the School Health Program.

REPORT OF THE PUBLICITY DIRECTOR OF OLD ORCHARD BEACH, FOR 1936

I herewith submit my annual report as Publicity Director of Old Orchard Beach for the year ending March 1, 1936.

The work of the Old Orchard Beach Publicity Bureau was greatly enlarged over that of the previous year and, as a result, there is every reason to believe that a much larger number of tourists visited the resort during the Summer season.

Reliable check-ups made by Canadian tourist bureaus and by Canadian government officials at the International border indicated that approximately 100,000 Canadians crossed into the United States giving Old Orchard Beach as their ultimate destination. The vast majority of these traveled in automobiles and very many of them probably were repeats, Canadian business men and women whose families were staying at Old Orchard Beach and who came down to visit them over week-ends and in connection with their annual vacations. The railroads, busses and public taxis between Canada and Old Orchard Beach carried more people last Summer than they have done before for many years.

Canadian railroad, automobile and other tourist bureaus credited this great increase in Old Orchard Beach travel to the vast amount of publicity which it received in the Canadian newspapers through its display advertising, coupled with a record-breaking lineage of general newspaper publicity, all of which was secured by the Old Orchard Beach Publicity Bureau. The major part of this publicity was rendered possible by contacts made and friendships formed by personal calls upon all of the leading newspaper heads, railroad officials, and touring bureau executives in Montreal, Toronto, Ottawa, Quebec, Sherbrook, P. Q., Three Rivers, P. Q., Hamilton Ont. and many other smaller centers. In all of these cities Old Orchard Beach folders were given out by the leading information bureaus.

Conferences in Montreal Boston and New York resulted in obtaining the best railroad and bus services Old Orchard Beach has ever had.

The through train service between Montreal and Old Orchard Beach, established through the efforts of the

Publicity Bureau the previous year, was continued, together with the same number of special week-end excursions.

A new feature was a rapid daily bus service between Montreal and Old Orchard Beach, made possible through a railroad connection over the Central Vermont (owned by the Canadian National), between Montreal and Essex Junction, near Burlington, Vermont. This was worked out through the co-operation of the Central Vermont Railroad, as stated, and the bus lines of the Boston & Maine and the Vermont Transit Company.

Later in the season still another through bus service between these two points was established by the Gray Line.

From United States points a vastly improved transportation service was made possible through the persistent efforts of the Publicity Bureau.

One of its most notable achievements was to get the Streamline Flying Yankee to recognize the importance of this resort by stopping here. This was accomplished first by getting the morning trip between Portland and Boston to stop and later the evening trip between Boston and Portland, which formerly operated over the Eastern Division, was transferred to the Old Orchard Beach line so as to make a regular stop at this resort. Large crowds patronized the train, especially to Biddeford and later special excursions were run to Dover, N. H. The Flying Yankee proved to be a great attraction for Canadian tourists who had not seen a Streamline train before.

One of the most interesting services inaugurated, and one which immediately gave Old Orchard Beach a standing as one of America's principal Summer resorts, was the inauguration of a week-end special excursion from New York City. Considerably over 100 New Yorkers came in each Sunday morning on this excursion just for the sole purpose of spending one day here.

Another fine recognition of the importance of Old Orchard Beach as a resort was its selection as one of the four stopping places in the Four Star Tours covering New England and starting from New York City, and operated by the New York, New Haven and Hartford Railroad and the Boston & Maine. Two days were spent here each week by these excursionists.

Another outstanding Publicity Bureau achievement, secured after a long campaign, was the establishment of a through service between New York City and Old Orchard Beach in both directions. Special Boston & Maine busses met each steamship at Portland and brought its Old Orchard Beach passengers directly here and a similar service was operated in the opposite direction. A large number of tourists were brought to us through this service and the fine publicity which it gave us.

A further important service inaugurated was the meeting of every Canadian National-Grand Trunk train into Portland from Montreal by special Boston & Maine busses which brought passengers without delay to Old Orchard Beach. Likewise a similar service was operated in the opposite direction.

Through bus services were operated by the Boston & Maine and the Grey lines between Old Orchard Beach and Boston, and other services were operated to New York, Albany, the White Mountains, Manchester, N. H., as far east as Calais, Maine, Toronto, Philadelphia, Washington, and hundreds of other American and Canadian points. A popular feature was a sight-seeing trip to the White Mountains and back in a single day which, with other similar trips helped to establish Old Orchard Beach as an excellent central point for tourists to make their headquarters and enjoy the attractions of all the vast territory, both sea-coast and inland, which surrounds it.

Clarence Chamberlain and Ruth Nichols, famous fliers, developed a large amount of publicity for Old Orchard Beach through their visits here during the Summer in connection with their sight-seeing flights in this vicinity and their trips to New York, Boston and other points. This service, however, developed serious problems in connection with the prevention of accidents on the beach, but was very effective in calling attention to the fact that Old Orchard Beach, known the World over as the scene of some of history's greatest flights, in order to maintain its great reputation in this field, needs a suitable airport in as close proximity as possible to the beach and the center of the town.

Old Orchard Beach also had some special events which attracted international attention, a fact undoubtedly un-

known to a vast majority of its citizens.

One of these was its International Beauty Pageant held in August. A first attempt in this field it attracted such wide attention that pictures of its winner, Geraldine Starr, of Montreal, and of Miss Marion Moll, of Philadelphia, who posed for the now famous "Old Orchard Beach Girl" on the cover of the Publicity Bureau's descriptive folder, were used in newspapers in every State in the United States and in every Province in Canada, together with stories of the event and of Old Orchard Beach.

Pictures of Miss Joyce Gilmour, of Montreal, selected as "Miss Old Orchard Beach" in an earlier contest and sent out by the Publicity Bureau, also were used in nearly every State and Province in the United States and Canada. These two events, alone, brought more publicity to Old Orchard Beach than anything else staged here.

In this connection, within the past month, the statement made by one of America's publicity experts is somewhat astounding and shows the immense value of the work of the Old Orchard Beach Publicity Bureau. This was that a check-up made of publicity secured by different leading American resorts indicated that Old Orchard Beach had secured publicity to the approximate value of \$100,000. Nearly all of this may be credited to the Old Orchard Beach Publicity Bureau which secured the co-operation of the various channels through which it was used and sent practically all of it out.

Canadian Day, with the visit of Mayor Camilien Houde, of Montreal, Charles K. Howard, Montreal, Manager of the Tourist and Convention Bureau of the Canadian National Railway System, and famous authority on recreational traffic, and D. Leo Dolan, Ottawa, Publicity Director for the Dominion of Canada, was another event which got great publicity for Old Orchard Beach throughout Canada especially and also within the United States.

One of the most important accomplishments of the Publicity Bureau in 1935 was the establishment of an up-to-date and fully equipped information bureau in the Town Hall, open every day, and many evenings and Sundays as well. Thousands visited this Bureau during the Summer and hundreds passing through Old Orchard Beach were persuaded to stay over for a visit in our resort as a result

of the efforts of the Publicity Bureau's staff. The Bureau received many compliments for the service which it rendered, one party which came by automobile from Florida declaring that it was the only Bureau of the many its members had called at which had been able to give a complete information service, including routes to far away points which they wished to visit and a list of places of interest which its members should see while in this vicinity.

Your Publicity Director not only visited all the leading information bureaus and transportation officials and newspaper offices in all of the principal cities of Canada, between the city of Quebec and Toronto, but also thoroughly canvassed a new and rich territory with excellent results for a first visit. This was the cities of New York, Philadelphia and Washington, the two latter being included in a trip to Washington in connection with the Sea Wall project. Other cities visited were Hartford and New Haven, Conn., Springfield, Newburyport, Lawrence, Haverhill and Worcester, Mass., Albany, N. Y., Providence, R. I., Dover and Portsmouth N. H., and Boston. In all of these the newspaper offices were visited and arrangements made for the use of publicity material when sent to them, and all important touring bureaus and high transportation officials were contacted and co-operation obtained in the distribution of Old Orchard Beach folders. The advantages of our resort were fully explained and arrangements made for special through rates and excursions to Old Orchard Beach with railroads and bus lines.

As a result a vast amount of promotion work for Old Orchard Beach was carried through, much of which will be helpful the coming season. If this work is continued this year there is every reason to believe that very desirable business will be obtained for our resort.

The successful resorts of the past two years are proving that this contact work is tremendously productive in securing tourists when coupled with advertising. Without advertising, however, efforts along this line are more or less wasted. Large information bureaus and transportation companies do not care to put much effort into trying to send business to a resort which is not well advertised and which is not receiving a large amount of publicity. Unless the resorts co-operate in this manner and make themselves

known to the public the transportation companies have a hard up-hill battle to get tourists interested in them.

Still another successful achievement of the Publicity Bureau was the publication of what was declared by many tourist organizations and publicity bureaus as one of the most attractive and worthwhile booklets published by any resort during 1935. This booklet, because of its up-to-date appearance, was given the best positions on the counters and in the racks of the leading tourist bureaus of Canada and the United States, East of Chicago and North of the Mason and Dixon line. Over 50,000 of them were printed and distributed. The attractive cover was the exclusive picture of the "Old Orchard Beach Girl" (Miss Marion Moll, noted American model) had an eye appeal which made prospects pick up the folder and after an inspection of it put it in his pocket for a more careful perusal when he had ample time to do so. The cover was equally attractive to women.

Present indications point to a good Summer's business this year for the resorts that go after it. Competition is to be very keen. Large sums of money are to be spent by all leading resorts in an effort to get the business and Old Orchard Beach, in order to maintain its position as a leading seacoast resort and to increase its Summer traffic, must maintain a program of promotion on, at least, as large a scale as that of 1935. It is a recognized fact, as previously stated, that the more a resort does along this line the more business it will get and the more co-operation it will receive on all sides from transportation companies, touring bureaus and newspapers.

Old Orchard Beach was represented at the Canadian Beauty Pageant in Montreal in December by Miss Marion Moll who was feted on every hand and an immense amount of Canadian publicity was secured through her visit. Already a dozen of the leading competitors in this event are pledged to come to Old Orchard Beach this Summer to participate in a second International Beauty Pageant. The new Canadian Queen of Sports is "Miss Sherbrooke" and already the Mayor of that city and a large group of its citizens have announced they are coming to Old Orchard Beach this summer with her when she is to be a guest here for one week and will preside at our own Beauty Pageant.

In this connection it should be stated that while many may not like beauty pageants they rank as the greatest publicity producers among events that are staged.

Your Publicity Director has kept Old Orchard Beach publicity going to the newspapers of Canada and the large centers of population in Northeastern United States throughout the Winter. Much of this was made possible because of the Canadian Beauty Pageant at which Old Orchard Beach was especially featured. Miss Moll's picture as the "Old Orchard Beach Girl" and her various receptions and radio talks while in Canada, kept our resort in the minds of millions who heard her and read about her.

Old Orchard Beach advertising during 1935 was used in the leading newspapers of Montreal, Ottawa and Toronto, in Canada; in New York City; in Boston, Lawrence and Springfield, in Massachusetts; in Providence, R. I.; in Hartford, Conn., and in some leading tourist publications. The Publicity Fund also maintained the effective electric Old Orchard Beach signs at the railroad underpass, West of Biddeford, and at the three main highways leading from the Atlantic Highway, Route No. 1, to our resort, between Saco and Dunstan.

Indications now are that business conditions will steadily improve and that the recreational industry will flourish during the coming Summer among the resorts that keep themselves in the public eye. Last year Old Orchard Beach was able to increase its June business very materially; further improvement seems possible. Labor Day, this year, is not until September 7 which will be a help, while the fact that Memorial Day and July 4th will both come on Saturday assures two big week-ends.

The Old Orchard Beach Publicity Bureau deeply appreciates the support which it has received during its two years of existence, not only from Old Orchard Beach citizens, but from the business houses and citizens of Biddeford, Saco and Portland. It also thanks the various transportation companies, newspapers and tourist bureaus of the United States and Canada for their wonderful co-operation.

In Memoriam

We have to report the death of two of our highly respected and former Town Officers during the fiscal year.

Charles A. Dolbier passed away at the Webber Hospital in Biddeford, February 14, 1935, aged 58. He was born in Salem, Maine, July 6, 1876, and had made Old Orchard Beach his home for 28 years. He was a building contractor by trade. He was deeply interested in our public schools, and served his town faithfully and well for eleven years as a member of the Superintending School Committee, part of the time as chairman of the Board. He was a prominent member of the Methodist Church, and an active member of its official board, and its Church Treasurer for the past five years.

He was also a prominent member of both the Atlantic Lodge of I. O. O. F., and Orchard Lodge of Masons.

Albert Armstrong of Ocean Park died suddenly in Phoenix, Arizona, while on a pleasure and photographic trip, November 1, 1935, aged 75 years. He was of Scotch ancestry. Mr. Armstrong was a graduate of Oberlin College and Emerson School of Oratory and for several years was a successful lecturer on the Lycum Platform. After coming to Ocean Park about 30 years ago he engaged in the real estate and photographic business. He was recognized as an artist of exceptional ability. He served the Town most faithfully for several years as Trustee of the Public Library, as a member of the Superintending School Committee and as Health Officer, and was chosen Moderator on several occasions.

He was an active member in the Board of Trade, and the Royal Ambassadors Boys Camp at Ocean Park. He was a Mason and member of the Baptist Church.

TOWN WARRANT

To Charles F. Jensen, Constable of the Town of Old Orchard Beach, in the County of York:

Greeting:—

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of said Town of Old Orchard Beach qualified to vote in town affairs, to assemble at the Town Hall on Monday, the 2nd day of March, A. D. 1936, at 9 o'clock in the forenoon, then and there to act upon the following articles, to wit:

- 1st. To choose a moderator to preside at said meeting
- 2nd. To choose all necessary Town officers for the ensuing year.
- 3rd. To hear and act upon the reports of the town officers and all special and standing committees.
- 4th. To see what action the town will take in relation to the pay of town officers.
- 5th. To see what sums of money the town will vote to raise. 1st, common schools. 2nd, for free high school. 3rd, for free textbooks. 4th, for repairing schoolhouses. 5th, for school supplies. 6th, for transportation of high school pupils. 7th, schoolhouse maintenance. 8th, for manual training. 9th, for school physician as required by law. 10th, for domestic arts. 11th, for nursing service. 12th, for making and repairing highways and bridges. 13th, for support of poor. 14th, for the pay of town officers. 15th, for maintaining street lights. 16th, for contingent expenses. 17th, for sanitary expenses. 18th, for town interest on bonds. 19th, for interest on notes for money hired in anticipation of taxes. 20th, for the public library and building fund. 21st, for heating, lighting, and care of town property. 22nd, for moth nests. 23rd, for

State aid road patrol. 24th, for public toilet. 25th, for advertising. 26th, for payment of serial bonds. 27th, for tarvia. 28th, for maintenance of third class highways. 29th, for cleaning streets and beach.

6th. To see what sums of money the town will vote to raise to pay collector's commission and abatements.

7th. To see if the town will vote to pay the premium on surety bonds for tax collector and treasurer.

8th. To see if the town will vote when the taxes shall be committed to the collector for collection and what rate of interest, if any, will be charged thereon, thereafter.

9th. To see if the town will vote pursuant to Section 83 of Chapter 5 of the Revised Statutes of 1930, to authorize the issuance and negotiation by the treasurer with the approval of the selectmen, of notes of the town, in anticipation of taxes, to the amount which shall not exceed in the aggregate outstanding at any one time, \$100,000, for temporary loans to be paid during the current year in which they are made out of money raised during such current year by taxes.

10th. To see if the town will authorize the selectmen and treasurer to issue town notes to pay those, if any, which fall due the present year.

11th. To see if the town will authorize the assessors to make such abatements as they think reasonable.

12th. To see what action the town will take and what sum of money, if any, the town will raise to maintain one or more yearly patrolmen.

13th. To see what action the town will take and what sums of money the town will raise to maintain a police force; to construct and maintain sidewalks; to construct

and maintain sewers and drains; to maintain a fire department; to maintain town team and driver; for hydrant rental; for liquidating serial bonds; for interest on serial bonds; for interest on notes issued in anticipation of taxes, all within the limits set out in Section IV of the act of incorporation of the Town of Old Orchard, to be a separate tax, to be assessed and collected as provided in said act.

14th. To see if the town will vote "yes" or "no" on the question of appropriating and raising money necessary to entitle the town to State aid, as provided in Section 20 of Chapter 28 of the Public Laws of 1930.

15th. To see if the town will raise and appropriate the sum of \$1,466.00, or what multiple of that sum, for the improvement of the section of the State aid road, as outlined in the report of the State Highway Commission, in addition to the amounts regularly raised for the care of ways, highways and bridges, the amount being the maximum which the town is allowed to raise under the provisions of Section 19 of Chapter 28 of the Public Laws of 1930, or under the provisions of Section 173 of Chapter 3 of the Revised Statutes of 1935.

16th. To see what streets or parts of streets the town will vote to lay dust by applying tarvia or some other like material during the summer months, and what sum of money they will appropriate for the same.

17th. To see if the town will authorize the selectmen to employ special officers as life guards from July 1st to Labor Day, and what sum they will appropriate therefor.

18th. To see what sum of money the town will vote to grant and raise to be expended and used for advertising the natural resources, advantages and attractions of the State of Maine.

19th. To see if the town will vote to exempt from taxation, in whole or in part, the property of the Home for Aged People Association for the year 1936.

20th. To see if the town will vote to instruct the selectmen to pay from any moneys in the contingent fund the sum of \$50.00 to the C. Fayette Staples Post, American Legion, for the care and decoration of soldiers' graves.

21st. To see if the town will vote to have the tax collector maintain his office in the town building from the first day of July to the first day of October, 1936.

22nd. To see what sum, if any, the town would recommend to take from the joint State aid account for the purpose of applying bituminous surface treatment to State aid roads in excess of the requirements of Section 2, Chapter 132, P. L., 1935.

SEWERS

23rd. To see if the Town will vote to construct a Sewer on Massachusetts Avenue in Ocean Park; extend sewer from its present terminal on Sixth Street in "Tanglewood" (so-called) to the property of the "Royal Ambassadors Boys Camp Corporation"; rebuild sewer on Church Street.

STREETS

24th. To see if the Town will vote to grade and gravel Ancona Avenue, St. John Street, Seaview Avenue, from Central Avenue to Somerset Avenue; Lake Avenue, from Central Avenue to Somerset Avenue; grade and gravel Leavitt Avenue; South Avenue and extension of Sixth Street; Olympia Avenue; 4th Street in Ocean Park; Smith-wheel Road; Grove Avenue, from Ivy Avenue to Norway Avenue; Fern Park Avenue, from Ivy Avenue to Queens Avenue; Pavia Avenue, from West Grand Avenue to Seaside Avenue.

STREET LIGHTS

25th. To see if the town will vote to locate a yearly electric light on Wildwood Lane; a yearly light on Union Avenue, near Surf Street and to see what action they will vote to take to improve the lighting on Atlantic Avenue

during the summer season, change light at corner of Temple Avenue and West Grand Avenue from 250 c. p. to 600 c. p.

SIDEWALKS

26th. To see if the town will vote to construct a sidewalk on the southerly side of Westland Avenue; on easterly side of Imperial Street, from present terminal to Hoffman Street; easterly side of Union Avenue, from present terminal to Tabernacle, so called; westerly side of Temple Avenue; on West Grand Avenue, from Casco Avenue to Tioga Avenue; eastly side of Kinney Avenue; southwest side of Flint Street, from present terminal to East Grand Avenue; Ancona Avenue, westerly side; eastly side of Winona Avenue, from Seaside to Surf Street; easterly side of Barton Street; repair walk on north side of Milliken Street; rebuild section of walk on West Grand Avenue, near Daniel Guiney property; repair walk on Courtland Avenue; replace brick walk at or near Ocean House property with cement; build gravel walk on Church Street, from 15th Street to 16th Street; build cement walk on southeast side of Washington Avenue, from Carlton Avenue to present terminal.

27th. To see if the town will vote to refund to the estate of Eva B. Lovell, the sum of \$69.59 for taxes paid in error from 1926 to 1934.

28th. To see if the town will vote to refund to B. W. Clark the sum of \$39.02 for taxes paid in error from 1925 to 1934.

29th. To see if the town will vote to install a Game-well Police Signaling System and if they so vote, how many Alarm Boxes they will provide for, and what sum of money they will raise therefor, or in what way said money will be provided.

30th. To see if the town will vote to authorize the selectmen to appoint a budget committee to serve for the budget of 1937.

31st. To see if the town will vote to accept Leavitt Avenue; South Avenue, and the Extension of 6th Street. as laid out by the Selectmen.

32nd. To see what action the town will vote to take in regard to the purchase of a truck or plow, or both, to be used for snow removal and other purposes, and what sum of money they will raise therefor, if any.

33rd. To transact any other business that may legally come before said meeting.

The polls will be open at 9 o'clock A. M. and will remain open until 1 o'clock P. M.

The selectmen will be in session at the Town Hall Thursday, Friday and Saturday afternoons, from 2 to 5 o'clock P. M., February 27, 28 and 29 for the purpose of correcting the voting list.

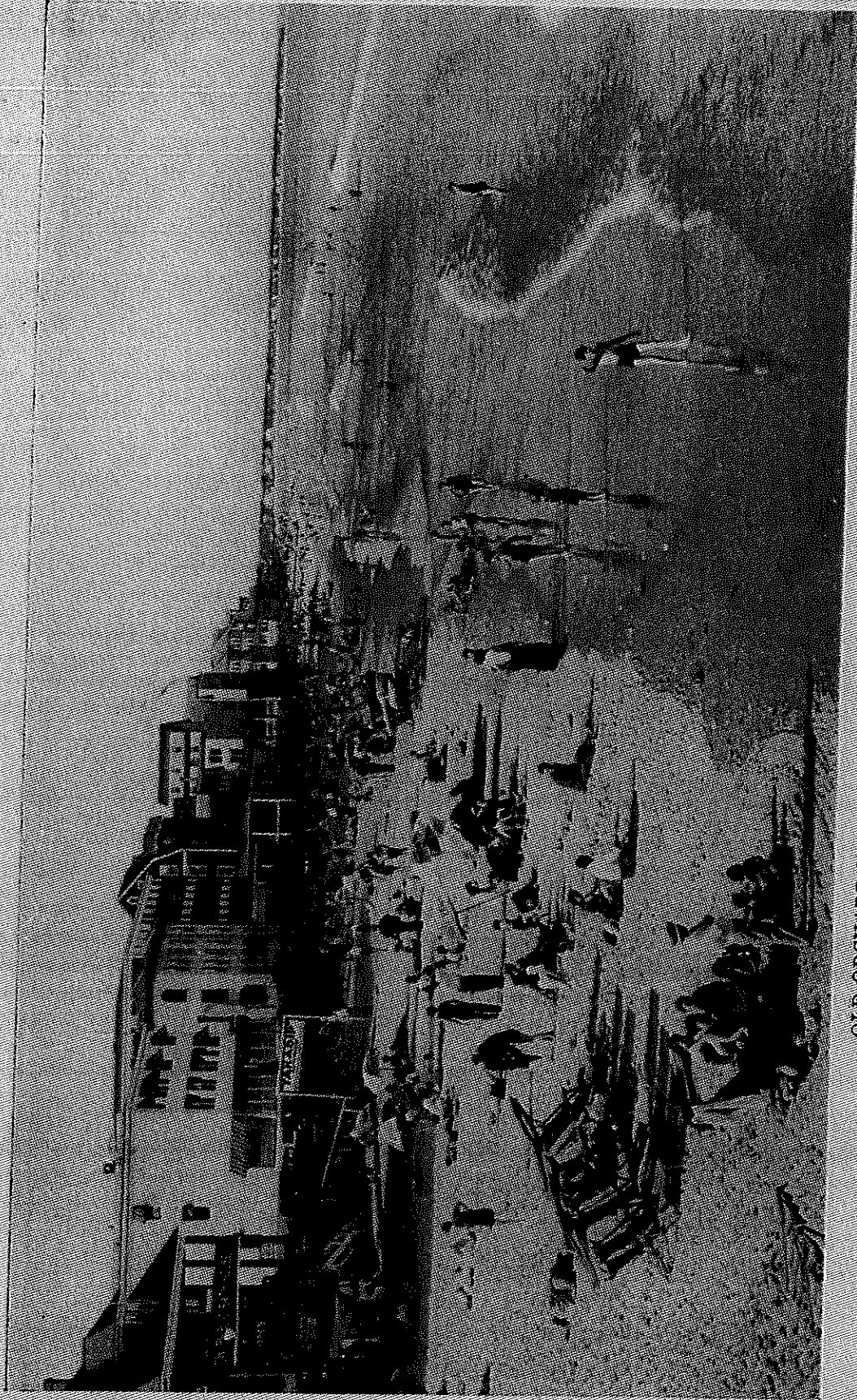
