





All notes raised in anticipation of taxes were paid from two weeks to two months previous to due date. These notes were obtained at the lowest rate of interest in many years, saving the town a considerable sum of money.

The Third Class Road shows a substantial overdraft, but there is due us a credit of \$1,048.00 from the State for this account.

Our population in 1940 was 2,257 and in six years has more than doubled in number. Consequently our present sewer system needs to be expanded and will call for the spending of a considerable amount of money. A Committee was appointed last year to study the situation and make recommendations. These recommendations were carried out this year as far as labor and material allowed. The engineers, employed by the town, have laid out plans for the coming year with the approval of the State Sanitary Water Board that will be a great step in revising our sewer system. With the cooperation of all citizens we feel sure this very necessary step can be carried through to completion.





Clinics for Tuberculosis Control

Two sessions of the Diagnostic and X-ray Clinic were held in Biddeford. One in March and one in September. These clinics are offered to the Community for the purpose of giving examination and X-ray to all persons referred by the Physicians, at a minimum or no cost, in the effort to control Tuberculosis, by means of early diagnosis.

- 80 Persons other than school children were given Tuberculin Tests.
- 26 Were positive reactors.
- 180 Persons including school children were X-rayed.

The annual cost analysis was submitted to the affiliating agencies, establishing a new provisional rate of \$1.19, per visit. This complies with the increase of per visit cost on a national average.

There is need of additional filing cabinets and replacement of equipment, for which the unexpended balance may have been used, but due to excessive increase in prices, it was deemed advisable to omit these purchases temporarily.

I wish to extend to the Physicians, School Nurse, Health Officer and co-operating agencies, my sincere appreciation for their interest and co-operation in making this program possible.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

To the Superintending School Committee and other Citizens of the Town of Old Orchard Beach:

I take pleasure in presenting to you my fourth annual report on the condition of our schools.

For probably the first time, the American nation is fully cognizant of the importance of education in a free society. We have always been aware of the necessity for good schools but have been unwilling to see to it that there should be appropriated sufficient funds so that the ones most vitally concerned with the process of education should be paid enough to compensate them for the years spent in preparation for their life work and to insure them a competance for their old age. It is unnecessary for me to call to public attention what may be seen in any magazine and newspaper or heard from any radio commentator as to the necessity of increasing teachers' salaries and having more money for education in general.

Old Orchard Beach has always been very considerate when dealing with schools and I bespeak your continued support. It is the earnest desire of your school officials to see to it that you have the kind of schools you want and we shall do all possible to see that your wishes are met.

TÉACHERS

Our community is very fortunate in having the services of so fine a group of people in charge of its youth. All by excellent training or long experience or both are well prepared to give our boys and girls the best preparation possible to meet the exigencies of this complex civilization of ours—the social, religious, political and economics life in which they soon must play an important part.

Changes in the High School faculty include Miss Marjorie Proctor, a graduate of Aurora College with graduate work at Boston University as head of the English department. Miss Proctor has had nine years previous teaching experience serving the last as principal of Hollis High School.

Mr. Winthrop Smith returned to us after serving, since March 1942, in the armed services where he obtained the rank of Major.

In the Elementary School Mrs. Alice Mason filled the vacancy caused by the resignation of Mrs. Ann Mullen. Mrs. Ethel Lombard, after completing her twenty-five years of faithful service retired at the close of the fall term and this vacancy was filled by one of our former teachers, Mrs. Mildred Hobbs.

In the Federal School, three vacancies occurred during the summer, two of which were filled by local girls Miss Arlene Davis in Grade 7 and Miss Eleanor Renton in Grade 6. Both these young ladies were graduated from Gorham State Teachers College in 1946. In Grade 5, Miss Lillian Savage, also a Gorham graduate was chosen to fill the vacancy caused by the resignation of Miss Alberta Littlejohn who went to the College to serve as a teacher in the training school. Miss Savage has had two years previous teaching experiences.

The remaining changes were in the special field. Mr. George W. Zeller a graduate of Springfield College with his Master's degree from Boston University, was elected to the position of Physical Director. Mr. Zeller served as a Lieutenant during the late war.

Mrs. Ruth Libby Worth was chosen Supervisor of Music. Mrs. Worth has had professional training at the New England Conservatory, Boston University and the American Institute of Normal Methods and fifteen years successful teaching experience in Maine schools.

Early in the fall, the excessive enrollment in grade 1 made it necessary to divide that grade. Mrs. McKenna who had one division of Sub Primary was given one of these divisions and Mrs. Taylor both divisions of Sub Primary with an assistant. Mrs. Patricia N. Hunt a two year student at Gorham State Teachers College was elected to this position and the arrangement is proving very satisfactory.

Of the faculty, Mr. Zeller and Miss Proctor attended the summer session at Boston University and Mrs. Grant the elementary work shop at the University of Maine.

I am very appreciative of the work our teachers are doing and I feel sure the citizens of the town are, too.

CENSUS, ENROLLMENT AND ATTENDANCE

Since the school census this year was based on school enrollment rather than age, we show quite a loss. I repeat again this year the importance of every child of school age being in school somewhere. Children do not have to be enrolled in our public schools to be counted in the census; they may be enrolled in any school anywhere in Maine.

The enrollment for the school year 1946-1947 shows a slight increase over the year 1945-1946.

Attendance continues to be good. Mr. Tice cooperates very well with the teacher and except for chronic offenders no children stay out of school unless for valid reasons. The attendance officer together with the excel-

lent home check up by the school nurse and the alertness of each teacher insure a fine record of school attendance.

SCHOOL LUNCH

A new project for our boys and girls was undertaken last March and continues to be very popular.

There are two programs, the A and the C. The A program is a complete meal which costs the pupil 15 cents a day, to which the National Government contributes nine cents. The C program is a milk program and the Federal contribution here is two cents daily. Wholesome, well balanced meals are provided at a cost much less than what such meals could be provided for at home and will certainly show results over the years as this program has now been made permanent by an Act of Congress.

The ladies who have managed the feeding of our children Mrs. Dawley and Mrs. Hogan with their assistants Mrs. McCurdy and Mrs. Paine have done an excellent job and are worthy of the commendation of all.

The sponsor of this program has been the Parent-Teacher Organization which has served as an advisor and a repository for funds given by various organizations, the Business Men's Club, K. of C., the Star Club, and the ladies of St. Margaret's Sodality.

The Old Orchard Branch of the American Red Cross made available necessary equipment by means of which this project was started. The valuable contributions of money and equipment have insured the success of the project and I am extremely gratefull to all who have made this a worthwhile undertaking.

There has been quite a variety of free food furnished by the government for this program, potatoes, onions and canned fruit and vegetables.

ATHLETIC FIELD

Seldom has any community been so keenly aware of the physical needs of its young people as has this one. I refer to the noteworthy projects of the local Lion's Club and the Fayette Staples Post American Legion. This Athletic Field at the high school has long been a source of concern to school officials because of its not being in proper condition even for practice.

A survey was made and costs determined seemed to be prohibitive when the Lions Club took over and made for the school a field which is first class in every way at a considerable expense to the group. The present goal of this club to secure a fund of \$25,000 for improvement of the field and construction of a grandstand besides other projects is very much worth your appreciation and support.

Next, the local Legion Post started getting the baseball diamond in condition. When this project is completed, these two playing fields will be as good as any in the county. If we could have a cinder track, some tennis courts and other appointments for outdoor games then with our fine gymnasium, which is used by both the High and Federal Schools, our equipment for an outstanding physical program would be complete. I wish to take this opportunity of thanking these two organizaions publicly for these splendid undertakings as I have individual members of the groups.

REPAIRS

Repairs this year have been extensive. During the war years materials were difficult to obtain and labor was at a premium. This year your officials decided something must be done.

At the elementary school, the entire interior was redecorated and the exterior given a coat of staining, the trim receiving two coats. A new section was installed in the boiler of the old high school building. The yard at these two buildings was properly graded and a coat of coal pack applied. Two sides of the old high school building were reshingled. All these besides minor repairs were needed and have wonderfully improved the efficiency and appearance of the plant.

At the high school the boys' locker room was plastered on two sides to overcome the breaking away of the old caused by the steam of the showers and as a result of the large amount of water in this room as a result of the fire in 1943. The installation of forced ventilation in this room should prevent the reoccurance of this condition. The heating system was overhauled and new valves and traps installed to replace the corroded ones.

There were no repairs made on the Federal building. However, there should be improvements made. The roof has been a source of trouble since we moved in and despite protestations to the Federal Works Administrations nothing could be done. When, as, and if this building comes into possession of the town, some extensive repair work will have to be done, particularly on the ceilings and in the basement.

I believe that another year we should plan to redecorate the interior of the old high school building and redo some rooms at the high school so that we shall not be in the position of having to redecorate so many rooms at the high school building at one time again.

With an investment of \$250,000 in school property it is most essential that it be kept in good condition. Our janitors do their best to keep the buildings in first class daily shape but they cannot avoid the damage to the buildings caused by ordinary wear and tear.

FINANCES

Our financial report, as may be seen, shows an over-draft which at first sight seems excessive. The last Legislature as you will recall changed the method of alloting State Aid for Census. Previously the census covered all children between the ages of 5 and 21 on the first day of April. Now this money is allocated on the actual number of children in school on April 1. This lowered our estimated budget expectation from the State by around \$2,000 from the 1945 receipts, and this loss accounts for the greater part of our overdraft. However, on the representation of your Board of Selectmen and School Department to the Federal Works Agency of our need and probable overdraft even with the rather large

orchard Beach is one of thirteen communities throughout the Nation whose application for federal funds under the Lanham Act has been approved by the New York office and sent to Washington. We expect and have every reason to believe that we shall receive sufficient funds to cover our 1946 overdraft.

Costs of materials and text books are constantly rising. For example, arithmetic paper which five years ago was 19 cents a ream is now 42 cents and composition paper which was 38 cents a ream in quantity is now 62 cents a ream. Text books have advanced one third.

Every householder knows of this advance in prices and we are no less able to do business for the same amounts than they. Salaries, of course, are the big item but if we want to keep the kind of teachers we have or indeed any teachers we must pay them. We mention these facts to let the people know that more money must be provided for the support of education. As a property owner, I realize the difficulty with which tax assessments are met. It is a question of putting first things first however, and what in life comes ahead of our boys and girls? They are the future of America.

SCHOOL SAVINGS

After an enviable record of selling War Stamps and Bonds during the war years, it was agreed that our efforts this year should be expended on a bank savings program which had gone on for a number of years with the Saco and Biddeford Institution. A large number of children in the school are systematically saving money. In some rooms there is a 100% participation each week which makes a splendid record, and worthy of encouragement by all parents.

SCHOOL NURSE

I am glad to present Miss Hoctor's report in full. This service is a very important adjunct of our school program with our large increase in school population. It is understood that the local Lions Club is intending to sponsor a renewal of the dental clinic which is a very excellent community project. We have fine equipment lying idle and could be used very effectly in our health program.

Report of School Nurse Year 1946

Classes in Home Nursing were carried on with Home Economics teacher, Miss Ham, from November 1945 to February 1946. Personal hygiene conferences with Home and Baby Care classes were a part of this teaching program with the High School and Seventh and Eighth Grade girls and were carried on through the school year.

Clinics were held for protection against diptheria and smallpox during the Spring and Fall months. Total number immunized for 1946: 198.

Sight tests using the Snellen Charts were done by the teachers in the grade schools during September and October and the nurse retested all failures found by the teachers. Second test failure pupils were advised to have an eye examination done by an eye doctor. In some cases the doctors recommended eye glasses and the others were advised regarding their eyesight habits. Poor posture and lighting plus the many common funny book followers are the chief offenders against good eyesight the eye doctors feel amongst school children.

The nurse did the eye tests in the High School and failure students were advised to get medical attention. This group was very cooperative and the eye conditions found were cared for rapidly.

Routine yearly School Health Checkups and Physical examination of the students were carried out with the School Doctor during October and November. Dr. Skilling spent some twenty hours examining the school children and reported that the health conditions found were in general of a good average. This year the doctor examined all new comers, first, third, sixth and eighth grade children plus the entire High School body. Dr. Skilling felt that with this method we reached the children at various stages of development and were not just checking off sheer numbers. Of course, in the skipped classes children were examined whom the teacher and nurse felt had need of special care. Total number examined: 534.

Dental Certificate and Seven Point Program

We have had the same difficulty during 1946 that we had during the previous years since the war started. The lack of a local or school dentist makes our problem of dental care a severe one. The children whose parents are able to provide dental care for them continue to have the necessary care but the children who do not

have this attention are largely in an acute state of dental need.

The Patch test and X-Ray program against T.B. in our schools (and community) was carried on with gratifying results. Several suspicious cases have shown improvement over last year and we can feel that our total health program contributed largely in helping us fight against T. B. The Patch test is offered to all the students after preliminary publicity planned to arouse their interest and their parents' cooperation in this very important health measure. The rate of T. B. runs the highest in recent years in the young adult group and protecting the children in their growing years should be of value. In December we started a strict Patch testing of all the students from the fourth grade on through High School. This has been asked by the State Health Department and this is a part of a survey of all of York County on the subject of T. B. incidence in our school children.

The Junior Red Cross has continued its excellent work during 1946 by contributing various services. They have filled gift boxes for overseas, assisted with the crippled children's program, the T. B. work, helped with clerical work for the teachers and nurse and worked on several local projects.

This Fall and Winter, we have had more social service calls involving personal home needs since previous to the war. We have many kind friends of our school children to thank for considerable assistance. To parents and friends, individuals and organizations, lay people and professional persons we are happy to say "Thank

you" for any and all help during 1946. Also we are glad to report that the past year was comparatively light in regard to serious communicable diseases amongst the children and we can only hope and work for the same in 1947.

In Home Nursing, First Aid, personal hygiene and class lectures in hygiene and community problems. Personal conferences with upper grade and High School students on various home and health problems varied from three weekly to a daily contact.

We expect to have the use of the audiometer loaned to us again by the Maine Public Health Association during the current school year to test the hearing of the students from the fourth grade on through the High School. We had it last in December 1945 and must wait our turn as the machine is used extensively through York County. The nurse would be very much interested in obtaining the use of a telebinocular machine for a more careful testing in the schools of the students' eyes. This machine would tell us much more than our simple Snellen Chart test provides.

In accordance with Chapter 16, Section 3, Revised Statutes of 1944 and at your request, the records of the Town of Old Orchard Beach have been audited by Auditors M. W. Bragdon, M. G. Allen and C. G. Hawes for the period January 1, 1945 to December 31, 1945 inclusive.

The examination was made in accordance with generally accepted auditing standards applicable in the circumstances and included all procedures which were considered necessary. Insofar as could be ascertained within the scope of the examination, the financial transactions of the town appear to have been satisfactorily handled.

Exhibits and schedules incorporated in this report impartially present the financial position of the town and the result of its operations for the period designated. Comments and other data incorporated in this report may prove of interest to you. All of which is respectfully submitted,

COMMENTS

Re: Audit of the town of Old Orchard Beach January 1, 1945 to December 31, 1945

CASH

As far as could be ascertained, all receipts were recorded and the cash was deposited currently in the bank.

Expenditures were made from properly authorized warrants, supported by invoices and payrolls on file.

The cash balance was reconciled with the bank.

ACCOUNTS RECEIVABLE

An item of \$12,309.14 representing funds due from the United States Government for educational purposes has been set up as a receivable.

Due to the age of various items contained in this account, it would appear that collection of many would be doubtful, therefore, a reserve for loss of approximately 50% has been set up to cover this contingency.

TAXES RECEIVABLE

After adjustment of several errors, the warrant of commitment was found to be in agreement with the amount committed.

The cash collection of the current year's taxes amounted to 93.8%, while collection of prior years' taxes was 44.4%.

All abatements were examined and found to be properly authorized.

TAX LIENS

The tax liens were examined and with the exception of a few appeared to be in proper form. A reserve of 25% was set up to cover the estimated loss in collection.

TAX ACQUIRED PROPERTY

Sales of tax acquired property in the amount of \$240.67 were made during the year under examination with a loss of \$38.15 being sustained by the town.

DUE GOVERNMENTAL AGENCIES

The Treasurer drew receipts for all Withholding Tax and Teachers' Retirement Fund deductions and made payment to the proper authorities at the required time. An unpaid balance, which was in the town's general cash account, appears on Schedule A-6.

NOTES PAYABLE

During the year \$5,000 was paid on notes payable and new notes were added in the amount of \$12,200. The new notes were issued for:

Sewers and Bridges Sanitary Department	\$2,500.00 5,700.00
Special Truck Account	4,000.00 \$12,200.00

These have been added to the Net Deficit.

BONDS PAYABLE

The sum of \$18,000 was appropriated and paid on the outstanding bonds, reducing the amount outstanding to \$139,000.

DEFERRED REVENUE

The 1946 excise tax collections were carried forward, the disposition of which is deferred until the 1946 town meeting.

A balance of \$2,673.21 remains of the amount realized from the insurance on the Milliken Property.

NET DEFICIT

The Net Deficit was increased by \$6,747.31 during the year under examination. The major contributing factors to this increase were the writing off of the municipal parking lot carried at \$27,200, to conform with generally accepted municipal accounting practices, and the issuance of \$12,200 of new Notes Payable.

Partially offsetting these increases in Net Deficit were the payments of \$18,000 on the Bonds Payable and the setting up of a federal grant amounting to \$9,328.19. A detailed analysis of the charge in Net Deficit may be found on Exhibit E of this report.

GENERAL

A test check of paid invoices and payrolls indicated they were proper charges and correctly recorded.

All balances as required by law were carried forward.

Greeting:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of said Town of Old Orchard Beach qualified to vote in town affairs, to assemble at the Town Hall on Monday, the 3rd day of March, A.D. 1947, at 9 o'clock in the forenoon, then and there to act upon the following articles, to wit:

- Art. 7. To see what sum, if any, the town will vote to raise and appropriate for support of poor.
- Art. 8. To see what sum, if any, the town will vote to raise and appropriate for the pay of Town Officers.
- Art. 9. To see what sum, if any, the town will vote to raise and appropriate for maintaining street lights.

- Art. 11. To see what sum, if any, the town will vote to raise and appropriate for sanitary expenses.
- Art. 12. To see what sum, if any, the town will vote to raise and appropriate for town interests on bonds.
- Art. 13. To see what sum, if any, the town will vote to raise and appropriate for operation and repair of Public Library.
- Art. 14. To see what sum, if any, the town will vote to raise and appropriate for heating, lighting and care of town hall.
- Art. 15. To see what sum, if any, the town will vote to raise and appropriate for moth nests.
- Art. 16. To see what sum, if any, the town will vote to raise and appropriate for State Aid road patrol.
- Art. 17. To see what sum, if any, the town will vote to raise and appropriate for comfort station.

- Art. 29. To see what sum, if any, the town will vote to raise and appropriate for maintaining a police force.
- Art. 30. To see what sum, if any, the town will vote to raise and appropriate to construct and maintain sidewalks.
- Art. 31. To see what sum, if any, the town will vote to raise and appropriate to construct and maintain sewers and drains.
- Art. 32. To see what sum, if any, the town will vote to raise and appropriate to maintain a fire department.

- Art. 36. To see what sum, if any, the town will vote to raise and appropriate for special officers as life guards from July 1 to Labor Day.
- Art. 37. To see what sum, if any, the town will vote to raise and appropriate for advertising the natural resources, advantages, and attractions of the State of Maine, and of the Town, and what part of said amount it will vote to give to the State of Maine Publicity Bureau.
- Art. 38. To see what sum, if any, the town will vote to raise and appropriate for the care and improvement of Old Orchard House Field.
- Art. 39. To see what sum, if any, the town will vote to raise and appropriate for mosquito extermination.
- Art. 40. To see if the town will vote to authorize the Selectmen to appoint a budget committee to serve for the budget of 1948.
- Art. 41. To see if the town will vote to instruct the Road Commissioner to clear all highways of ragweed as recommended by the State Director of Health; in the interest of those who are subject to hay fever.

- Art. 65. To see if the town will vote to add Winona Avenue between West Grand Avenue and Ninth Street, and Colby Avenue between West Grand Avenue and Ninth Street to the list of streets to which tarvia is to be applied.
- Art. 66. To see if the town will vote that all petitions to be entered in the Annual Town Warrant shall be in the hands of Selectmen by February 1.
- Art. 67. To see if the town will vote to enter into a contract with Central Maine Power Company for a term of ten years, whereby, in consideration of the furnishing of street lighting service to the town during the term of said contract, all as more fully set forth in the contract, copy of which has been presented to this meeting, the town will pay for such street lighting service in accordance with the Company's municipal street lighting rate—contract basis.
- Art. 68. To see what action the town will take with reference to authorizing the Selectmen to execute and deliver the contract referred to in the preceding Article.
- Art. 69. To see what sum, if any, the town will vote to raise and appropriate to install a hydrant on Walnut Street between East Grand Avenue and Portland Avenue.

- Art. 70. To see what sum, if any, the town will vote to raise and appropriate to grade and gravel Wesley Boulevard from the junction of Carll Avenue and Wesley Boulevard to lot No. 8 on Wesley Boulevard.
- Art. 71. To see if the town will vote to authorize the selectmen and treasurer to issue serial bonds or notes to the amount of \$60,000.00 for the laying of 2,500 feet of 20-inch sewer pipe for the outfall at Mullen Avenue.
- Art. 72. To see what sum, if any, the town will vote to raise and appropriate to expend on Temple Avenue from Saco Road to Grand Avenue in order to have the State take over the maintenance of said road in the future.
- Art. 73. To see if the town will vote to change the form of management of the free public library by reverting to the former plan of electing its trustees by the town at the Annual Town Meeting.
- Art. 74. To see what sum, if any, the town will vote to raise and appropriate to repair Ninth St. bridge at Ocean Park.
