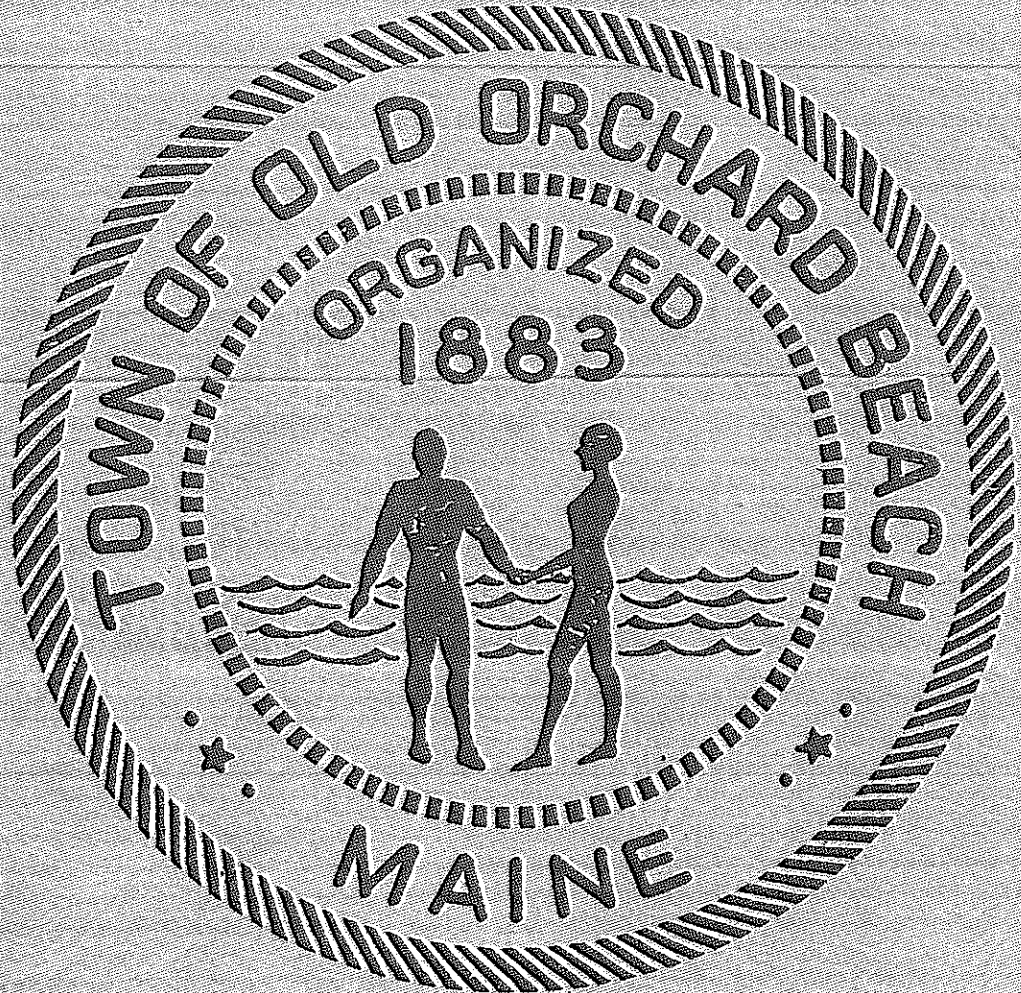

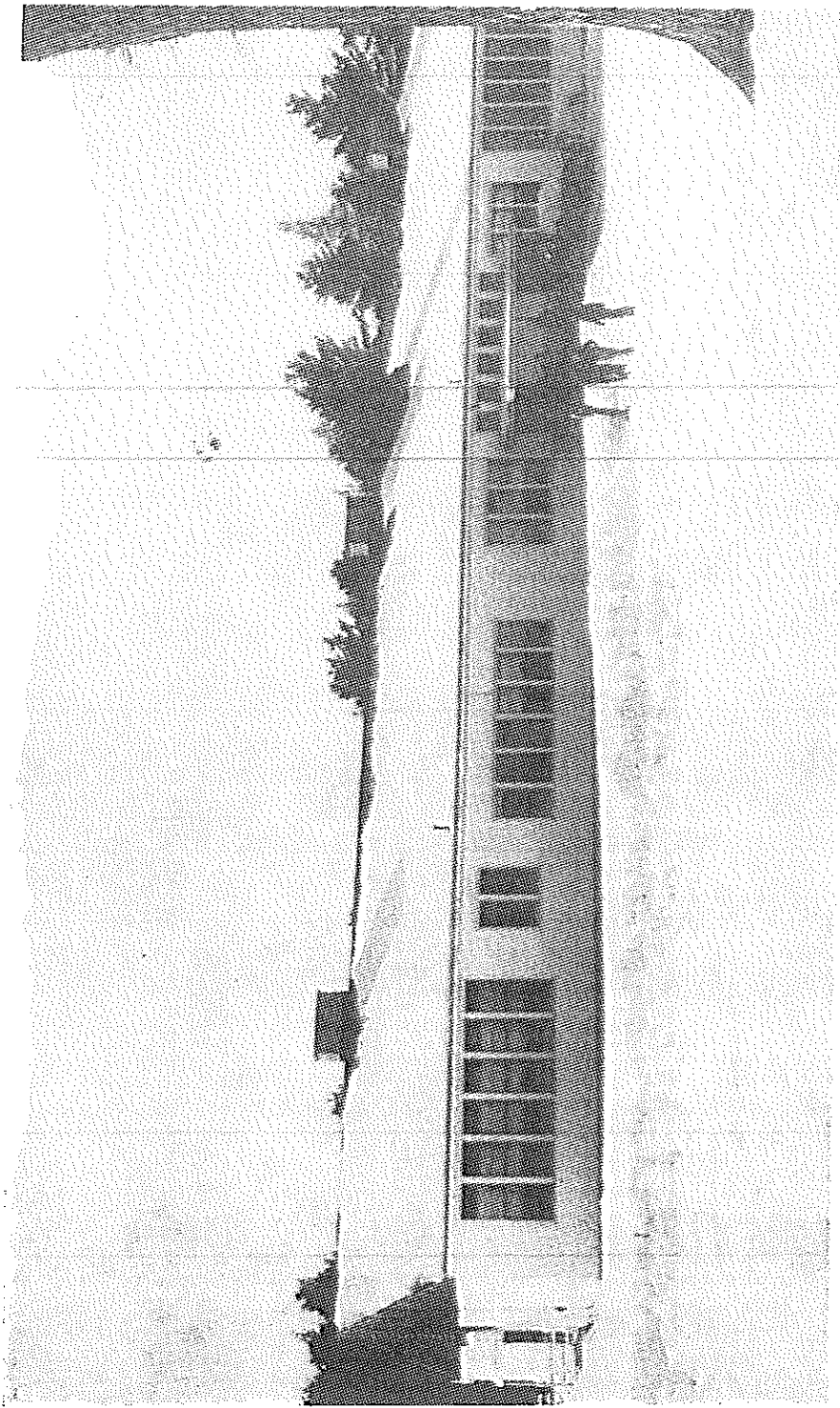

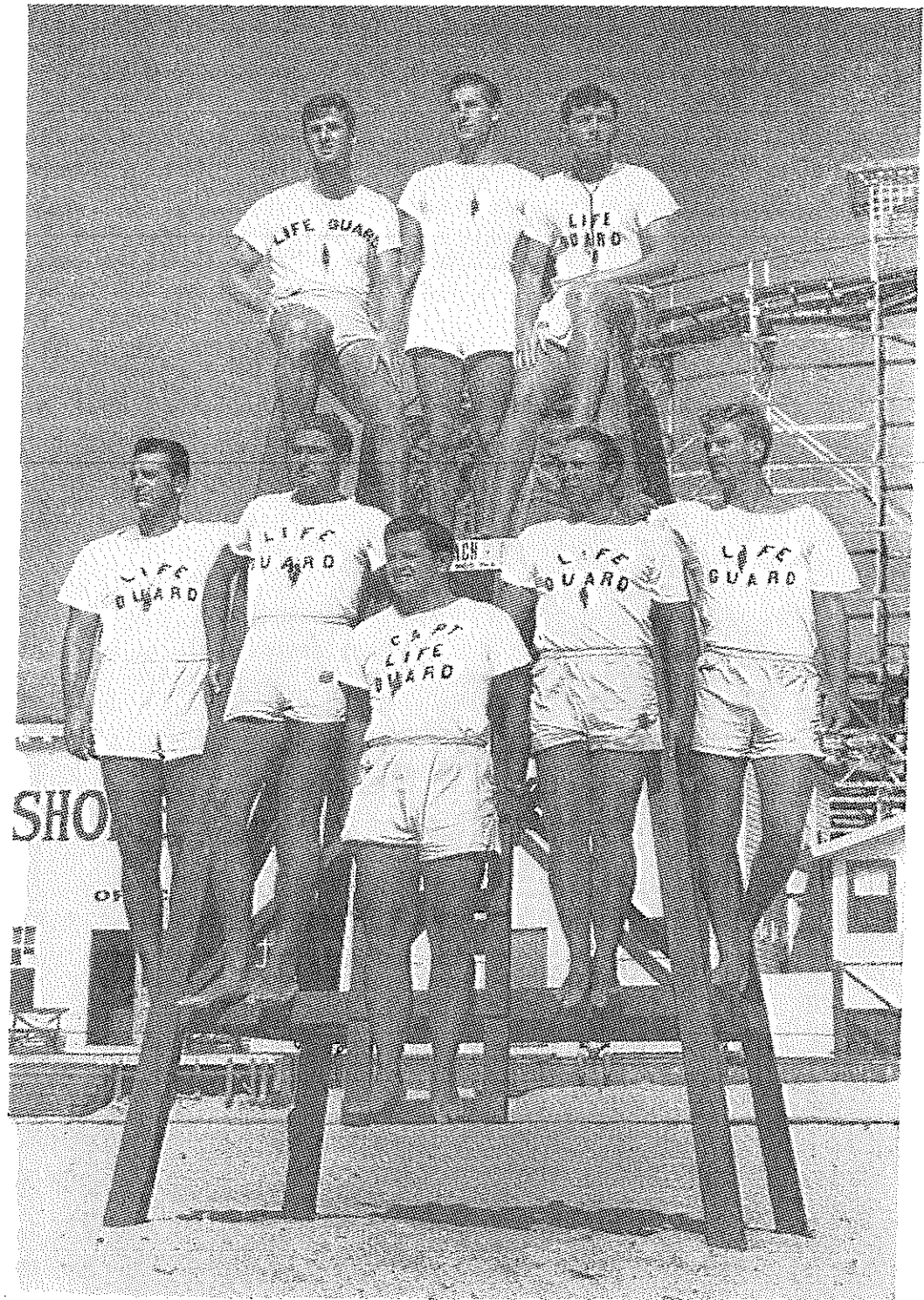

REPORTS

Report of the Board of Selectmen

In spite of the drain on our Town's resources caused by the devastating fires adjacent to this area in the fall of last year, we are pleased to report that the cash balance of \$20,451.16 on hand at the end of the year, is the largest in the history of our Town.

We are including in this issue of the Town Report a letter from Barker & Wheeler, engineers, outlining five steps that are necessary for a more complete sewer plan. We trust that a thoughtful and careful study will be made of this report. We have accomplished a lot in 1946 and 1947 in bringing our sewer system up-to-date, and we hope our townspeople will see the need of carrying this plan forward through 1948.

The State Highway Commission has completed plans for straightening the Cascade Road, eliminating the dangerous curve at the underpass, and work has already been started. We feel this is a major accomplishment in correcting a most dangerous stretch of road. West Grand Avenue has been made a permanent road, and Milliken Street has been rebuilt. Both of these compare favorably with those of larger communities.

The bridge at Goose Fare Brook is under construction. The State Highway Commission accepted the requests of the Selectmen to have this new bridge made wider than the former one and to straighten out the road at the approach to the bridge. The Town's share of the cost of rebuilding this bridge has already been paid to the State.

In regard to the Federal School, it was made clear to us by the Government that we had to either purchase this building or give up occupancy. We had no choice but to negotiate for the School, and the figure arrived at, \$12,500, is the lowest possible, in our estimation.

All departments of the Town have cooperated one hundred

percent with the Board of Selectmen in endeavoring to give our Townspeople the best of service and maintenance, such cooperation resulting in a smooth-running and efficient administration.

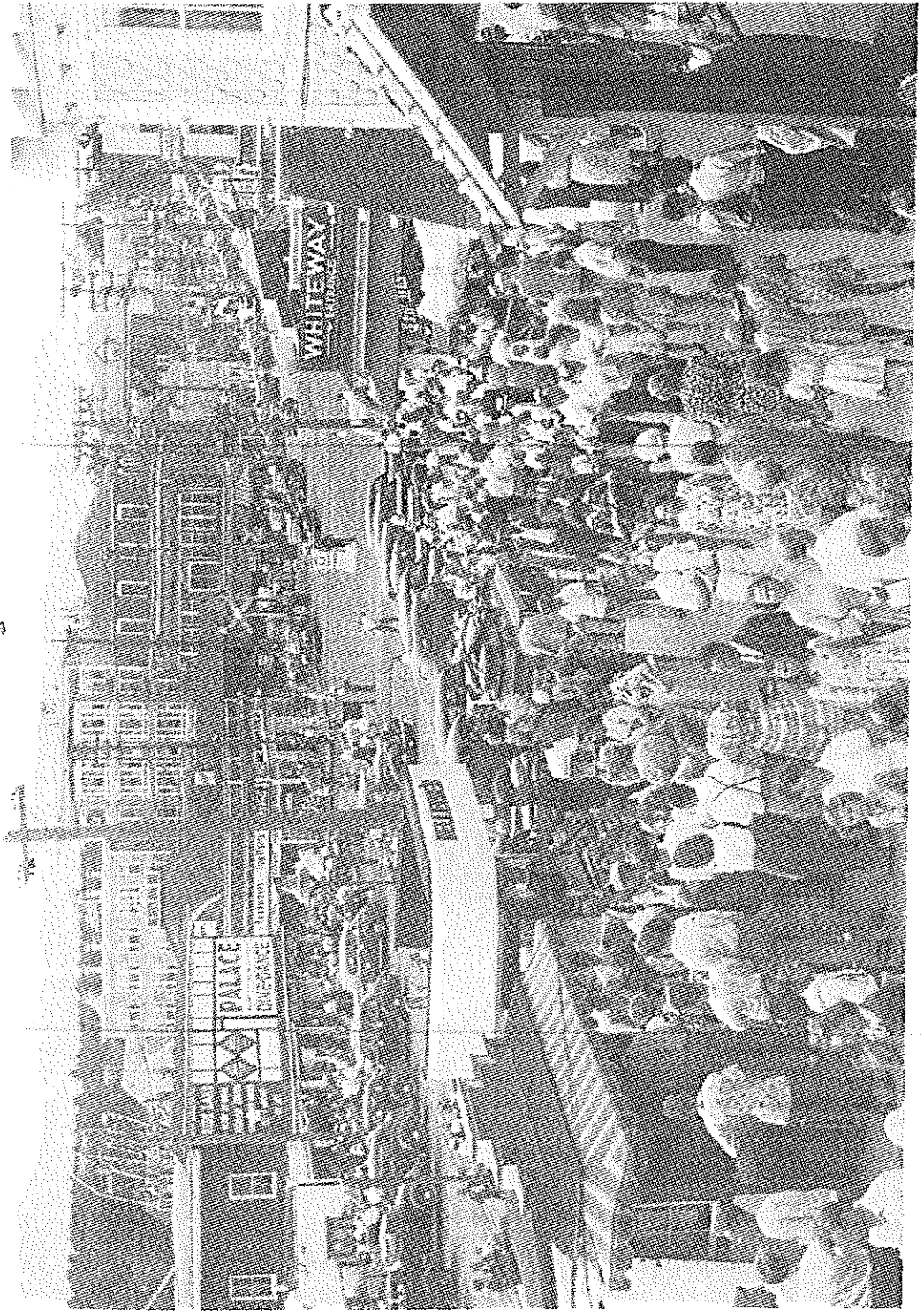

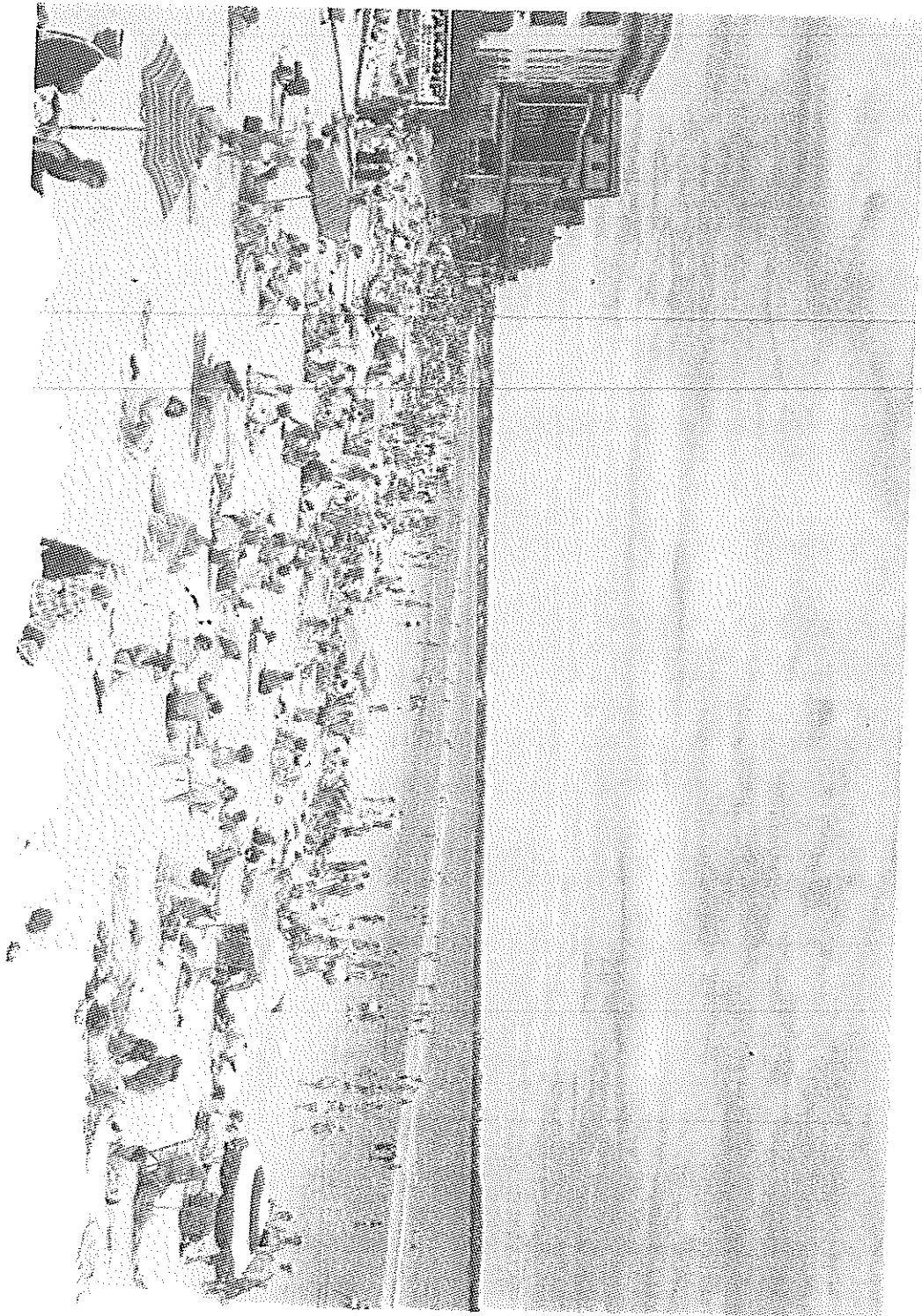

Clinics for the control of Tuberculosis.

Two sessions of the Diagnostic and X-ray clinic were held in Biddeford, March 6th and September 4th. These clinics offer at a minimum or no charge Physical examinations and Chest X-ray to any person in the Community who is referred by a physician. The control of Tuberculosis is in Early Diagnosis and regular physical examination and X-ray.

68 persons other than school children were given Tuberculin tests.

23 were positive re-actors to the test.

142 persons including school children were X-rayed. (Exclusive of teachers who were in separate classification.)

The annual cost analysis was made and submitted to affiliating agencies, it was accepted as submitted.

The rapid expansion in the Halfway area should be given due consideration for the establishing of Child Health Conferences at regular intervals in that area. A small amount of portable equipment may be necessary and a suitable location for holding the conferences.

I wish to extend to the Selectmen, Budget Committee, Physicians, Health Officer and School Nurse, my sincere appreciation for their support and co-operation in making this program possible.

REPORT OF THE SUPERINTENDENT OF SCHOOLS OF OLD ORCHARD BEACH

To the Superintending School Committee and other Citizens of Old Orchard Beach:

I am happy to present to you the verbal and financial reports on the conditions of school affairs.

It is very difficult to evaluate school progress properly since there are so many hidden items which are apparent only after rather long periods of time. Then, too, there are many factors in guiding school policy in which human nature plays an important part that can never be adequately measured.

Our schools have a very good reputation in educational circles thruout the State due to the fine teaching staff we have been able to attract and hold and to no less a degree the splendid financial support given by the citizens of the town.

I am appreciative of these factors and only hope that these same conditions will prevail thru the years.

The general teacher situation is alarming. Altogether too few young people are training for this profession due to a number of reasons. The opportunities for earning substantial salaries are limited and the many restrictions placed upon teachers as a group—some demanded by the communities and others self-imposed are two of the most important. But there are so many things which may be said in favor of our profession—opportunities for service, security and permanence of position, retirement benefits among others—that I wish more parents would consider urging their children to consider this great work and that a larger number of high school students would seek more information regarding this worthwhile profession.

TEACHERS

New teachers in our school are as follows:

High School. Mr. Paul M. Kittridge, a graduate of Colby College with additional work at the Sorbonne in Paris, heads the English department. Mr. Kittridge is a former Naval officer with two years civilian teaching experience.

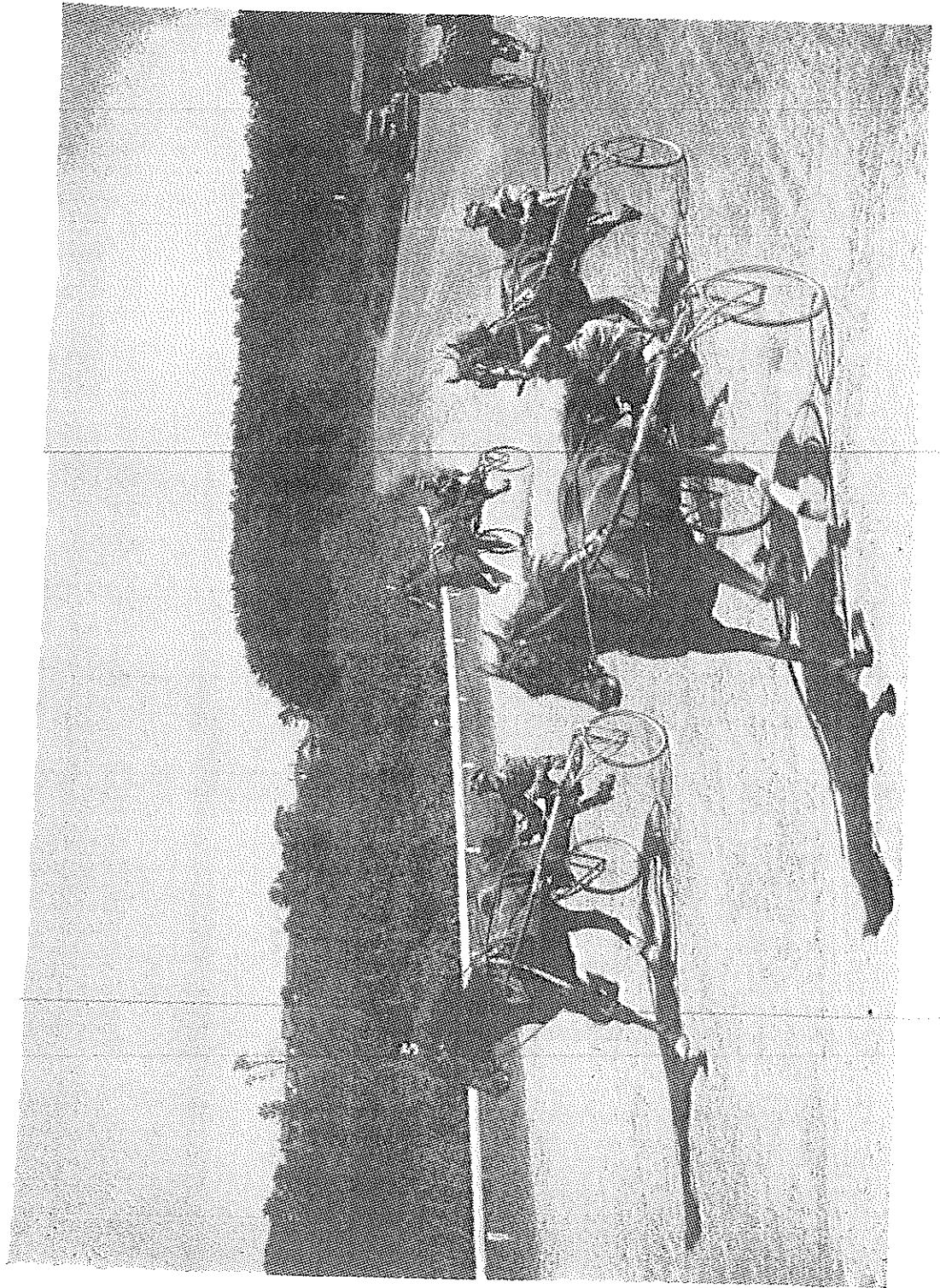
Federal School. Miss Catherine O'Connor, former principal of the Birch Street School in Biddeford with several years' teaching experience in the fifth grade. She is a graduate of Gorham State Teachers' College. Miss Penelope Margone, a recent graduate of Gorham State Teachers' College is teacher of the fourth grade.

Elementary School. Mrs. Mary Fallon, one of our former teachers, is now teaching one class of sub-primary children. Mrs. Fallon is a graduate of Worcester State Teachers' College which qualifies her for both elementary and secondary school teaching.

Mrs. Lillian Keene also one of our former teachers is in charge of a group of third and fourth grade children. Miss Lois A. Cameron is teaching one division of second grade children. She is a graduate of Gorham State Teachers' College.

All our teachers are doing commendable work. That they are interested in educational improvement on the teaching level is best shown by attendance at extension courses and summer schools. Last spring at an extension course sponsored by Boston University & Harvard, several of our teachers participated and this fall almost half of the ninety-seven teachers enrolled in a course offered by the University of Maine are teachers from Old Orchard Beach and Saco. Mr. Smith from the High School and Miss McCarthy from the Elementary School attended summer school. Mr. Smith completed his work for his Master's degree which he has received and Miss McCarthy did work toward her Master's degree both during the summer and by attending extension courses during the past school year.

New State legislation requires the acquiring of six hours professional credit in five years for renewal of teaching certificates and the State will refund \$50 to each teacher earning those six credits thru the local treasury. This should be an incentive to teachers to earn credits and advance professionally.



SCHOOL LUNCH

The school lunch program has been continued during the year on a firm financial basis. The food is well prepared and served. Over 100 are being fed daily. Mrs. Hogan, assisted by Mrs. Skidds is in charge of the program under the direction of Mrs. Crowley.

New equipment was received during the year and paid for from government funds including a ten burner, two oven gas range and a food carrier. Besides these items, food was made available consisting of potatoes, concentrated tomatoes, dried eggs and canned fruit, juices and vegetables.

The total number of A-type meals served during the year was 16,021. The C-type or the ½ pint of milk daily program totaled 10,360 half pints. The cost of the A-type program to each child was 75 cents weekly and for the milk program nineteen cents. This year due to rising food costs, it was necessary to advance this price to \$1.00 and 20 cents for the respective programs.

The Parent Teacher Organization was very helpful in the program by helping to meet expenses last year. During the present year the Veterans of Foreign Wars has made a contribution for furnishing free milk. This help is appreciated by those in charge of the program.

CENSUS & ENROLLMENT

The school census for April 1947 showed an increase of five over that of 1946 and yet with the opening of school in the fall we find a total school enrollment of 906 as against 832 in 1945. This increase of almost 10% makes our schools almost as large as during the war impact years and brings to the front problems which all too soon must confront our citizens. Buildings, even with the complete utilization of the recently purchased Federal School, will soon be overcrowded as some rooms are already. Mr. Bean's report to us states that an increase in the High School will mean crowded conditions there. The graduation of a senior class of 34 will just be about half room enough

for the prospective incoming freshmen class. The extremely large sub-primary class made two teachers in this grade mandatory and this only by having double sessions.

In general, we have been able to keep the class size in the grades down to the number recommended by national authorities—around 30. I feel that it is an obligation to youth to keep the numbers in each classroom as low as possible so that we may maintain the high school level of instruction now going on in our school and which Old Orchard Beach has always demanded.

Something does disturb me greatly and that is the large number of high school students who pursue the commercial course. There are too many boys and girls preparing for this kind of work for the number of commercial positions now and will be available in the future. This is not true only in Old Orchard Beach but is a universal trend. Far too many youths are registered in this course for a variety of reasons. Parents should examine for themselves what they would want their children to train to become and guide them toward that end. I feel that we as school people have been lax in proper guidance of our youth to the end that they often embark on training careers for which they are neither by nature nor inclination fitted. It would seem desirable and necessary to add another member to the teaching staff of this department at the high school if this number continues to expand. It is too much for Mr. Cunningham to handle this department alone.

A review of the enrollment of the past three years as of the opening of schools in September is enlightening.

Mr. Fred Tice continues to be our most efficient truant officer and for the most part the attendance is good. The average daily attendance not too good, not so much because of absence but because of the fact that there is a great deal of change of residence by some of our pupils.

EDUCATION OF HANDICAPPED CHILDREN

New State Legislation requires that education be offered to any child prevented from attending school because of some handicap. This includes any boy or girl between the ages of 5 and 21. Any excess cost over that required to school any pupil in the regular school program is paid by the State up to \$200.00. Our handicapped children's teacher is Mrs. Dresser from Scarborough who has been especially certified by the State Department of Education for this kind of work. Last year, we had one child on the program, who was homebound. She is able to go on with her regular school work this year, and is one of the leaders in her class. As an extra subsidy for this work, we received \$100.00 from the State. This year we have two children on the program, both of whom are making satisfactory progress which is remarkable due to the extreme physical disability of the pupils.

This is a worthwhile project and deserving of our interest and support.

SPECIAL PROGRAMS

Our special programs—Physical Education, Music, Home Economics, Industrial Arts, and Nursing are being continued very successfully, I think.

The School Boy Patrol is again proving its worth to our children. I urge parents to cooperate with these boys to the end that their children will obey the simple rules established and thus traffic accidents avoided among our school children. The police department cooperates splendidly with this program.

REPAIRS

Altho little was planned in the way of repairs for the year, it was thought advisable to do some work and necessary to do other.

At the old High School building two rooms were completely redecorated, a linoleum tiled floor laid in one room and oil heat re-installed. Fluorescent lights were installed in the new room opened for the sub-primary, which were very necessary and according to Miss Harriman's report are very much appreciated. It is our hope that more of this lighting may be installed during the coming year.

The rooms on the first floor of the High School and all halls and corridors were redecorated. Weather stripping was installed in the windows in the Home Economics department and changes made on the heating plant to meet requirements of the boiler inspection. The lawn mower used here and at the Federal School wore out so a new one was purchased at a good bargain.

Little work was done at the Federal School since the property was not ours. Now that apparently this building is the property of our town, extensive repairs must be made. The plumbing system will have to be completely overhauled since most of the fixtures are made of war substitute materials. Extensive repairs are necessary to the roof to prevent leakage, all ceilings must be repaired, a beginning should be made on redecorating the rooms, some work must be done in the furnace room and several minor repairs made.

The yards at the Elementary, yards and driveways at the Federal and High Schools were given a coat of tar during the summer vacation.

We should plan to do some more interior decoration at the High School this coming year, complete the work started last year in the old High School building and do an appreciable amount of work at the Federal Building during the coming summer. We shall soon have to renew the roofing on the Elementary building.

Nothing unreasonable or unjustifiable has been done that has not been to insure the comfort and well-being of our children, not only during the past but in all previous years.

FINANCES

As may be seen, we have a net balance in our school budget of \$243.11. Items which show an overdraft are in common schools \$130.76, which may be explained by the fact that the large number of children in the lower grades made the contracting for the services of an extra teacher shortly after the opening of schools. The second overdraft is on Insurance, which is caused by an underestimated budget request for that item.

Our request for Lanham Funds for 1946 was finally disapproved after I had been assured by telephone from the office of the War Assets Administration in New York that the request was approved. The reason given was that since our overdraft was less than 10% of the total school appropriation, we could not share in the Fund. In other words, had we had an overdraft of \$6,000 instead of \$3,000 we would have profited. It is difficult to understand such philosophy.

The State School Fund increased from \$10,195.10 in 1946 to \$14,073.71 besides the same allocations of \$500 for both Industrial Arts and Home Economics and \$600.00 for Physical Education. As in previous years this increase was brought about by the increasing State subsidy for teaching positions from \$300 to \$400 by the Legislature and altho not as much as we expected does help out in the school budget picture.

SCHOOL SAVINGS

The schools are continuing the school savings program with the Saco and Biddeford Savings Institution. I find by inquiring

from bank officers that not only do our children have a good weekly saving plan during their school days but that they continue saving after leaving school. Many of the bank's depositors are these same youth who began saving during their school career and who are still continuing this admirable practice.

ORGANIZATIONS

All buildings participate in the annual Junior Red Cross program, in the January campaign of the Foundation for Infantile Paralysis and the April sale of stamps for the Maine Society for Crippled children. These are worthwhile projects and offer opportunities for children to work and plan for others less fortunate than themselves.

IN CONCLUSION

I am appreciative of the high quality of cooperation given to me during the year by the people of the town. The teachers and children have been thoughtful and courteous to me and, above all, hard working and interested in the advancement of our educational program. My contacts with all public officials have been pleasant. I am especially grateful to the Superintending School Committee who have been loyal to me, and painstaking in overseeing all problems which have arisen relating to school affairs.

COMMENTS

Re: Audit of Accounts—Town of Old Orchard Beach
January 1, 1947 to December 31, 1947

An examination has been completed of the books and records of the Town of Old Orchard Beach for the year ended December 31, 1947. This examination included such tests and procedures consistent with generally accepted auditing standards as were considered necessary. Included in and made a part of this report are a Balance Sheet with supporting Schedules and a Statement of Operations. It is believed that these statements fairly present the financial position of the Town at December 31, 1947, and the result of its operations for the year then ended.

CASH

An analysis of cash receipts and deposits indicated that all cash recorded as received had been promptly deposited in the bank. The cash balance of \$20,451.15 as reflected by the records of the Treasurer was reconciled with the bank statement of the York National Bank. The cash was brought up to January 15, 1948, the date of the audit. It was ascertained that all warrants had been paid in full. It was noted, however, that several payments had been made by cash instead of by check.

ACCOUNTS RECEIVABLE

The accounts receivable totaled \$2,497.84. As it is doubtful if these accounts will be collected in full, a reserve for possible losses has been established. During the year, accounts receivable totaling \$1,114.76 were written off as uncollectible. The detail of the accounts receivable may be found on Schedule A-1.

TAXES RECEIVABLE

The valuation book was added and compared with the commitment book to verify the warrant of commitment. In connection with the examination of the valuation book, it was noted

that again this year many changes had been made in this book after the commitment had been submitted to the Collector. After the commitment has been submitted, all adjustments should be made by supplemental taxes or by abatements.

The total assessment charged to the Collector was accounted for as follows:

Prior years' taxes receivable were checked and all cash receipts were traced to deposit with the Treasurer. Authorization was given to write off as uncollectible old prior years' taxes receivable totaling \$9,857.10.

The detail of the taxes receivable appearing on Schedules A-10, 11, 12 and 13 was compiled from the records of the Collector and was in agreement with the control accounts.

It was determined that all abatements had been signed by a majority of the Board of Assessors.

It was also ascertained that all uncollected 1946 taxes assessed against real estate had been secured by tax liens.

TAX LIENS AND DEEDS

The tax liens and deeds at December 31, 1947 amounted to \$6,826.65. All payments received were checked to the individual accounts and were traced to the records of the Treasurer. A reserve for possible losses in collection of \$1,707.14 has been established. The liens and deeds on file, which substantiated the balance in this account, were examined.

TAX ACQUIRED PROPERTY

During the year under review, \$156.74 was received for sale of tax acquired property. This left a balance at the close of the year of \$1,090.41, the detail of which appears on Schedule A-15.

ACCOUNTS PAYABLE

There were accounts payable of \$3,839.35 at December 31, 1947, the principal item of which was \$3,174.62 for withholding taxes applicable to the last quarter of the year. Complete detail of the accounts payable may be found on Schedule A-5.

NOTES PAYABLE

During the year, the following new notes were issued:

These are 1½% notes and were issued on September 1, 1947 and October 15, 1947, respectively. The Highway Truck notes mature at the rate of \$2,000.00 per year and the Goose Fare Bridge notes mature at the rate of \$2,000.00 per year for three years and \$2,850.00 for the fourth year. There also was a 1¾%, \$2,500.00 note held by the Free Public Library Fund at December 31, 1947.

BONDS PAYABLE

A new bond issue totaling \$50,000.00 was floated during the year, the proceeds of which are to be used on the Mullen Avenue sewer. These are 2% bonds and mature \$3,000.00 annually from 1948-1957 and \$4,000.00 annually from 1958-1962. The total of the bonds outstanding at the year end was \$171,000.00. Complete detail of the bonds payable may be found on Schedule A-7.

The Appropriated Surplus represents the net unexpended

balances of certain appropriation accounts which have been carried forward to the ensuing year.

The Net Deficit represents the excess of the liabilities over the assets. This account was increased by \$33,999.93 during the year under review. A complete detail of the factors contributing to this increase is presented on Exhibit E.

PUBLIC LIBRARY FUND

The cash balance of \$395.18 of the Public Library Fund was reconciled with the bank statement of the York National Bank. The time deposits totaling \$2,496.33 were verified by examination of the bank passbooks. The securities were verified by physical inspection. A statement of cash receipts and disbursements is presented on Schedule A-8.

GENERAL

The excise tax collections were verified by examination of the prenumbered copies of the receipts retained by the Collector. Cash receipts were traced to deposit with the Treasurer.

The following corporate surety bonds were found on file:
Treasurer, \$15,000.00—Hartford Accident & Indemnity Co.
Collector, \$10,000.00—Hartford Accident & Indemnity Co.

During the year, tax anticipation loans of \$100,000.00 were issued and paid.

Attention is invited to the overdrafts reflected in several appropriation accounts, the summary of which appears on Exhibit D. An opinion rendered by the Attorney General reads, in part,

"The municipal officers are bound by the terms of the articles in the warrant calling the meeting providing for the expenditure of money. The officers should not spend more than the taxpayers appropriated at town meeting, unless the statute expressly authorizes an expenditure in excess of the appropriation."

The provisions of Chapter 84, Section 81 of the Revised Statutes of 1944, however, relate to expenditures of monies for highway purposes and permit overdrafts in cases of emergencies to the extent of 15% of the appropriation.

RECOMMENDATION

It is recommended that more care be exercised by the Assessors when making up the valuation and commitment books for the ensuing year. No changes should be made on the valuation book after the commitment has been submitted to the Collector.

COMMENTS

Re: Audit of Accounts—Town of Old Orchard Beach
January 1, 1946 to December 31, 1946

CASH

Cash on deposit and subject to check as of December 31, 1946 was verified with the bank statement. The amount so reported reconciled with the balance as reflected by the records of the Treasurer.

All receipts were examined and were found to have been deposited in the bank and correctly recorded.

All expenditures were made by check and were supported by warrants which had been signed by the required number of officials.

As there are no banking facilities in the Town of Old Orchard Beach, it is the practice of the Treasurer to issue checks in order to obtain funds with which to cash town checks payable to individuals. It is recommended that this practice be discontinued.

ACCOUNTS RECEIVABLE

The accounts receivable totaled \$2,783.32 at December 31, 1946 and are shown in detail on Schedule A-1 of this report. Due to the age of many of these accounts, a reserve of \$1,145.14 is carried to provide for possible losses in collection.

TAXES RECEIVABLE

In connection with the examination of the valuation records and the tax commitment, it was noted that many changes had been made after the commitment had been submitted to the Collector. After the commitment has been submitted, all adjustments should be made by supplemental taxes or by abatements.

The balance due from the Tax Collector on the 1946 tax commitment is represented by a list of unpaid taxes, the detail of which appears on Schedule A-11 of this report.

Cash receipts and properly authorized abatements on prior

years' unpaid taxes appeared to have been credited against the proper accounts.

TAX LIENS AND DEEDS

The liens and deeds on hand were examined. Payments received were found to have been applied against the proper items.

It was noted in some cases that liens and deeds were not on file with the Treasurer.

DUE GOVERNMENTAL AGENCIES

This account is made up of deductions for Withholding Tax and Teachers' Retirement.

NOTES PAYABLE

During the year, notes in the amount of \$12,200 were paid from general cash.

Authorization was given at a special town meeting held May 27, 1946 for the purchase of a police car. A note in the amount of \$665.00 was issued for this purpose.

BONDS PAYABLE

Bonds outstanding amounting to \$18,000 were paid from the appropriation made at the annual town meeting.

During the year, Sewer Improvement Bonds were issued in the amount of \$20,000, payable in ten years.

NET DEFICIT

At the close of the year, the net deficit amounted to \$116,295.46, as compared to a net deficit of \$118,413.35 at January 1, 1946. This represented a decrease of \$2,117.89 during the year under examination, the detail of which is shown on Exhibit E of this report.

GENERAL

The 1946 excise tax receipts, No. 122 to 1,145, and those for 1947, Nos. 1 to 101 and Nos. 126 to 147, were checked from the copies of the receipts and all monies were found to have been deposited with the Treasurer.

Dear Mr. Gerrish:

We beg to submit the following report to the Selectmen and citizens of the Town of Old Orchard Beach covering the progress made to date toward the improvement of the Town sewerage system, and our recommended program for the year 1948.

Our firm was engaged by the Town of Old Orchard Beach in the Spring of 1946 to make studies and recommendations for the improvement of the Town's sewerage and sewage treatment facilities. Preliminary investigations made during May 1946 disclosed urgent need for repairs to the Old Orchard Street and Mullen Avenue outfalls. Immediate arrangements were made with the Boyce Machine Company of Portland to repair the Old Orchard Street outfall, and this line was restored to full working order early in July, 1946 at a cost of \$22,066.57, a sum considerably less than the cost of replacing the line at present day prices.

Further investigation of the Mullen Avenue outfall revealed that this line required replacement, and the cast iron pipe was ordered immediately after authorization at the Annual Town Meeting. Plans and specifications were prepared for the Mullen Avenue outfall sewer, bids were advertised, and the contract for the construction was awarded to the Rev-Lyn Contracting Company, lowest of seven bidders, August 1, 1947. The new pipe arrived a few days later and construction of the

outfall was begun on August 11th. This project was completed and the new line placed in service on November 21, 1947. The cost of the new Mullen Avenue outfall was \$49,046.68. This line is large enough to serve the Surfside section of Old Orchard, as well as any future growth in this area, and can ultimately serve as the main outfall of any future central sewage treatment plant. Provision was made in the Mullen Avenue outfall sewer to permit connection with the Brown Street outfall sewer in case additional outfall capacity is ever required.

In addition to the two main projects, plans were prepared and construction is practically completed for the utilization of the existing Colby Avenue sump as a sewage pumping station to eliminate pollution of the canal, tributary to the Goosefare, which flows along West Grand Avenue, in Ocean Park. While this project does not represent the ultimate plan for this area, it will eliminate a serious nuisance, which has existed and has been the subject of complaint for several years, at a cost to date of about \$2,369.51. A duplicate pumping unit to insure constant operation in case of the breakdown of the present single pump and motor is to be recommended under next year's program.

The Ocean Pier Corporation also constructed improved sewerage facilities during 1947.

We are gratified to report, and I am sure the Townspeople will be pleased to learn, that the completion of these three projects provides Old Orchard Beach with five outfall sewers in full working order, eliminates the immediate conditions most detrimental to the bathing facilities, and marks the completion of the first phase of the Town's comprehensive program to "Keep Old Orchard Beach the Finest Beach in the World."

We have in the past and still recommend that future plans for the consistent improvement of the Town sewerage system and sewage treatment facilities be made on a unit basis, building such portions of the ultimate plan indicated necessary by careful studies and observations of conditions prevailing along the Beach from year to year. Facilities constructed from time

to time under this program will be designed in such manner as to fit into the ultimate plan if ever the need for central sewage treatment becomes apparent, and will be no more costly than performing all the work at once under prevailing prices. In the event that conditions do not indicate the need for the ultimate plan, a considerable saving would result.

To continue the program for the improvement of the sewerage system and sewage treatment facilities during 1948, we recommend and submit for the consideration of the Selectmen and Citizens the following items, in addition to those generally appropriated for routine maintenance and operation of the sewerage system:

(1) An appropriation to conduct a sanitary survey, and make accurate scientific studies of conditions prevailing along the Beach and in Saco Bay, during the 1948 season. The studies will include daily observations and records of the Beach by a competent person, daily water samples at several locations during the bathing season, observation of currents, temperatures, wind directions, and other necessary data during the 1948 summer season. Such studies are now possible since all the out-fall sewers are in full working order, and they will determine the need for and type of any additional sewage treatment facilities required. This office will review the data collected and submit a report to the Selectmen covering the interpretation of the information secured and recommendations for future improvements. Estimated Cost \$3,500.00

(2) An appropriation for an additional pumping unit and appurtenances to complete the Colby Avenue Pumping Station. For uninterrupted operation of a sewage pumping station, at least two pumping units should be provided in order that one unit may function in the event of clogging or breakdown of the other. At present there is only one pumping unit in this station. Estimated cost \$1,700.00

(3) An appropriation to provide for the purchase of mechanically operated sewer cleaning equipment to permit adequate periodic cleaning of all sewer lines. Use of this equipment will

clear sewers of roots, sand, and other obstructions which cannot be accomplished with the present hand operated equipment. Estimated cost \$925.00

(4) An appropriation for general improvements to the existing sewerage system, including the extension of some storm sewers to at least minimum tide so as not to discolor the Beach surface, installation of manholes with tide valves on Brown Street and Old Orchard Street to control backing up and overflowing in some sewers during high tides, replacement of broken tile pipe in some shallow sewer lines with cast iron or reinforced concrete pipe to improve service, elimination of any sumps requiring repairs, and minor extensions of existing sewers and raising of manhole covers.

Estimated cost \$12,000.00

(5) An appropriation to investigate and prepare plans for placing the idle Surfside sewerage system into working order. This project will involve cleaning existing sewers with mechanical sewer cleaning equipment recommended under Item No. 3, the completion of sewers and sewage pumping facilities started under a W.P.A. project, and relaying a section of inadequate sewer along East Grand Avenue. The Surfside system will discharge into the new Mullen Avenue outfall sewer.

Estimated cost \$4,000.00

To summarize, all five outfall sewers are now restored to full working order and the Colby Avenue pumping station will be ready for operation during 1948.

A future program has been suggested involving careful studies of conditions next season, purchase of needed sewer cleaning equipment repair and additions to present facilities where required for improved service, and the preparation of plans to serve a densely populated area which now has an idle, incompleated sewerage system.

The summary of cost estimates for the 1948 program is as follows:

Item 1: For a sanitary survey of the Beach during
the 1948 season, the sum of \$3,500.00

Item 2: For an additional pumping unit and appurtenances to complete the Colby Avenue pumping station, the sum of	1,700.00
Item 3: For the purchase of mechanically operated sewer cleaning equipment, the sum of	925.00
Item 4: For general improvements to the existing sewerage system, as outlined, the sum of	12,000.00
Item 5: For the investigation and preparation of plans to complete the idle Surfside sewerage system, the sum of	4,000.00

WARRANT

To George J. Mainville, Constable of the Town of Old Orchard Beach, in the County of York: Greeting:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of said Town of Old Orchard Beach, qualified to vote in town affairs, to assemble at the Town Hall on Monday, the 1st day of March, A.D. 1948, at 9 o'clock in the forenoon, then and there to act upon the following articles, to wit:

Art. 6. To see what sum, if any, the town will vote to raise and appropriate for constructing and repairing highways and bridges.

Art. 7. To see what sum, if any, the town will vote to raise and appropriate for support of poor.

Art. 8. To see what sum, if any, the town will vote to raise and appropriate for the pay of Town Officers.

Art. 52. To see if the town will vote that all petitions for articles to be entered in the Annual Town Warrant shall be in the hands of the Selectmen by February 1.

Art. 53. To see if the town will vote to reimburse Robert J. McConnell for money expended on reconstruction of the cement sidewalk on Bay Avenue, in the amount of \$220.00.

Art. 54. To see if the town will vote to authorize the Selectmen to close certain streets during the winter months for the safety of children sliding.

Art. 55. To see what sum, if any, the town will vote to raise and appropriate for comfort station.

Art. 56. To see what sum, if any, the town will vote to raise and appropriate to install street lights on First Street, Heath Street, Oceana Avenue, Pine Avenue, and Colby Avenue at the corner of Ninth Street.

Art. 57. To see if the town will vote to raise and appropriate the sum of \$200 for immunization.

Art. 58. To see what sum, if any, the town will vote to raise and appropriate to locate two hydrants on Smithwheel Road.

Art. 59. To see what sum, if any, the town will vote to raise and appropriate to grade and gravel Winona Avenue from West Grand Avenue to Ninth Street; Colby Avenue from West Grand Avenue to Ninth Street; Winter Street (Old Salt Road so-called); lower part of Hillside Avenue; Benoit Avenue.

Art. 60. To see if the town will vote to have tarvia applied to the balance of Smithwheel Road; lower part of Hillside Avenue; and Benoit Avenue.

Art. 61. To see if the town will vote to raise and appropriate the sum of \$1,619.00 for the purchase of a truck for the use of the Sewer Department.

Art. 62. To see what sum, if any, the town will vote to raise and appropriate to repair or rebuild the sidewalk on Temple Avenue from easterly end of No. 30 to corner of Grand Avenue.

Art. 63. To see what sum, if any, the town will vote to raise and appropriate to widen the sidewalk three feet on the westerly side of Old Orchard Street.

Art. 64. To see if the town will vote to increase the fee for entrance to sewer to \$50.00.

Art. 65. To see if the town will vote to adopt the following ordinance to wit: AN ORDINANCE RELATING TO PARKING REGULATED BY PARKING METERS.

Be it ordained by the Voters of the Town of Old Orchard Beach in Town Meeting Assembled as Follows:

Section 1. Definitions. Whenever in this Ordinance the words hereinafter defined in this section are used, they shall, unless the context requires otherwise, be deemed to have the following meanings:

(a) Parking meters. A device for the purpose of measuring the time elapsed since the deposit of a coin in the slot provided and equipped with a mechanism to indicate the legal time a vehicle may remain parked in a designated space.

(b) Parking Space. A portion of the paved surface of the street of sufficient length and depth from the sidewalk curb to accommodate a vehicle to be parked as shall be designated and marked off by or under the direction of the Board of Selectmen.

Section 2. The Board of Selectmen may enter into a contract or contracts for the installation of parking meters, with the provision that the payment for such meters and installation is to be made from the receipts and funds and revenues obtained from the operation of said parking meters, without in any manner obligating the Town of Old Orchard Beach for the same from any other source whatsoever.

Section 3. The Board of Selectmen shall supervise the installation, regulation, control, operation and use of parking meters on such streets as may hereafter be subject to limited parking and use by vehicles under the provisions and authority of this Ordinance.

The Board of Selectmen, after said parking meters have been installed and in operation, shall be empowered and authorized to make such changes in the zoning and parking time limits, which, in their judgment, shall be deemed prudent, wise and more efficient in the operation of the said parking meters. They shall further be empowered and authorized, from time to time, to designate certain additional areas in the town wherein only limited parking shall be allowed and fix the limit of parking for said areas. It shall be unlawful for any person to park or leave standing, or permit or cause to be parked or left standing any vehicle in any limited parking area beyond the limit so set.

Section 4. The amount of the fee for the use of each parking meter space shall be based upon the length of the legal parking period for said parking space as may be designated by Ordinance, and shall be computed at the rate of five (5) cents for each sixty (60) minutes of use.

Section 5. Each said parking meter shall be so set as to display a signal showing legal parking upon the deposit of the required coin of the United States therein, for the period of time conforming to the parking limit established upon which said parking meter is placed; and each such meter shall by its mechanism indicate the legal time a vehicle may remain parked and shall continue in operation from the time of depositing such coin until the expiration of the time fixed by this Ordinance as the parking limit for the part of the street upon which said meter is placed. Each Parking Meter shall also be arranged that upon the expiration of said parking limit, it will indicate by a mechanical operation and the indicating of a proper signal that the lawful parking period as fixed or authorized under this Ordinance has expired.

Section 6. The Board of Selectmen shall direct the Chief

of Police to maintain lines of marks on the curb or on the street about or along side of each parking meter to designate the space for which said meter is to be used, and each vehicle parking along side of or next to any parking meter shall park within the lines or markings so established.

Section 7. When any vehicle shall be parked in any space along side of or next to which there is located, under this Ordinance, a parking meter, the owner, operator, manager or driver of said vehicle shall upon entering the said parking meter space immediately deposit or cause to be deposited in such parking meter such coin or coins of the United States as are designated for deposit therein on such parking meter in accordance with the terms hereof. Upon the deposit of such coin or coins and placing said meter in operation the parking meter space may be lawfully occupied by such vehicle during the period of parking time prescribed for said parking meter space. If said vehicle shall remain parked in any such parking space beyond the established parking limit as shown by meter indication for such parking space the parking meter shall display a sign or signal showing illegal parking, and in that event, such vehicle shall be considered as parked overtime or beyond the period of time fixed now or hereafter by the provisions of this Ordinance and punished as hereinafter provided. It shall be unlawful for any person to cause, allow, permit or suffer any such vehicle registered in his name to be parked overtime or beyond the lawful period of time as above described.

Section 8. It shall be unlawful and a violation of this Ordinance for any person to deposit or cause to be deposited in a parking meter a coin or coins for the purpose of increasing or extending the parking time of any vehicle beyond the legal parking time established for said parking meter space.

Section 9. Any vehicle, parked in any parking space as herein provided, shall be parked with the hood of such vehicle along side of or next to parking meter along side of such parking space in parallel parking spaces, and with the radiator

directed at said meter in diagonal parking spaces, and in either event shall be parked within the lines marked on the street for such parking space, as provided herein.

Section 10. It shall be unlawful to park any vehicle across any line or mark designating the parking space for which any parking meter is to be used or to park said vehicle in such way that the same shall not be within the area so designated by such lines or markings.

Section 11. It shall be unlawful for any person to deposit or cause to be deposited in any parking meter any slug, device or metallic substitute for a coin of the United States.

Section 12. It shall be unlawful for any person to deface, injure, tamper with, open or wilfully break, destroy or impair the usefulness of any parking meter installed under the provisions of the Ordinance.

Section 13. All parking is prohibitive in any parking space where a parking meter is installed, unless a deposit of the coin or coins indicated by said meter is made as herein provided. Any vehicle parked in violation of this provision shall be deemed to be illegally parked under the provisions of this Ordinance.

Section 14. The provisions of this Ordinance shall apply only during the hours of 9:00 A.M. and 9:00 P.M. daily including Sunday.

Section 15. The Board of Selectmen is hereby authorized to have parking meters installed wherever advisable.

Section 16. The coins required to be deposited in parking meters as provided herein are hereby charged, assessed and levied as fees to provide for the proper regulation and control of traffic upon the public streets and also the cost of supervising and regulating the parking of vehicles in the parking spaces hereby created, and to cover the cost of purchase, installation, operation, maintenance, control, inspection, supervision and use of the parking meters described herein.

Section 17. Each meter shall have an aperture for receiving deposited coins. The Board of Selectmen shall appoint a person

or persons who shall collect the coins deposited in parking meters, and the person or persons collecting such coins shall deliver the same to the Treasurer of the Town of Old Orchard Beach, who shall count the coins so delivered and deposit the same to the credit of the Town of Old Orchard Beach.

Section 18. After the initial installation of parking meters, it shall be the duty of the Chief of Police to enforce the rules and regulations laid down in this Ordinance.

Section 19. Penalties. Any person who shall violate or assist in violating Sections 11 and/or 12 shall upon conviction be fined in an amount not exceeding Fifty (\$50.00) Dollars.

Any person or persons, firm or corporation who shall violate or permit or allow anyone to violate any of the provisions of this Ordinance, with the exception of Sections 11 and 12, shall be fined fifty (\$.50) cents. The Chief of Police shall account, remit and transfer twice each month to the Treasurer of the Town of Old Orchard Beach all moneys collected under this section.

Section 20. This Ordinance shall be deemed to be in addition and supplementary to, and not in conflict with nor a repeal of prior or existing ordinances of the Town of Old Orchard Beach, but shall be an additional provision for the regulation of traffic and parking in those zones or areas provided herein.

Nothing in this Ordinance shall be construed as prohibiting the Town of Old Orchard Beach from providing for free parking space for loading and unloading, for taxicab stands, bus stops and for other matters or purposes of similar nature.

Section 21. If any section or part thereof, sentence, clause or phrase of the Ordinance shall be held to be unconstitutional or invalid, the remaining provisions hereof shall, nevertheless, remain in full force and effect.

Art. 66. To see if the town will let the Memorial Post No. 7997, Veterans of Foreign Wars, have the use of the Old Orchard Field, so-called, for parking cars. The proceeds there-

from to be used by the above named organization for the following purposes; one-half of said proceeds for charitable purposes and one-half toward the building of a V.F.W. Memorial Home.

Art. 67. To see if the town will vote to refund the real estate taxes for the year 1947, in the amount of \$65.10, assessed against lot No. 15 and the building thereon, situated on the northwesterly side of Hoffman Street and owned by the Old Orchard Beach Lions Club, this sum having been paid by said organization.

Art. 68. To see if the town will grant the Old Orchard Beach Lions Club the free use of the parking lot, so-called, situated on the corner of First Street and Staples Street, for the purpose of parking cars, from the first day of June 1948 to the first day of October 1948, in order that funds may be raised for charitable purposes within this community.

Art. 69. To see if the town will vote to accept Ervin Avenue as laid out by the Selectmen.

Art. 70. To see if the town will vote to accept the extension of North Street and Park Avenue as laid out by the Selectmen.

Art. 71. To see what sum, if any, the town will vote to raise and appropriate to grade and gravel the extension of North Street and Park Avenue.

Art. 72. To see if the town will vote to abolish the public dump now located in the rear of the High School and direct the Selectmen to forthwith relocate the same elsewhere.

Art. 73. To see what sum, if any, the town will vote to raise and appropriate to install ornamental lights between the junction of Portland Avenue and Imperial Street, and the junction of Portland Avenue and Cascade Road.

Art. 74. To see if the town will vote to use the Parking Lot, so-called, as a free parking project and, if so voted, to see what sum, if any, the town will vote to raise and appropriate for lights, signs, and maintenance.

Art. 75. To see if the town will vote to extend the line of sewer on Adelaide Road a distance of approximately 200 feet and appropriate a sum of money therefor.

Art. 76. To see if the town will vote to appoint a committee to revise license fees. Said committee to consist of three or five members to work in conjunction with the Board of Selectmen.

The polls will be opened at 9:00 o'clock A.M. and will remain open until 7:00 o'clock P.M.

The Selectmen will be in session at the Town Hall, Thursday, Friday, and Saturday, February 26, 27, and 28, from 10:00 A.M. to 12:00 noon, and from 2:00 to 5:00 P.M., and on Friday evening from 7:00 to 9:00 P.M., for the purpose of registering new voters and correcting the voting list.
