

IN MEMORIAM




William J. C. Milliken, a pioneer resident of Old Orchard Beach, passed away on June 10, 1948, after a long period of failing health, at the age of 86.

Mr. Milliken served many years as a town officer in the various positions of clerk, treasurer, road commissioner, and one year as Selectman, Overseer of Poor, and Assessor. He had also been sealer of weights and measures for many years. Mr Milliken was the founder of the Milliken Ice Company, and managed an extensive gravel business.

A charter member of the Masonic Lodge, he was also a member of the Lodge of Odd Fellows and the Rebekah Lodge.

Mr. Milliken was much interested in town affairs, and was held in high esteem in this community.

IN MEMORIAM




Clement P. Wight, a resident of Old Orchard Beach since early boyhood, passed away suddenly at his home on May 17, 1948.

Report of Selectmen

As may be seen by the report of the State Auditors, the Town finances are in good condition at the end of the year. A check from the State Highway Commission for \$203.00 which arrived too late to be credited in the report, has been added to the treasury under the 1948 balance. Another check, also not shown for the same reason, is for \$585.00 for damages from the destruction of the Goose Fare Brook Bridge. This was obtained through the efforts of Judge Daniel E. Crowley.

We feel that some action should be taken on rebuilding the Milliken Mills Bridge. The State Highway Commission has offered three plans. The Selectmen favor the economical one, feeling it will well fill the need, without running into too much money.

In a period of less than ten years, the Town of Old Orchard Beach has grown to three times the size. It is difficult when making plans and suggestions, for the citizens of the Town to remember that we are not the small community we were ten years ago, and that we must have a broader outlook toward construction and maintenance that such an increase warrants. A progressive attitude is necessary more than ever at this time to keep our Beach in the foreground as one of the finest places in New England in which to live as a year round resident, or as a vacation spot for the summer months.

Superintendent of Schools Report

To the Superintending School Committee and Citizens of OLD ORCHARD BEACH

The annual report of the Public Schools of Old Orchard Beach for the fiscal year ending December 31, 1948 deals briefly with general educational problems, outlines local progress, and plans, and concludes with pupil statistics followed by a financial summary.

EDUCATION TODAY

American people long have believed that through education they invest in America's future. By advancing the schools, they have enriched home and community life, reduced the drag of illiteracy, and improved individual resources.

America's children today are introduced to an incredibly complex world of rapidly achieved knowledge and skills, of racial and class as well as international frictions. They must have an education which will help them to find their way in a constantly confused world. Our provisions for such an education have never been adequate and now we have rising costs, teacher shortages, and overcrowded schools to contend with while attempting to satisfy present day needs.

Someone has said, "A people who can pay for a war can pay for that for which they fought." If this is true, costs will be met.

The over-all picture of the teacher personnel situation will brighten only as standards and the status of teaching are improved. When the teaching profession is recognized with equal economic and social prestige of other professions, there will be no problem.

A nation wide school building program is inevitable despite the era of high costs. There is no evidence of lower costs for constructions of this type in the immediate future. The need of housing increased school population must be met first at the elementary level followed by the secondary. Peak enrollments of entering classes should be reached in the 1952-53 school year according to the average birth rates.

LOCAL ADMINISTRATION

The organization of the four school buildings in the Old Orchard Beach system continued in the fall as of the spring term. Relief from the accompanying burdens of increased enrollments could not be arranged under the existing circumstances. With an elementary school faculty of 21, funds budgeted for 21, and only 21 possible classrooms available a sound solution could not be offered at that time. As a result, class enrollment approached 40 on an average and several teachers were assigned more than 40.

A shifting population in the high school due to a small graduating class in the spring of 1948 caused a reduction of the curriculum offering in the commercial field, due to lack of personnel. In effort to present a worthwhile daily physical education program instead of the one hour a week previous assignment, physical education was restricted to boys.

Following a study of modern reporting methods, a revision of the antiquated formal rank card was made. The old system was condemned because it was not in line with present day thinking in terms of mental health objectives and the new card was developed based upon the ability and achievement of the individual. To appreciate the new reporting system with understanding and approval, the basic functions of the school must be clarified. Today our schools are providing an environment which will stimulate and encourage the child to achieve his maximum capacity or growth, uninhibited by emotional disturbances created by any instrument that scores heavily in favor of the superior mentally endowed individual.

The teachers in Old Orchard Beach have strength in a background of experience and they are to be highly complimented for their patience and cooperation under trying circumstances in several areas. Following the resignation of Mr. Horace Morse, the position of Faculty Manager of Athletics and Science instructor was created. Mr. Ralph Hansen, former instructor in Long Island University, was elected to this position. The remainder of the veteran group under Principal Bean re-

turned for the present year.

A new principal of the Federal Building, George Batchelder of Lisbon Falls, was elected following the resignation of Electa Chapin. One other experienced teacher, Miss Catherine Neilon of Biddeford, was assigned to an 8th grade class in this building.

the faculty of the Elementary and Old High School buildings returned once again under Principal Margaret Harriman.

SPECIAL PROGRAMS

Pages could be written, if space permitted, with deep pride expressed in the auxiliary services performed by teachers, pupils, and parents, representing the many service organizations.

Unusual highlights include the work, financial contributions, and personal interest of the Lion's Club, American Legion, Veterans of Foreign Wars, Teachers' Association, and the local Teachers' Club. Their projects are well known. The new football field, they new baseball field, the dental clinic, free milk, pupil scholarships, free movies, and the long range building program are all a product of these groups. More power to them in all their endeavors.

A special effort is being made this year to increase the size of the orchestra. Special classes have been organized for the instrumental training under the direction of Mrs. Worth.

The school physician, Dr. Shillings, and the school nurse, Mrs. Murphy. have worked in conjunction with the State Health Services to the advantage of the local pupils and parents.

The following additional services have been continued with a very high rating:

- 1. School Savings--Saco and Biddeford Savings Institute
- 2. Education of Physically Handicapped—Mrs. Ruth Dresser
 - School Lunch Program—Mrs. Angela Hogan
 - 4. Attendance—School Traffic—Chief Leo Harrington
- 5. Pupil Projects—Junior Red Cross, March of Dimes, Infantile Paralysis, the American Red Cross, and American Education Week projects.

PLANNING

Similar to many other towns in Maine, Old Orchard Beach is faced with the problem of providing more classroom space as well as additional teachers. One cannot argue with the stork as illustrated by the following tabulations:

At the request of the School Committee, a survey of the public school of Old Orchard Beach was made, at no cost to the town, by William Bailey, Deputy Commissioner of Education. His conclusions and recommendations follow:

Conclusions

1. Existing elementary school buildings in Old Orchard Beach can reasonably house 19 elementary school teachers. Although 30 pupils per teacher should be considered a maximum, these 19 rooms would house only 665 pupils if each class size were increased to 35 pupils per teacher.

This means that immediate provision should be made for the additional 147 pupils now enrolled and the 200 additional pupils who will be enrolled within the next five years.

- 2. If a 6 year High School were established thereby removing from the elementary building all of grades 7 and 8 (145 pupils now and increasing to 211 in 1954), present elementary buildings would be adequate to handle the Sub Primary through 6, and for years to come.
- 3. A better High School would result if more space could be provided for such needs as Library, Shop, and Home Economics.

Recommendations

- I. That Old Orchard Beach re-organize its public schools on a 6-6 basis so that all grades 7 and 8 pupils will be included in the high school.
- 2. That an addition be built on the High School building to provide 4 additional classrooms, suitable library space, a larger, Home Economics laboratory, a larger Industrial Arts

Shop, enlarged Locker and Shower rooms, and additional toilet facilities.

3. That consideration be given to including suitable cafeteria space and equipment in the High School and also in the basement rooms at the Elementary School.

In line with this report and supported by the Parent Teachers Association in their long range planning to meet the needs, a resolve was passed by the School Committee to request a \$60,000 bond issue for the immediate construction of a four room annex to the high school. The continuation of the complete project would then be conditioned upon State and Federal building fund aids and the possible formation of a school district to complete the financing.

The need for additional space beyond the six rooms in the initial project will of course be dependent upon the economics of the period and school population. It is possible that as the high school approaches the 400 registration, the elementary enrollment will decrease and present space may suffice for the elementary groups as the high school gradually absorbs the annexed rooms. In order to be protected against any emergency, it seems wise to have the permissive legislative Act for the formation of a school district available.

FINANCES

Expenditures in nearly every item in the budget exceeded estimations due to the rise in the over-all economic picture. Actually the amount appropriated for the school maintenance account was less the past year than it was in 1947. This, was, of course, unusual since the 1948 year was the most expensive year in the history of school expenditures. An excessive fuel cost and a budgeting omission created a total deficit of \$1,298.17. This item will add materially to other necessary increases in the 1949 budget.

Budget recommendations for 1949 were presented to the Town Budget Committee for study. The total request is fairly modest representing a 13 per cent rise over that of last year. The amount calls for no innovations other than the addition of

3 teachers to the faculty. The actual cost of the increase to the town will depend upon the action of the 1949 Legislature. Under the present McKinnon Act, this budget should cause Old Orchard Beach to realize at least \$2,700.00 return in addition to past amounts a year from next December. The following appropriations are recommended as necessary to maintain the public schools for the 1949 fiscal year:

CONCLUSION

I deeply appreciate my associations with the School Committee, parents, and teachers for the past few months. I admire and respect their willingness to help in the promotion of equalized educational opportunity for the children of Old Orchard Beach. We have pressing immediate needs that have caused the requested appropriation for 1949 to be reduced a numbed of times. Actually six new teachers should be added to the faculty instead of the three in order to handle the present enrollment effectively. If funds were available, an opportunity room for the slow learner should be provided with a special teacher to guide them. Consideration for art and penmanship instruction should be made at an early date. There is need, also, for a girls' Physical Education instructor and an automobile driving course in the high school. Audio and visual education have been neglected. Radios and record players are needed in every classroom of the elementary schools. Each building should be equipped with sound and film strip projectors. Yes, there is much to be done for the education of youth today if we are to prepare them to compete in the world of tomorrow.

ANNUAL REPORT OF SCHOOL NURSING FOR 1948

To the Superintendent of Schools and School Committee:

Our School Nursing year for 1948 was a busy and productive period and much to our satisfaction very low in rate for serious and contagious disease. Our greatest nuisance was the common cold and a close companion of that pest was an intestinal and stomach upset quite prevalent amongst the younger children during the colder months of the year.

At the beginning of 1948—after we had returned from the Xmas holidays, classes were continued by the School Nurse in conjunction with Miss Harriet Ham, of the high school Horne Economics Dept. in Home Nursing with a group of Freshmen Students and carried on through the Spring months. About 15 girls received Red Cross Home Nursing Certificates, at the completion of the course of 72 hours. While conducting these classes we try to keep the problems and attempted solution close and true to normal life situations to make them as valuable to the girls as is possible. Personal and community problems, first aid, and preventive health measures are some of the topics studied under Home Nursing care.

Along with our work in preventive health teachings comes the finding and prevention of the spread of T. B. amongst our school population. At the State Diagnostic Clinic, held in Biddeford last March, 40 children ranging from the Sub-primary through the High School group had a chest X-ray taken. We are happy to report that even though some of these children had reacted Positively to T.B. Patch tests and others had shown suspicious symptoms and their family physicians had requested chest X-rays because of these symptoms all X-ray findings were pronounced ok.

Considerable work is entailed in carrying on a worthwhile T.B. preventive program but it is well worth the effort to know that our children are being protected against such a scourge as T.B. to the best of our ability at home and in school. Along with this the adults in our schools,—teachers, kitchen force, janitors, nurse, etc., all have had chest X-rays taken during the past

year and a half and were found to be in a good state of health.

We closed school in June with only one case of possible serious contagious disease during the Spring Term,—scarletina—and the small victim appears to have made a very fine recovery from any possible after effects. Other contagious diseases as measles, etc., number fifteen (15).

Physical exams totaled 475. (Instead of a quick inspection of total numbers we are trying to make our physical exams more productive by skipping some grades except for children of a known poor health record and new students and doing a stricter check-up on Sub-primary groups then 4th, 8th, and total High School groups where athletic competition strain needs watchful care.

General eye tests using the Sullen Chart were given by the teachers in the grades totaling 800.

The school nurse retested all failures I-3 times and repeated failures were advised to have a careful eye exam to find out what difficulty might exist that prevented them from passing an average normal vision test.

Retests totaled 75.

In some instances the medical recommendation was glasses for school work or the entire day. In other cases better eye habits and exercises were found necessary to correct faulty vision difficulties.

The comic book was blamed in some cases for helping vision injury plus poor reading habits, bad posture and inadequate lighting.

The School Nurse tested the High School group totaling 187, and advised medical eye care for 11 students.

This group is old enough to realize the need for careful use of their eyes and in most instances are interested and cooperative in this matter.

From the 4th grade on we were able to use the audiometer machine loaned to us by the Maine Public Health Asso. for testing hearing ability.

In the lower grades the watch tick and whisper test were used plus the teacher's observation of her small charges to note an apparent lack of normal hearing.

Height and Weight measurements were taken of each grade school child to see if he is making fairly normal progress in growth and development. Our Hot Lunch program has been of great benefit to our children who needed the boost of a hot meal at mid-day to keep them up to par.

Clinics were held this fall for the benefit of those children who hadn't had toxoid immunization against diphtheria or been vaccinated against smallpox.

This service will again be available in the Spring for new students or anyone who lost the opportunity thru being absent ect., this Fall.

The Sub-primary group of some 125 children were Patch tested for T.B. reactions and 9 showed Positive results. These children have had private X-rays or will be done at the State Diagnostic Clinic to be held in March 1949. This young age group and the Senior High School students were the two age classes that recent studies on T.B. have found to show the most signs of disease possibilities. For this reason we will for the present concentrate on these students in our T.B. work. The State Diagnostic Clinic keeps us closely in touch with their newest results and studies in the question of T.B. and we are fortunate indeed to have their services at our disposal each year.

In November the School Nurse started classes the 8th grades at the Federal School in First Aid and Accident Prevention and these classes will be continued thru the Winter months. It is hoped that the pupils will do well enough in their courses to merit receiving Red Cross First Aid Certificates at the completion of this work.

As in the Home Nursing Classes we try in these First Aid Courses to keep the work to the level of the students interests and possible home and school situations likely to develop which they can handle.

We close this general summary with many thanks to all who help us in the School Nursing Program.

Herewith is the report of the examination of the pupils and students in the schools of Old Orchard Beach. I feel that the findings are comparable to previous years and I am personally pleased with the response of the parents in following along with our efforts to immunize all those who desire it against any possible outbreak of the severest of contagious diseases.

There was however a slight "scare" as the result of a few cases of a contagious dermatitis which was quite readily brought under control. Because of this condition and at the request of the school board I examined the children in the Elementary schools.

As a part of the physical fitness program and in cooperation with those in charge of athletic activities all those who enter competitive sports are examined.

The examination was made in accordance with generally accepted auditing standards applicable in the circumstances and including all procedures which were considered necessary. Insofar as could be ascertained within the scope of the examination, the financial transactions of the Town appear to have been appropriately handled, with such exceptions as may be noted in the accompanying Comments.

Exhibits and Schedules incorporated in this report present the results of the financial operations of the Town for the period designated.

Recommendations are also offered which are believed to be worthy of your consideration.

COMMENTS

Re: Audit of Accounts—Town of Old Orchard Beach January 1, 1948 to December 31, 1948

An examination has been completed of the books and records of the Town of Old Orchard Beach for the year ended December 31, 1948. This examination included such tests and procedures consistent with generally accepted auditing standards as were considered necessary. Included in and made a part of this report are a Balance Sheet with supporting Schedules and a Statement of Operations. It is believed that these statements fairly present the financial position of the Town at December 31, 1948, and the result of its operations for the year then ended.

CASH

The cash receipts as recorded were checked in detail, and it was ascertained that all cash recorded as received had been promptly deposited in the bank. The cash balance of \$1,560.79 at the end of the fiscal year was represented by cash in bank of \$1,488.52, cash on hand \$17.27, and memorandum slips of \$55.00. The check book balance of \$1,488.52 was reconciled with the December 31, 1948 bank statement of the York National Bank. Cash on hand was verified by physical count. All payments were made by check with the exception of petty cash items which were made from cash on hand. The warrants were checked and found to be correctly recorded, and properly approved by the municipal officers. Check numbers had not been recorded in the space provided on the warrants or pay rolls.

ACCOUNTS RECEIVABLE

Accounts receivable totaled \$2,458.31. Accounts set up during the current year totaled \$1,380.37. The detail of this account is shown on Schedule A-I.

SEWER ENTRANCE PERMITS RECEIVABLE

The Sewer Entrance Permits Receivable totaled \$45.00. This account represents permits issued without having received payment at time of issue. According to the records of the

Town Clerk, one permit in the amount of \$15.00 had been issued and paid for, but the Treasurer's record did not indicate payment. Therefore, this amount was set up as due from Town Clerk. The detail of this account is shown on Schedule A-2.

TAXES RECEIVABLE

The 1948 tax commitment book was added and checked. This book was found to total \$312,027.32 as compared with the actual computation of the assessment of \$313,645.14, and the Tax Collector warrant for collection of \$312,047.21. The computation of the assessment was adjusted to the actual amount of taxes committed to the Tax Collector. In connection with this examination it was noted that again this year changes had been made in both the tax commitment book and the valuation book after taxes had been committed to the Tax Collector. Any odjustment necessary during the year should be made by supplemental assessments or abatements. Approximafely 90% of the current commitment was collected or abated.

Taxes receivable totaling \$32,607.13 were checked and listed.

It was noted that interest had not been charged in accordance with a vote at annual town meeting.

All transactions affecting prior years' taxes were examined and taxes outstanding in the amount of \$3,145.09 were checked and listed.

The record of abatements totaling \$1,119.70 was examined and found to be properly authorized by the Assessors.

All unpaid 1947 real estate taxes have been secured by tax liens with the exception of two items totaling \$96.10

TAX LIENS AND DEEDS

All transactions affecting these accounts were examined. Tax liens and tax deeds totaling \$8,325.76 were checked and listed. It was noted that all tax lien and tax deed transactions are handled through one ledger controlling account.

TAX ACQUIRED PROPERTY

During the year under examination \$37.35 was received for

the sale of tax acquired property. The balance of this account at the end of the fiscal year was \$1,053.06.

ACCOUNTS PAYABLE

The accounts payable totaled \$5,831.07 at the year end. This account is made up of the following items: balance of sewer construction \$3,138.83, withholding taxes \$2,402.90, tax collector's commissions \$186.36, miscellaneous items \$102.98.

NOTES PAYABLE

There were notes payable totaling \$8,400.00 outstanding at the end of the fiscal year. During the year new notes in the amount of \$5,900.00 were issued for the purpose of repairing the so-called Federal School Building. Notes paid during the year totaled \$20,850.00. This reduction of debt was made without an appropriation or authorization at the regular or special town meetings.

BONDS PAYABLE

The bonds payable totaled \$178,000.00 at the end of the fiscal year. Bonds retired during the year by appropriation totaled \$23,000.00. A new bond issue totaling \$30,000.00 was issued during the year, for the purpose of purchasing a new fire truck, and additional necessary work on the sewers. These are 23/4% bonds dated July 18, 1948 and mature \$3,000.00 annually from 1949-1958.

During the course of the examination of the bond and bond coupon account it was noted that a record of the retirement of bonds and coupons paid is not maintained.

RESERVE

Carrying balances in the amount of \$14,571.21 represents the unexpended balances of certain appropriation and income accounts, which have been carried forward to the ensuing year. The detail is shown on Exhibit D.

DEFICIT

The deficit for the fiscal year ended December 31, 1948 was \$163,858.24. The detail of this account is shown on Exhibit E.

PUBLIC LIBRARY FUND

The records of the Treasurer of the Public Library Fund were examined. The cash balance of \$541.90 was reconciled with the depository bank, and it was found that the cash in the bank exceeded the cash balance by \$1.80. This variation was accounted for by an overdeposit of \$1.00 and an item of \$.80 which belongs in the invested funds. The investments of this fund were examined and listed. The detail of this fund is shown on Schedule A-9-10-11.

During the examination of this fund it was noted that payments were not supported by detailed invoices.

GENERAL

An examination was made of licenses issued by the Town Clerk. These licenses totaled \$4,911.00. Of this amount \$4,887.50 had been turned over to the Treasurer, and \$23.50 represented licenses issued and not paid for, which has been set up as due from the Town Clerk. It was also noted that license fees were received for which licenses were not issued.

Parking meter fines totaled \$1,211.00 and were supported by receipts No. 1 to 2429, the first seven having been voided. Fines were assessed at the rate of \$.50 for each violation.

During the course of the examination it was noted that \$467.50 was received from the Lions Club for the payment of interest on the Parking Area Bonds. The Town Clerk's record of the annual town meeting indicated that under Article 68, it was voted to turn the Parking Area over to the Lions Club to operate. As pointed out by Mr. Francis M. Sullivan in a letter to the Municipal Officers, this appears to be contrary to a law court decision 82 Me. 43. According to the town records the parking area netted the town \$2,299.15 for the 1947 year.

It was also voted under Article 67 to refund \$65.10 tax on property acquired by the Lions Club which was assessed before acquisition. Mr. Sullivan stated that this procedure also appears to be contrary to statute.

The following excise tax receipts were examined, and it was determined that the monies represented by these receipts had been deposited with the Treasurer.

Vouchers and pay rolls on file were examined to an extent deemed necessary, and so far as could be determined from this examination, those examined appear to be proper charges and correctly recorded in the distribution book. During the course of the examination of vouchers and pay rolls it was noted that checks were being drawn before the warrants were issued. It was also noted that no permanent record is being kept of bonds and bond coupons paid. However, payments are made when bonds and coupons are presented at the bank for redemption.

Road Commissioner

Salaries were not voted for the Selectmen, Assessors, Overseers of Poor and Town Clerk. However, they received remunerations based on a prior years' vote.

RECOMMENDATIONS

It is recommended that the Municipal Officers give consideration to the following suggestions:

- (1) That the Treasurer discontinue making payments from cash on memorandum slips.
- (2) That the Treasurer procure receipts prenumbered, and that these receipts be issued in numerical order.
- (3) That the Treasurer make payments only when the warrant is presented for payment, and that the check numbers be entered in the space provided on the warrant and pay roll.
- (4) That all licenses be paid for when issued.
- (5) That all Sewer Entrance Permits be paid for when issued.

- (6) That the Assessors reconcile the valuation book with the tax commitment book and that any necessary adjustments be made by abatements or supplemental assessments.
- (7) That the Tax Collector secure all unpaid real estate taxes by either tax liens or deeds.
- (8) That the Treasurer of the Public Library Fund maintain a file of detail vouchers supporting all expenditures.
- (9) That vouchers supporting all expenditures be numbered in consecutive order and filed in a readily accessible manner.
- (10) That a permanent record be installed and maintained for paid bonds and coupons.
- (11) That the Tax Collector charge and collect interest in accordance with the vote at the annual town meeting.
- (12) That ledger accounts be set up for each years' tax liens and tax deeds.

To Herbert E. Greene, Constable of the Town of Old Orchard Beach, in the County of York:

Greetings:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of said Town of Old-Orchard Beach, qualified to vote in town affairs, to assemble at the Town Hall on Monday, the 7th day of March, A.D. 1949, at 9 o'clock in the forenoon, then and there to act upon the following articles, to wit:

- Art. 3. To hear and act upon the reports of the Town Officers and all special and standing Committees.
- Art. 4. To see what sums, if any, the town will vote to raise and appropriate for, 1st, Common Schools; 2nd, High Schools; 3d, Textbooks; 4th, Repairs of School Houses; 5th, School Supplies; 6th, School House Maintenance; 7th, Industrial Arts; 8th, School Physician; 9th, Home Economics; 10th, Physical Education.
- Art. 5. To see if the town will vote to erect and equip a four classrooms and cafeteria addition to the High School building, and if so voted, to see if the town will vote to authorize the Selectmen and Treasurer to issue serial bonds of the Town to the amount of \$60,000 for such addition.
- Art. 6. To see if the town will vote to elect a Building Committee at this Town Meeting, said Committee to consist of

three members: this Committee to act in conjunction with the Board of Selectmen and the Superintending School Committee for the purpose of executing any and all agreements necessary, proper and advisable in connection with the proposed addition to the High School Building.

- Art. 68. To see what sum, if any, the town will vote to raise and appropriate to widen and improve Surf Street between Tioga and Tunis Avenues, and to widen and improve the southerly side of Tunis Avenue between Seaside Avenue and Surf Street.
- Art. 69. To see if the town will vote to allow the Chamber of Commerce to erect a suitable building in the Square, so-called, for use as an information bureau.
- Art, 70. To see if the town will vote to assign a sum of money for use of the Chamber of Commerce to be used for advertising purposes, said sum to be expended with the approval of the Board of Selectmen.
- Art. 71. To see what sum, if any, the town will vote to raise and appropriate to install a fire hydrant on Ocean Avenue, between Hillside Avenue and First Street.
 - Art. 72. To see if the town will vote to raise and appro-

priate the sum of \$1,500 for sidewalks beginning near the junction of Saco and Temple Avenues, running southerly on said Saco Avenue to town line and easterly on said Temple Avenue to the Boston and Maine Railroad Tracks; to see if the town will vote to raise and appropriate the sum of \$1,000 to construct a sidewalk on the northerly side of Saco Avenue from the junction of Saco Avenue and Ocean Park Road, and running approximately 1,200 feet toward the town line.

Art. 73. To see what sum, if any, the town will vote to raise and appropriate to raise the sidewalk on Highland Avenue from the corner of Washington Avenue to a distance of approximately 250 feet; to repair the sidewalk on the westerly side of Ocean Avenue between Central Avenue and Hillside Avenue; to construct a sidewalk on the easterly side of Union Avenue from the right of way, so-called, at the Highland House to the corner of Third Street; to repair the walk adjoining the Boston & Maine Railroad; to repair approximately 50 feet of sidewalk at lot No. 1, Randall Avenue; to repair or construct a sidewalk on the easterly side of West Grand Avenue from Tioga Avenue to Tunis Avenue; to repair or construct a sidewalk on the northerly side of Temple Avenue from West: Grand Avenue to Fourth Street; to repair or construct a sidewalk on the southerly side of Oceana Avenue beginning at Surf Street and proceeding approximately sixty feet westerly; to repair or construct a sidewalk on the southerly side of Randall Avenue beginning approximately fifty feet west of West Grand Avenue and proceeding westerly 150 feet; to construct a sidewalk in front of the Federal School, and to repair York Street and Cedar Avenue.

To see what sum, if any, the town will vote to raise and appropriate to relay the sewer line on Maplewood Avenue; to extend the sewer line on St. John's Street; to relay the sewer line on Bradbury Street; to lay a storm sewer line to drain Westland Avenue and Heath Street area; to rebuild and extend the storm sewer line on Atlantic Avenue; to complete

- Art. 75. To see if the town will authorize the Selectmen and Treasurer to execute a deed to Old Orchard Beach Memorial Post No. 7997 Veterans of Foreign Wars of Lots 6 and 7 on Milliken Street, acquired by tax process, and an adjoining lot on the northwesterly side of said street having a frontage of 275 feet on said street and extending back therefrom 300 feet, acquired by purchase, and being the southeasterly corner of the Davis lot, so-called, for a nominal consideration of one Dollar.
- Art. 76. To see what sum if any the town will vote to raise and appropriate to install two overhead red and green traffic blinkers. One at the corner of Washington and Atlantic Avenues and one at the corner of West Grand and Atlantic Avenues.
- Art, 77. To see if the town will vote to authorize the Police Department to issue and enforce the following rules in regard to bicycles and their riders during the summer months; 1st, all owners of bicycles shall register them with the Police Department; 2d, bicycles belonging to minors, must be registered with the consent of parents or guardian; 3d, that riding on handlebars is strictly forbidden; 4th, that hooking a ride on a moving vehicle is forbidden; 5th, that bicycles to be operated at night must be equipped with head lights at front and reflex mirror at rear; 6th, that bicycle riders must observe the same traffic regulations as drivers of motor vehicles; 7th, that there shall be no bicycle riding on the sidewalk during the months of June, July, August and September: 8th, that bicycle riders shall not ride more than two abreast and shall ride single file when passing a vehicle; 9th, violation of these rules shall be punished by a fine not to exceed five dollars.
- Art. 78. To see if the town will vote to employ a Town Manager.

Art. 79. To see if the town will vote to tix the compensation of such Town Manager, or delegate the same to the Selectmen.

Art. 80. To see if the Town will vote to choose five (5) Selectmen and five (5) assessors annually.

The polls will be opened at 9 a.m. and will remain open until 7 p.m.

The Selectmen will be in session at the Town Hall, Thursday, Friday, and Saturday, March 3, 4, and 5, from 10 a.m. to 12 noon, and from 2 p.m. to 5 p.m., and on Friday evening, from 7 p.m. to 9 p.m. for the purpose of registering new voters and correcting the voting list.
