NOTICE OF PUBLIC HEARING MUNICIPAL OFFICERS OF THE TOWN OF OLD ORCHARD BEACH

The Municipal Officers of the Town of Old Orchard Beach, Maine hereby give Public Notice that there will be a Public Hearing held at the Town Hall, Council Chambers, on March 15, 2011, at 7:00 p.m. to consider the following:

Be it hereby ordained, by the Town Council of the Town of Old Orchard Beach, Maine, in Town Council assembled, that Chapter 78 – Zoning, Section 78-1, 78-2 through and including 78-5, 78-34, 78-93 through and including 78-95, 78-456 through and including 78-457, Division 17, Section 78-1176 through and including 78-1185, 78-1201 through and including 78-1218, are hereby amended by adding the underscored language and deleting the strikethrough language. These amendments deal with mandated Shoreland Zoning.

AMENDMENT TO OLD ORCHARD BEACH ZONING ORDINANCE CONCERNING SHORELAND ZONING

Be it hereby ordained, by the Town Council of the Town of Old Orchard Beach, Maine, in Town Council assembled, that Chapter 78, **ZONING**, of the Old Orchard Beach Code is amended as follows.

Section 78-1, **Definitions**, is amended by adding the underscored text and deleting the text in strikeover type, as shown below. Terms not listed below are unchanged.

If there is any difference of meaning or implication between the text of this chapter and any map or illustration other than the Official Shoreland Zoning Map, the text shall control. Within the shoreland zone, the Official Shoreland Zoning Map shall control. Terms not defined in this section shall have their commonly accepted meanings. Certain terms specific to the shoreland zone are defined in Section 78-1218. The following words, terms and phrases, when used in this chapter, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

<u>Basal Area</u> - the area of cross-section of a tree stem at 4 1/2 feet above ground level and inclusive of bark.

No underline <u>Canopy means the more or less continuous cover formed by tree crowns</u> in a wooded area.

<u>Cross-sectional area of a stream or tributary stream channel means an</u> <u>area which is determined by multiplying the stream or tributary stream channel</u> <u>width by the average stream or tributary stream channel depth. The stream or</u> <u>tributary stream channel width is the straight line distance from the normal high-</u> <u>water line on one side of the channel to the normal high-water line on the</u> <u>opposite side of the channel. The average stream or tributary stream channel</u> <u>depth is the average of the vertical distances from a straight line between the</u> <u>normal high-water lines of the stream or tributary stream channel to the bottom of</u> <u>the channel.</u>

<u>DBH means the diameter of a standing tree measured 4.5 feet from</u> ground level.

<u>Disability means any disability, infirmity, malformation, disfigurement,</u> congenital defect or mental condition caused by bodily injury, accident, disease, birth defect, environmental conditions or illness; and also includes the physical or mental condition of a person which constitutes a substantial handicap as determined by a physician or in the case of mental handicap, by a psychiatrist or psychologist, as well as any other health or sensory impairment which requires special education, vocational rehabilitation or related services.

<u>Disruption of shoreline integrity means the alteration of the physical</u> shape, properties, or condition of a shoreline at any location by timber harvesting and related activities. A shoreline where shoreline integrity has been disrupted is recognized by compacted, scarified and/or rutted soil, an abnormal channel or shoreline cross-section, and in the case of flowing waters, a profile and character altered from natural conditions.

Emergency operations means operations conducted for the public health, safety or general welfare, such as protection of resources from immediate destruction or loss, law enforcement, and operations to rescue human beings, property and livestock from the threat of destruction or injury.

Essential services means gas, electrical, or communication facilities; steam, fuel, electric power or water transmission or distribution lines, towers and related equipment; telephone cables or lines, poles and related equipment; gas, oil, water, slurry or other similar pipelines; municipal sewage lines, collection, supply or disposal systems; and associated storage tanks. Such systems may include towers, poles, wires, mains, drains, pipes, conduits, cables, fire alarms and police call boxes, traffic signals, hydrants and similar accessories, but shall not include service drops or buildings which are necessary for the furnishing of such services.

Family means one or more persons occupying a premises and living as a single housekeeping unit, as distinguished from persons occupying a boardinghouse, lodging house, or hotel. The maximum number of persons occupying a premises shall be governed by the ICC International Property Maintenance Code, section 404.

Family unit means a unit which is occupied by <u>a family</u>, as defined by this <u>chapter</u>.

Floodway means the channel of a river or other watercourse and adjacent land areas that must be reserved in order to discharge the 100-year flood without cumulatively increasing the water surface elevation by more than one foot in height.

Floor area means the sum of the horizontal areas of the floor<u>(s)</u> of a structure enclosed by exterior walls, plus the horizontal area of any unenclosed portions of a structure such as porches and decks.

Forest management activities means timber cruising and other forest resources evaluation activities; pesticide or fertilizer application, management planning activities, timber stand improvement, pruning, regeneration of forest stands, and other <u>similar or</u> associated activities <u>exclusive of</u> timber harvesting and the construction, creation or maintenance of roads.

Forest Stand means a contiguous group of trees sufficiently uniform in age class distribution, composition, and structure, and growing on a site of sufficiently uniform quality, to be a distinguishable unit.

Functionally water-dependent uses means those uses that require, for their primary purpose, location on submerged lands or that require direct access to, or location in, coastal <u>or</u> inland waters and <u>that</u> cannot be located away from these waters. The uses include, but are not limited to, commercial and recreational fishing and boating facilities (excluding recreational boat storage buildings); finfish and shellfish processing; fish storage and retail and wholesale fish marketing facilities; waterfront dock and retail and wholesale fish marketing facilities; waterfront dock and port facilities; shipyards and boatbuilding facilities; marinas; navigation sides, basins and channels; retaining walls; industrial uses dependent upon waterborne transportation or requiring large volumes of cooling or processing water <u>that</u> cannot reasonably be located or operated at an inland site; and uses <u>that</u> primarily provide general public access to <u>coastal or inland</u> waters.

<u>Great pond means any inland body of water which in a natural state has a</u> surface area in excess of ten acres, and any inland body of water artificially Formatted: No underline

formed or increased which has a surface area in excess of thirty (30) acres except for the purposes of this Ordinance, where the artificially formed or increased inland body of water is completely surrounded by land held by a single owner,

<u>Great pond classified GPA means any great pond classified GPA,</u> pursuant to 38 M.R.S.A. Article 4-A Section 465-A. This classification includes some, but not all impoundments of rivers that are defined as great ponds.

<u>Ground cover means small plants, fallen leaves, needles and twigs, and the partially decayed organic matter of the forest floor.</u>

Harvest Area means the area where timber harvesting and related activities, including the cutting of trees, skidding, yarding, and associated road construction take place. The area affected by a harvest encompasses the area within the outer boundaries of these activities, excepting unharvested areas greater than 10 acres within the area affected by a harvest.

Height of a_wireless telecommunications facility means the vertical measurement from a point on the ground at the mean finished grade adjoining the foundation as calculated by averaging the highest and lowest finished grade around the building or structure to the highest point of the building or structure. Measurement of the highest point shall exclude flagpoles, chimneys, ventilators, skylights, domes, water towers, bell towers, church spires, tanks, bulkheads, or other building accessory features usually erected at a height greater than the main roofs of buildings, but shall include the entirety of the wireless telecommunications towers.

Land Management Road means a route or track consisting of a bed of exposed mineral soil, gravel, or other surfacing materials constructed for, or created by, the passage of motorized vehicles and used primarily for timber harvesting and related activities, including associated log yards, but not including skid trails or skid roads.

<u>Licensed Forester means a forester licensed under 32 M.R.S.A. Chapter</u> 76.

Lot area, net, means the area of contiguous land suitable to support a building unit enclosed within the boundary lines of a lot, minus land below the normal high water <u>line</u> of a waterbody or upland edge of a wetland, <u>areas</u>

<u>Market value means the estimated price a property will bring in the open</u> market and under prevailing market conditions in a sale between a willing seller and a willing buyer, both conversant with the property and with prevailing general price levels.

Native means indigenous to the local forests.

<u>Non-conforming condition means a non-conforming lot, structure or use</u> which is allowed solely because it was in lawful existence at the time this chapter or subsequent amendment took effect.

<u>Non-conforming lot means a single lot of record which, at the effective</u> date of adoption or amendment of this chapter, does not meet the area, frontage, or width requirements of the district in which it is located.

<u>Non-conforming structure means a structure which does not meet any</u> one or more of the following dimensional requirements; setback, height, or lot coverage, but which is allowed solely because it was in lawful existence at the time this chapter or subsequent amendments took effect.

Normal high water <u>line of coastal waters</u> means that line on the shore of tidal waters at the upland edge of the coastal wetland, as defined by this chapter.

Normal high water <u>line of inland waters</u> means that line which is apparent from visible markings, changes in the character of soils due to prolonged action of the water or changes in vegetation, and which distinguishes between predominantly aquatic and predominantly terrestrial land. <u>Areas contiguous with</u> <u>rivers that support non-forested wetland vegetation and hydric soils and that are</u> at the same or lower elevation as the water level of the river during the period of **Deleted:** Normal high water elevation. <u>Person means an individual, corporation, governmental agency,</u> <u>municipality, trust, estate, partnership, association, two or more individuals</u> <u>having a joint or common interest, or other legal entity.</u>

Piers, docks, wharves, <u>bridges</u>, and <u>other structures</u> and uses <u>extending</u> over or beyond the normal high water line or within a wetland means as follows:

(1) Permanent means structures which remain in or over the water for

six months or more in any period of 12 consecutive months.

(2) *Temporary* means structures which remain in <u>or over</u> the water for less than six months in any period of 12 <u>consecutive</u> months.

Recreational facility means a <u>place designed and equipped for the</u> <u>conduct of sports, leisure time activities, and other customary and usual</u> <u>recreational activities, including,</u> but not limited to, amateur athletic fields, playgrounds/tot lots, tennis courts and picnic shelters/areas, swimming pools, minigolf and hot tubs. <u>Within any shoreland zone, the term shall not include</u> <u>boat launching facilities.</u>

Recreational vehicle means a portable unit designed as temporary living quarters for recreational, camping, travel or seasonal use that is mounted on a chassis and either self-propelled or towed by another vehicle. A recreational vehicle may be a "dependent recreational vehicle," a "self-contained recreational vehicle" or a "park model." The term "recreational vehicle" includes but is not limited to a "motor home", "camping trailer", "park model" or "pick-up coach". In order to be considered as a recreational vehicle and not as a structure, the unit must remain with its tires on the ground, and must be registered with a state division of motor vehicles or similar agency, unless it is a park model located within a campground or a pick-up coach and is located outside the shoreland zone.

<u>Residual basal area means the average of the basal area of trees</u> remaining on a harvested site.

<u>Residual stand means a stand of trees remaining in the forest following timber harvesting and related activities.</u>

<u>River means a free-flowing body of water including its associated</u> <u>floodplain wetlands from that point at which it provides drainage for a watershed</u> <u>of twenty five (25) square miles to its mouth. The portion of a river that is subject</u> <u>to tidal action is a coastal wetland.</u>

Road means a route or track consisting of a bed of exposed mineral soil, gravel, asphalt, or other surfacing material constructed for or created by the repeated passage of motorized vehicles, excluding a driveway as defined.

Salt marsh means areas of coastal wetland (most often along coastal bays) that support salt tolerant species, and where at average high tide during the growing season, the soil is irregularly inundated by tidal waters. The predominant species is saltmarsh cordgrass (Spartina alterniflora). More open areas often support widgeon grass, eelgrass, and Sago pondweed.

Salt meadow means areas of a coastal wetland that support salt tolerant plant species bordering the landward side of salt marshes or open coastal water, where the soil is saturated during the growing season but which is rarely inundated by tidal water. Indigenous plant species include salt meadow cordgrass (Spartina patens) and black rush; common threesquare occurs in fresher areas.

<u>Service drop means any utility line extension which does not cross or run</u> beneath any portion of a water body provided that:

1. in the case of electric service

a. the placement of wires and/or the installation of utility poles is located entirely upon the premises of the customer requesting service or upon a roadway right-of-way; and b. the total length of the customer is less than and the upond (1,000)

b. the total length of the extension is less than one thousand (1,000) feet.

2. in the case of telephone service

<u>a.</u> the extension, regardless of length, will be made by the installation <u>of telephone wires to existing utility poles, or</u>

b. the extension requiring the installation of new utility poles or placement underground is less than one thousand (1,000) feet in length.

<u>Substantial start means completion of thirty (30) percent of a permitted</u> structure or use measured as a percentage of estimated total cost.

Subsurface sewage disposal system means any system designed to dispose of waste or waste water on or beneath the surface of the earth; includes, but is not limited to: septic tanks; disposal fields; grandfathered cesspools; holding tanks; pretreatment filter, piping, or any other fixture, mechanism, or apparatus used for those purposes; does not include any discharge system licensed under 38 M.R.S.A. section 414, any surface waste water disposal system, or any municipal or quasi-municipal sewer or waste water treatment system.

<u>Sustained slope means a change in elevation where the referenced</u> percent grade is substantially maintained or exceeded throughout the measured area.

<u>Tidal waters means all waters affected by tidal action during the</u> <u>maximum spring tide.</u>

Timber harvesting means the cutting and removal of timber for the primary purpose of selling or processing forest products. The cutting or removal of trees in the shoreland zone on a lot that has less than two (2) acres within the shoreland zone shall not be considered timber harvesting. Such cutting or removal of trees shall be regulated pursuant to Section 78-1213 Clearing or Removal of Vegetation for Activities Other Than Timber Harvesting.

<u>Timber harvesting and related activities means timber harvesting, the</u> construction and maintenance of roads used primarily for timber harvesting and other activities conducted to facilitate timber harvesting.

Tributary stream means a channel between defined banks created by the action of surface water, which is characterized by the lack of <u>terrestrial vegetation</u> or <u>by the</u> presence of a bed, devoid of topsoil, containing waterborne deposits or exposed soil, parent material or bedrock, and which is connected hydrologically with other water bodies. "Tributary stream" does not include rills or gullies forming because of accelerated erosion in disturbed soils where the natural vegetation cover has been removed by human activity. This definition does not include the term "stream" as defined in this section, and only applies to that portion of the tributary stream located within the shoreland zone of the receiving waterbody or wetland.

Upland edge<u>of a wetland</u> means the boundary between upland and wetland. For purposes of a coastal wetland, this boundary is the line formed by

Sec. 78-2. Purpose.

(a) This chapter and its regulations are designed for all the purposes of zoning embraced in the state statutes as an integral part of a comprehensive plan.

(b) This chapter is, among other things, designed to:

(1) Encourage the most appropriate use of land throughout the town;

(2) Provide safety from fire and other elements, and further the maintenance of safe and healthful conditions;

- (3) Promote public safety;
- (4) Provide adequate light and air;
- (5) Prevent overcrowding of real estate;

Section 78-34, **Building permits**, is amended by adding the following new subsections (d), (e), (f) and (g), as shown below.

(d) Activities for Which a Permit is Not Required.

(1) A permit is not required for the replacement of an existing road culvert within any shoreland zone as long as:

(a) The replacement culvert is not more than 25% longer than the culvert being replaced;

(b) The replacement culvert is not longer than 75 feet; and

(c) Adequate erosion control measures are taken to prevent sedimentation of the water, and the crossing does not block fish passage in the watercourse.

Any other replacements of culverts within the shoreland zone which do not meet these criteria shall require a permit.

(2) A permit is not required for an archaeological excavation as long as the excavation is conducted by an archaeologist listed on the State Historic Preservation Officer's level 1 or level 2 approved list, and unreasonable erosion and sedimentation is prevented by means of adequate and timely temporary and permanent stabilization measures.

(e) Standard Conditions in Any Shoreland Zone. No permit shall be issued for any structure or activity within any shoreland zone unless all of the following standard conditions are met:

- (1) Will maintain safe and healthful conditions;
- (2) Will not result in water pollution, erosion, or sedimentation to surface waters;
- (3) Will adequately provide for the disposal of all wastewater;
- (4) Will not have an adverse impact on spawning grounds, fish, aquatic life, bird or other wildlife habitat;
- (5) Will conserve shore cover and visual, as well as actual, points of access to inland and coastal waters;

- (6) Will protect archaeological and historic resources as designated in the comprehensive plan;
- (7) Will avoid problems associated with floodplain development and use; and
- (8) Is in conformance with the provisions of all applicable shoreland zoning standards in division 17 of this chapter.
- (f) Installation of Public Utility Service. A public utility, water district, sanitary district or any utility company of any kind may not install services to any new structure located in the shoreland zone unless written authorization attesting to the validity and currency of all local permits required under this chapter or any previous ordinance has been issued by the appropriate municipal officials or other written arrangements have been made between the municipal officials and the utility.

(g) Other permits. Any permit required by this chapter shall be in addition to any other permit required by other law or ordinance.

Sec. 78-37. Maintenance of records.

The code enforcement officer shall maintain a record of all building permits and certificates of occupancy and letters and notices issued by him, and a copy shall be issued upon request to any person. In addition, within the shoreland zone, the Code Enforcement Officer shall keep a complete record of all essential transactions of the office, including applications submitted, permits granted or denied, variances granted or denied, revocation actions, revocation of permits, appeals, court actions, violations investigated, violations found, and fees collected. On a biennial basis, a summary of this record shall be submitted to the Director of the Bureau of Land and Water Quality within the Department of Environmental Protection.

The boundaries of the <u>zone</u> and <u>subdistricts</u> shall be determined by measurement of the distance indicated on the maps from the normal high water line of the waterbody or the upland edge of wetland vegetation, regardless of the location of the boundary shown on the map.

Sec. 78-1180. Land use requirements.

Except as <u>hereinafter</u> specified in this division, no building, structure or land located within the shoreland <u>zone</u> <u>shall hereafter</u> be used or occupied, and no <u>building or structure or</u> <u>part thereof shall hereafter</u> be erected, constructed, expanded, moved, or altered and no new lot shall be created except in conformity with all of the regulations <u>herein</u> specified for the district in <u>which it is located</u>, unless a variance is granted.

setback by 30 percent or more is a substantial expansion which is prohibited unless a variance is obtained.

b. Whenever a new, enlarged, or replacement foundation is constructed under a nonconforming structure, the structure and new foundation must be placed such that the setback requirement is met to the greatest practical extent as determined by the planning board, basing its decision on the criteria specified in subsection (b)(2) of this section pertaining to relocation. If the completed foundation does not extend beyond the exterior dimensions of the structure, except for expansion in conformity with section (a) above, and the foundation does not cause the structure to be elevated by more than three (3) additional feet, as measured from the uphill side of the structure (from original ground level to the bottom of the first floor sill), it shall not be considered to be an expansion of the structure.

c. No <u>structure which is less than the required setback from the normal</u> high water line of a waterbody, tributary stream, or upland edge of a wetland shall be expanded toward the waterbody, tributary stream, or wetland.

(2) *Relocation.* A nonconforming <u>structure may be relocated within the</u> boundaries of the parcel on which the <u>structure is located</u>, provided that the site of relocation conforms to <u>all setback requirements</u> to the greatest practical extent as determined by the planning board and provided that the applicant demonstrates that the present subsurface sewage disposal system meets the requirements of state law and the state subsurface wastewater disposal rules or that a new system can be installed in compliance with the law and <u>said rules</u>. In no case shall a <u>structure</u> be relocated in a manner that causes the <u>structure</u> to be more nonconforming.

In determining whether the <u>structure</u> relocation meets the setback to the greatest practical extent, the planning board shall consider the size of the lot, the slope of the land, the potential for soil erosion, the location of other <u>structures</u> on the property and on adjacent properties, the location of the septic system and other on-site soils suitable for septic systems, and the type and amount of vegetation to be removed to accomplish the relocation.

When it is necessary to remove vegetation within the water or wetland setback area in order to relocate a structure, the Planning Board shall require replanting of native vegetation to compensate for the destroyed vegetation. In addition, the area from which the relocated structure was removed must be replanted with vegetation. Replanting shall be required as follows:

(a) <u>Trees removed in order to relocate a structure must be replanted</u> with at least one native tree, three (3) feet in height, for every tree removed. If more than five trees are planted, no one species of tree shall make up more than 50% of the number of trees planted. Replaced trees must be planted no further from the water or wetland than the trees that were removed.

Other woody and herbaceous vegetation, and ground cover, that are removed or destroyed in order to relocate a structure must be re-established. An area at least the same size as the area where vegetation and/or ground cover was disturbed, damaged, or removed must be reestablished within the setback area. The vegetation and/or ground cover must consist of similar native

(b) Where feasible, when a structure is relocated on a parcel the original location of the structure shall be replanted with vegetation which may consist of grasses, shrubs, trees, or a combination thereof.

(3) Reconstruction or replacement. Any nonconforming structure which is located less than the required setback from a waterbody, tributary stream, or wetland and which is removed, or damaged or destroyed, regardless of the cause, by more than 50% of the market value of the structure before such damage, destruction or removal, may be reconstructed or replaced, provided that a permit is obtained within <u>eighteen (18) months</u> of the date of <u>said</u> damage, destruction, or removal, and provided that such reconstruction or replacement is in compliance with the waterbody, tributary stream or wetland setback requirement to the greatest practical extent as determined by the planning board in accordance with the purposes of this chapter. In no case shall a structure be reconstructed or replaced so as to increase its nonconformity. If the reconstructed or replacement structure is less than the required setback it shall not be any larger than the original structure, except as allowed pursuant to Section 78-1181(c)(1) above, as determined by the non-conforming floor area and volume of the reconstructed or replaced structure at its new location. If the total amount of floor area and volume of the original structure can be relocated or reconstructed beyond the required setback area, no portion of the relocated or reconstructed structure shall be replaced or constructed at less than the setback requirement for a new structure. When it is necessary to remove vegetation in order to replace or reconstruct a structure, vegetation shall be replanted in accordance with Section 78-1181(c)(2) above.

Any non-conforming structure which is located less than the required setback from a water body, tributary stream, or wetland and which is removed by 50% or less of the market value, or damaged or destroyed by 50% or less of the market value of the structure, excluding normal maintenance and repair, may be reconstructed in place if a permit is obtained from the Code Enforcement Officer within one year of such damage, destruction, or removal.

In determining whether the <u>structure reconstruction or replacement meets the</u> water setback to the greatest practical extent, the planning board shall consider, in addition to the criteria in subsection (c)(2)_Relocation, above, the physical condition and type of foundation present, if any.

(4) <u>Change of Use of a Non-conforming Structure</u>. The use of a non-conforming structure may not be changed to another use unless the Planning Board, after receiving a written application, determines that the new use will have no greater adverse impact on the water body, tributary stream, or wetland, or on the subject or adjacent properties and resources than the existing use.

In determining that no greater adverse impact will occur, the Planning Board shall require written submissions from the applicant, regarding the probable effects on public health and safety, erosion and sedimentation, water quality, fish and wildlife habitat, vegetative cover, visual and actual points of public access to waters, natural beauty, floodplain management, archaeological and historic resources, and commercial fishing and maritime activities, and other functionally water-dependent uses, as applicable.

(1) Expansions. Expansions of nonconforming uses are prohibited, except that nonconforming residential uses may, after obtaining a conditional use permit from the planning board be expanded within existing residential structures or within expansions of such structures as permitted in subsection (b)(1) of this section.

(2) Resumption Prohibited. A lot or structure in or on which a non-conforming use is discontinued for a period exceeding two years, or which is changed to a conforming use for a period exceeding one year, may not again be devoted to a non-conforming use except that the Planning Board may, for good cause shown by the applicant, grant up to a one year extension of the period of discontinuance or changed use. This provision shall not apply to the resumption of a use of a residential structure provided that the structure has been used or maintained for residential purposes during the five (5) year period preceding the discontinuance or change of use.

(3) Change of Use. An existing non-conforming use may be changed to another non-conforming use provided that the proposed use has no greater adverse impact on the subject and adjacent properties and resources than the former use, as determined by the Planning Board. The determination of no greater adverse impact shall be made according to criteria listed in Section 78-1181(c)(4) "Change of Use of a Non-conforming Structure," above.

(e) Nonconforming lots.

(1) Nonconforming lots. A nonconforming lot of record as of the effective date of this chapter or amendment thereto may be built upon, without the need for a variance, provided that such lot is in separate ownership and not contiguous with any other lot in the same ownership, and that all provisions of this chapter except lot area, lot width and shore frontage can be met. Variances relating to setback or other requirements not involving lot area, lot width or shore frontage shall be obtained by action of the Board of Appeals.

(2) Contiguous built lots. If two or more contiguous lots or parcels are in a single or joint ownership of record at the time of adoption of this chapter, if all or part of the lots do not meet the dimensional requirements of this chapter, and if a principal use or structure exists on each lot, the non-conforming lots may be conveyed separately or together, provided that the State Minimum Lot Size Law (12 M.R.S.A. sections 4807-A through 4807-D) and the State of Maine Subsurface Wastewater Disposal Rules are complied with.

If two or more principal uses or structures existed on a single lot of record on the effective date of this chapter, each may be sold on a separate lot provided that the State Minimum Lot Size Law and rules are complied with or each lot is served by public sewer. When such lots are divided each lot thus created must be as conforming as possible to the dimensional requirements of this chapter.

Contiguous lots - vacant or partially built. If two or more contiguous lots or 3) parcels are in single or joint ownership of record at the time of or since adoption or amendment of this chapter, if any of these lots do not individually meet the dimensional requirements of this chapter or subsequent amendments, and if one or more of the lots are vacant or contain no principal structure the lots shall be combined to the extent necessary to meet the dimensional requirements.

Sec. 78-1182. Establishment of Shoreland Zone Subdistricts.

(a) Generally.

(1) The depiction of these subdistricts on the official zoning map is illustrative of their Jocation. The boundaries of these subdistricts, unless shown to be the centerline of a street or railroad, shall be determined by measurement of the distance indicated on the maps from the high water line of the waterbody or the upland edge of wetland vegetation, regardless of the location of the boundary shown on the map. Exact boundaries shall be determined by on-site inspection and measurement from the normal high water line or from the upland edge of a wetland.

(2) Such on-site inspection and measurement may be requested by the property owner at any time or by the applicant at the time of filing an application for a permit or approval under this chapter. As part of such on-site inspection and measurement, the property owner or the applicant for any permit or approval may present evidence from persons with training and/or experience related to the identification, delineation and classification of wetlands and/or the delineation of the high water line or the upland edge of a wetland. Such evidence shall be presented to the code enforcement officer or to the planning board, if an application for a planning board permit or approval is pending, and a determination shall be made as to the exact boundaries, subject to review by the board of appeals pursuant to subdivision II of division 2 of article II of this chapter.

(b) Resource protection subdistrict (RP). The Resource Protection Subdistrict includes areas in which development would adversely affect water quality, productive habitat, biological ecosystems, or scenic and natural values. This subdistrict is intended to include the following areas when they occur within the limits of the shoreland zone, exclusive of the stream protection subdistrict, except that areas which are currently developed and areas which meet the criteria for the Limited Commercial or General <u>Development Subdistricts were not included within the resource protection subdistrict:</u>

(1) Areas within 250 feet, horizontal distance, of the upland edge of freshwater wetlands and wetlands associated with great ponds and rivers, which are rated "moderate" or "high" value waterfowl and wading bird habitat, including nesting and feeding areas, by the Maine Department of Inland Fisheries and Wildlife (MDIF&W) that are depicted on a Geographic Information System (GIS) data layer maintained by either MDIF&W or the Department as of December 31, 2008, For the purposes of this paragraph "wetlands associated with great ponds and rivers" shall mean areas characterized by non-forested wetland vegetation and hydric soils that are contiguous with a great pond or river, and have a surface elevation at or below the water level of the great pond or river during the period of normal high water. "Wetlands associated with great ponds or rivers" are considered to be part of that great pond or river. Also included in this district are areas within 250 feet, horizontal distance, of the upland edge of salt marshes and salt meadows which are rated "moderate" or "high" value waterfowl and wading bird habitat, including nesting and feeding areas, by the MDIF&W as of January 1, 1973.

(2) Floodplains along rivers and floodplains along artificially formed great ponds along rivers defined by the 100-year floodplain as designated on the Federal Emergency Management Agency's (FEMA) flood insurance rate maps or flood

(5) Land areas along <u>rivers</u> subject to severe bank erosion, undercutting, or <u>riverbed</u> movement, and lands adjacent to tidal waters which are subject to <u>severe erosion or mass movement</u>, such as steep coastal bluffs.
 (6) In addition, the Resource Protection Subdistrict extends seaward to the

(6) In addition, the Resource Protection Subdistrict extends seaward to the municipal boundary.

(c) Shoreland <u>residential</u> activity subdistrict (<u>RA</u>). <u>The Shoreland Residential Activity</u> <u>Subdistrict includes those areas within the shoreland zone suitable for residential and recreational development</u>. It includes areas other than those in the Resource Protection <u>Subdistrict</u>, or <u>Stream Protection Subdistrict</u>, and areas which are used less intensively than those in the Limited Commercial Subdistrict or the General Development <u>Subdistrict</u>.

(d) <u>Limited Commercial Subdistrict (LC).</u> The Limited Commercial Subdistrict overlays the following underlying zoning districts:

Beachfront resort district (BRD); Residential beachfront district (RBD); Residential 3 district (R3); Neighborhood commercial district 1 (NC-1); Neighborhood commercial district 2 (NC-2)

It includes areas of mixed, light commercial and residential uses, exclusive of the Stream Protection Subdistrict, which should not be developed as intensively as the General Development Subdistrict. This subdistrict includes areas of two or more contiguous acres in size devoted to a mix of residential and low intensity business and commercial uses. Industrial uses are prohibited.

(e) General Development Subdistrict (GD). The General Development Subdistrict overlays the following underlying zoning districts:

Downtown district 1 (DD-1); Downtown district 2 (DD-2); Contract zone 1 (CZ-1) It includes the following types of existing, intensively developed areas:

(1) Areas of two or more contiguous acres devoted to commercial or intensive recreational activities, or a mix of such activities, including but not limited to the following:

(a) Areas devoted to retail trade and service activities, or other commercial activities; and

(b) Areas devoted to intensive recreational development and activities, such as, but not limited to amusement parks.

(2) Areas otherwise discernible as having patterns of intensive commercial, industrial or recreational uses.

<u>(f)</u> Stream protection subdistrict (SP). This subdistrict includes all land areas within one hundred (100) feet, horizontal distance, of the normal high water line of a stream and all

land areas within 100 feet of the high water line of the nontidal portion of the Goosefare Brook, located from the Boston and Maine Railroad tracks upstream to the Saco border, exclusive of:

(1) areas within 250 feet, horizontal distance, of the normal high water line of at tidal saltwater body; and

(2) areas within 250 feet, horizontal distance, of the upland edge of coastal or <u>freshwater</u> wetlands.

Where a stream and its associated shoreland area is located within <u>the proscribed</u> horizontal distance, <u>above</u>, <u>from</u> such waterbodies or wetlands, that land area should be regulated under the terms of the shoreland <u>zone</u> subdistrict associated with that waterbody or wetland.

(g) Public beach subdistrict (PB). This subdistrict includes the beach area and public park land acquired by the Town of Old Orchard Beach for a public park on or about April 23, 1935 and May 5, 1935. The purpose of this subdistrict is to allow continuation of all the public recreational uses which have been made of the beach historically, subject to such rules and regulations as the Town Council may from time to time impose by ordinance, regulation or policy governing the use of the public park.

Sec. 78-1183. Land uses.

Generally. <u>The use of land, buildings and structures in the shoreland zone is governed</u> / <u>as follows:</u>

(a) In the Resource Protection, Stream Protection and Public Beach subdistricts. uses are governed exclusively by the table "Land Uses in the Shoreland Zone," below (the "Shoreland Use Table")

(b) In the Shoreland Residential Activity, Limited Commercial and General Development subdistricts, uses are governed by the Shoreland Use Table and by the use regulations for the underlying zoning district as set forth in the other divisions of this article. In cases where comparison between the Shoreland Use Table and the underlying zoning district regulations creates uncertainty as to whether a use is permitted, the regulation imposing the greater restrictions and/or allowing a less intensive use shall control. Sec. 78-1186. Special permit for undeveloped lots in resource protection.

In addition to the criteria specified in subsection 78-34(e), excepting structure setback requirements, the planning board may approve a permit for single-family residential structure in a resource protection district provided that the applicant demonstrates that all of the following conditions are met:

(a) There is no location on the property, other than a location within the resource protection district, where the structure can be built.

(b) The lot on which the structure is proposed is undeveloped and was established and recorded in the registry of deeds of the county in which the lot is located before the adoption of the resource protection district.

(c) The proposed location of all buildings, sewage disposal systems and other improvements are:

(1) Located on natural ground slopes of less than 20 percent; and

(2) Located outside the floodway of the 100-year floodplain along rivers and artificially formed great ponds along rivers and outside the velocity zone in areas subject to tides, based on detailed flood insurance studies and as delineated on the Federal Emergency Management Agency's flood boundary and floodway maps and flood insurance rate maps; all buildings, including basements, are elevated at least one foot above the 100-year floodplain elevation; and the development is otherwise in compliance with any applicable municipal floodplain ordinance.

If the floodway is not shown on the Federal Emergency Management Agency Maps, it is deemed to be one-half the width of the 100-year floodplain.

(d) The total ground-floor area, including cantilevered or similar overhanging extensions, of all principal and accessory structures is limited to a maximum of 1,500 square feet. This limitation shall not be altered by variance.

(e) All structures, except functionally water-dependent structures, are set back from the normal high water line of a waterbody, tributary stream or upland edge of a wetland to the greatest practical extent, but no less than 75 feet, horizontal distance. In determining the greatest practical extent, the Planning Board shall consider the depth of the lot, the slope of the land, the potential for soil erosion, the type and amount of vegetation to be removed, the proposed building site's elevation in regard to the floodplain, and its proximity to moderate-value and high-value wetlands.

Subdivision II. Shoreland, Zone Performance Standards

Sec. 78-1201. Applicability; conformance required.

All land use activities within the shoreland <u>zone shall conform to the performance</u> standards in this division, if applicable. When there is any conflict between these performance standards and the other standards of this chapter, the more restrictive standards shall apply.

Sec. 78-1202. <u>Principal and accessory buildings and structures</u>.

(1) All new principal and accessory buildings and structures in the shoreland zone shalls be set back at least 100 feet, horizontal distance, from streams or tributary streams, as defined by this chapter, or 100 feet, horizontal distance, from the normal high water line of other waterbodies or the upland edge of a wetland or coastal wetland, except that in the General Development District the setback from the normal high water line shall be at least twenty five (25) feet, horizontal distance. In the Resource Protection District the setback requirement shall be 250 feet, horizontal distance, except for structures, roads, parking spaces or other regulated objects specifically allowed in that district in which case the setback requirements specified above shall apply.

(2) In addition, the water body, tributary stream, or wetland setback provision shall neither apply to structures which require direct access to the water body or wetland as an operational necessity, such as piers, docks and retaining walls, nor to other functionally water-dependent uses.

(3) On a non-conforming lot of record on which only a residential structure exists, and it is not possible to place an accessory structure meeting the required water body, tributary stream or wetland setbacks, the code enforcement officer may issue a permit to place a single accessory structure, with no utilities, for the storage of yard tools and similar equipment. Such accessory structure shall not exceed eighty (80) square feet in area nor eight (8) feet in height, and shall be located as far from the shoreline or tributary stream as practical and shall meet all other applicable standards, including lot coverage and vegetation clearing limitations. In no case shall the structure be located closer to the shoreline or tributary stream than the principal structure.

(4) <u>All tidal land which is subject to tidal action during the maximum spring tide is coastal</u> wetland. A tributary stream may be perennial or intermittent. Where a tributary stream is

present within the shoreland zone, setback standards from that tributary stream are applicable.

(5) The lowest floor elevation or openings of all buildings and structures, including basements, shall be elevated at least one foot above the elevation of the 100 year flood, the flood of record, or in the absence of these, the flood as defined by soil types identified as recent flood-plain soils. In those municipalities that participate in the National Flood Insurance Program and have adopted the April 2005 version, or later version, of the Floodplain Management Ordinance, accessory structures may be placed in accordance with the standards of that ordinance and need not meet the elevation requirements of this paragraph.

(6) <u>Retaining walls that are not necessary for erosion control shall meet the structure setback requirement, except for low retaining walls and associated fill provided all of the following conditions are met:</u>

(a) <u>The site is located outside of a frontal or back dune area as designated by</u> <u>Maine Department of Environmental Protection Sand Dune rules;</u>

(b) <u>The site has been previously altered and an effective vegetated buffer does</u> <u>not exist:</u>

(c) <u>The wall(s) is(are) at least 25 feet, horizontal distance, from the normal high-water line of a water body, tributary stream, or upland edge of a wetland;</u>

(d) <u>The site where the retaining wall will be constructed is legally existing lawn or</u> is a site eroding from lack of naturally occurring vegetation, and which cannot be stabilized with vegetative plantings;

(e) The total height of the wall(s), in the aggregate, are no more than 24 inches;

(f) <u>Retaining walls are located outside of the 100-year floodplain on rivers,</u> streams, coastal wetlands, and tributary streams, as designated on the Federal <u>Emergency Management Agency's (FEMA) Flood Insurance Rate Maps or Flood</u> <u>Hazard Boundary Maps, or the flood of record, or in the absence of these, by soil</u> types identified as recent flood plain soils.

(g) <u>The area behind the wall is revegetated with grass, shrubs, trees, or a</u> combination thereof, and no further structural development will occur within the <u>setback area, including patios and decks; and</u>

(h) <u>A vegetated buffer area is established within 25 feet, horizontal distance, of the normal high-water line of a water body, tributary stream, or upland edge of a wetland when a natural buffer area does not exist. The buffer area must meet the following characteristics:</u>

(i) <u>The buffer must include shrubs and other woody and herbaceous</u> vegetation. Where natural ground cover is lacking the area must be supplemented with leaf or bark mulch;

(ii) <u>Vegetation plantings must be in quantities sufficient to retard erosion</u> and provide for effective infiltration of stormwater runoff;

(iii) Only native species may be used to establish the buffer area;

(iv) <u>A minimum buffer width of 15 feet, horizontal distance, is required,</u> measured perpendicularly to the normal high-water line or upland edge of <u>a wetland</u>;

(v) <u>A footpath not to exceed the standards in Section 15(P)(2)(a), may</u> traverse the buffer;

(7) Notwithstanding the requirements stated above, stairways or similar structures maybe allowed with a permit from the Code Enforcement Officer, to provide shoreline access in areas of steep slopes or unstable soils provided: that the structure is limited to a maximum of four (4) feet in width; that the structure does not extend below or over the normal high-water line of a water body or upland edge of a wetland, (unless permitted by the Department of Environmental Protection pursuant to the Natural Resources Protection Act, 38 M.R.S.A. section 480-C); and that the applicant demonstrates that no reasonable access alternative exists on the property.

Sec. 78-1203. <u>Piers, docks, wharves, bridges and other</u> structures and uses extending over or <u>below the normal high water line of a waterbody or within a</u> wetland.

In the shoreland districts, the following are required for piers, docks, wharves, bridges and other structures and uses extending over or beyond the normal high water <u>line_of_a_</u>, waterbody or within a wetland:

(1) Access from the shore shall be developed on soils appropriate for such use and constructed so as to control erosion.

- (2) The location shall not interfere with existing developed or natural beach areas.
- (3) The facility shall be located so as to minimize adverse effects on fisheries.

(4) The facility shall be no larger in dimension than necessary to carry on the activity and be consistent with the surrounding character and uses of the area. A temporary pier, dock or wharf in non-tidal waters shall not be wider than six feet for non-commercial uses.

(5) Outside of the DD-1 and DD-2 districts, no new structure shall be built on, over or abutting a pier, wharf, dock or other structure extending beyond the normal high-water line of a water body or within a wetland unless the structure requires direct access to the water body or wetland as an operational necessity.

(6) New permanent piers and docks on non-tidal waters shall not be permitted unless it is clearly demonstrated to the Planning Board that a temporary pier or dock is not feasible, and a permit has been obtained from the Department of Environmental Protection, pursuant to the Natural Resources Protection Act. (7) No existing structures built on, over or abutting a pier, dock, wharf or other structure extending beyond the normal high water <u>line of a waterbody or within a wetland shall be</u> converted to residential dwelling units in any district.

(8) Except in the DD-1 and DD-2 districts, structures built on, over or abutting a pier, wharf, dock or other structure extending beyond the normal high water line_of a waterbody or within a wetland shall not exceed 20 feet in height above the pier, wharf, dock or other structure. In the DD-1 and DD-2 districts, structures built on, over or abutting a pier, wharf, dock or other structure extending beyond the normal high water line of a waterbody or within a wetland shall not exceed 35 feet in height above the pier, wharf, dock or other structure.

Sec. 78-1204. Campgrounds.

All campgrounds located within the shoreland <u>zone</u> shall meet the following additional criteria:

(1) The areas intended for placement of a recreational vehicle, tent or shelter, and any utility and service buildings or drainage and runoff control features, shall be set back a minimum of one hundred (100) feet, horizontal distance, from the normal high-water line of a water bodies, streams, tributary streams, or the upland edge of a wetland.

(2) Campgrounds in the shoreland zone shall contain a minimum of 5,000 square feet of land, not including roads and driveways, for each site. Land supporting wetland vegetation and land below the normal high water <u>line_of a waterbody shall not be</u> included in calculating land area per site.

Sec. 78-1205. Parking.

Notwithstanding article VIII, division 4 of this article, all parking areas in the shoreland <u>zone</u> shall meet the following additional criteria:

(1) Parking areas shall meet the shoreline <u>and tributary stream</u> setback requirements for structures for the district in which such areas are located. <u>The setback requirement</u> for parking areas serving public boat launching facilities shall be no less than fifty (50) feet, horizontal distance, from the shoreline or tributary stream if the Planning Board finds that no other reasonable alternative exists further from the shoreline or tributary stream.

(2) Parking areas shall be <u>adequately sized for the proposed use and shall be</u> designed to prevent stormwater runoff from flowing directly into a waterbody, <u>tributary stream or</u> <u>wetland</u> and, where feasible, to retain all runoff on site.

(3) In determining the appropriate size of proposed parking facilities, the following shall apply:

(a) Typical parking space: Approximately ten (10) feet wide and twenty (20) feet long, except that parking spaces for a vehicle and boat trailer shall be forty (40) feet long.

(b) Internal travel aisles: Approximately twenty (20) feet wide.

Within the shoreland zone the following standards shall apply to the construction of roads and/or driveways and drainage systems, culverts and other related features:

(1) Roads and driveways shall be set back at least 75 feet, horizontal distance, from the normal high water <u>line</u> of waterbodies, tributary streams, or the upland edge of a wetland unless no reasonable alternative exists as determined by the planning board. If no other reasonable alternative exists, the planning board may reduce the road and/or driveway setback requirements to no less than 50 feet upon clear showing by the applicant that appropriate techniques will be used to prevent sedimentation of the waterbody, tributary stream or wetland. Such techniques may include but are not limited to the installation of settling basins and/or the effective use of additional ditch relief culverts and turnouts placed so as to avoid sedimentation of the waterbody, tributary.

On slopes of greater than 20 percent, the road and/or driveway setback shall be increased by ten feet for each five percent increase in slope above 20 percent.

This subsection <u>does not</u> apply to approaches to water crossings <u>or</u> to roads or driveways that provide access to permitted structures and <u>facilities</u> located nearer to the <u>shoreline or tributary stream due to an operational necessity</u>, <u>excluding temporary docks</u> for recreational uses. <u>Roads and driveways providing access to permitted structures</u> within the setback area shall comply fully with the requirements of this subsection except for that portion of the road or driveway necessary for direct access to the structure.

(2) Existing public roads may be expanded within the legal road right-of-way regardless of <u>their</u> setback from a waterbody, <u>tributary stream or wetland</u>.

(3) New roads and driveways are prohibited in the shoreland resource protection district except that the Planning Board may grant a permit to construct a road or <u>driveway</u> to provide access to permitted uses within the district. A road or <u>driveway may also be</u> approved by the planning board in a shoreland resource protection district upon a finding that no reasonable alternative route or location is available outside the district. When a road or <u>driveway is permitted in a resource protection district</u>, the road and/or <u>driveway shall be set back as far as practicable from the normal high water line of a</u> waterbody, tributary stream, or upland edge of a wetland.

(4) Road<u>and driveway</u> banks shall be no steeper than a slope of two horizontal to one vertical and shall be graded and stabilized in accordance with the provisions for erosion and sedimentation control contained in article VIII, division 7 of this chapter.

(5) Road<u>and driveway</u> grades shall be no greater than ten percent except for short segments of less than 200 feet.

(6) In order to prevent road<u>and driveway</u> surface drainage from directly entering waterbodies, <u>tributary streams or wetlands</u>, roads<u>and driveways</u> shall be designed, constructed, and maintained to empty onto an <u>unscarified</u> buffer strip at least 50 feet plus two times the average slope, in width between the outflow point of the ditch or culvert and the normal high water <u>line</u> of a waterbody, tributary stream, or upland edge of a wetland. Surface drainage which is directed to an <u>unscarified</u> buffer strip shall be

diffused or spread out to promote infiltration of the runoff and to minimize channelized flow of the drainage through the buffer strip.

(7) Ditch relief (cross drainage) culverts, drainage dips and water turnouts shall be installed in a manner effective in directing drainage onto <u>unscarified buffer strips before</u> the flow <u>gains sufficient volume or head to erode the road, driveway or ditch.</u> To accomplish this, the following shall apply:

a. Ditch relief culverts, drainage dips and associated water turnouts shall be spaced along the road <u>or driveway</u> at intervals no greater than indicated in the following table:

b. Drainage dips may be used in place of ditch relief culverts only where the grade is ten percent or less.

c. On sections having slopes greater than ten percent, ditch relief culverts shall be placed at approximately a 30-degree angle downslope from a <u>line</u> perpendicular to the centerline of the road or driveway.

d. Ditch relief culverts shall be sufficiently sized and properly installed in order to allow for effective functioning, and their inlet and outlet ends shall be stabilized with appropriate materials.

(8) Ditches, culverts, bridges, dips, water turnouts and other stormwater runoff control installations associated with roads and driveways shall be maintained on a regular basis to assure effective functioning.

Notwithstanding those standards in article VIII, division 5 of this chapter, the following shall govern the use of signs in the <u>following shoreland zone subdistricts</u>: resource protection, <u>stream protection</u>, <u>shoreland residential activity and limited commercial</u>;

(1) Signs relating to goods and services sold on the premises shall be <u>allowed</u>, provided that such signs shall not exceed six square feet in area and shall not exceed two signs per premises. <u>In the Limited Commercial District</u>, however, such signs shall not exceed sixteen (16) square feet in area. Signs relating to goods or services not sold or rendered on the premises shall be prohibited.

Where possible, existing natural runoff control features, such as berms, swales, terraces and wooded areas, shall be retained in order to reduce runoff and encourage infiltration of stormwater<u>s</u>.

(b) Stormwater runoff control systems shall be maintained as necessary to ensure proper functioning.

Sec. 78-1209. Essential services.

(a) Where feasible, the installation of essential services in the shoreland districts shall be limited to existing public ways and existing service corridors.

(b) The installation of essential services, other than road-side distribution lines, is not permitted in a resource protection or stream protection district, except to provide services to a permitted use within such district or except where the applicant demonstrates that no reasonable alternative exists. Where, allowed, such structures and facilities shall be located so as to minimize any adverse impacts on surrounding uses and resources, including visual impacts.

(c) Damaged or destroyed public utility transmission and distribution lines, towers and , related equipment may be replaced or reconstructed without a permit.

(a) All subsurface sewage disposal systems shall be installed in conformance with the State of Maine Subsurface Wastewater Disposal Rules, and the following: a) clearing or removal of woody vegetation necessary to site a new system and any associated fill extensions, shall not extend closer than seventy-five (75) feet, horizontal

(b) The Maine Subsurface Wastewater Disposal Rules require new systems, excludingfill extensions, to be constructed no less than one hundred (100) horizontal feet from the normal high-water line of a perennial water body. The minimum setback distance for a new subsurface disposal system may not be reduced by variance.

Sec. 78-1211. Agriculture.

(a) All spreading of manure in the shoreland districts shall be accomplished in conformance with the *Manure Utilization Guidelines* published by the Maine Department of Agriculture on November 1, 2001, and the Nutrient Management Law (7 M.R.S.A. sections 4201-4209).

(b) <u>Manure shall not be stored or stockpiled within one hundred (100) feet, horizontal distance, of a great pond classified GPA or a river flowing to a great pond classified GPA, or within seventy-five (75) feet horizontal distance, of other water bodies, tributary streams, or wetlands. All manure storage areas within the shoreland zone must be constructed or modified such that the facility produces no discharge of effluent or contaminated storm water.</u>

(c) Agricultural activities involving tillage of soil greater than 40,000 square feet in surface area within the shoreland zone shall require a conservation plan to be filed with the planning board. Nonconformance with the provisions of said plan shall be considered to be a violation of this chapter.

(d) There shall be no new tilling of soil within one hundred (100) feet, horizontal distance, of the normal high water line of a great pond classified GPA; within seventy-five (75) feet, horizontal distance, of other waterbodies and coastal wetlands; nor within twenty-five (25) feet, horizontal distance, of tributary streams and freshwater wetlands. Operations in existence on the effective date of this chapter and not in conformance with this provision may be maintained.

(e) Newly established livestock grazing areas shall not be permitted within one hundred (100) feet, horizontal distance, of the normal high water line of a great pond classified GPA; within seventy-five (75) feet, horizontal distance, of other waterbodies and coastal wetlands; nor within twenty-five (25) feet, horizontal distance, of tributary streams and freshwater wetlands. Livestock grazing associated with ongoing farm activities and which are not in conformance with the above setback provisions may continue, provided that such grazing is conducted in accordance with a conservation plan.

(6) Except for water crossings, skid trails and other sites where the operation of machinery used in timber harvesting results in the exposure of mineral soil, roads shall be located such that an unscarified strip of vegetation of at least seventy-five (75) feet, horizontal distance, in width for slopes up to ten percent (10%) shall be retained between the exposed mineral soil and the normal high water line of a waterbody or upland edge of a wetland. For each ten percent (10%) increase in slope, the unspecified strip shall be increased by twenty (20) feet, horizontal distance. The provisions of this paragraph apply only to a face sloping toward the waterbody or wetland; provided, however, that no portion of such exposed mineral soil on a back face shall be closer than twenty-five (25) feet, horizontal distance, from the normal high water line of a waterbody or upland edge of a wetland.

(a) In the resource protection shoreland district, the cutting or removal of vegetation shall be limited to that which is necessary for uses expressly authorized in that district.

(b) In all other portions of the shoreland zone, and except to allow for the development of permitted uses, within a strip of land extending 75 feet, horizontal distance, from a waterbody, tributary stream, or the upland edge of a wetland, a buffer strip of vegetation shall be preserved as follows:

(1) There shall be no cleared opening greater than 250 square feet in the forest canopy (or other existing woody vegetation if a forested canopy is not present) as measured from the outer limits of the tree or shrub crown. However, a footpath not to exceed six (6) feet in width as measured between tree trunks and/or shrub stems is allowed, provided that a cleared line of sight to the water through the buffer strip is not created.

- (i) The 25-foot by 50-foot rectangular plots must be established where thelandowner or lessee proposes clearing within the required buffer;
- (ii) Each successive plot must be adjacent to, but not overlap a previous plot;
- (iii) Any plot not containing the required points must have no vegetation removed except as otherwise allowed by this chapter;

Notwithstanding the requirements of this subsection, no more than 40 percent of the total volume of trees four inches or more in diameter, measured at 4 1/2 feet above ground level, may be removed in any ten-year period.

(3) <u>In order to protect water quality and wildlife habitat, existing vegetation under</u> three (3) feet in height and other ground cover, including leaf litter and the forest duff layer, shall not be cut, covered, or removed, except to provide for a footpath or other permitted uses as described in 78-1213(b)(1) above.

(4) Pruning of tree branches, on the bottom one-third of the tree, is allowed.
(5) In order to maintain a buffer strip of vegetation, when the removal of stormdamaged, diseased, unsafe, or dead trees results in the creation of cleared openings, these openings shall be replanted with native tree species unless existing new tree growth is present.

This subsection shall not apply to those portions of public recreational facilities adjacent to public swimming areas as long as cleared areas are limited to the minimum area necessary.

(6) At distances greater than 75 feet, horizontal distance, from the normal high water <u>line of any other</u> waterbody, tributary stream, or the upland edge of a wetland, there shall be <u>allowed on any lot</u>, in any ten-year period, selective cutting of not more than 40 percent of the volume of trees four inches or more in diameter, measured 4 1/2 feet above ground level. Tree removal in conjunction with the development of permitted uses shall be included in the 40-percent calculation. For the purposes of these standards, volume may be considered to be equivalent to basal area.

(7) In no event shall cleared openings for development, including but not limited to principal and accessory structures, driveways and sewage disposal areas, exceed in the aggregate 25 percent of the lot area or 10,000 square feet, whichever is greater, including land previously developed. This shall not apply to shoreland <u>zone subdistricts in the BRD, GB-1, GB-2, AO, DD-1, DD-2 and NC districts</u>.

(8) Legally existing nonconforming cleared openings may be maintained, but shall not be enlarged, except as <u>allowed by this chapter</u>.

(9) Fields and other cleared opening which have reverted to primarily shrubs, trees, or other woody vegetation shall be regulated under this section.

No activity in the shoreland districts shall deposit on or into the ground or discharge to the waters of the state any pollutant that, by itself or in combination with other activities or substances, will impair designated uses or the water classification of the waterbody, tributary stream or wetland.

Sec. 78-1218. Definitions exclusive to shoreland zone.

As used in this division and applied in the shoreland zone and its subdistricts, the terms listed below have meanings set forth below, whether or not such terms are otherwise defined elsewhere in this chapter. Terms not listed below have the same meanings as in sec. 78-1 of this chapter.

Basement means any portion of a structure with a floor-to-ceiling height of 6 feet or more and having more than 50% of its volume below the existing ground level.

<u>Commercial use means the use of lands, buildings, or structures, other than a "home occupation," the intent and result of which activity is the production of income from the buying and selling of goods and/or services, exclusive of rental of residential buildings and/or dwelling units.</u>

<u>Driveway means a vehicular access-way less than five hundred (500) feet in length</u> serving two single-family dwellings or one two-family dwelling, or less.

Expansion of a use means the addition of one or more months to a use's operating season; or the use of more floor area or ground area devoted to a particular use.

<u>Foundation means the supporting substructure of a building or other structure, excluding</u> wooden sills and post supports, but including basements, slabs, frost walls or other base consisting of concrete, block, brick or similar material.

<u>Height of a structure means the vertical distance between the mean original (prior to construction) grade at the downhill side of the structure and the highest point of the structure, excluding chimneys, steeples, antennas and similar appurtenances that have no floor area.</u>

Increase in nonconformity of a structure means any change in a structure or property which causes further deviation from the dimensional standard(s) creating the nonconformity such as, but not limited to, reduction in water body, tributary stream or wetland setback distance, increase in lot coverage, or increase in height of a structure. Property changes or structure expansions which either meet the dimensional standard or which cause no further increase in the linear extent of nonconformance of the existing structure shall not be considered to increase nonconformity. For example, there is no increase in nonconformity with the setback requirement for water bodies, wetlands, or tributary streams if the expansion extends no further into the required setback area than does any portion of the existing nonconforming structure. Hence, a structure may be expanded laterally provided that the expansion extends no closer to the water body, tributary stream, or wetland than the closest portion of the existing structure from that water body, tributary stream, or wetland. Included in this allowance are expansions which in-fill irregularly shaped structures.

Industrial means the assembling, fabrication, finishing, manufacturing, packaging or processing of goods, or the extraction of minerals.

Institutional means a non-profit or quasi-public use, or institution such as a church, library, public or private school, hospital, or municipally owned or operated building, structure or land used for public purposes.

Lot coverage means the total footprint area of all structures, parking lots and other nonvegetated surfaces within the shoreland zone.

Lot width means the closest distance between the side lot lines of a lot. When only two lot lines extend into the shoreland zone, both lot lines shall be considered to be side lot lines.

<u>Public park means a tract of land owned by the Town of Old Orchard Beach and</u> available to the general public for recreational purposes.

Residential dwelling unit means a room or group of rooms designed and equipped exclusively for use as permanent, seasonal or temporary living quarters for only one family at a time, and containing cooking, sleeping and toilet facilities. The term shall include mobile homes and rental units that contain cooking, sleeping and toilet facilities regardless of the time period rented. Recreational vehicles are not residential dwelling units.

Structure means anything built for the support, shelter or enclosure of persons, animals, goods or property of any kind, together with anything constructed or erected with a fixed location on or in the ground, exclusive of fences, and poles, wiring and other aerial equipment normally associated with service drops as well as guying and guy anchors. The term includes structures temporarily or permanently located, such as decks, patios, and satellite dishes.

(c) *Special exceptions.* In addition to the criteria specified in subsection (b) of this section, the planning board may approve a permit for single-family residential structure in a resource protection district provided that the applicant demonstrates that all of the following conditions are met:

(1) There is no location on the property, other than a location within the resource protection district, where the structure can be built.

(2) The lot on which the structure is proposed is undeveloped and was established and recorded in the registry of deeds of the county in which the lot is located before the adoption of the resource protection district.

(3) The proposed location of all buildings, sewage disposal systems and other improvements are:

a. Located on natural ground slopes of less than 20 percent; and

b. Located outside the floodway of the 100-year floodplain along rivers and artificially formed great ponds along rivers and outside the velocity zone in areas subject to tides, based on detailed flood insurance studies and as delineated on the Federal Emergency Management Agency's flood boundary and floodway maps and flood insurance rate maps; all buildings, including basements, are elevated at least one foot above the 100-year floodplain elevation; and the development is otherwise in compliance with any applicable municipal floodplain ordinance.

(4) If the floodway is not shown on the Federal Emergency Management Agency Maps, it is deemed to be one-half the width of the 100-year floodplain.
