## Piping Plovers and Dogs

- Irv brought a photo of Saco's beach leash law: All dogs must be leashed on Saco beaches from April 1st thru September 30th. Also - 12 foot leash max and stay 200 feet from areas marked for piping plovers
- Underneath is a sign provided by Maine Audubon, Fish & Wildlife, etc. of information about piping plovers
- Our sign welcome to our beach, dogs leashed Memorial Day to Labor Day from 9-5
- Kimbark will contact Lisa about OOB's new leash law: Same as Scarborough dusk till 9 am can be unleashed, then no dogs on beach 9-5, then leashed 5 pm to dusk
- We need consistent signage for the new law. Kimbark will call Lisa about signs.
- Eventually new laws and enforcement.
