Attending this portion of the meeting were Mr. and Mrs. Rick White, Kelsey Daniels and Jeanna Martez. There was an extensive discussion on covenants as it related to the Bread and Breakfast restrictions. A covenant is a rule governing the use of real property. Prospective buyers enter into such covenants as a condition of purchasing the land. Condominium associations and housing cooperatives make use of covenants for the benefit of all residential owners and their neighbors for better safety and cooperation. It should be noted that covenants, conditions, and restrictions (also called "CC&Rs") are used by many "common interest" developments, including condominiums and co-ops, to regulate the use, appearance, and maintenance of property. CC&Rs, most commonly drafted and enforced through homeowners' associations (HOAs), often restrict what homeowners can do on their property. There are at times some restrictive covenants in the condominium association documents mean they don't exist. This makes it hard or impossible for the Town to enforce anything because it is not stated that the Town has that option.

There was discussion with the Council on this item with questions about the activities being considered as far as the rentals and Councilor Tousignant felt it should be discussed at the next meeting when the public would have access to the discussion.
