TOWN OF OLD ORCHARD BEACH Administrative Review Board Minutes

Thursday, September 17, 2020, 2pm Town Hall Council Chambers

Meeting Convened: Thursday September 17, 2020 @ 2:06pm

The Administrative Review Board convened to review the status of the business license issued to GFB Scottish Pub, 34 Old Orchard Street and to consider a recommendation to Town Council regarding suspension or revocation of the business license.

Summary of Discussion:

Beginning with a summary by Chief Dana Kelley in which he stated OOB PD had been called for service multiple times over the last 12 months. Majority of the calls were for noise complaints but he stated there were other issues directly related to social distancing, crowd management and security; as evidenced by video collected.

Video presentation (totaling 45 minutes worth of video) displayed what were alleged GFB patrons participating in alleged public urination, large group congregations with little regard to social distancing and facial coverings, physical altercations, a hit-and-run, and an alleged illegal drug exchange.

Abutting business neighbor, Bob Gurry, Owner – Beach Villa, offered a statement in writing (see attached) as well as video evidencing increased noise late into the evening by the GFB.

Chief Fred LaMontagne stated that the situations occurring at the GFB were not top of scale of compliance and he noted an ongoing challenge to see compliance. Furthermore, it was noted that when some compliance to social distancing & COVID protocols was evidenced it was observed towards the early parts of the business' operating hours and less so during the later parts of the business' hours of operation. Moreover, Chief LaMontagne noted multiple occasions when corrective action of violations occurred only when OOB PD or FD were on site for inspection or a call for service.

Town Manager Larry Mead noted that what was most disturbing was the atmosphere of fighting and public urination at the establishment. Chief Kelley followed up by stating that the atmosphere at the GFB attracts negative behaviors, noting that a past hearing for the same alleged behaviors.

Robert Greenlaw, Owner GFB, defended that these actions were isolated incidents at the GFB noting there was a level of hysteria from individuals being locked in quarantine due to COVID-19.

Chief LaMontagne & Town Manager Mead stated they were both leaning towards full revocation of the GFB's business license and were concerned that the Greenlaws did not comprehend the severity of the issues at hand.

Tina Kelly, Business Representative, voted for limited outside seating (10pm curfew), increased security outside and in parking lot, and increased parking lot lighting. Furthermore, Rickey advised the Greenlaws to create a plan to improve the parking lot layout, containment fencing, g and constant security.

Jeffery Hinderliter, Town Planner, stated that a <u>written plan</u> of the GFB plan-of-action to improve the issues noted in the hearing were due to Town Hall by Friday 9/25/2020.

Expansion of Licensed Area to serve food and alcohol

Given the slow progression of allowing us to open our inside dining we are asking to <u>add</u> an area of service to allow us to serve more patrons.

I have attached a set of plans outlining the area we are currently licensed for the service of food and alcohol and a plan showing the area we would like to add service.

The "back" parking area of 32 Old Orchard Street has an entrance of Imperial Street that has been blocked by a dumpster so no vehicular access to or from Imperial Street.

We would extend "chains" across the area of the dumpster from the GFB building corner to the corner of the Beach Villa motel to eliminate patrons walking of the premises with alcohol. The access point between the GFB and Beach Bagel will be monitored by an employee of the GFB Scottish Pub to check ID's and monitor traffic to the back-parking lot.

We would like to add this area to expand the social distancing area and give people ample area to move around and enjoy the outdoors.

We plan to use this area from the time we open, which could be as early as noon and close the expanded area approximately one-half hour after sunset.

As we stated a trained employee will always be observing the area.







In an effort to clearly define your license premise and the areas that consumption and storage of liquor is allowed, The Liquor Licensing & Inspection Division is requiring all applicants to submit a diagram of the premise to be licensed in addition to a completed license application.

Diagrams should be submitted on this form and should be as accurate as possible. Be sure to label the areas of your diagram including entrances, office area, kitchen, storage areas, dining rooms, lounges, function rooms, decks and all areas that you are requesting approval from the Department for liquor consumption.



My name is Robert Gurry. My wife and I have owned and operated the Beach Villa at 17 Imperial Street for the past 15 years. We are seasonal and known for family friendly lodging. We take pride in our business and services we offer.

I'm here today, not specifically asking that the GFB be shut down, yet, at a minimum, to request major changes and stricter requirements for compliance to be added to GFB's business license.

I'll be honest, these past 8 years being next door to the GFB have been tough and this year the GFB has managed to hit a new low – basically showing a complete and utter disregard for anyone other than themselves including disregard for the town by not following guidelines to be open under the current COVID-19 situation. There is no question that this has negatively affected our business and the town.

This year: The loud noise, with yelling and screaming, the fights (from single attacks to all out brawls) the parking lot tailgate parties with the back and forth and back and forth between the cars and the bar throughout the night. The continued partying and noise after hours. The blatant lack of compliance with COVID regulations. The level of intoxication including a number of patrons unable to stand/walk on their own when leaving. The side parking lot abutting our building and the back of our building has become GFB's outside urinal. Most recently (this past weekend) one of the GFB regulars (following a group discussion in front of the GFB entrance and pointing at the Beach Villa) proceeded to walk over and urinate right at/onto our office window — exposing himself roughly 15 feet away from where our teenage daughter was. All of this has affected the quality of our product. We have had number of complaints (usually about the noise) from our guests, yet, also many anecdotes that began with "Did you see what happened next door at the bar last night?!"

I'd like to play one video that I believe sums up what we've put up with this summer. It is important to note that this was taken after the owner went in front of the town to request the new regulations be overturned (saying things are better and noting the effective security in place). ****VIDEO****

I would appreciate you considering this information while deciding if any amendments to GFB's license are necessary. Thank you.
