Come one, come all. Also let me remind you of the Chili Fest on the Pier on Saturday, September 17th at non which will benefit the Community Watch.

ACCEPTANCE OF MINUTES:

Discussion with Action: Accept the Town Council Minutes of August 19, 2016.

MOTION: Councilor Tousignant motioned and Councilor Kelley seconded to Accept the Minutes as read.

VOTE: Unanimous.

BUSINESS LICENSES AND APPROVAL:

CHAIR: I open this Public Hearing at 6:34 p.m.

Marcia Noyes, Steve Noyes, Amy Greenlaw (323-10-17), 32 Randall Avenue, one year round rental; and Lori Sylvester (207-2-13-207), 161 Saco Avenue, Unit 206, one year round rental.

CHAIR: I close this Public Hearing at 6:34 p.m.

MOTION: Councilor Tousignant motioned and Councilor Blow seconded to Approve the business licenses as read.

VOTE: Unanimous.

TOWN MANAGER'S REPORT:

Dunegrass Litigation: Good news received when Superior Court Judge ruled in the Town's Favor. Pine Ridge Realty filed suit against the Town claiming that the Planning Board erred in its approval of a 24-unit subdivision. The Judge found that the Planning Board acted appropriately.

More Dunegrass: The Town Manager met with representatives of the DRA and Maine Water to discuss concerns related to both ownership and maintenance of water infrastructure. This issue has been linked to the litigation concerning the subdivision. Maine Water is attempting to obtain ownership and responsibility for the water lines in the Long Cove neighborhood and the related Wild Dunes Way developments. Currently Pine Ridge Realty retains ownership of that infrastructure. We also discussed sidewalk maintenance and development in this area. The neighborhood is seeking to have a sidewalk put in along Wild Dunes Way between Dirigo Road and Ross Road. The Town Manager is going to meet with the Residents Association this Fall.

Grant Opportunities: The Town is continuing work on obtaining CDBG grants for infrastructure and neighborhood improvements to the Washington Avenue and Atlantic Avenue area. In order to apply for funding in early 2017, the Town will be conducting door-to-

door survey work in the next few weeks in that neighborhood between 1st Street and Saco Avenue. The purpose is to document that the average income levels for this neighborhood are within grant guidelines.

Worker's compensation Dividend: The Town received a reimbursement dividend of \$7,500 from the Maine Municipal Association in recognition of the low incidents of works compensation claims for the 2014 calendar year.

Labor Negotiations: We have reached a tentative agreement on a new three year CBA with the Police Union. The Union membership will be voting on the agreement and if the membership approves the agreement it will then come to the Council for consideration at the next meeting. We have also renewed bargaining with the Fire Union for the contract that expired this past June. Finally, I expect to begin in the next month or so negotiations with the new bargaining unit representing administrative support staff at Town Hall.

Dunkin Donuts: They paid permit fees this week (\$12,000) so this project is moving forward.

Cascade Road: Paving work will begin this week between Ross Road and the Saco Town Line. Funding is shared equally between the Town and the State through the PACTS municipal parking initiative.

The Town Manager serves as a member of the Executive committee for PACTS, which oversees transportation planning and allocates infrastructure investments of State and Federal funds. Today I was able as a member of that Committee to assist the Old Orchard Beach/Biddeford/Saco regional bus service to secure \$32,000 in funds to be used this year to implement new ways to improve service for our residents who have mobility limitations.

NEW BUSINESS:

The Ballpark Commission is recommending the appointment of John Gallo as a Regular Member of the Ballpark Commission.

It should be noted that Arundel Ford submitted two bids. The first bid for \$27,994 does not have cloth seats and does not meet the specifications. The second bid for the 2016 F-350 from Arundel Ford at \$29,165 does meet the specifications. The bid from Rowe Ford at \$26,660.15 has a white exterior and also does not meet the specifications.

The Waste Water Superintendent is recommending accepting the bid of \$30,415 with a trade in of the 1997 Ford F-350 for \$1,250, for a total amount of \$29,165 from Arundel Ford.

RE: ORDER #6783 RENEWAL OF WASTE HANDLING CONTRACT WITH BBI

This order would extend the contract with BBI for handling trash and solid waste pick-up and recycling materials for an additional 3-year term to 2019, with two 2-year options that would extend the contract to 2013. The option years are automatic unless either party provides notice of discontinuance 90 days prior to the renewal date. The annual cost of the service is tied to changes to the Consumer Price Index (CPI). There will be no cost increase in FY17 as compared to FY16. Because the CPI has been quite stable in recent years the cost to the Town for waste collection has also remained stable over the life of the current contract.

The RFP for the current agreement was issued by the Town in 2009 and included a provision for an initial seven-year contract with an option for another seven years. The contract approved by the Town Council in 2009 also provided for the option to extend the agreement for another seven years.

BBI has done an excellent job over the years. They are very flexible and responsive to resident needs and issues. The Town Manager's office receives very few complaints from property owners and residents regarding trash collection. For this reason and because the pricing terms are favorable to the Town I recommend Council approve the contract renewal.

Attached for your review are the proposed Addendum and the current contract.

ADDENDUM TO CONTRACT FOR SOLID WASTE COLLECTION SERVICES BY AND BETWEEN BLOW BROTHERS, INC. d/b/a BBI WASTE INDUSTRIES, AND THE TOWN OF OLD ORCHARD BEACH, MAINE

Original Agreement Dated October 6, 2009

THE PARTIES AGREE THAT THE FOLLOWING PROVISIONS SHALL BE BINDING UPON THE PARTIES AND SHALL SUPERSEDE ANY PROVISIONS IN THE AGREEMENT WHICH CONFLICT WITH THIS ADDENDUM.

1. Section 2.1, Term and Contract Price shall be deleted in its entirety and replaced as follows:

The initial Contract period will be for seven (7) years beginning October 5, 2009 and ending October 4, 2016. The contract will contain renewal options for a three year period beginning October 4, 2016 and ending October 4, 2019, a two year period beginning October 5, 2019 and ending October 4, 2021, and a two year period beginning October 5, 2021 and ending October 4, 2023. If the Town and/or the Contractor choose not to exercise a renewal option written notice of intent not to renew an option period must be given by either party at least 90 days prior to the starting date of a new option period.

2. Section 2.3 shall be deleted in its entirety and replaced as follows:

The Contractor shall dispose of municipal solid waste at the facility approved to receive the Town's waste and dispose of recycling materials at the facility approved to receive the Town's recycling materials.

3. Section 2.5 (c), Contract Cost shall be amended by adding the following language:

Beginning October 5, 2016 the rate of annual increase will be determined by the U.S. Department of Labor's Northeast CPI-U average for December of the previous year.

4. Section 5.2, Liability Insurance and Indemnification shall be amended by adding the following:

Nothing herein shall, nor is intended to, waive any defense, immunity or limitation of liability which may be available to the Town or its respective officers, agents and employees, under the Maine Tort Claims Act or any other privileges and/or immunities provided by law.

5. All other terms and conditions of the Agreement remain the same.

Councilor Blow informed the Council that he is no longer a partner but does have affiliations and therefore will abstain from voting.

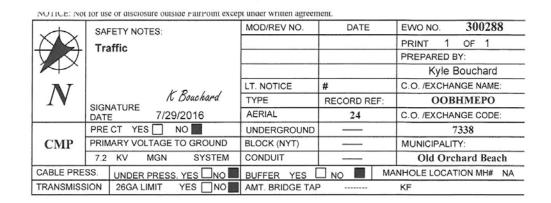

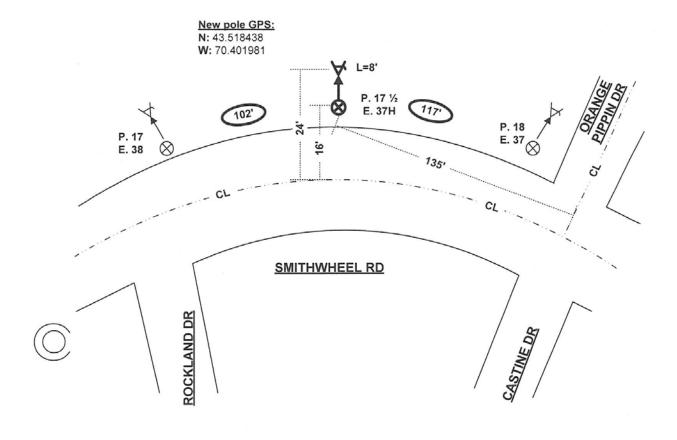
