Town Manager's Report

Parking Ban: With this week's snow event starting tomorrow evening a parking ban has been posted starting Wednesday, February 22 at 7:00 am until Saturday morning, February 25 at 7:00 am.

When a <u>PARKING BAN</u> is declared, vehicle parking on public streets will not be allowed until the emergency ban is officially lifted. Residents can park their vehicles in the Milliken Street parking lot, Veterans Memorial parking lot, and Ocean Park Square during the <u>PARKING BAN</u>.

Community Animal Watch: There are currently four open seats on the Community Animal Watch Committee, and we need your help. This is a group that helps our pets in need and OOB residents that are having a hard time caring for them. The committee was active in fundraising efforts and also active in pursuing donations of pet supplies that are offered through the Community Food Pantry. Bus Fare Discounts:

The southern ME Transit agencies are promoting a discounted bus fare campaign called "Fare Deal" that runs from March 1st through September 30th. All bus fares will be half off the regular bus fare during this promotion, with a goal of increasing ridership to pre-pandemic levels, and to help those transit users hit hard by inflation. The participating agencies are BSOOB (Biddeford Saco Old Orchard Beach Transit), Greater Portland METRO, and South Portland Bus Service.

This campaign is part of a collaboration between the three agencies, where each designated funding for this as part of the American Rescue Plan Act.

Community Resiliency Partnership Workshop 2/13/2023:

Last week on February 13th a workshop was held to learn more about climate change and what Old Orchard Beach can do to be more resilient. The Town is enrolling in the State's Community Resiliency Partnership or CRP program, in partnership with Southern Maine Planning and Development, to better understand what is important to Old Orchard Beach and the priorities for addressing local climate change. Part of the process it hear receive public feedback on what is important to you with regards to climate change. We had a good turnout for the workshop and received helpful feedback, but there is still time for your comments.
