Alvarez the property owner of 2 Randall Ave, identified on the Town Assessor's Map as 324-15-9, of a solar light pole and fixture to be installed at the coastal dune on Randall Ave, replacing the CMP LED street light, and the acceptance of funds in the amount of \$2,500 to be held in escrow to supplement the existing 10-year warranty to provide a total of 20-year maintenance period.

The town manager and public works director have been working with the developer of 2 Randall Ave to replace the CMP streetlight and pole at the dune with a comparable solar light to eliminate overhead wires. Council approved the CMP pole permit to move the pole at the end of the street further inland along Randall Ave. The developer has received approval from DEP on the replacement pole and solar light in the dune. The Town Manager has discussed with the Town's attorney the process and concluded that it is best if the property owner gift the light to the town along with the funds to maintain it for a period of 20 years. The replacement light is comparable lumens to the old light being removed.
