Your Town Council has worked diligently this past year to govern fairly and budget responsibly. We have contracted our Dispatch Services to the Town of Sanford, a move that shortens response times and cuts our Dispatch costs. You now have a Community Garden where you can grow fresh vegetables and flowers while interacting with friends, neighbors and community members. We have adopted the PACE - Property Assessed Clean Energy program that makes low interest loans available for energy efficiency improvements to your homes. In an effort to make the air we all breathe cleaner we passed a resolution discouraging the use of tobacco products on the beach. This coming summer you should see signage as you enter the beach saying 'PLEASE DO NOT USE TOBACCO PRODUCTS ON OUR BEACH.'

This year your Council conducted 13 public workshops, going thru the entire budget line by line, resulting in a budget that maintains the services we believe you want with no increase in your property taxes.

I and my Council colleagues realize little could be done without a capable and willing operational and administrative town staff, the volunteers who put in countless hours at The Ballpark, the involvement of the many citizens serving on committees, boards and commissions, and the numerous residents who serve as good will ambassadors for our community. Your Town Council extends a heartfelt THANK YOU for all you do to make Old Orchard Beach the gem that it truly is.

DEDICATION TO:

It is my privilege as the Chair of the Old Orchard Beach Town Council, to dedicate this year's Annual Report to "one of our own" who has served with distinction and honor – Shawn Edward O'Neill.



SHAWN EDWARD O'NEILL

Shawn Edward O'Neill is the son of Old Orchard Beach residents, Edward 'Ted' and Jacqueline O'Neill. He is a 1982 graduate from Old Orchard Beach High School where he was involved in many activities including the Cross Country and Track Teams, Ski Club, Marching, Concert and Jazz Bands. Shawn was recognized nationally by "Who's Who in Music" in his junior and senior years. It was perhaps as a Southern Maine Delegate and Alternate to Boy's State that ignited his interest in public service. To this day Shawn is a member and continuing supporter of the Old Orchard Beach Alumni Association.

Shawn's service to our community began in 1980 when as a sophomore in High School he joined the Fire Department's call force – that service continued through 1997 when he retired with the rank of Lieutenant. During that period he was able to squeeze in the time to serve as a Reserve Police Officer from 1986 to 1989. In 1997 Shawn was elected to the first of what would turn out to be seven consecutive terms covering fourteen years of service as a Town Councilor. During some of those years he served as Council Chair and Vice Chair. Over his years there were millions of dollars in upgrades to the Wastewater Treatment Plant; the purchase of a ladder truck for the Fire Department, which was first presented at a cost of \$800,000 and was challenged by Councilor O'Neill, with a final cost of \$500,000; the establishment of a rotation system for purchases of emergency and Public Works vehicles; construction projects including the new Athletic Field at Loranger Middle School, (the road we now know as Dirego Drive), and the new Police Station; creation of a contract zone for the construction of the Grand Victorian; completion of the "missing mile" on East Grand Avenue from Kinney to Walnut; installation of lights and the resurrection of the Ballpark; recently new bleachers for our High School Football Field; and support for upgrades to Memorial Park; all over years of countless Council Meetings and Workshops.

Shawn's professional career began in 1984 as an Electricians Apprentice at the Portsmouth Naval Shipyard. In 1986 he transferred to the U.S. Postal Service here in Old Orchard Beach as a letter carrier and later served as Service Associate and Acting Postmaster. Over the past several years he has held a multitude of positions of increased responsibilities with the postal service including Supervisor of Customer Services at the Kennebunk and Biddeford Post offices, Interviewer, Route Examiner and Auditor. Currently Shawn is the Acting Postmaster in Scarborough and was recently elected Vice President of Customer Services for the National Association of Postal Supervisors.

With possible future State government aspirations, Shawn is currently 'resting and residing' in his new home in Saco. Shawn is an Old Orchard Beach 'home-town boy' who has given much to our Town and who, with the connection of his parents and property here, continues to be very connected and grateful to a community that he has so ably served for thirty consecutive years.

TOWN MANAGER



Dear Town Council and Citizens:

I welcome Mark Pearson to the Town of Old Orchard as the new Town Manager. I wish you a long and successful tenure.

I leave this assignment as your Town Manager as positive as I was two-and-a-half years ago when I arrived. Working for the Town of Old Orchard Beach has been a great experience and I will sadly miss the opportunity to serve this great community. But most people know – winding down one's work commitment is a natural event in everyone's career. I have worked over forty years as a School Principal, Superintendent of Schools and Town Manager which adds up to "it is time to slow down." My goal is to stay involved in Old Orchard Beach in some small way; nothing would please me more than to be able to stay connected to this great community.

During the 2010-2011 calendar year Old Orchard Beach benefited from the ambitions of the current Public Works Director, Bill Robertson, and his ten man crew who tackled a number of major street and infrastructure repairs. New sewer lines, new storm drainage and new street surfaces are evident throughout the Town. Construction work funded by a local Bond is addressing the flood concerns of West Grand Avenue area which is resulting in good results. Although the Town will likely always be subject to flooding due to its close proximity to the sea water level and rain event flooding seem to be diminished as a result of the construction effort. Future Tide Gate reconfiguration remains in the hand of the engineers and the Department of Environmental Protection, but will likely create additional flood controls.

E. Emmons Cummings Boulevard has been reconstructed with an emphasis on safety for the school children and will receive its final new asphalt surface in the spring and is a remarkable improvement from the past. A new traffic light intersection is scheduled for construction with a new right-hand turn lane being added to assist traffic headed to the beach.

Many people have remarked on the shabby exterior of our beautiful Town Hall. A number of years ago the building was painted and due to weather conditions the paint did not adhere well to the wood shingles. In addition, particularly on the sea side of the building, there is noticeable wood rot that needs to be replaced. Because repainting the building may not be the best choice the Town is exploring replacing the current shingles with siding that resembles the exact look of the current shingles. Because of the historic nature of the Town Hall facility it is important to maintain the building by keeping its original look. The Town has a budget of 2/3 of the payment cost and it is my hope the Town Council will provide the additional 1/3 during the next budget cycle. It would be wonderful if the project could be started in late spring/beginning of summer and be completed by the fall season. I believe we all agree the current look of disrepair is not the image we want for one of the most beautiful building in Town.

In last year's Town Report I thanked the voters for the support of the new Police Station. The station has opened and is serving the needs of the Police Department very well. If you have not had the opportunity to visit the facility, feel free to contact Chief Dana Kelly and I am sure he would be happy to give you a tour of this great building. The project was a stress-free experience and the Town is grateful to Benchmark Construction who was the General Contractor. The project resulted in a surplus balance of approximately \$270,000.

This year I am pleased to thank the voters once again for the support of a renovation and addition to the Edith Belle Memorial Library. As a result of your positive vote the Library is planning a major expansion project. Currently TFH Architect from Portland Maine is drawing up the construction documents and the Town will soon be in the construction business for the second time in the last two years.

The retirement announcement of the Library Director, Eileen McNally, was recently announced. Eileen is turning over of her responsibility to Lee Koenigs. Although Eileen may be relinquishing her duties as Director, reports indicate she has accepted the position as the Library's Assistant Director allowing Eileen to assist with the transition. Eileen has been a major influence throughout her leadership years at the Library and much of the Library's success can be attributed to her dedication. I am sure the Town is sad to see her relinquish her Director position but her willingness to stay connected is greatly appreciated.

I can't possibly leave this position without a special thanks to the staff who are the proud employees of Old Orchard Beach. I was very fortunate to have received their individual support. I arrived inexperienced and untrained and they accepted me for what I was and assisted me in the undertaking of my responsibilities as Town Manager. I believe the Old Orchard Beach Municipal staff is the backbone and strength of the Municipal structure.

A very special thank you to Assistant Town Manager, V. Louise Reid, who has experienced many changes in the Town Manager's Office. Louise provided me with all the possible support a person could ever ask. She was a great Assistant Town Manager as well a very special "right hand" for me. Her dedication to Old Orchard Beach will never be matched and her friendship will always be appreciated.

Old Orchard Beach faces many challenges but I am confident the Town Council, Municipal staff and the local citizens will meet the challenges with enthusiasm and will always make decisions in the best interest of "the Beach."

Thank you for allowing me to be a part of your community.

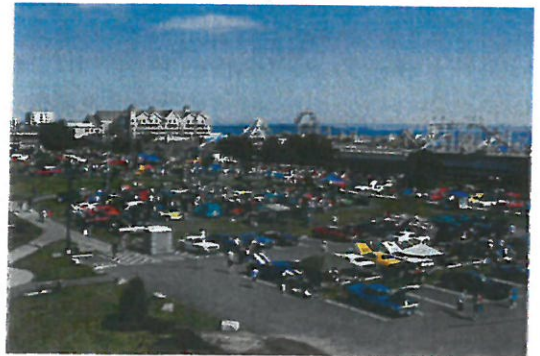

TOWN CLERK:

To the Citizen's of Old Orchard Beach

I am truly honored to provide you with information about the activities of the Town Clerk's Office.

The Office of the Town Clerk is responsible for all the records of the town, including all birth, death and marriage records, issuance of marriage licenses, all meeting minutes from the Town Council, School Board, as well as all boards appointed by the Town Council. This Office is also responsible for Elections, hunting and fishing licenses, horse permits, as well as dog licenses, and parking permits. The Town Clerk's Office also issued Passports until June 14th, 2011. At that time, the Federal Government mandated that municipal offices that handle vital records (birth, death and marriage) are no longer grandfathered and cannot handle Passports. The Code Enforcement Office in Town Hall is now an authorized Passport Acceptance Agent.

The breakdown of licenses issued are as follows:

Sadly, the Town of Old Orchard lost Paul Robillard, who worked for the Public Works Department from October of 2002 to February of 2005; Robert Chamberlain, a member of the Recreation Committee in 1971; Shirley Mullen, a Libby Memorial Library Trustee for many years; Faith Hogan, the beloved wife of our State Representative, George Hogan; Robert LoPresti, a member of many boards and committees, including the Town Council, Zoning Board of Appeals, Design Review Committee, Planning Board, Director of the Biddeford/Saco/OOB Transit Committee, and generously donated flowers to Memorial Park each year; and John Margarones, who chronicled the history of Old Orchard Beach in the 1930's and 40's for educational research;

The real estate market for Southern Maine properties, particularly for seacoast communities such as Old Orchard Beach, has continued to slow down when compared with the past several years. In FY '11 the assessing office reviewed several hundred permits resulting in approximately \$6,419,380 of new growth. The Town's total valuation went up approximately \$12,890,240. The mill rate increased by .46 from 12.94 to 13.40. The median assessment ratio (assessment ratio = assessment divided by sales price) is approximately 98% which means properties are being assessed at about 98% of their fair market value. This is an increase of 1% from the FY'10 ratio indicating a continued slight softening in some areas of the local real estate market. The assessment ratio has moved closer to fair market value as of April 1, 2010.

The challenges for assessing in this difficult economic period have provided us opportunities to explore better ways for public understanding of the importance of the assessing office in maintaining a stable, fair, and equitable taxation base. Our focus has always been to provide the public with all the information necessary to make the best decisions on whatever situations are at hand. Transparency is key.

Our goal will continue to be to provide an equitable and accountable real estate based assessment program that is fairly administered as outlined in the State Statues governing property assessment. The assessment ratios will also continue to be in compliance with the standards for quality assessment as outlined by the International Association of Assessing Officers.

There are programs such as the Homestead Exemption and Veteran Exemption available to those residents who qualify to help alleviate some of the tax responsibility and are outlined on the Town's website and are also available in our office in the Town Hall. These forms are due in the Assessor's Office by April 1st in order to be applied to the next fiscal year.

Report of the Town Planner

After 3 years of fine service with the town of Old Orchard Beach, Gary Lamb left the position of town planner and continued his public service work as a town manager in Northern Maine. Also, Jessica Wagner, the assistant town planner, chose to depart our town and continue her studies towards a graduate degree. The town decided to take a new direction and consolidate the town planner and assistant town planner positions into one. After several months of reviewing resumes and interviewing candidates, I was hired as your new town planner and began work during May 2011.

As your Town Planner, my primary responsibility is to coordinate growth and development in Old Orchard Beach through the administration of local, state, and federal laws, regulations, and ordinances. Some of my duties include responding to requests for assistance on all land use development questions, reviewing development proposals and plans, creation and implementation of the comprehensive plan, economic development, staff advisor for the Planning Board, Design Review Committee and Comprehensive Plan Committee. One particular upcoming challenge is the creation of an entirely new comprehensive plan. Some highlights from July 2010 – June 30, 2011 are below.

- A new planner was hired during 2011.
- The creation of a new comprehensive plan began.
- Planning Board activity began to increase with more proposals coming to the board during the latter part of this reporting period then during the past several years.
- Town takes the first steps toward creating an economic development office without staff increase.
- Active participation with regional planning programs such as the Eastern Trail, New England Passenger Rail Association and the Sea Level Action Work Group.

The Planning Department is a key contact point for all development inquiries and economic development matters. The Department routinely answers citizen questions whether planning related or not. The Planning Board members are Chair Win Winch, Vice Chair Don Cote, Tianna Higgins, Mark Koenigs, Eber Weinstein, and alternate David Darling. I feel very fortunate to have such a committed, hard-working group. Every month, the Planning Board holds a workshop on the first Thursday at 6:00 PM and a regular meeting on the second Thursday at 7:00 PM. Meetings are held at town hall in the Council Chambers.

Design Review Committee. The Design Review Committee (DRC) is responsible for conserving the cultural architectural heritage of our town, providing technical design assistance to property owners, and promoting quality architectural design and historically sensitive building renovation as a means of sustaining economic vitality and stable property values. The DRC is responsible for reviewing and providing recommendations on exterior building/structure and property modifications, alterations, additions, new construction, and demolition within specific locations of town. The DRC offers a recommendation on the above-mentioned proposals which is then brought to the Planning Board for the final decision. The DRC meets on the first Monday of each month at 7:00 PM in the Council Chambers. Between July 2010 and June 2011, the DRC considered the following proposals:

BUILDING INSPECTIONS & CODE ADMINISTRATION

July 2010 – June 2011

Annual Report

The primary responsibility of the Building Inspections and Code Administration Office is to protect the public health, safety, and general welfare of all of the Citizens and Visitors of the Town of Old Orchard Beach through the administration of various Local, State and Federal Laws and Ordinances. To help achieve that goal, the office reviews plans and issues general building permits, electrical permits, internal plumbing and septic system permits. The Staff also conducts progress inspections relative to each of those permits, as well as all Business License application sites for compliance with applicable provisions on the Housing, Plumbing, Electrical, Life Safety/ Fire Codes and the Town's Zoning Regulation. This is limited to new licenses, changes in ownership or licensed properties that have delayed their renewal or that complaints have been filed against. Our staff responds to hundreds of complaints annually about violations of the Town's various Ordinances. Our Department works very closely with the all of the Town's Departments and State Agencies to maximize service to our broad range of clients.

Our personnel continue to improve their code knowledge by attending continuing education classes and seminars sponsored by various governmental agencies. Staff members also maintain memberships in the Maine Building Officials & Inspectors Association, the National Fire Protection Association, and the International Code Council.

Our State and Nationally Trained and Certified Staff assists residents in determining flood zones, base flood elevations, and requirements relative to Federal Emergency Management Agency (FEMA) Floodplain Management Standards. We also assist in identification of location, setbacks, activities, and permits required in area regulated by the State Department of Environmental Protection (DEP) pursuant to the Natural Resources Protection Act (NRPA) The areas include: Coastal and Inland Wetlands; Rivers, Streams, and Brooks; Significant Wildlife Habitat; Resources of Special Significance; and Coastal Sand Dune Systems.

Old Orchard Beach participates in the Community Rating System through the National Flood Insurance Program (NFIP) overseen by FEMA. Because the Staff is committed to provide an elevated level of services, The Town has maintained a level 8 CRS Rating which entitles residents who hold flood insurance policies a discounted rate. FEMA released new Flood Insurance Rate Maps which, after significant Community outreach, and study, were withdrawn The Town and FEMA is partnering in a new program called RiskMap which will be a collaborative effort to create the most accurate Flood Insurance Rate Maps.

The Code Enforcement Officer and Administrative Staff are the staff support to the Zoning Board of Appeals which meets monthly as needed to consider a variety of Zoning Appeals and the Ordinance Review Committee which met every two weeks reviewing all of the Town's Ordinances and recommends changes to the Town Council.

Once again, I have enjoyed serving as Local Health Officer for the Town of Old Orchard Beach. The complaints have included:

1. Illegal tattooing, and referred to the Police Department, and the state licensing agency.
2. Mold issues.
3. Bed Bugs.
4. Lack of water in a rental.

Mold issues can be eradicated by keeping all components of the structure dry and clean. Any moisture needs to be identified and the source resolved to insure the dry and clean status which inhibits spore growth.

All used items brought into a structure must be examined closely for the presence of bed bugs. Although they do not transmit disease, they are aesthetically undesirable, and can lead to the assumption of uncleanliness. They do not only appear in beds. They can be in clothes, under chairs, and other furniture, as well as on picture frames, and other permanent fixtures in the structure.

I met with the Bar & Restaurant Association to review issues that may surface for the upcoming tourist season.

Reported influenza cases were at a normal to low level.

CONSERVATION COMMISSION ANNUAL REPORT

July 1, 2010 to June 30, 2011

The Conservation Commission has been busy working on its mission to obtain information about and to create an index of unique natural areas and open spaces in town, conduct research into local land areas and coordinate with other local conservation organizations.

The Commission has spent much of the last year reviewing information compiled by the Maine Department of Inland Fisheries and Wildlife and distributed to us via their Beginning with Habitat series of maps. These include specific information on our town's high value plant and animal habitats, water resources and riparian habitats and areas of open space.

Utilizing this information, we have compiled a preliminary list of our unique natural areas, including, of course, the beach itself as well as areas of old growth pines, piping plover and least tern nesting areas and our town-owned "blueberry plains" property on Ross Road. More information about areas listed in the inventory can be found on the town's web site. The list is a living document meant to be revised and updated, and so any input from interested citizens is welcome.

The Veteran's Memorial Park Subcommittee of the Conservation Commission also remains very active in maintaining and improving that very popular piece of property, along with the town's Department of Public Works. The subcommittee sponsors an annual cleanup and plant sale at the park, and continues to add amenities to the facility. A nightly flag raising ceremony was added this year to park activities.

An Alternative Energy Subcommittee was formed to facilitate the placement of a temporary anemometer tower on E. Emerson Cummings Boulevard in order to collect data on the feasibility of a wind power site in the vicinity. The study has been completed, with data showing that wind speeds are marginal for moving ahead with any turbine(s) at this time.

In April, the Conservation Commission co-sponsored an Earth Day event with the Recycling Committee at Memorial Park. Several participants from OOB and nearby towns provided displays and information on their organizations' work.

In June, the commission conducted a clean-up at the blueberry plains site on Ross Road. Two full one-ton dump truck loads of debris were removed, and the Department of Public Works upgraded the parking area at the site. Plans are underway to improve signage and erect a kiosk at the property.

The Conservation Commission welcomes new members and ideas for upcoming projects.

**FIRE DEPARTMENT
ANNUAL REPORT FY 2011**

The Old Orchard Beach Fire-Rescue Department continues its mission to supply fire prevention and suppression protection to the citizens of Old Orchard Beach. Accomplishments this year include:

- Placed a new 2010 Ford/PL Custom ambulance into service as our primary ambulance.
- Continued to enhance our fire prevention program by expanding outreach efforts to elderly community and participated in the York County Juvenile Fire Setter Education program.
- Expanded our Fire-Police program to assist with security and traffic direction at major incidents and added new personnel.
- Continued our participation in the Maine Healthy Beaches program to include Goosefare Brook monitoring.
- Purchased new firefighting equipment for our Career & Call Force.
- Expanded our training programs to reach more Call Force personnel.
- Became NIMS compliant according to Federal Regulations.
- Placed an 18 foot Boston Whaler surf rescue boat into service.
- Began remodeling plans for the vacant police services wing of the public safety complex.

We continue to pursue fire prevention through inspections and educational activities and have reduced the number of accidental fires annually in Town. Our in-house training program has been expanded to include more firefighter safety programs for personnel.

Our lifeguard staff, under the direction Captain Keith Willett, continued to provide safe beach activities with additional towers, manpower, and have updated their equipment to include additional rescue boards. The close proximity of another Hurricane Irene made life guarding challenging for several days at the end of summer. OOB lifeguards hosted the New England Lifeguard Competition and our personnel placed well in many categories.

Old Orchard Beach Life Guard Report

The 2011 summer season was very busy for the Old Orchard Beach Lifeguards. Lifeguards responded to 145 emergency calls, over an 11 week period this past summer. There were 86 swimmers rescued from the surf by lifeguards, 4 of which were transported to the hospital via ambulance. As a result of many storms up and down the east coast during the winter of 2009, there was a large amount of beach erosion along the coast. This erosion resulted in the formation of new sandbars along the shoreline, these sandbars in turn created powerful riptides up and down the beach. By summer 2011 the shoreline had changed again and most of the danger zones were eliminated.

On top of rescuing swimmers from the surf, guards also responded to 24 medical emergencies, removed 2 sexual predators from the beach, assisted the police 9 times with unruly subjects on the beach, and reunited 78 lost children with their parents or guardians.

The Northern New England Lifesaving Championships were held in OOB this year. The team of guards, made up of a great group of veterans and outstanding rookies competed against 9 other beaches from Northern New England. Like last year the competition came right down to the final two events, the teams from Ogunquit Maine, Salisbury Mass, and Old Orchard Beach were only separated by 1 or 2 points. Unfortunately Old Orchard was not able to come out with a 1st place finish but took many trophies.

We are also planning once again to host the Northern New England Lifesaving Championships in 2012, so throughout the winter the lifeguards will be busy at work to try to ensure that it is a big success. The staff is looking forward to having some fun competing against other services from around Northern New England while at the same time raising money for some great charities.

The 2011 summer season has unfortunately come to an end and with many things in the works for the 2012 season the lifeguard staff is looking forward to working with town officials throughout the winter to make the beach a safer and even more enjoyable experience.

Jack Turcotte, Town Manager, Mike Nugent, Code Enforcement Officer and the Public Works Department, all participated in seeing that this project moved forward with Public Works doing much of the sewer and water line work which saved a great deal of money which went back into the building itself. Lastly, I want to thank the Town Council for supporting the project and voting to let the citizens decide whether to build a new building or not. For anyone who would like a tour of the new building please stop by and we will happy to show you around.

This year also saw the contracting of dispatch services with the Town of Sanford with the objective of this change to reduce our annual cost for dispatching services. There were some immediate reductions in our dispatch operating costs and we expect that they will continue to grow as we move forward. We are very satisfied with the service that Sanford has provided and I expect that it will improve as we go.

Animal Control Officer – Annual Report 2010-2011

Old Orchard Beach Animal Control is continuing its mission to ensure the health and welfare of all animals within the town. This year the ACO and the Police Department answered 1282 calls relating to animal welfare, most involved domestic animals, but several complaints were related to wild animals.

In the last fiscal year there was one case where a pet was bitten by a wild animal, the animal was captured and tested positive for rabies. There was also two additional cases two cases where rabies were suspected, however because no humans or domestic animals were bitten, the Dept. of Health & Human Services decided not to test the animals in question.

The ACO continues to work with the Old Orchard Beach Community Animal Watch (CAW), with a lot of the effort being put into the establishment of a pet food pantry. Currently the ACO & CAW work with the Salvation Army's food bank to distribute dog and cat food to those in need. Hannaford's and a private donor in Old Orchard Beach have donated much of the food.

Through the assistance of a training grant the ACO has attended a week long class on animal cruelty investigations that was hosted in South Portland. The ACO has also completed the training program and testing process to become nationally certified through the Nation Animal Control Association.

Town of OOB Wastewater Department FY 11 Annual Report

The Wastewater Department oversees the operation and maintenance of the wastewater facility and remote pump stations. Approximately 450,000,000 gallons of waste water is treated on an annual basis. While our federal and state permit requires that 85% of the pollutants are removed; the staff and facility routinely see removal rates of 95%. In 2010 the department applied for and was granted a five year discharge permit. Because the facility did not violate its discharge parameters in the previous license period, the town received the new discharge permit without any additional treatment requirements or additional cost to the taxpayer. Budgeting continues to be a difficult task and meeting the challenges of helping taxpayers minimize their costs are a priority. Recent agreements with our electrical supplier have reduced electrical supply costs significantly in 2011 and the most recent agreement will see additional savings in 2012. An ongoing agreement with Enernoc allows the department to shed electricity usage during high demand which earns dividends back to the town at about \$6,000 per year. Although not a major impact on the budget; chemical costs have gone up slightly making efficient application even more important. In the fall of 2010 the West Grand PS upgrade was completed on time and on budget. Although the footprint of the building stayed the same, the inside of the pump station has been totally changed. New pumps are designed for summer and winter flows. Employees now have added safety features such as automated gas detection and proper ventilation. As with all remote pump stations, West Grand pump station status is now reported to a central computer located at the wastewater facility allowing employees to have a real time view of operations.

In 2010 the Chief Operator retired and due to budget constraints the position has not been filled. Although some of the tasks that fell on their shoulders were challenging; they both filled the void and continue to work together to meet discharge license parameters. It is certainly a benefit to the town to have employees that are willing to take on new challenges. In November of 2011 the DEP inspector came down for an annual inspection and the report complimented the staff on the condition of the facility. I would also like to congratulate Larry Thomas for his forty years of service to the town and his willingness to be flexible in the face of adversity.

The maintenance staff was also impacted by the temporary loss of one of the more experienced mechanics. This void was filled by the existing maintenance department and the hiring of a new employee. As usual, the maintenance staff has worked diligently to insure that the equipment is working at full capacity and any down time is minimal. The maintenance staff also completed numerous pump and equipment replacement projects at the facility and pump stations. A grinder which had originally been approved for replacement was rebuilt at half the cost of a new one. I would like to congratulate the Department Foreman Mike Hersey for passing his Grade II Wastewater License!

Staff is often required to respond to alarms in inclement weather. Alarms include extended power outages, mechanical failures, electrical failures and heavy rainstorms. Ongoing

training and experience with equipment is vitally important for a safe and efficient response. Recently, the department recently asked SafetyWorks to a voluntary audit and although there were some minor violations the Maintenance Department moved quickly to remedy these unsafe situations. Staff will continue to work together in getting the proper safety training and insuring that record keeping is kept up to a high standard.

Finally, I would like to thank the town council and administration for their willingness to allocate the proper funds to insure that the facility and pump stations run at a high level. Although many of the tasks performed here are routine; this department especially thrives on capital improvement projects (CIP) that make this a safer and more efficient operation. Technological advances are a big part of the operation and can be a bit challenging at times. They are however worth the effort and in the long run a benefit to the taxpayers of Old Orchard Beach. This department looks forward to future projects and hopes the council and administration will continue to study the CIP needs of this department that were spelled out in a 2009 engineering report.

PUBLIC WORKS DEPARTMENT ANNUAL REPORT 2011-2012

The Public Works Department is responsible for protecting the public's investment in the complex infrastructure that is necessary to support the physical operations of the Town. Our staff is responsible for streets, sidewalks, parking lots, sewer and storm drain lines (including catch basins & manholes), beach, parks/green space, transfer station (leaves and brush only), solid waste, recycling with respect to the Silver Bullet at DPW, fleet and facility management, and tide gate & outfalls.

CAPITAL FUNDING: Approval from the voters in November 2007 supporting an infrastructure bond package of 5.3 million in an effort to more efficiently and effectively carry out the strategic plans of the DPW. The following projects were targeted for major infrastructure improvements over the next few years. The following is an updated status of the projects.

Ocean Ave/Seaview Ave Sewer Project:



Dear Citizens of RSU #23,

In this, my first, annual report on the status of the district, I have the pleasure of taking note of several important positive developments, while also being the bearer of some rather sobering financial news, but I will save the financial update for the end!

The citizens and parents of the RSU have much to be proud about in the quality of educational programs offered by the district. Since coming to the district last July, I have been extremely impressed by the quality of teaching that goes on in our classrooms, and the quality of educational leaders supporting that work. I have often stated that the presence and quality of teacher leaders are good indicators of the overall health of a school system. Here in RSU #23, we are truly fortunate to have numerous teacher leaders serving in roles involving instructional improvement, curriculum design, assessment development, and data analysis. Likewise, our building principals are a visionary and child-focused group who provide practical, daily expertise to keep our programs strong.

At the top of the list in district-wide work is the development of the RSU #23 Strategic Plan. Begun over a year ago, the district vision will be completed in the 2011-12 school year, and will include a detailed implementation plan for the next five years. A primary concern of the School Board in developing the Strategic Plan has been the involvement of citizens and parents. The public's voice was elicited in the early steps in plan development, and care was taken in drafting the plan to ensure that the public's input was incorporated. The final plan addresses broad categories of action, including teaching and learning, professional staff, facilities, finances, and public engagement. The Board has also been very clear in its commitment to identifying a set of measurable targets that will be used over the life of the plan to assess how effectively our goals have been met. In the meantime, we will post updated information of the district's website and try to keep the public informed and involved.

This year also saw the passage of a new cost-sharing plan for the three towns that comprise the RSU. One of the most important aspects of the discussion was clarifying that the cost-sharing plan—no matter what it is—pertains to only about 6% of the district's \$43 million expenditure budget. The remaining part of the budget is determined by Maine school finance law. I know I speak for the Board in expressing my gratitude for the positive vote in favor of the new plan, which passed by solid majorities in each of the three towns. As one of our Board members expressed at the public hearing prior to the vote, "We must consider these issues as members of the same school district, not as three separate towns." Along with the Strategic Plan, the cost-sharing plan is a step in solidifying our future as a strong and mutually beneficial school district.

But Strategic Plans and cost-sharing formulas are not the most important aspects of the work of this past year. Much more significant are the ongoing efforts among teachers and administrators to improve, even reinvent, our educational practices. From strengthening reading instruction through implementing the Readers' Workshop model to creating a new interdisciplinary "academy" approach to learning at Old Orchard Beach High School, our teachers are energetically working to improve student learning through thoughtful innovation. Teachers and administrators have also worked hard to building a common vision for excellent instructional practice, and constructing a new evaluation system linked more closely to that vision than in the past. Sixteen principals and 19 teachers took part in a course on the "Skillful Teacher," a landmark book on effective teaching practices.

I have truly enjoyed my first few months on the job, and I look forward to working hand-in-hand with municipal officials, parents, and community members to build an education program that is second to none in the state.

The 2010-2011 school year got off to a great start. As of Friday, October 1, 2010, Jameson School had 221 students. Of this 221, 127 are boys and 94 are girls. Our three kindergartens had 17, 17 and 16 students. Our three first grades had 16, 14 and 14 students. Our four second grades had 19, 19, 18 and 18 students. Our three third grades had 17, 18 and 17 students. All 13 of our classrooms fall within the RSU 23 School Board's preferred class size range.

Breakfast in the Classroom, (BIC) is having a very positive affect on our school climate. All 13 classrooms are participating in this terrific program that allows all of our students to have breakfast in their own classroom between 8:30 and 8:45 every morning, free of charge. Before this program began, Jameson School fed between 25-45 students breakfast on a daily basis. With BIC, Jameson is now feeding 155-175 student's breakfast on a daily basis. This is great news for our school!

Tuesday, October 12th – Friday, October 22nd was the official testing window for Jameson School's administration of the New England Common Assessment Program (NECAP). The purpose of this testing is to determine student achievement of Grade Level/Span Expectations (GLE's and GSE's) in Reading, Writing, and Mathematics as required by the *No Child Left Behind Act of 2001*.

Our Jameson School PBiS (Positive Behavioral interventions & Supports) Assemblies have proven to be a great addition to our school culture. This is our opportunity to reach all of our students with common language regarding our school rules, expectations and our social skills curriculum. We also look forward to sharing classroom performances, guest readers and speakers.

Jameson School's Technology capabilities continue to grow. We saw the installation of 8 SMARTBoards and 1 additional portable SMARTBoard. A SMARTBoard is a digital whiteboard that is touch sensitive and runs off of local computer system resources. It is an interactive whiteboard that can save and store any information that is written on it, as well as enable the user to refer to notes downloaded from the Internet or other sources. We have had one training on the use of SMARTBoards already this year and expect another new training each month for a total of 10 SMARTBoard trainings this year. Also, FastMath is up and running for our 3rd graders. Fast Math is a software package that helps all students develop fluency with basic math facts with 10 minutes of use daily.

The Scholastic Book Fair followed the same schedule, as did our parent teacher conferences. Candice LaSalle and Lisa Giese were of huge help to Beth Orlando, our new librarian, in setting up and running this book fair. It looks like we sold a bit more than we did last year and, as a result, have earned more than \$2000 in Scholastic Bucks, good for any books or products Scholastic has to offer.

volunteer time. We have begun our annual Giving Tree program and have coordinated these efforts this year with our local Toys for Tots in hopes of reaching an even larger audience. This is happening again, in large part to Jan Clark, the Jameson staff, and Jameson's students and their families. What a terrific testament to our Jameson community as a whole!

Mr. Lafortune, our superintendent, and the RSU 23 School Board have frozen the RSU 23 budget effective January 3, 2011, for the remainder of the school year. This budget freeze has been made in hopes that RSU 23 might save funds to be carried over to the 2011-2012 budget.

At the superintendent's request, we have begun work on our 2011-2012 school budget proposals to the school board. Due to impending changes in our federal and state subsidies, Mr. Lafortune has asked us to include a 0% increase from our 2010-2011 budgets. This will mean that Jameson will again be unable to fund field trips of any kind and nor will we be able to support outside learning programs such as the Children's Museum program funded this year by our PTO.

At our weekly Jameson Assembly on Thursday, January 6th, we celebrated our first Caught Being Good recognition and lottery. Caught Being Good is a Positive Behavior Support, PBS, which we are piloting. This program focuses on those students who are witnessed doing an exemplary job of following one of Jameson School's 4 tenets, (be honest, be safe, be respectful, follow rules.) 37 students, grades K-3, were recognized in our first week of the program. Marcus Gaudet, Mrs. Boucher's class grade 2, was selected as our first winner. Marcus earned a \$10 gift certificate to McDonald's, (presented by our local Rotary president, Dru Laduke), and a goodie bag of school supplies. The Rotary has pledged to offer a \$10 gift certificate to each week's winner throughout this school year.

The first annual Jameson School Yearbook continues to take shape. We are currently taking pictures of those students who have entered Jameson School since our fall picture day in hopes of including those students in our upcoming Yearbook. In discussions with our Life Touch representative, Sue Briggs, we can expect a few sample copies of this Yearbook sometime just after our April vacation.

Kindergarten screening for next year's incoming kindergarteners was a big success. We held three full days of screening, Tuesday, May 24th through Thursday, May 26th. This screening is required by Special Education law and is meant to identify those students in need of special education. At Jameson, we also involve our kindergarten teachers as this is a prime opportunity to "get to know" our incoming students and to have a better idea for their classroom placements. This year we had 50 students screened and this number is a bit higher than usual. As we are a transient school, we do expect to have another 5 or 6 incoming kindergarteners join us during the summer months. These students, and any that may have missed our screening dates, will be screened at the start of next school year.

Our Books for Bikes program was a huge success! To have been eligible for this program, students needed to be a part of the Jameson Reading Team for at least three months of this 2010-2011 school year. To be a part of the Jameson Reading Team, students need to have read or be

read to for 20 minutes 20 days during that month outside of the school day. Books for Bikes had 6 winners, randomly drawn from each grade level K-3, a Librarian pick and a Principal's pick. Paul Golzbein and the Golzbein Family Literacy Foundation, sponsors of this program, have promised to make this an annual event for Jameson School! The winners are as follows...

Our summer Brain Boost program is ready to go. In an effort to help our students avoid the "summer slide", (educational research demonstrates that a majority of K-12 students regress in terms of academic skills during the summer vacation due to lack of use), we have compiled what we hope to be enjoyable yet appropriate activities that we hope will help our students be ready for a strong start to next school year. All of the students who complete this summer work will be honored at an ice cream party at the end of our first week back to school and be eligible for some cool prizes! Further, as we know that this work isn't possible without help at home, all parents who sign off on their child's summer efforts will be entered into a drawing for some gasoline gift cards. It is our hope that everyone benefits from this program!

The Jameson School Evening of the Arts was again a big success! Following this event we were able to again select student artwork for the Principal's Collection. A panel of staff members independently judged all artwork and two pieces per grade level were selected. One piece from each grade level was an "honorable mention" piece. These pieces will be framed and hung in our hallways for all of next school year. The second piece from each grade level was a "permanent collection" piece. These pieces will be framed and hung in our hallways forever and for always. All eight artists and their families should be very proud. Those selected are as follows...

Finally, we are preparing to interview candidates for our many openings for next school year. Due to four retirements and a resignation, the following openings exist at Jameson School... Title 1 teacher, 2 first grade classroom teachers, a Special Education teacher with a strength in behavioral strategies, and a part-time school nurse. (Due to the reduction in force called for by the School Board, Erin Fleming, currently teaching 5th grade at LMS, will be joining us as a 3rd grade teacher for next school year.) It is our hope to make our great school even greater with these new hires. I look forward to sharing our new hires with you soon.

Town Report

Loranger Middle School – 2010-2011

Loranger Middle School is one of eight schools in RSU #23 (OOB/Saco/Dayton). It is located in Old Orchard Beach, and is one of two middle schools in the district, serving students in grades 4-8. We began the year with approximately 326 students and ended the school year with 305 students. At this point in the 2011-2012 school year, our present enrollment is 311 students. This past year Loranger had 51 professional staff; 37 teachers, 14 support staff, 1 guidance councilor, 1 social worker, 2 secretaries, and 2 administrators. Janet Giguere left her 5th grade teaching position to take a literacy specialist position in the district, and to replace her we hired Casey Rossignol. Our long time office secretary, Natalie Picard, retired after 35 years of service to the parents, staff, and students of Old Orchard Beach. Sheila Johnson, a long time ELA teacher at LMS, took disability retirement this year as well. Both Natalie and Sheila will be greatly missed by the Loranger community. In April of this past year the RSU #23 school district hired a new superintendent to replace the retiring Michael Lafortune. The new superintendent is Patrick Phillips who was previously the superintendent in RSU #61. This year Principal Crocker is serving as the President of the Maine Principals' Association, which is an honor he accepted with the support to the RSU administration and the staff at LMS.

Once again, this past year was a very challenging budget year. Early in the year we went into a district-wide discretionary budget freeze that had some impact on our educational programming throughout the district. But in lieu of this restricting spending, the LMS staff continued to provide both meaningful and valuable experiences for our 300+ students. Two main goals for the year were realized – 1. Demonstrated high academic performance which was evident by making (AYP) Adequate Yearly Progress, which we did not make the previous year, and 2. Implementation of a school-wide RtI (Response to Intervention) initiative, that provides academic support to struggling students, through different tiered interventions.

Some Highlights of the 2010-2011 School Year:

- ❖ Active Loranger PTO that hosted a number of fund-raising events throughout the year (i.e. Kids Night Out, Penny Social) that raised money to support music camp scholarships, Camp Kieve scholarships, and materials for the academic classrooms.
- ❖ 8th grade Camp Kieve week-long experience at the leadership school
- ❖ 7th grade Camp Kieve day-long experience with adventure-based learning
- ❖ Continued work with the Center for the Prevention of Hate through the Unity project initiative – an anti-bullying & harassment program
- ❖ School-wide “Red Ribbon Week” celebration focused on no tolerance for drugs
- ❖ 6th grade awareness – day program focused on team-building skills and responsible decision-making
- ❖ STAR Day – A day that focuses on diversity/tolerance/respect/& safety. The presenter/performer this year was Johnny the “K” who did an outstanding job getting his message across to the school-wide audience.

- ❖ In February the 8th graders participated in the State History Day competition. We had a number of LMS students who were recognized for their fine efforts in this competition.
- ❖ In February, we had our annual LMS Talent show which showcased many talented students who performed in the show. There were 18-20 different performances by students in grades 4-8.
- ❖ In the Spring 7th graders participated in a “JA in a Day” activity. This is sponsored by Junior Achievement and gives great exposure to our students in helping to connect the learning environment with the real-world environment of business.
- ❖ Also in the spring the 7th and 8th grade participated in a Career Day that was sponsored and organized by our LMS guidance counselor – Beth Nason.
- ❖ In early June, LMS hosted the annual “Evening of the Arts” event where we showcase the artistic talents and musical talents of our LMS students.
- ❖ In late May, the LMS Drama club, under the direction of Jessie Hemphill, hosted a series of mini-skits as their drama production for the year.
- ❖ With the help of some Title I parent involvement funds, the LMS Title I team hosted a musical literacy event that featured the “High Ryders” Band, which is the band that our music director George Shabo plays with.

OLD ORCHARD BEACH HIGH SCHOOL- ANNUAL TOWN REPORT 2010-2011

The Old Orchard Beach High School enrollment began August 31, 2010 at 295 students and ended in June 2011 at 274. The first day of school, August 31, was devoted to the freshman class. To start the day, students were welcomed and introduced to all of the faculty and staff. They then met with their advisors to go over rules and school policies, walk through their schedules, and met with their teachers. The day concluded with a scavenger hunt and the distribution of "Class of 2014" t-shirts. On September 1, all students were back at the high school for their first official day. An assembly to welcome students and introduce new faculty and staff started the day. Students then met with their advisors before attending a full day of classes. The High School held its sixth annual Freshman Cookout on the lawn in front of the high school on September 8. We had a wonderful turnout of parents and students on a glorious fall evening. Many thanks go to Mr. Trull and Mr. Walsh, who took on the grilling responsibilities. Mrs. Bartlett and Mr. Mondor, Freshman advisors, teachers, and the three high school secretaries all helped out to make it an informal opportunity for parents and teachers to introduce themselves and put a face with a name. It was a good evening for all.

Homecoming activities were held the week of Sept. 27th. The Student Council and Mr. Parise did a fabulous job of organizing and successfully running the week long Spirit Week Activities. The various activities were highlighted by the annual Thursday night Bonfire and with the Saturday night Homecoming Dance.

October started with all sophomores and juniors taking the PSATs on the 13th. On the 14th, the guidance department hosted a College Information Night in the high school cafeteria where our guidance counselors presented material to seniors and their parents regarding the college application and selection process. Also on October 14 all sophomores attended Sophomore Awareness day at Camp Ketcha in Scarborough. Students discussed a wide range of topics including anti-harassment and alcohol and drug education awareness. This program has been extremely informative and beneficial to our students.

The academic focus of November is always Parent Conferences. This year's parent conferences were held on the evening of Thursday, Nov. 18 and on Tues., Nov. 23. We ended with more than one third of our parents participating in conferences. The Interact students have been hard at work volunteering around the Community. A handful of members volunteered at Seasons by the Sea event in December. A couple even dressed up as reindeer and greeted children. They also raised money to buy gifts for the giving tree at Loranger.

On December 22, 53 seniors from OOBHS attended a seminar on financial literacy. This was a full-day presentation by Mark Jones and his colleagues from Saco & Biddeford Savings Institute. Using collaborative and interactive activities and materials, the students learned about budgets, credit, marketing, saving, and investing. This was a fabulous seminar teaching extremely important information. Our seniors were actively engaged in the presentation and found the information to be highly relevant.

On January 7th, an alumni luncheon was held in the Achievement center. Fifteen alumni returned to talk to seniors about their experience of college life. Spring College Night was held on Feb. 10, 2011. All sophomore and junior students and parents were invited to come and learn about the college search process. Guidance will be meeting with all juniors individually this spring for additional future planning. On Martin Luther King Day, a few members volunteered with T.A. Interact members and people from surrounding communities to help support people who are in need of certain items/services. In February, the Interact club visited the Barbra Bush Children's Hospital to celebrate Valentine's Day.

March 2nd, in an effort to promote current HS programs and offerings, the guidance department held an informal meeting for 8th grade parents and students to meet with current HS staff, parents and students. The evening was a huge success with $\frac{3}{4}$ of our students being represented. In March, Interact members volunteered for Mary's walk and made story markers for the students at Loranger middle school.

A group of ten adventurous Old Orchard Beach High School students and teachers spent their 2011 February vacation exploring Costa Rica. The travelers began with an 18-hour visit to Costa Rica's bustling capital, San Jose. There, students practiced speaking Spanish and enjoyed local food and entertainment. The group left the city behind them to spend two nights sleeping in a secluded rain forest lodge, only accessible by an hour-long boat ride on jungle rivers and canals. Students and chaperones shared their cabins with lizards, scorpions, and mosquitoes. Rainforest hikes offered sightings of poisoned dart frogs, cocoa trees, monkeys, and spectacular views. Wildlife like crocodiles, otters, birds, and monkeys were spotted from various boat rides. After departing from the jungle, our Old Orchard Beach explorers zip lined through the canopy of the rain forest. They whitewater rafted down one of the Americas' cleanest rivers. Students hiked and kayaked along the lush base of a volcano that was actively spewing smoke and lava. The group soaked in the mineral waters of natural hot springs heated by the volcano. The tour included horseback riding, visits to coffee and banana plantations, and waterfalls galore. Students swam in the Caribbean Sea as well as the Pacific Ocean. The group was impressed with the beauty of Costa Rica, and came home with thousands of photographs. All travelers returned home with a greater worldview, a better understanding of Costa Rican land and culture, as well as a renewed appreciation for the benefits of living in the United States. On the heels of this very successful trip, plans are beginning for a visit to the Mediterranean coast in April of 2012.

Interact worked closely with the American Red Cross to host a Blood Drive on May 3, 2011 in the gym at Old Orchard Beach High School. About 15 Interact students worked the Blood Drive throughout the day. In total, about 43 people donated blood. They collected 28 pints of blood in total. The donors consisted of students, faculty, and staff of Old Orchard Beach High School along with the Old Orchard Beach community. Overall, it was an excellent turnout and the American Red Cross was pleased with how smoothly everything went.

Saturday, May 7th, SATs were a huge success with all expected students in attendance. The Maine Principal's Association recognizes one senior from every high school for outstanding academic achievement and citizenship at a banquet held on April 2. This year Taylor Mazoian was recognized for this outstanding distinction. The Western Maine Conference Principals recognized two seniors from each of the 15 conference schools for their outstanding achievements at a Citizenship Awards Banquet that was held on May 9 at Kelley's the Caterer. This year's recipients from OOBHS were Victoria Bryan and Gillian Foss.

On May 13, the high school held its annual prom at Dunegrass Country Club. We had 106 students attend. It was an enjoyable night for all. On June 2nd, the high school held its annual Awards Night to recognize students from grades 9-12 for their academic achievements over the course of the school year. Twenty-eight students were recognized for earning high or highest honors for the first 3 quarters of the school year. The top 10 stoles were awarded to: Taylor Mezoian, Gillian Foss, Maryanne LaFollette, Victoria Bryan, Shelby Bourgault, Michelle Johnson, Kelsey Koenigs, Brett Allen, Kathryn Hatch, & Ariane Bouchard. The salutarian was Gillian Foss and Valedictorian was Taylor Mezoian. Three College Book Awards were also presented to 3 outstanding juniors: Rebecca Wittman received the Dartmouth College Book Award, Adam Nye received the Brown University Book Award, and Cody Stack received the Bowdoin College Book Award. The school year concluded for seniors on Sunday, June 5th as we graduated 54 seniors. The ceremony was held at the Seaside Pavilion.

**Old Orchard Beach School Department
Special Education Annual Report

The Special Education Department of the Old Orchard Beach Schools is responsible for providing an appropriate education to all students with disabilities in accordance with Federal and State laws. The State of Maine defines the following disability categories to which schools must be responsive:

The school is responsible for developing an Individual Educational Plan (IEP) for each student with a disability. This plan is developed in an IEP team meeting attended by the student's parents, classroom teacher, special education teacher and a school administrator. Parental consent is required before a student can be evaluated or receive services through the special education department. 144 students received special education and supportive services in the Old Orchard Beach Schools. The special education teachers who provided services to our students are as follows:

In addition, speech and language therapy is provided to eligible students in grades K-12 by Deborah Maksut, Maureen Butler and Sandra Welzel. Lisa Kurtz and Molly Walrath provide occupational therapy. We contract with Mainely Kidz PT to provide physical therapy. Laurel Tinkham, psychological examiner provides evaluations and consultation for our special education students. A total of 2 students were placed in special programs outside of our public schools in order to receive appropriate special education programming.

The Old Orchard Beach Schools also provide Title I services to students in grades K-12 who could benefit from remediation in reading and in math. Title I personnel provide these services through the direction of classroom teachers to approximately 105 students. Our Title I personnel are as follows:



As we begin a new year, I welcome this opportunity to share some of my recent work for the people of our great state.

The economy and jobs remain my highest priorities. More efficient transportation is essential to our economic growth. After a years-long, hard-fought battle, I successfully pushed through Congress a bill I wrote to allow the heaviest trucks to travel on Maine's federal interstates, instead of forcing them to use our secondary roads and downtown streets. This will make our streets safer, reduce fuel consumption, and allow our businesses to be more competitive. I was pleased to have the support of many Maine groups, from the Maine State Police and the Parent-Teacher Association to the Maine Motor Transport Association and many others that helped me advocate for this sensible change.

I was also successful in my efforts to prevent the federal government from limiting certain vegetables, including Maine's potatoes, in school meal programs. Nationwide this ill-conceived proposal would have cost our schools, the states, and families an estimated \$6.8 billion over five years. I built support from both sides of the aisle and from across the country to ensure that schools maintain the flexibility they need to serve students healthy and affordable meals. This proposed rule was a prime example of excessive Washington regulation.

In my effort to protect jobs, I also introduced bipartisan legislation to ensure that the proposed EPA regulations known as the "Boiler MACT" rules protect the environment and public health without jeopardizing jobs in our state, particularly in the forest products industry. I also continued to help advance the development of deep water, off-shore wind energy at the University of Maine, which has the potential to provide clean energy and to create thousands of new jobs.

On the Armed Services Committee, I worked to secure funding for shipbuilding at Bath Iron Works, submarine overhauls at Portsmouth Naval Shipyard, and the manufacturing of aircraft engines at Pratt and Whitney, as well as to strengthen the 101st *Air Refueling Wing* in Bangor and the Maine Military Authority in Limestone. The new defense funding bill also includes my amendment to expedite the claims of veterans with severe disabilities like the soldier I met who is suffering from ALS, also known as Lou Gehrig's disease.

Last year, the President signed legislation I coauthored creating a national plan for combating Alzheimer's disease, which affects more than five million Americans and their families. In another health-related development, at my urging, the Food and Drug Administration allowed clinical trials to begin on the artificial pancreas, a device that could dramatically improve the health and quality of life for people with Type I diabetes.

Many Mainers have contacted me to express concern about the Postal Service, which is the linchpin of a nearly \$1 trillion mailing industry that employs 8.6 million people. I've sponsored bipartisan legislation to rescue the U.S. Postal Service from financial failure next year. This bill provides flexibility to the USPS to restructure itself in an effort to save billions of dollars and preserve universal postal service for all Americans, no matter where they live.

In December, I cast my 4,825th consecutive vote, making me the longest currently serving Senator never to have missed a vote. I am grateful for the opportunity to serve the Town of Old Orchard Beach and Maine in the United States Senate.

Dear Friend,

I hope this letter finds you and your family well. It continues to be an honor to represent you, and I wanted to take a moment to share with you some the work I've done in Washington and Maine over the last year.

As you know, times are not easy. The country still struggles to recover from the recession, which is why I'm so frustrated Congress has not been serious about job creation. Voters elected us to Congress with the highest priority of getting the country back to work. While we should have been voting on jobs legislation, we have ended up debating anything but.

I am proud, though, to have worked on my own piece of jobs legislation in 2011. Local food is a growing part of Maine's economy and has helped revitalize a traditional staple of our communities—the family farm. We have seen incredible increases in CSA farm shares, farmers markets, and acres in cultivation.

But outdated federal policy hasn't done enough to support this bright spot, and often hinders it. I've introduced the Local Farms, Food, and Jobs Act to bring local farmers the resources they need to continue growing. If passed, it means investments in our regional food infrastructure, help for local schools to buy food produced in their communities, and giving more and more people affordable access to local food.

Another piece of legislation I introduced in 2011 would help service members who are victims of military sexual assault. This has become an alarming problem as thousands of women—and men—report being sexually assaulted while serving. I've listened to many of them who are from Maine. My legislation would ease the restrictions they currently face to get disability benefits from the VA.

As a member of the House Armed Services Committee, I've been able to work on several polices that affect our military personnel. It also means that I've kept close watch on our operations overseas. In 2011, we saw some good news on this front. First, we finally found and killed Osama bin Laden. The second came with the official end to the war in Iraq.

I am so glad that the Mainers who have served there will be able to return home. But we can't forget the nearly 4,500 soldiers we lost in Iraq—24 of them from Maine—nor the men and women who continue to serve in Afghanistan. I hope we can start to bring them home in 2012.

My thoughts now are also with the many Maine families who can't afford to heat their homes. I'm disappointed to see deep cuts in LIHEAP, a program thousands of Mainers rely on. I've introduced legislation to restore the funding and I will keep fighting to get Mainers the support they need.

MESSAGE TO THE CITIZENS OF OLD ORCHARD BEACH

Dear Friends and Neighbors:

It continues to be an honor to serve as your State Representative during the 125th session of the Maine State Legislature. As your voice in Augusta, I pursue my fourth term with the same hard work, responsiveness and dedication as I have my previous three terms. It was gratifying to receive the support of so many of you with whom I have worked with for so long on behalf of the people of our town and region. I hope to continue working for you and representing you in the years to come.

It will come as no surprise, but our greatest challenge again, during the 125th Legislature, was the budget. In the previous legislature there was federal stimulus money that Maine had access to, but due to opposition at the Federal level those funds will not be available again. We are facing many very challenging decisions and there are no easy answers.

We were again faced with having to make difficult cuts in order to bring the state budget into balance. After eight years of budget cutting to meet shrinking revenues this has become an ever more difficult task. You can find out more about the budget at <http://www.maine.gov/legis/ofpr/>.

Yet even with these tough conditions, we made it a priority to protect the most vulnerable of our communities keeping our state's safety net intact for those truly in need. This included protecting Maine's rural critical access hospitals and continuing the effort begun in 2003 to pay back the MaineCare debts owed to our hospitals. This includes over \$500 million in the previous two years for a total of over \$914 million in back payments to Maine's hospitals during the Baldacci administration.

My Democratic colleagues and I successfully protected Maine's public retirees, who receive no social security, from drastic and impoverishing cuts and protected thousands of senior citizens from being cut-off from their prescription drug subsidies. We also supported common sense, bipartisan efforts to lessen the regulatory burdens on businesses while protecting our natural resource based economy.

I continue to work on the Transportation Committee to save Maine's public transportation infrastructure from continuing deterioration. Of course, good roads and bridges are vital to all economic development in Maine. Here in old Orchard Beach we know that making travel more difficult, more time consuming and more dangerous could be devastating to our local economy.

Unfortunately the Maine based private employers who build and maintain our roads and bridges are facing bleak times ahead as Governor LePage, State Treasurer Polaquin and Republican legislative leadership refuse to support the bonds necessary to bring in the Federal money to invest in our roads at the lowest interest rates in years. However, I will remain hopeful that a transportation bond package will be passed in this coming session.

Independent Auditor's Report

We have audited the accompanying financial statements of the governmental activities, business-type activities, each major fund, and the aggregate remaining fund information of the Town of Old Orchard Beach, Maine as of and for the year ended June 30, 2011, which collectively comprise the Town's basic financial statements as listed in the table of contents. These basic financial statements are the responsibility of the Town of Old Orchard Beach, Maine's management. Our responsibility is to express opinions on these financial statements based on our audit.

We conducted our audit in accordance with auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in *Government Auditing Standards* issued by the Comptroller General of the United States. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation. We believe that our audit provides a reasonable basis for our opinions.

In our opinion, the basic financial statements referred to above present fairly, in all material respects, the respective financial position of the governmental activities, business-type activities, each major fund, and the aggregate remaining fund information of the Town of Old Orchard Beach, Maine, as of June 30, 2011, and respective changes in financial position and cash flows, where applicable, thereof and the respective budgetary comparison for the General Fund for the year then ended in conformity with accounting principles generally accepted in the United States of America.

In accordance with *Government Auditing Standards*, we have also issued a report dated October 31, 2011, on our consideration of the Town of Old Orchard Beach, Maine's internal control over financial reporting and our tests of its compliance with certain provisions of laws, regulations, contracts, and grant agreements and other matters. The purpose of that report is to describe the scope of our testing of internal control over financial reporting and compliance and the results of that testing and not to provide an opinion on the internal control over financial reporting or on compliance. That report is an integral part of an audit performed in accordance with *Government Auditing Standards* and should be considered in assessing the results of our audit.

Accounting principles generally accepted in the United States of America require that the management's discussion and analysis and budgetary comparison information, as listed in the table of contents, be presented to supplement the basic financial statements. Such information, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board, who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context.

We have applied certain limited procedures to the required supplementary information in accordance with auditing standards generally accepted in the United States of America, which consisted of inquiries of management about the methods of preparing the information and comparing the information for consistency with management's responses to our inquiries, the basic financial statements, and other knowledge we obtained during our audit of the basic financial statements. We do not express an opinion or provide assurance on the information because the limited procedures do not provide us with sufficient evidence to express an opinion or provide any assurance.

Our audit was conducted for the purpose of forming opinions on the financial statements that collectively comprise the Town of Old Orchard Beach, Maine's basic financial statements as a whole. The introductory section, combining and individual nonmajor fund statements, and statistical section, are presented for purposes of additional analysis and are not a required part of the financial statements. The combining and individual nonmajor fund financial statements are the responsibility of management and were derived from and relate directly to the underlying accounting records and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. In our opinion, the information is fairly stated in all material respects in relation to the financial statements as a whole. The introductory and statistical sections have not been subjected to the auditing procedures applied in the audit of the basic financial statements and, accordingly, we do not express an opinion or provide any assurance on it.

HISTORY OF OLD ORCHARD BEACH, MAINE

The earliest records of the Old Orchard Beach area date back to 1653. The first settler, Thomas Rogers, established "Garden by the Sea" in 1657. A few years' later ten militiamen repelled 150 attacking Indians near the beach, but a relief party of townspeople coming to support the militiamen was killed in an ambush and Roger's home was burned.

The "old" apple orchard from which the Town took its name, a landmark to sailors for many years, was on high land above the long sand beach. In 1820 Maine, formally part of Massachusetts, became a State by act of Congress. In that same year the first Public House (inn) was opened serving coach travelers and other transients year round. In 1837, E. C. Staples was coaxed into taking summer boarders at his farm for \$1.50 per week. Convinced of Old Orchard Beach's potential as a summer resort, Staples built the first Old Orchard Boarding House near the top of today's Old Orchard Street.

In 1842 brought the first steam railroad from Boston to Portland with a station just two miles west of town. The first restaurants to sell seafood treats and "shore dinners" opened in 1851 near Staples Street. The Grand Trunk Railroad opened in 1853 connecting Montreal to Old Orchard Beach, enabling Canadian visitor to flock to the closest beach to Montreal and avoid the long carriage trip.

The Civil War began in 1861 followed by years of growth and building of homes, streets, stores, livery stables, and beachfront hotels. 1873 brought the Boston & Maine Railroad passing right through Old Orchard Beach and stopping on the site of today's Chamber of Commerce. In that same year a group of Methodists formed the Old Orchard Camp ground which in the early 1950's was purchased by The Salvation Army. Yearly thousands of Salvationists come to Old Orchard for the ten days of camp meetings. The Ocean Park Association also building their temple in 1881 and nationally known speakers were heard every Sunday all summer.

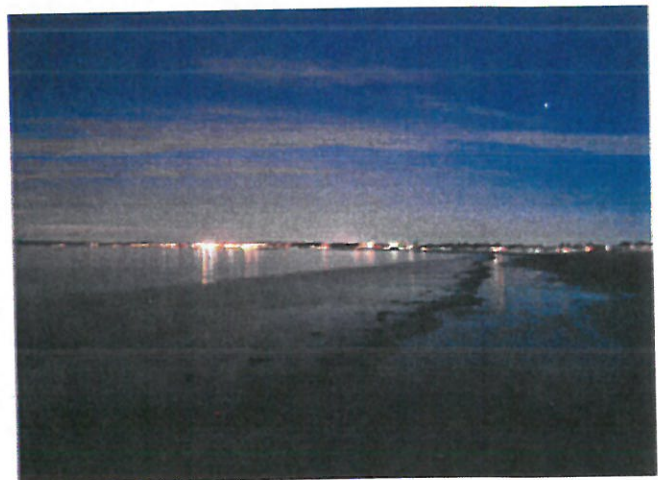
In 1892 electric trolley cars replaced horse cars to Biddeford and Saco. 1898 proved to be an unfortuitous year to complete the first Pier. Built of steel and measuring 1,770 feet long and 20 feet above the tides, their Pier was severely damaged in November of the same year. 1900 brought the first Town Hall and 1902 the first amusement area complete with roller skating, merry-g-round, rides, games and refreshment stands. The Portland to Old Orchard Beach Electric Railway opened in 1903 where 14 miles of track were traveled in under one hour for \$.20 cents.

The great fire of 1907 destroyed the entire beachfront as firemen from Portland, Biddeford, and Saco rushed to the beach but struggled to contain the blaze, hampered by low water pressure. Rebuilding began at once, and one project "the standpipe" assured adequate water for all.

March 1909 brought another damaging storm destroying "White City" at the end of the Pier and reducing the pier to 700 feet. An international auto race was held on the beach in 1910 with Dave Lewis winning the 100 mile race. The 1920's and 1930's were the Big Band era. All the famous dance bands, Guy Lombardo, Rudy Valle, Duke Ellington, and more visited the Pier Casino each summer and thousands dances over the waves under the revolving crystal ball.

Sparked by Lindbergh's daring flight, many Trans-Atlantic flights took advantage of Old orchard Beach's long stretch of wide hard packed sand to attempt their own crossings. The storm of February 1978 almost demolished the Pier and a new pier was immediately planed which opened in June of 1980.

The winter residents of 10,000 welcome over 150,000 during the summer months. Old Orchard is alive with exciting things to do.
