## **We Salute the C. Fayette Staples American Legion Post 57 for its near century of giving to our community, our state and our nation.**

Nationally the American Legion was chartered by Congress in 1919 as veterans returned from the battlefields of World War I. Locally post 57 received its charter on August 1, 1920. The Post was named after C. Fayette Staples, a benefactor and member of a prominent Old Orchard Beach family. Unique in its naming, Post 57 is the only Post in Maine not named after a military veteran. The Legion's first home here was on School Street in a building that at one time was a school house. In the early 80's the Post moved to its current location on Imperial Street.

Membership in the Legion is open to veterans of the military who served on active duty during wartime. Aiding the Legion in its work are two subsidiary organizations, the Ladies Auxiliary and Sons of the Legion, open to sons and grandsons of Legion members and sons and grandsons of deceased war-time veterans.

The C. Fayette Staples Post has an enviable record of providing support to its members in time of need, Beyond its own, Post 57 is known for its extensive and long standing charitable giving including, locally, its annual sponsorship of the Memorial Day parade, financial support to the Salvation Army, United Methodist Church Food Pantry, Edith Belle Libby Memorial Library, Run for Cash, Cub Scouts, OOB Little League, and Loranger Band Camp. The Post provides food for Gunter our police dog, candy for the Fire Department's Halloween party, college assistance for Old Orchard Beach High School graduates and more. Beyond Old Orchard Beach boarders Post 57 supports Special Olympics, Run for the Fallen, Junior Achievements, Meals on Wheels, the Ronald MacDonald House and the list goes on.

The numerous charitable accomplishments of Legion Post 57 are made possible in large part by Bingo held year round on Mondays and Saturdays and parking revenue during the summer months, these activities take place at the Post's facilities on Imperial Street. Hard to imagine all this happens due to the work of a devoted group of our service heroes currently 87 strong, aided by its Auxiliary and Sons of the Legion.

**TO THE CITIZENS  
OF OLD ORCHARD BEACH**

What a year it has been for Old Orchard Beach! In spite of a stagnant economy our town experienced brisk construction activity, store fronts on Old Orchard Street were filled for the first time in years, and our businesses enjoyed a rewarding tourist season.

Your council appointed a new Town Manager to fill the vacancy created by the retirement of Jack Turcotte. We signed a two year lease with the Old Orchard Beach Collegiate Baseball Club for use of The Ballpark. Conflict of interest was explored in an open forum that led to new understandings and insights surrounding this complex issue. After listening to considerable public and staff input as well as council deliberation, the safety of our citizens and visitors was addressed through the adoption of a new fireworks ordinance. Shortly after the unfortunate embezzlement of funds at the Edith Belle Libby Memorial Library surfaced your council, in close coordination with town staff, put in controls that assure your tax dollars allocated to the library will be used for their intended purposes.

A budget was adopted that held the line on taxes while maintaining the same level of municipal services. A new accounting firm has been retained to audit our financials, and we began discussions on the pursuit of more vigorous tax collection and the possible disposal of tax foreclosed properties.

It has been an honor and privilege to chair the council for a second year, thank you council colleagues for your confidence and support. I thank my wife Margaret for being at my side in such a supportive way. Thanks to our awesome Assistant Town Manager and Council Secretary, Louise Reid, for your consistent understanding and patience with us councilors. I thank all those citizens who serve on boards, commissions and committees or volunteer in community activities, you are what helps make Old Orchard Beach the great town that it is.

Since my arrival on February 15, 2012 serving as your Town Manager has been a very dynamic and busy time. We faced situations that required quick responses and major changes with respect to financial controls in order to correct deficiencies.

Past lack of compliance dealing with State and Federal laws requirements forced a reorganization of the decentralized hiring and accounts payable functions. A Human Resource Department was created and centralized at Town Hall along with the accounts payable function. The creation of a Human Resource Director and an Account Payable and Payroll Clerk have solved several compliance issues going forward. The hiring of full and part-time personnel through the Human Resource Department has improved the quality of the seasonal workforce.

Working with the Town Council the FY2013 Town budget was reduced by .53 cents per \$1,000 valuation to offset the increase of .49 cents on the RSU (School) side, creating nearly 0% or a flat tax rate (mill rate) to the taxpayers. The FY2013 approved budget increased services including the creation of a full-time Tax Clerk in the Tax Collector's office while creating a job-share position with another community for General Assistance and modernizing our reporting through electronic reporting to the State.

We moved forward with applying for and receiving a couple of State and Federal grants; reconstructing the intersection of Saco Avenue and E. Emmons Cummings Boulevard; and the Energy Efficient Wastewater Blower project which are underway.

The Town Council has directed me to create and implement a merit-based performance evaluation for non-union personnel which was completed before the year's end. During the year we renegotiated a solid waste contract for the next twelve years saving the Town of Old Orchard Beach \$1.5 million over the twelve year period. Old Orchard Beach received the most beneficial of all thirteen Towns involved in this achievement. IRS compliance addressed old IRS issues to bring the Town into compliance and avoid future hefty fines. As a result of an embezzlement issue with the Library, provided extensive multitude of tasks to handle this sensitive situation while protecting the tax payers. We instituted a mandatory IRS W-9 filing for vendors to be paid by the Town. The IRS requires any entity paying funds greater than \$600 a year to all non-Corporate, LLC's, sole proprietors, etc. to fill out a W-9 so those vendors will be issued an IRS 1099 reporting that income to the IRS. This was not a standard practice in Old Orchard Beach prior to February 2012. Mandatory 1099's were issued to vendors paid by the Town. Approximately one hundred and forty-four 1099's were issued from 2006 through 2011. We also brought into compliance all issues related to Health Benefits. Arranged for a General Assistance sharing position with Wells, saving the Town a \$20,000 year position. Identified and eliminated payments for vehicles no longer owned by the Town, with a savings of \$11,700. Secured the payment of \$5,360 for Town benches which were owed and not collected.



**We brought into compliance Homeland Security I-9's lacking before. Non-compliance bares a fine of \$11,000 each. We are currently updating the Town's RFP and Purchasing Policy to ensure fair and competitive bidding and awards as well as proof of mandatory insurance coverage. The institution of a standardized process will give the Town recourse in performance, delivery, etc. should they arise.**

**The working relationship between the town offices has been outstanding and I give great recognition to the outstanding staff that this Town employees. Their dedication and professionalism is one of the finest I have seen.**

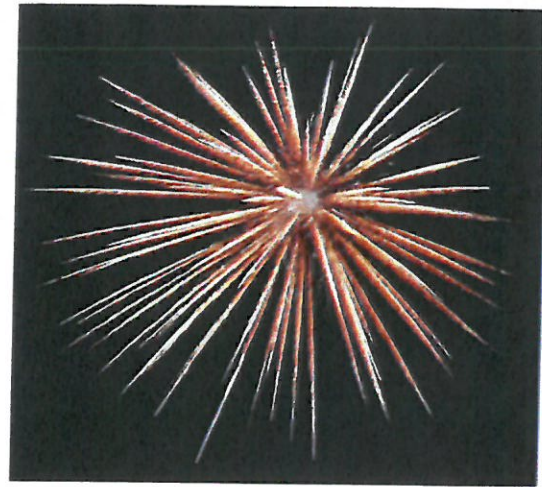

## **TOWN CLERK:**

**To the Citizen's of Old Orchard Beach**

**I am truly honored to provide you with information about the activities of the Town Clerk's Office.**

**The Office of the Town Clerk is responsible for all the records of the town, including all birth, death and marriage records, issuance of marriage licenses, all meeting minutes from the Town Council, as well as all boards appointed by the Town Council. This Office is also responsible for Elections, hunting and fishing licenses, horse permits, as well as dog licenses, and parking permits.**

**This year the Town Clerk's Office recorded 73 births, 101 deaths and 104 marriages. It is with great sadness that the Town lost Irving "Bud" Hertz. Bud graduated from Old Orchard Beach High School, and worked for the Fire Department for 16 years; many of those years he worked his shifts with Deputy Fire Chief Donald Roy. Bud donated much of his time to his community, whether it be the Knights of Columbus or St. Margaret's Church. We also lost Thomas Lee Sr. Tom was on the Town Council from 1975-1976, serving as Town Council Chair in 1975. He was also the Election Warden from 1981-2000. His long tenure as Election Warden showed his dedication to the Town and to the election process.**

The real estate market for Southern Maine properties, particularly for seacoast communities such as Old Orchard Beach, has continued to soften, yet the assessed values are well within the state standards when compared to the qualified sales. In FY '12, the assessing office reviewed several hundred permits resulting in approximately \$7,989,500 of new growth. The Town's total valuation went down slightly, approximately \$3,120,730, due to some adjustments. The mill rate remained the same at 13.40. It is interesting to note that 12% or 1.61 of the 13.40 mill rate is designated for operations of the wastewater department. In many cities and towns, this is a separate bill for homeowners who are connected to the town wastewater system. The median assessment ratio (assessment ratio = assessment divided by sales price) is approximately 99% which means properties are being assessed at about 99% of their fair market value. This is an increase of 1% from the FY'11 ratio indicating a continued slight softening in some areas of the local real estate market. The assessment ratio has moved closer to fair market value as of April 1, 2011.

The challenges for assessing in this continued and difficult, economic period have provided us opportunities to explore better ways for public understanding of the importance of the assessing office in maintaining a stable, fair, and equitable taxation base. Our focus has always been to provide the public with all the information necessary to make the best decisions on whatever situations are at hand. Transparency is the key.

Our goal will continue to be to provide an equitable and accountable real estate based assessment program that is fairly administered as outlined in the State Statues governing property assessment. The assessment ratios will also continue to be in compliance with the standards for quality assessment as outlined by the International Association of Assessing Officers.

There are programs such as the Homestead Exemption and Veteran Exemption available to those residents who qualify to help alleviate some of the tax responsibility and are outlined on the Town's website and are also available in our office in the Town Hall. These forms are due in the Assessor's Office by April 1<sup>st</sup> in order to be applied to the next fiscal year.

## Report of the Town Planner

I've completed my first year as your new Town Planner and I must say that it's been quite a challenge. From the development of a new comprehensive plan to increased Board and Committee activity and re-organization of the code office- there has been and will continue to be plenty of work. What I find most challenging is applying the needed time to all projects so I can insure I do my best work. I expect this will continue to be a challenge with no sign of work slowing down.

As your Town Planner, my primary responsibility is to coordinate growth and development in Old Orchard Beach through the administration of local, state, and federal laws, regulations, and ordinances. Some of my duties include responding to requests for assistance on all land use development questions, reviewing development proposals and plans, creation and implementation of the comprehensive plan, economic development, staff advisor for the Planning Board, Design Review Committee and Comprehensive Plan Committee. One particular upcoming challenge is the creation of an entirely new comprehensive plan. Some highlights from July 2011 – June 30, 2012 are below.

- A new planner was hired during 2011.
- Continued work on the new comprehensive plan.
- Planning Board and Design Review activity increased with more proposals compared to the past several years.
- Begin re-organizing the planning and code office.
- Participation with regional planning programs such as the Eastern Trail, New England Passenger Rail Association and the Sea Level Action Work Group.

The Planning Department is a key contact point for all development inquiries and economic development matters. The Department routinely answers citizen questions whether planning related or not. Planning Board. The Planning Board responsibilities include, but are not limited to the review of subdivisions under State Subdivision Law and Old Orchard Beach Subdivision Ordinance, Site Plan Review, Conditional Use review, Private Ways, Design Review Certificates, and consideration of zoning and ordinance changes. The Planning Board has been quite busy. Below is a list of Site Plan Review, Subdivision and Conditional Use Applications considered by the Planning Board between 2008 and July, 2012:

As you can see, the number of projects increased during 2011 and 2012. Also, the types of projects have changed from smaller to larger in size, scope and investment- especially projects associated with subdivision and site plan review. This includes a new 44 lot residential subdivision, 53 dwelling unit subdivision and partial demo and completely new rebuild of a motel.

The Planning Board members are Chair Win Winch, Vice Chair Eber Weinstein, Mark Koenigs, David Darling, and Carl D'Agostino. I feel very fortunate to have such a committed, hard-working group. Every month, the Planning Board holds a workshop on the first Thursday at 6:00 PM and a regular meeting on the second Thursday at 7:00 PM. Meetings are held at town hall in the Council Chambers.

Design Review Committee. The Design Review Committee (DRC) is responsible for conserving the cultural architectural heritage of our town, providing technical design assistance to property owners, and promoting quality architectural design and historically sensitive building renovation as a means of sustaining economic vitality and stable property values. The DRC is responsible for reviewing and providing recommendations on exterior building/structure and property modifications, alterations, additions, new construction, and demolition within specific locations of town. The DRC offers a recommendation on the above-mentioned proposals which is then brought to the Planning Board for the final decision. The DRC meets on the first Monday of each month at 7:00 PM in the Council Chambers.

Design Review proposal numbers tripled this year from previous years. These increases show people are improving our downtown areas a whole through improvements to their own properties. Between July 2011 and June 30, 2012, the DRC considered the following proposals:

- Construct a 32' x 40' building containing two rental units and associated parking. 12 Foote St., MBL 205-19-11
- Construct 24' x 26' addition to single family home (expansion, new construction). 6 Bradbury St., MBL 205-19-12
- Construct 28' x 27' rear addition to a single family building. 7 Francis St., MBL 205-7-12
- Demolition of entire structure. 10 East Grand Ave., MBL 306-5-4

- **Reconstruct existing pool and build new pool layout. Beach St., MBL 313-5-1**
- **Building Façade Work. 32 East Grand Ave., MBL 305-6-1**
- **Application Revision: Change fence design around pool. Beach St., MBL 313-5-1**
- **Replace Roof Shingles and Painting. 26 Staples St., MBL 206-31-15**
- **Design Review Certificate: Library expansion, renovation and site work. 27 Staples St., MBL: 206-27-1**
- **Design Review Certificate: Install framed in wooden door in entryway. 50 Old Orchard St., MBL: 205-3-4**
- **Workshop: Discuss DRC related items such as the Design Review Ordinance; Application and Review Procedure; Design Review Districts.**
- **In addition to the above, there were 18 Administrative Design Review Approvals.**

Like the other boards and committee's I work with, the DRC works hard to improve the town and I'm very thankful to have such committed volunteers. The DRC members include Chair Don Comoletti, Kim Schwickrath, Ray Deleo, and Shirley Holt. The DRC meets on the First Monday of each month, 6:00 PM in the Council Chambers.

### Comprehensive Plan Committee

A comprehensive plan is the adopted official binding document for future development and conservation. The plan sets forth goals; analyzes existing conditions and trends; describes and illustrates a vision for the physical, social and economic characteristics of Old Orchard Beach in the years ahead; and outlines policies and guidelines intended to implement that vision.

Comprehensive plans address a broad range of interrelated topics in a unified way. The planning process provides a chance to look broadly at programs including housing, economic development, public infrastructure and services, natural resources, demographics, local history, recreation, and land use and how they relate to each other. One of the most important functions of a comprehensive plan is to provide valuable guidance to those in the public and private sector as decisions are made affecting the future quality of life of current and future residents, business owners and visitors and the natural and built environment in which they live, work, shop, recreate, and enjoy.

A comprehensive plan serves as a guide for how a town will grow. The Old Orchard Beach Comprehensive Plan Committee looks forward to the future and thinks about what kind of growth is appropriate, where it should take place, what special assets need protection—in short, what kind of a town and way of life Old Orchard Beach citizens, businesses and visitors want for the years to come. A plan is essential if the town is to encourage growth in constructive ways.

This fiscal year, the initial public process was completed. This process included four public meeting sessions (one was televised and held on a Saturday) and a survey (mailed to every taxpayer's address, available electronically via the town's website and a service named 'Survey Monkey', available as hard copies at public locations). Public session feedback and survey response rate was quite good. Overall attendance at the public sessions was approximately 75 and we received 447 completed surveys. What impressed me the most is how much of this feedback was positive and extremely thorough and helpful!



The Comprehensive Plan Committee is a committed group of hard working residents and the progress we've made is due to their efforts. We expect the first draft of the comprehensive plan to be complete during the spring/summer of 2013. Committee members include Chair Lou Valentine, Win Winch, Trish Driscoll, Phil Denison, Jason Webber, Jean Leclerc, and Maria Pastulovic. The Committee calls meetings as needed and typically meets 1-2 times each month.

There is much exciting work the Planning Department will engage in during the next fiscal year. Creation and implementation of a new comprehensive plan, continued work to improve the code and planning functions and the establishment of an economic development office will certainly open our town up to new opportunities and improve the assets we have. I appreciate the incredible amount of time and effort from all Board and Committee members, the Council's support, the help and kindness from town staff, and the positive encouragement from the town's people.

**REPORT OF LOCAL HEALTH OFFICER**  
**FISCAL YEAR 7/1/11-6/30-/12**

Once again, I have enjoyed serving as Local Health Officer for the town of Old Orchard Beach. The issues have included:

1. Mold issues.
2. Bed Bugs.
3. Research and discussion of revised policy regarding inspections of commercial/non-profit inspections to reflect changes in state statute.
4. Responding to residents' inquiries regarding various health related issue.

Mold issues can be eradicated by keeping all components of the structure dry and clean. Any moisture needs to be identified and the source resolved to insure the dry and clean status which inhibits spore growth.

All used items brought into a structure must be examined closely for the presence of bed bugs. Although they do not transmit disease, they are aesthetically undesirable, and can lead to the assumption of un-cleanliness. They do not only appear in beds. They can be in clothes, under chairs, and other furniture, as well as on picture frames, and other permanent fixtures in the structure.

## Code Enforcement Department

July 1, 2011 – June 30, 2012

### Annual Report

The reins have been passed several times in the Code enforcement office this past year. Mike Nugent left in November of 2011 to take a job out of state. He was replaced by Mark Mitchell who was only with the Town for a few months and moved on. Alan Borg who had previously been an Assistant Code Enforcement Officer in Old Orchard Beach stepped up to the challenge during an extremely busy time with major projects and building going on in preparation for the 2012 season here in Old Orchard Beach. William (Bill) DiDonato who does part time code and is the Deputy Assessor assisted as he could and they managed to conduct business as usual even though they were very short staffed. They both devoted countless hours and brought work home with them just so the office could stay on top of things. Interviews took place to hire a part-time (25 hours/week) position in hopes that between Alan Borg, Bill DiDonato, and the new CEO they could manage. After the interview process I was hired as your new Code Enforcement Officer and I reported to work the end of April of 2012.

The Town of Old Orchard Beach is a very unique community that has a strong year-round population, but explodes during the summer season. The Code Enforcement Department is responsible for protecting the public health, safety, and general welfare of all the citizens and visitors of the Town of Old Orchard Beach through the administration of local, state, and federal laws and ordinances. In the Code Department we review plans, issuing building permits, septic system permits, internal plumbing permits, and electrical permits. Beyond issuing building permits the inspectors have to conduct several inspections during progress of permitted building or projects. We are inspecting to ensure compliance with all applicable building & energy codes, plumbing, electrical, life Safety/fire codes and also all local town ordinances. Business licensing absorbs a great amount of time because of new, businesses and businesses whose licenses have lapsed, change of ownership and complaints. On top of that we follow up on complaints received ensuring there are grounds for enforcement. If enforcement must happen then we work with property owners with hopes in obtaining voluntary compliance.

Old Orchard Beach continues to participate in the Community Rating System through the National Flood Insurance Program (NFIP) which is overseen by FEMA. The staff strives to stay committed to provide superior services and information. As a result the Town has continued to maintain a level 8 CRS rating which entitles residents who have flood insurance policies a discounted rate.

## **OLD ORCHARD BEACH CONSERVATION COMMISSION ANNUAL REPORT**

**Members: Ginger McMullin (Chair), John Bird (Vice-Chair), Mark Koenigs (Secretary), Pat Holland, Pierre Bouthiller**

**The Conservation Commission had a busy year, starting with a clean-up of the town-owned "Blueberry Plains" property on Ross Road. With the help of the Department of Public Works, two dump truck loads of debris were removed from the property, and the parking area was paved.**

**Commission members participated in the Maine Healthy Beaches and Maine Land Trust conferences, and are applying this information toward learning more about water quality issues in Goosefare Brook and the development of management plans for public land.**

**The commission continues to research town owned properties, and did a site walk of a 50 acre parcel owned by the town on Portland Avenue at the intersection of Milliken Mills Road. Deeds for this property as well as the Blueberry Plains parcel and School Street extension have been obtained.**

**An updated inventory of the town's wetland resources is being conducted, and should be completed by early next summer. The inventory will provide us with good locations on these areas, as well as give us good data on their status, including vegetative characteristics and the ecological functions that each area provides.**

**The commission met with representatives of the Eastern Trail and Saco Bay Trails, and continues to look at possible recreational trails for Old Orchard Beach. In particular, a Trails Subcommittee was formed to help make the "OOB-ET Connector Trail" a reality. This is a plan for a 2.8 mile combination off-road and along-road bike and pedestrian trail that will connect Memorial Park to the Eastern Trail via the School Street extension. A hoped-for grant that would help to design and build the trail did not come through, so the subcommittee is working with the Department of Public Works to bring this to fruition using volunteers. Two public meetings have been held, and plans for the trail are progressing.**

**The Memorial Park Subcommittee also remains very active, and instrumental in the flag raising ceremonies that take place nightly at the park during the summer season. This dedicated group of volunteers advocates for the care of the park and its distinctive plantings, as well as for serving the veterans that it honors.**

The Old Orchard Beach Fire-Rescue Department continues its mission to supply fire prevention and suppression protection to the citizens of Old Orchard Beach.

Accomplishments this year include:

- Continued to enhance our fire prevention program by expanding outreach efforts to elderly community and participated in the York County Juvenile Fire Setter Education program.
- Added a used vehicle to our Fire-Police program to assist with security and traffic direction at major incidents and added new personnel.
- Purchased new firefighting equipment for our Career & Callforce.
- Expanded our training programs to reach more Callforce Officer personnel.
- Became National Incident Management Training (NIMS) compliant according to Federal Regulations.
- Continued remodeling of the Administration Wing of the Public Safety Complex.

We continue to pursue fire prevention through inspections and educational activities and have reduced the number of accidental fires annually in Town. Our in-house training program has been expanded to include more firefighter safety programs for personnel.

Our Lifeguard staff, under the direction Captain Keith Willett, continued to provide safe beach activities with additional towers, manpower, and have updated their equipment to include additional portable radios. OOB Lifeguards hosted and participated in the New England Lifeguard Competition and our personnel placed high in many categories.

## ***OLD ORCHARD BEACH SURF RESCUE***

### Citizens of Old Orchard Beach:

After having the busiest summer season on record in 2010, the Old Orchard Beach Lifeguards got a little break from the action in 2011. Lifeguards responded to 47 emergency calls, over an 11 week period; a little short of the 172 emergency runs responded to in 2010. There were 13 swimmers rescued from the surf by Lifeguards, 2 of which were transported to the hospital via ambulance. Old Orchard Beach Lifeguards also played a vital role in rescuing an 11-year-old boy from a deep hole on the beach, which had collapsed down on him. When Lifeguards arrived on scene the boy was 7 feet down and buried up to his neck in sand. Acting with the upmost professionalism and with the help of the Fire, Police and Public Works Departments, Lifeguards were able to successfully free the boy. On top of rescuing multiple swimmers from the surf, and the boy in the sand, Lifeguards also responded to 28 medical emergencies, removed 3 sexual predators from the beach, assisted the Police 5 times with unruly subjects on the beach, and reunited 88 lost children with their parents or guardians.



Not only were the Lifeguards hard at work on the beach, but they also found some time to play as the annual Northern New England Lifesaving Championships returned to Old Orchard Beach. The event brought roughly 200 lifeguards and spectators from as far away as Cape Cod here to Old Orchard Beach. The competition was a great success, as Ogunquit, Maine edged out Salisbury, Massachusetts, by a few points. On an even higher note, the competition raised \$1,500 for the Make-a-Wish-Foundation. A very big thanks goes out to those area business and residents that donated their time and money to make the competition a great success and also to Lifeguard Lieutenant, Phil Bourassa, for putting in many hours organizing the event.

As we approach the winter season there is still much work to be done in order to be prepared for the 2012 season. New Lifeguard towers need to be built and painted this-off season. On top of that, equipment and supplies must be ordered so that we are ready for the start of the 2012 summer. There are also a lot of repairs to be made to Lifeguard towers, radios, and rescue torpedoes as they were subjected to a lot of wear and tear this past summer.

The 2011 summer season has unfortunately come to an end and with many things in the works for the 2012 season the lifeguard staff is looking forward to working with Town officials throughout the winter to make the beach a safer and even more enjoyable experience.

From the Citizen's Police Academy to our Community Watch Council and Citizens Patrol, we are seeing growing numbers of Citizens who are willing to get involved and make a difference in our community. ## **Animal Control Officer – Annual Report 2011-2012**

**Old Orchard Beach's Animal Control is continuing its mission to ensure the health and welfare of all animals within the Town. This year the Animal Control Officer (ACO) and the Police Department answered 870 calls relating to animal Welfare; most involved domestic animals, but several complaints were related to wild animals.**

**The ACO, in cooperation with the Old Orchard Beach Community Animal Watch (CAW), has helped to maintain and supply a Pet Food Pantry. The Pet Food Pantry is located at the Salvation Army's Food Bank and helps to distribute donated food to the owners of needy pets, in an effort to help keep them out of Animal Shelters or in harm's way. Much of the food has been donated by Hannaford Brothers and private donors in Old Orchard Beach.**

**Through the assistance of a training grant the ACO has attended a week-long class on Animal Cruelty Investigations that was hosted in Augusta, Maine. This class was the last portion of a 120 hour training program and testing process to become a Certified Animal Cruelty Investigator through the University of Missouri's Law Enforcement Training Institute.**

**During the strong Spring storms that hit the coast, the ACO responded to several complaints of Seals on the Beach as well as a beached Whale. We would just like to remind everyone that they should leave any stranded or beached marine mammals alone and immediately contact that Old Orchard Beach Police Department or the Maine Marine Patrol.**

**There have been over 30 confirmed cases of rabies in wild animals in Maine from 1/1/12 – 6/12/12. We would like to remind all dog and cat owners, that you are required by law to vaccinate your pets against this horrible disease. Please contact the ACO for questions on low cost rabies clinics.**

## Our Mission:

The mission for the Old Orchard Beach Community Animal Watch Committee (CAW) is to create an environment in Old Orchard Beach that will help establish humane practices for protecting the health and welfare of animals within the Town.

## Our Goals:

- 1) To recruit a wide range of animal supporters who are committed to our Mission Statement;
- 2) To set up organizational liaisons with existing Town agencies and committees (Police, Animal Control, and the Town Council) supporting the Committee's work with personnel and finances to achieve our goals;
- 3) To coordinate our efforts with "Feral Felines" to develop a Town's "Feral Feline" Program;
- 4) To set up a "Regional Network" to establish and maintain a centralized method to advertise, contribute, and obtain information relevant to all animals in need.

*This past year, with the help of many in our Old Orchard Beach Community, we have raised more money, and helped more pets (and their owners) than ever before. The Town has a contract with the Animal Welfare Society (AWS), where lost or abandoned pets may be taken as well as a low-cost spay/neuter program at AWS in Kennebunk. We have worked hand-in-hand with the Animal Control Officer, William Watson, and also with Feral Feline, to trap-test-vaccinate-alter-release, keeping down the population of feral cats and insuring their health.*

*Many of the seniors, and lower-income families, have looked to us for help with being able to keep their pets and have used the Pet Food Bank administered by Arlene Dolgon. We meet the third Thursday of every month at 6:00 p.m. at the OOB Police Department. We also have a donation box, at the Town Hall, for Pet Food to be dropped off. The Town Hall hours are: Monday, Wednesday, Thursday, Friday 8 a.m. to 4 p.m., and Tuesday 8 a.m. to 6 p.m.*

## TOWN OF OLD ORCHARD BEACH

### WASTE WATER DEPARTMENT

The Town of Old Orchard Beach owns and operates a Wastewater Treatment Facility (WWTF) that is licensed to discharge up to 3.5 million gallons a day on. The last discharge permit was granted in 2010 and expires in 2015. The WWTF receives average flows of 750,000 gallons in the off season and 1,750,000 gallons in the summer time. There are six (6) full time union employees and a Superintendent that oversee the operation of the WWTF and eight (8) remote pump stations. The West Grand pump station is the largest of the eight pump stations and was recently upgraded to include capacity for future build out.

In 2012, Town Council approved a major capital improvement that is expected to save substantial costs related to the electricity usage. As an added benefit, the WW department procured a \$70,000 grant from Efficiency Maine. As part of this project, electrical deficiencies were identified and the department is working to put together as estimate to correct the issues. Both projects are expected to be completed by February of 2013. The department also worked closely with the Town manager to extend the current electricity contract that will lower per kilowatt hour prices by almost 10% starting in December of 2012.

In 2012, the department welcomed two new employees in the operations department. Both come with extensive knowledge and mechanical abilities. I would also like to congratulate the Department Foreman for passing his Grade 4 Collection Systems license and the Operator for passing his Grade 5 wastewater licenses. As part of the continued effort to modernize and create efficiencies in the operations department, we purchased a new microscope and computer for the laboratory. It is anticipated that all lab entries will be done electronically by the end of the year. Continuing its mission to protect the bay and off shore waters, the department took over the administration of the Maine Healthy Beaches program. This program is vital to protecting the beaches and warning swimmers of possible contamination.

Total expenditures for the annual operation and maintenance budget came is well below projected costs. Equipment replacement costs (single items over \$5,000) were also reduced due to the aggressive maintenance schedule and willingness of the Council to be proactive with approving expenditures in past budgets. Concerns about the current condition of the WWTF remain. The original WWTF construction was completed in 1988 with minor improvements in 1996. The WWTF continues to use above and underground electrical service installed in 1976. In early 2012 the Council held a work shop on a 2009 engineering report that highlighted the needs at the WWTF. In this report there were three phases of needs described by the engineering firm of Wright Pierce. Phase one detailed approximately ten million dollars of immediate needs at the WWTF. It is anticipated that further workshops will be held on this subject. This report will be an important part of the Comprehensive plan that will assist the Town on identifying the growth areas and planning for the upgrades needed to facilitate planned and unplanned growth.

**PUBLIC WORKS DEPARTMENT  
ANNUAL REPORT JULY 1, 2011 – JUNE 30, 2012**

The Public Works Department is responsible for protecting the public's investment in the infrastructure that is necessary to support the operations of the Town. Our staff is responsible for streets, sidewalks, parking lots, sewer and storm drain lines (including catch basins & manholes), culverts, the beach, parks/green space, transfer station (leaves and brush only), solid waste, recycling with respect to the Silver Bullets at DPW and Radley's Market and the cardboard container at DPW, fleet and facility management, and tide gate & outfalls.

**CAPITAL FUNDING:** Approval from the voters in November 2007 supporting an infrastructure bond package of 5.3 million in an effort to more efficiently and effectively carry out the strategic plans of the DPW. The following projects were targeted for major infrastructure improvements over the next few years. The following is an updated status of the projects.

**Ocean Ave/Seaview Ave Sewer Project:**

- Completed, July 2010

**Ross Road Culvert Project:**

- 90% completed/final top course of paving needed, awaiting documentation from a local developer in that Ross Rd will be paved from Portland Ave to Jim's Auto, including this project.

### **Annual Report and Statistics – 2011/2012**

**The purpose and function of the Edith Belle Libby Memorial Library is to provide services and materials in all formats that will promote life-long personal enrichment for all citizens of this community—Libby Memorial Library Mission Statement.**

**This has certainly been an interesting year for the Library, the Staff and the Board of Trustees. As the new Library Director, I expected to be consumed with fulfilling the long-awaited and desperately needed Library expansion project. Of course we all know that that this was not the case as the Library faced a crisis that it had never experienced in its history, dating back to the formation of the corporation known as the Old Orchard Beach Free Public Library Association in 1942. However, this experience has afforded me a very valuable education regarding a range of issues not generally found within the purview of librarianship.**

**In spite of an often stressful workplace, the Staff continued to focus on the Library, our patrons and providing excellent service. I would like to especially thank the Staff and the Board of Trustees for their steadfast commitment to the Library during this trying time. I would also like to thank our Library Patrons for their amazing support and patience. Now that the investigation is complete, we all need to look again to the future of the Library and the future of our Town with the vision and passion that both deserve.**

**Regardless of extraneous issues that consumed a great deal of time and energy, the Library continued to move forward with its on-going commitment of expanding educational user-friendly data-bases by adding Mango Languages, Ancestry.com and Maine Infonet download library (e-book access). In addition, 1,638 new print/media/audio titles were added to the collection through purchasing and donations.**

**The total number of patron visits for the year was 28,065 with the average daily number of patrons being 110 and 505 new cards issued.**

## **RSU 23 Annual Report – SUPERINTENDENT OF SCHOOLS**

**I am pleased to report that the state of the district, in spite of complex and unprecedented challenges, is strong and improving over time. In the midst of incredible budgetary pressures, ongoing efforts to de-consolidate the district and an urgent need to re-imagine secondary educational programs, hard working and committed educators are producing very positive results for the students of RSU #23. Above all, the teachers and principals in schools across the RSU are keeping their focus on student learning, becoming sharper with each passing year in identifying essential learning outcomes, improving instructional expertise, using assessment tools and data more effectively, and intervening with students who need extra support. Student achievement indicators show strong growth in recent years, but just as importantly, RSU schools are supportive, respectful, and safe places to learn and grow.**

**The RSU #23 Leadership Team devoted considerable time at its summer retreats to setting priorities and establishing goals and objectives. The resulting three priority areas have driven the improvement efforts underway in the 2012-13 school year:**

- a) Increase the effectiveness of, and supports for, building level Professional Learning Communities (PLCs), as the principle method for ensuring that classroom instruction leads to positive outcomes for all students;**
- b) Provide richer and more frequent professional learning opportunities focused on instructional proficiency (the Skillful Teacher), which in turn provide a more solid basis for teacher observation and evaluation; and**
- c) Develop instructional strategies and school-wide cultures that promote the acquisition of 21<sup>st</sup> century skills, such as creativity, critical reasoning, collaboration, and communication—skills that will be more necessary in the 21<sup>st</sup> century as a foundation for success.**

**While these priority areas take center stage this year, other work continues to move forward. Teachers, administrators, and students are using technology to support learning. A framework for improving district facilities was developed in the 2011-12 school year, which should provide policy makers and citizens a long-term set of goals and tax impacts. Work continues on examining the use and distribution of educational resources across the schools, and with each passing year any gaps in equity are being addressed—within the limits of our budget restrictions.**

**Two additional areas of progress deserve mention: First, Old Orchard Beach High School is re-imagining the high school curriculum, taking initial steps in using a “career academy” approach to organizing the student experience. The first academy that will be rolled out in the fall of 2013 is a hospitality, tourism, and culinary arts program that will prepare students for jobs or advanced education in one of Maine’s cornerstone industries. With strong support from local businesses, the career academy will be based on an interdisciplinary, project-based, community-connected instructional design. The second**

**area of progress focuses on our work in building a restorative justice approach to student discipline and conflict resolution. RSU #23 middle and high schools will be building awareness with staff, parents, and students this year with 2-13-14 targeted as an implementation year. The district is also partnering with DHHS, local law enforcement agencies, and juvenile justice staff in a collaborative “Juvenile Community Resolution Board” which will allow all the above agencies to work more effectively with students and their families.**

**Over the past year, Mike Pulsifer, Assistant Superintendent for Finance and Operations, and his predecessor Dennis Carignan, have brought an increased focus on accountability and accuracy to the day-to-day operations of our business office. New, more responsive procedures have been established in both payroll and human resources, and periodic “audits” of all personnel records have led to greater accuracy and predictability in district accounts. Both Mike and Dennis deserve a great deal of credit for the improvements, as well as the staff in the business office whose efforts have been essential in regularizing our practices. Jason DiDonato, our district accountant, deserves special mention for his work on financial analysis and budgeting.**

**Unfortunately, the broader fiscal environment in which our business office operates is becoming more challenging by the year. The pressures on the local property tax, generated by shrinking support from federal and state governments, have made it very difficult to overcome the emotional response to tax bills and obtain public approval for annual budgets. This trend appears to be far from over, and indeed may become worse. The current year’s budget required three budget validation referendums on its path to approval, though to be clear, the change in the cost sharing formula and the loss of \$3.5 million in revenue created a “perfect storm” of budget challenges.**

**With so many initiatives on the agenda, our teachers and administrators should take great pride in consistently examining our educational programs, keeping up to date with emerging research on best practices, and improving RSU #23 programs each and every year. Again, this is occurring in spite of historic budget challenges. The citizens of RSU #23 communities have a great deal to be proud of!**

## Annual Report 2011-2012 School Year

Jameson School had a very busy and productive 2011-2012 school year resulting in significant learning and achievement for all in our community. With a whole school population averaging 235 and a 20% transiency rate, (24 moved in and 24 moved out during the year), 51% of our students qualify for free and reduced lunch, 18% of our students receive Special Services and 100% of our students benefit from our Universal Breakfast Program through which all of Jameson School receives breakfast in the classroom daily, free of charge. While our 3<sup>rd</sup> graders scores on the 2010-2011 New England Comprehensive Assessment Program (NECAPs) were above the State average and that of the other RSU 23 elementary schools, we were identified as a Continuous Improvement Plan School (CIPS 1), due to our student Average Daily Attendance (ADA) percentage for that whole year. (The State sets 95% as the benchmark and Jameson averaged 91%.) As a result of this status, Jameson is receiving some additional funds from the Maine Department of Education to target this issue specifically and to help us fine tune our curriculum and to sharpen our pedagogy in all classrooms.

Our Positive Behavior interventions and Supports (PBiS) work continued throughout the year with positive results in terms of student behavior and engagement in learning. Our Jameson Assembly continues to be a strong part of our school culture. This Assembly happens every Monday morning for the whole school and focuses on our 4 school rules, (Be Honest, Be Safe, Be Respectful & Follow Procedures), helping students understand what they need to do to be successful, (rather than hearing what happens when they are not), and to celebrate achievements and happenings across our community. These Assemblies are videoed and posted to our school website for all families to enjoy at their leisure.

Our Student AV Team, (the folks who video our Assembly), is a 21st century skills (critical thinking, communication, collaboration and creativity), enrichment opportunity for a group of high achieving 2nd and 3rd graders. They film our weekly Jameson Assembly every Monday morning and create Public Service Announcements and documentaries on matters at Jameson and shared at our Assemblies and on our website.

Our Caught Being Good program acknowledges those students who do an exemplary job of following our 4 school rules, with opportunities on a daily and weekly basis. All Jameson staff carry Caught Being Good tickets and whenever they happen upon a student doing a fine job, they award them a ticket, specifying what rule they were following, how their choice exceeded expectation, and what affect the choice had on others. A portion of this ticket is shared with the student's family and the remainder brought to the next Jameson Assembly where the student receives a CBG badge and gets their name entered into the weekly drawing for a highly coveted, hard to come by, Jameson School Gift Bag. In this way, we are truly focusing the school's attention on positive behavior and minimizing any negative behavior.

Our grade level Professional Learning Communities (PLCs) continued their focus on identifying, collecting and analyzing student performance data to be sure that all students are learning and to provide additional support for those students falling short of expected learning benchmarks and to enrich those students exceeding those same expected learning benchmarks. Learning is our purpose.

Finally, Jameson School has developed a Partnership with the University of Southern Maine's Education & Teacher Certification Department for the 2012-2013 school year. Jameson was identified for this partnership by USM as Jameson exudes the qualities USM desires for it's interns; high functioning PLCs, a strong Response to Instruction (Rtl) program, an established PBiS structure and learning technology being utilized effectively. We are very proud of our work this year. It's all cool at Jameson School!

## Town Report

### Loranger Middle School – 2011-2012

Loranger Middle School is one of eight schools in RSU #23 (OOB/Saco/Dayton). It is located in Old Orchard Beach, and is one of two middle schools in the district, serving students in grades 4-8. We began the year with approximately 312 students and ended the school year with 310 students. At this point in the 2012-2013 school year, our present enrollment is 333 students. The increase in our enrollment this past year is due to the efforts to equalize resources (class sizes) across the RSU. To address this inequity, we have provided Dayton & Saco students, who are or would be attending Saco Middle School, the “choice” to attend Loranger Middle School. As a result we have 26 new students at LMS from these two communities. This past year Loranger had 51 professional staff; 37 teachers, 14 support staff, 1 guidance counselor, 1 social worker, 2 secretaries, and 2 administrators. We hired a new art teacher, as our long time art teacher, Piper Bolduc, moved to OOB high school. We also hired Matt Kirby as our new choral music teacher, replacing Lisa Andrade. This past year Principal Crocker served as the President of the Maine Principals’ Association, which is an honor he accepted with the support to the RSU administration and the staff at LMS. This year Principal Crocker will continue to serve as an officer in his role as past-president.

Once again, this past year was a very challenging budget year. Early in the year we went into a district-wide discretionary budget freeze that had some impact on our educational programming throughout the district. We also lost two staffing positions as a result of budgetary cutbacks. Our long time health teacher, Sharon Smarc retired, and that position was then cut. A Title I math position was also cut. But in lieu of this restricted spending and loss of teaching positions, the LMS staff continued to provide both meaningful and valuable experiences for our 300+ students. Two main goals for the year were realized – 1. Demonstrated high academic performance, which was evident by making (AYP) Adequate Yearly Progress for a second year in a row, 2. Continued refinement and implementation of a school-wide RtI (Response to Intervention) initiative, that provides academic support to struggling students, through different tiered interventions, 3. Development of a PBIS (Positive Behavior Intervention System) initiative that we plan to fully implement this school year, and 4 Development of anti-bullying/anti-harassment program that incorporates the use of “student ambassadors” as peer advocates for victims of bullying and harassment.

#### Some Highlights of the 2011-2012 School Year:

- 1 Active Loranger PTO that hosted a number of fund-raising events throughout the year (i.e. Kids Night Out, Penny Social) that raised money to support music camp scholarships, Camp Kieve scholarships, and materials for the academic classrooms.
- 2 8<sup>th</sup> grade Camp Kieve week-long experience at the leadership school
- 3 Continued work with the Center for the Prevention of Hate through the Unity



- project initiative – an anti-bullying & harassment program
- 4 School-wide “Red Ribbon Week” celebration focused on no tolerance for drugs
  - 5 6<sup>th</sup> grade awareness – day program focused on team-building skills and responsible decision-making
  - 6 STAR Day – A day that focuses on diversity/tolerance/respect/& safety. The presenter/performer this year was Johnny the “K” who did an outstanding job getting his message across to the school-wide audience.
  - 7 In February the 8<sup>th</sup> graders participated in the State History Day competition. We had a number of LMS students who were recognized for their fine efforts in this competition.
  - 8 In February, we had our annual LMS Talent show which showcased many talented students who performed in the show. There were 18-20 different performances by students in grades 4-8.
  - 9 In the Spring 7<sup>th</sup> graders participated in a “JA in a Day” activity. This is sponsored by Junior Achievement and gives great exposure to our students in helping to connect the learning environment with the real-world environment of business.
  - 10 Also in the spring the 7<sup>th</sup> and 8<sup>th</sup> grade participated in a Career Day that was sponsored and organized by our LMS guidance counselor – Beth Nason.
  - 11 In early June, LMS hosted the annual “Evening of the Arts” event where we showcase the artistic talents and musical talents of our LMS students.
  - 12 In May the LMS administration and staff hosted the 1<sup>st</sup> annual Anti-bullying & Anti-harassment parent forum to educate and inform parents on issues specific to Loranger Middle School

## **OLD ORCHARD BEACH HIGH SCHOOL- ANNUAL TOWN REPORT**

The 2011-2012 school year ended in some outstanding ways. Old Orchard Beach High School had a graduation rate of 87.7%, with 72% of those graduates going on to a two or four-year college. Old Orchard Beach also made the “No Child Left Behind” criteria for by making Annual Yearly Progress, by which all public high schools in the state are evaluated. This is a significant accomplishment, for only approximately 20% of the high schools in Maine earned this distinction.

The Old Orchard Beach High School began the school year on September 5, 2012 at 251 students. The first day of school, September 4, 2012, was devoted to the freshman class. On September 5th, all students were back at the high school for their first official day. An assembly to welcome students and introduce new faculty and staff started the day.

The High School held its sixth annual “Freshman Welcome” at the high school on September 4th. We had a wonderful turnout of parents and students on a glorious fall



evening. After the Freshman Welcome, we had our Annual Open House where parents were able to meet with their child's teachers and get a comfortable feel for our school.

Our Homecoming activities were held the week of October 1st. The Student Council and Mrs. Partridge did a fabulous job of organizing and successfully running the week long Spirit Week Activities. The various activities were highlighted by the annual Bonfire and with the Saturday night Homecoming Dance.

October started with all sophomores and juniors taking the PSATs on the 17th. The guidance department hosted a College Information Night in the high school cafeteria where our guidance counselors presented material to seniors and their parents regarding the college application and selection process.

All of our fall sport teams did very well this year. Each team (football, field hockey, golf and girls' soccer) made it to the playoffs for the first time together in a while. Way to go! The field hockey team lost to Lisbon in the quarterfinals, the football team ended their season with a hard fought loss to Dirigo in the quarterfinals 19-14, and the girls' soccer team lost to Sacopee Valley with a score of 1-0 in double overtime. Congratulations to all teams for a great 2012 season!

On Friday, November 2nd at midnight, 4 Interact students from OOBHS joined about 50 other Interact students from Maine and NH to head to New York City. They spent most of the day at the United Nations building listening to other Interact clubs from around the world and their projects. A few organizations spoke to the students about different service projects the Interact club can participate in. It was nice for the students to meet other students from all over the US and other countries. The four from OOBHS got a few ideas to bring back to our club. After the UN portion, they walked to the Empire State Building where they experienced some great views of the city. Then they headed to Time Square for some shopping, dinner and a Broadway play. After they saw "Newsies", they boarded the bus and headed home. We are hoping to make this an annual trip, with a goal of presenting a service project we have done.

The academic focus of November is always Parent Conferences. This year's parent conferences were held on the evening of Nov. 18 and on Nov. 23. We ended with more than one third of our parents participating in conferences.

On November 8<sup>th</sup>, we had 13 students inducted into the National Honors Society. After the students were inducted their families were treated to a wonderful dinner buffet to celebrate their accomplishments.

The week ended with one of our best Food Drive's yet. We as a school were able to collect over 42,000 pounds of food that was evenly distributed over our five local food pantries. On top of donating all of that food, we were able to give each pantry a check for \$1200.00. This definitely was a great feeling to give back to such a great community.

**The Interact students have been hard at work volunteering around the Community. A handful of members volunteered at Seasons by the Sea event in December. A couple even dressed up as reindeer and frosty to greet the children.**

**As of December 13, 2012, our Guidance office has processed over 125 transcript request and 17 of our seniors have already been accepted to College's they applied to.**

**We look forward to continuing a great year here at OOBHS.**

**The Special Education Department of the Old Orchard Beach Schools is responsible for providing an appropriate education to all students with disabilities in accordance with Federal and State laws. The State of Maine defines the following disability categories to which schools must be responsive:**

In addition, speech and language therapy is provided to eligible students in grades K-12 by Deborah Maksut, Cherelle Oakes and Sandra Welzel. Lisa Kurtz and Molly Walrath provide occupational therapy. We contract with Mainely Kidz PT to provide physical therapy. Laurel Tinkham, psychological examiner provides evaluations and consultation for our special education students.

A total of 1 student was placed in special programs outside of our public schools in order to receive appropriate special education programming.

The Old Orchard Beach Schools also provide Title I services to students in grades K-12 who could benefit from remediation in reading and in math. Title I personnel provide these services through the direction of classroom teachers to approximately 105 students. Our Title I personnel are as follows:

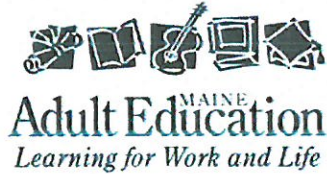

## **Old Orchard Beach/Saco Adult & Community Education**

OOB/Saco Adult & Community Education offers a variety of academic, vocational, and enrichment classes for residents of Old Orchard Beach, Saco, and other surrounding communities.

### **OOB/Saco Adult & Community Education Program Areas**

#### **High School Completion**

GED program that includes pre-testing, instruction and testing for high school equivalency and through an adult high school diploma program that provides the opportunity for individuals to complete their graduation requirements.

#### **Literacy & Family Literacy**

Through classroom instruction or tutoring, this program area teaches the basic reading comprehensive and numeracy skills necessary to function in our literate community. Specific areas of literacy programming include English as a Second Language instruction and Family Literacy, an approach integrating both early childhood and adult education and parenting skills.

#### **College Transitions**

Maine College Transitions, in partnership with community colleges and the university system, offer high-quality, cost-effective and accessible pathways to post-secondary education for adults. Offered through local adult education programs, College Transitions includes career planning, assessment, college experience, tracking and follow up, and instruction in college preparation coursework.

#### **Business & Skills Training**

Instructional programs designed to meet the needs of individuals seeking to gain employment or small businesses in need of training programs for their workers. Common programming areas include medical transcription, personal support specialist, career counseling, and office skills.

#### **Personal Enrichment**

Programs designed to meet the lifelong learning needs of adults and their communities. The activities are varied in response to the unique needs of each community ranging from foreign language, to wellness and exercise, to a wide-variety of skill and craft classes. The courses are housed in public schools but all instructional and material costs are borne by the learners.

As we begin a new year, I welcome this opportunity to share some of my recent work for the people of our great state.

The economy and jobs remain my highest priorities. More efficient transportation is essential to our economic growth. After a years-long, hard-fought battle, I successfully pushed through Congress a bill I wrote to allow the heaviest trucks to travel on Maine's federal interstates, instead of forcing them to use our secondary roads and downtown streets. This will make our streets safer, reduce fuel consumption, and allow our businesses to be more competitive. I was pleased to have the support of many Maine groups, from the Maine State Police and the Parent-Teacher Association to the Maine Motor Transport Association and many others that helped me advocate for this sensible change.

I was also successful in my efforts to prevent the federal government from limiting certain vegetables, including Maine's potatoes, in school meal programs. Nationwide this ill-conceived proposal would have cost our schools, the states, and families an estimated \$6.8 billion over five years. I built support from both sides of the aisle and from across the country to ensure that schools maintain the flexibility they need to serve students healthy and affordable meals. This proposed rule was a prime example of excessive Washington regulation.

In my effort to protect jobs, I also introduced bipartisan legislation to ensure that the proposed EPA regulations known as the "Boiler MACT" rules protect the environment and public health without jeopardizing jobs in our state, particularly in the forest products industry. I also continued to help advance the development of deep water, off-shore wind energy at the University of Maine, which has the potential to provide clean energy and to create thousands of new jobs.

On the Armed Services Committee, I worked to secure funding for shipbuilding at Bath Iron Works, submarine overhauls at Portsmouth Naval Shipyard, and the manufacturing of aircraft engines at Pratt and Whitney, as well as to strengthen the 101st Air Refueling Wing in Bangor and the Maine Military Authority in Limestone. The new defense funding bill also includes my amendment to expedite the claims of veterans with severe disabilities like the soldier I met who is suffering from ALS, also known as Lou Gehrig's disease.

Last year, the President signed legislation I coauthored creating a national plan for combating Alzheimer's disease, which affects more than five million Americans and their families. In another health-related development, at my urging, the Food and Drug Administration allowed clinical trials to begin on the artificial pancreas, a device that could dramatically improve the health and quality of life for people with Type I diabetes.

Many Mainers have contacted me to express concern about the Postal Service, which is the linchpin of a nearly \$1 trillion mailing industry that employs 8.6 million people. I've sponsored bipartisan legislation to rescue the U.S. Postal Service from financial failure next year. This bill provides flexibility to the USPS to restructure itself in an effort to save billions of dollars and preserve universal postal service for all Americans, no matter where they live.

In December, I cast my 4,825<sup>th</sup> consecutive vote, making me the longest currently serving Senator never to have missed a vote. I am grateful for the opportunity to serve the Town of Old Orchard Beach and Maine in the United States Senate.

Dear Friend,

I hope this letter finds you and your family well. It continues to be an honor to represent you, and I wanted to take a moment to share with you some of the work I've done in Washington and Maine over the last year.

As you know, times are not easy. The country still struggles to recover from the recession, which is why I'm so frustrated Congress has not been serious about job creation. Voters elected us to Congress with the highest priority of getting the country back to work. While we should have been voting on jobs legislation, we have ended up debating anything but.

I am proud, though, to have worked on my own piece of jobs legislation in 2011. Local food is a growing part of Maine's economy and has helped revitalize a traditional staple of our communities—the family farm. We have seen incredible increases in CSA farm shares, farmers markets, and acres in cultivation.

But outdated federal policy hasn't done enough to support this bright spot, and often hinders it. I've introduced the Local Farms, Food, and Jobs Act to bring local farmers the resources they need to continue growing. If passed, it means investments in our regional food infrastructure, help for local schools to buy food produced in their communities, and giving more and more people affordable access to local food.

Another piece of legislation I introduced in 2011 would help service members who are victims of military sexual assault. This has become an alarming problem as thousands of women—and men—report being sexually assaulted while serving. I've listened to many of them who are from Maine. My legislation would ease the restrictions they currently face to get disability benefits from the VA.

As a member of the House Armed Services Committee, I've been able to work on several policies that affect our military personnel. It also means that I've kept close watch on our operations overseas. In 2011, we saw some good news on this front. First, we finally found and killed Osama bin Laden. The second came with the official end to the war in Iraq.

I am so glad that the Mainers who have served there will be able to return home. But we can't forget the nearly 4,500 soldiers we lost in Iraq—24 of them from Maine—nor the men and women who continue to serve in Afghanistan. I hope we can start to bring them home in 2012.

My thoughts now are also with the many Maine families who can't afford to heat their homes. I'm disappointed to see deep cuts in LIHEAP, a program thousands of Mainers rely on. I've introduced legislation to restore the funding and I will keep fighting to get Mainers the support they need.

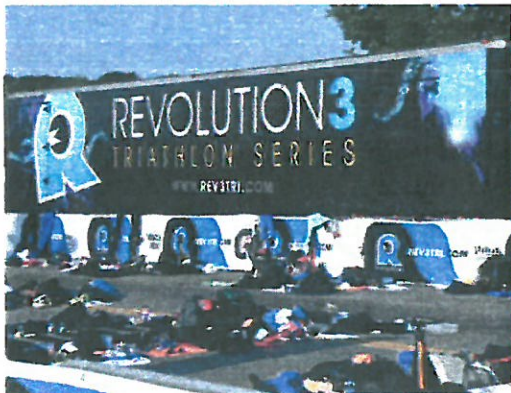
