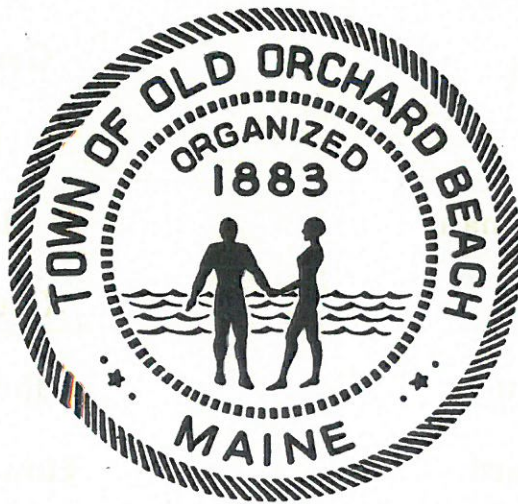

REPORT OF SUPERINTENDENT OF SCHOOLS

To the Superintending School Committee and Citizens
of Old Orchard Beach:

The annual report of the public schools of Old Orchard Beach for the fiscal year ending December 31, 1956 summarizes in part the year in education at the national and local level and concludes with teacher, pupil, and financial statistics.

THE 1956 STORY

I. Nation-wide—Here are the headlines of the chapter headings of the book on education for the past year which we have experienced directly or indirectly.

NEW SCHOOLS?

Let's construct roads! Schools can wait it out. Nobody denied the need for roads or schools, but, strangely enough, nobody asked why the States could not build their own highways. For every dollar invested in State roads there will be a matching federal dollar and inter-state roads will bring a nine for one return. So some of the children in the United States will go without schoolhouses because road building is a more practical proposition.

ENROLLMENTS?

One-half of the nation's population is engaged in some organized program of education. The September enrollments in all schools and colleges were increased by some 1,754,300 over that of last year. The elementary grades were up 4 per cent; and colleges and universities were up 9 per cent.

TEACHERS?

School administrators named their greatest problem of the year as "getting and holding teachers." Some added "of quality" while some prefixed the word "any." This has been a well known problem since 1943. But an upturn in the annual production was noticed in 1956. The shortage in qualified elementary and secondary school teachers this past year was 120,700 as compared with 141,300 in September of 1955. As average salaries move upward, supply and demand figures move closer together.

II. Old Orchard Beach

Most of the problems in education locally could be placed on a dollar and cents basis for a solution. Certainly the high turnover of teachers, 22 per cent in 1956, could have been checked somewhat with a better salary schedule. Teachers left our schools for better paying positions in Portland, South Portland, New Jersey, New York, and California. Seven of our teachers have accepted positions in the greater Portland area during the last two years.

SALARIES

Maine is in the 44th position in average salaries of school teachers among the 48 states. Only four states have lower teachers' salaries. Old Orchard Beach is in 50th position among 64 towns and cities of 2500 population or better. The highest average salaries in this group were \$4,183.00, the lowest were \$2,806.00, and Old Orchard Beach salaries averaged \$3,149.00.

A new salary schedule calling for immediate raises of at least \$300.00 per teacher has been recommended. Since most other communities are raising their teachers by a similar amount it is not expected that this increase will affect the relative positions of local average salaries.

VOCATIONAL EDUCATION

A building problem has been called to our attention by the State Department of Education. The space requirements for present day courses in Home Economics and Industrial Arts are not available in the present rooms used for the above purposes in the High School.

It has been suggested that modern shop, complete to present day standards be constructed as a separate building. The present shop might then be used for Home Economics. Again, since the gymnasium is classified as much too small for present day needs, it has been suggested that a new gymnasium be constructed separately from the present building and a new Industrial Arts shop be housed in this building.

It has been recommended that study groups be formed to clarify the needs and develop a satisfactory solution. A committee under the sponsorship of the Parent-Teacher Association has been activated relative to the needs of Vocational Education. Perhaps others will study the problem from the athletic point of view.

SCHOOL MAINTENANCE

Maintenance works under the direction of Edward Townsend were carried on throughout the summer months. Cleaning, painting, general repairs, and care of grounds were scheduled as in the past.

Special projects in addition to the usual professional care of boilers and oil burners included: grading and surfacing the Federal School year, new playground surface at the Elementary School, painting the window frames and trim of the Elementary School, installation of a sprinkler system at the Elementary School, ledge removal and landscaping at the Jameson School as well as the installation of new drinking fountains at the High School and the Federal School.

A steam line leak was discovered and corrected under the floor of the old typewriting room. The under-floor was leveled and new tile completed the renovation of this room.

The redwood on the Jameson School was refinished under an agreement with the architect who supplied the material. A new sign was constructed by the Art and Manual Training departments and erected on the grounds of this school and closet shelving was completed during the fall under the direction of Mr. Gilley.

NEW TEACHERS

While the total number of teaching positions remained the same for the 1956 fall term as that of last year, the per cent of new teachers for replacements was 10 per cent higher than the State average. Ten new teachers representing more than one fifth of the teaching roster were engaged for the new year.

Three local teachers were among those selected. Mrs. Mary Fallon returned once again to teaching duties as an 8th grade instructor. Mrs. Fallon replaced Mrs. Mildred Woodworth who accepted a position in the Portland School system. Mr. Jerome LePelletier accepted the English Department assignment held by Mrs. Pearl Fickett of Gorham. Mrs. Fickett was given a year's leave of absence because of illness. Mr. E. Emerson Cummings replaced Mr. Charles Loranger in the Mathematics and Science fields. Mr. Loranger resigned to enter a teaching branch of the insurance business.

Mrs. Dorothy Wilson of Winterport was elected to replace Mrs. Margaret Scott who had accepted a position in the South Portland schools. Mrs. Wilson has taught for the past five years in Winterport. Mrs. Phyllis Borden of Saco, a former Biddeford teacher, replaced Mr. James Scully, a teacher in the 7th grade in the Federal School. Mr. Scully resigned to accept a position in New Jersey.

King Bishop of Cape Elizabeth succeeded Mr. Donald Allgrove who left for a teaching position in New York State. Miss Norma Blanchard of Leominster, Mass., was assigned the Art teaching vacancy created by the resignation of Mr. Robert Scamman. Mr. Scamman is now teaching in California.

Mrs. Clarice Stanley of Saco, a former teacher in Biddeford High School, replaced Mrs. Mary Graff in the English Department while Miss Reginia Cheney of Dover-Foxcroft was assigned to Mrs. Pauline Fisher's class in the Jameson School. Mrs. Graff and Mrs. Fisher did not return to teaching last fall. Miss Celia Philbrook left to be married and Mrs. Lillian Lee of Portland replaced Miss Philbrook in the Physical Education Department.

FINANCES

The fiscal year closed on December 31 with a balance in the school account of \$1,141.42. The account was helped to a large degree with financial aid under Public Law 874 to the amount of \$2,474.66.

It is to be expected that school costs in Maine will rise due to our relatively low position nation-wide as well as due to the increase in the cost of living. School cost in Old Orchard Beach should increase from the salary factor viewpoint alone. We cannot afford to lose our well trained experienced teachers.

It is possible that some measure of relief to the several towns and cities of Maine will be forthcoming in the form of increased State subsidy in this new legislative year.

CONCLUSION

In closing, I would like to leave the thought that while we are all very proud of what has been accomplished with and in our schools, there is still much to be done.

My thanks are especially extended to the Kiwanis Club of Old Orchard Beach for their outstanding gifts of machines to test for defects in sight and hearing. It is a pleasure, as well, for me to extend my personal thanks to the Superintending School Committee and to the citizens of Old Orchard Beach for their contribution to the progress of education at the local level.

SUPERINTENDENT OF SCHOOLS

SCHOOL NURSING REPORT 1956

To C. J. Cutts, Superintendent of Schools:

We opened our school year for 1956 with First Aid classes held twice weekly from January into April for the 8th grade group. Sixty-eight students received Junior Red Cross First Aid Certificates. (This marks our twelfth year of having over 60 students per year gain First Aid Certificates.)

Polio clinics were held in February, April and June and again during the fall term (October and December 1956). A total of 1,783 inoculations were given during 1956.

Our thanks from the school service is extended particularly to our school doctor, Dr. Donald Skilling, who gave all the inoculations and to the following group of nurses and workers who covered the clinics:

Mrs. Helen Curry, R. N., Mrs. Gertrude Milliken, R. N., Mrs. Jean Fitanides, R. N., Mrs. Diana Bird, R. N., Mrs. Helene Fowler (our secretary).

The whole school personnel, principals, teachers, custodians and children cooperated on the polio clinic project.

(1957—January clinic—576 received the third inoculation.)

The regular Patch testing program of checking for signs of T. B. was carried on for the Junior primary group, the new students in all grades, the 8th grade group and the senior high school class, plus extra pupils as advised by the State X-ray clinic or requested by local doctors.

Over 250 test patches were given on this health project. Chest X-rays were done on two students who were positive reactions and had a suspicious family health picture. Both were found O. K.

Toxoid and vaccine clinics were held at the town hall and children needing such protection were referred to this service. The general figure on this immunization program is low for the past year as the polio vaccine program was given precedence and to

avoid the possibility of "upsets", other immunizations were kept at a minimum. We are pleased to report now that a year has passed since the polio program was started that we have had no upsetting reactions to the inoculations.

During February, 1956, we started on a new service of Mental Health tests. Dr. Leighton Cheney of the Sweetser Home in Saco, has visited us several times during the past year for the purpose of helping children and parents to recognize various emotional and mental problems and to make adjustments accordingly.

Some 13 children have worked with this program by taking the tests and 6 more have had conference advice through the year. This has been a valuable help to the children, parents and teachers concerned.

Another new addition to the school nursing duties has been a class on Health and Hygiene carried on in the high school since the fall term of 1956. We discuss various teenage problems, do reading assignments and write summaries on matters of health and hygiene, make reports to the class group, and have a question box. We must give thanks to several state agencies, book companies and individuals for help on materials for this class. The job of growing up calls for many helping hands today—for both "a pat or a push" along the way.

Another excellent help to us during the fall term of 1956 was a double gift from our local Kiwanis Club.

An eye sight testing machine that Dr. Oliver, our local eye doctor, found very helpful in his work with the school children, and a Pure Tone audiometer which the school nurse had studied and practiced on and hopes for the future to make much use of in hearing tests.

Other local services, as our Town Nursing service, the Hot Lunch program, the Dental Clinic, and individuals and groups interested in our school children's welfare helped to make 1956 a good year in school nursing.

Dear Mr. Cutts:

This year the total number of students examined in our schools was seven hundred and seventy-five. In this group there were forty-six minor abnormalities, most of which can be corrected and only a very few whose condition are repetitive.

As of this writing there has been a minimum of contagious or infectious diseases and we hope the pattern will continue.

It is with a great deal of pleasure that I report to you that all the students in our schools have had the opportunity to receive the Salk vaccine. This program was set up and started last year and inoculations given this year so that by the time school closes in June the vast majority will have received the full protection as set up by the National Foundation for Infantile

Paralysis. This is indeed a tremendous step forward in protecting our children against one of its greatest enemies.

A few parents have been reluctant to give their permission for the Salk vaccine, but it is hoped they may take advantage of this at a later date.

Some pupils received the inoculations from their own physicians.

Let me also state that too much credit cannot be given to the lay-personnel and nurses who gave their time and skill so willingly and ably at each and every clinic. I understand Mrs. Murphy will list them in her report.

To Mr. Cecil J. Cutts, Superintendent of Schools:

The results of the visual program conducted this year in the grade schools at Old Orchard Beach on the students who failed to pass the required Snellen Test given by their teachers were as follows:

1. Of the 138 children seen, 34 were recommended for immediate care.
2. 42 were recommended for rechecks before school each fall.
3. 7 minor pathology cases were noted.
4. 12 pairs of glasses were dispensed to children whose cost was paid by local service clubs.

It is expected that the new visual sight screening device donated to the town by the Kiwanis Club of Old Orchard Beach will further refine the screening done by the teachers next fall, so that a child's vision as well as his visual comfort can be detected, and the proper correction made to improve his facility to learn.

My thanks to the School Committee for recommending continuation of the Sight Screening program; to the teachers for their cooperation; and to Mrs. Murphy for her interest and help.

MEMORIAL PARK

REPORT OF THE PARK COMMISSIONERS

It is with pleasure that the Park Commissioners can report to the residents of the Town of Old Orchard Beach that the State auditors personally complimented this Commission for the way and manner in which the parking money was collected, accounted for and deposited. A new system of collection was put into effect this past year, whereby automobiles drove by a toll house and the parking fee collected by bonded employees. The money collected was insured against theft until the time of deposit in the York National Bank.

Cement steps were constructed from the parking area down to First Street. The park area between the parking lot and First Street, the area between First Street and the railroad property, as well as the area between the parking lot and the Libby Memorial Library was graded, seeded, watered and mowed, under the direction of your park commissioners.

The public park area between Atlantic Avenue and Central Park Avenue, known as Centers Park, was also mowed and taken care of by your commissioners.

Fill was obtained free and placed in the park area next to Heath Street and will be leveled and covered with gravel to improve and make additional parking space available.

Expenses were high this year due to the reorganization of the parking area. This increased cost of operation will not be necessary this coming season as the organization and method of operation and the cost to set up this operation will not have to be duplicated.

The Commissioners would like to extend their appreciation to the thoughtful cooperation and help given the park commissioners by the Women's Civic Group, who planted flowers and trees to beautify the park, all for the benefit of the Town of Old Orchard Beach.

REPORT OF OFFICIAL INFORMATION BUREAU

To the Honorable Board of Selectmen and Citizens of
Old Orchard Beach:

It is again with pleasure that I express my appreciation to you and to the citizens of Old Orchard Beach for the courtesy and cooperation extended to me during 1956 in my capacity as director of the Official Information Bureau.

We again followed the same procedures as proposed in 1955—an agreed upon advertising and publicity program whereby the Chamber of Commerce would operate the Information Bureau and pay all its expenses. In turn our town appropriation for advertising would be spent for increased newspaper advertising and promotion as approved by your board.

All expenses for the operation of the Information Bureau including the Executive Director's Salary, printed booklets, forms, stationery, postage and telephone were paid by the Chamber of Commerce and totaled \$7,685.00. This money was raised by the sale of advertising space in our booklet on accommodations and from membership dues in 1956. Our membership in 1956 numbered 138 members showing better than 100 per cent increase over 1955.

The Harry M. Frost Advertising Agency of Boston in cooperation with the Advertising Committee of the Chamber of Commerce and the executive director, planned a program of newspaper advertising and publicity which returned 4,724 direct mail inquiries and 422 inquiries from travel bureaus located in various newspaper offices, both in Canada and the United States. Our cost per inquiry of ninety-eight cents is considered exceptionally low and basically sound in the field of newspaper advertising where the cost of lineage continually increases. Our direct mail shows a

gain of 1,871 inquiries for 1956 over 1955. Sixty per cent of the town appropriation allocated to newspaper advertising was spent in the four Canadian Provinces, over seventy per cent of our inquiries come from this source. I wish to express my sincere thanks to Mr. James Cruikshank and to the Frost Agency of Boston for their efforts in our behalf.

Traffic records at the Bureau shows a decrease in the number of parties routed to different types of accommodations. In 1956 we placed 637 parties totaling 2,440 persons or an average of 3.7 persons per party and staying for an average of 4.7 days. Train and bus inquiries totaled 4,250. We also distributed 1,652 road maps, 3,000 bumper decals and 65,000 pieces of literature from the Information Bureau. We mailed in package form to travel bureaus and Chamber of Commerce Bureaus over 20,000 brochures in our effort to attract summer vacationists to Old Orchard Beach.

The Chamber of Commerce had a window display in the Montreal Star Travel Bureau and the Canadian National Ticket Agency in Quebec City where we will again have our displays in 1957. We also had a booth display at the Hartford Travel Show and expanded on all services catering to the tourist business in our effort to attract visitors to our area.

Now just a word about 1957 advertising, I have requested that the budget committee recommend an appropriation for advertising which will allow us to expand our newspaper coverage to include new areas which have been brought closer to Old Orchard Beach for those traveling by car with improvement in highway travel. This coverage includes; Lowell, Lawrence, Haverhill, Nashua, central and western New York, New Jersey and Pennsylvania, also additional coverage in central Quebec Province. The 1956 Federal Reserve Survey covering vacationist to New England showed the greatest number coming from the above mentioned points. We also need roadside and directional signs along the routes from Canada—new town brochures

and a listing of all resorts who have accommodations available, all to be used in publicizing the natural and recreational resources of Old Orchard Beach. Tourist business is 70 to 80 per cent of basic economy of our community, and we must advertise to be able to compete with other beach resorts along the Atlantic Coast. With sufficient budget to work with, we can plan a progressive program that will attract more vacationers to this community.

My report would not be complete if I did not express my appreciation to the following for their fine cooperation, the Montreal Star Travel Bureau Personnel, The Canadian National Railroad Travel Bureau Personnel of Quebec City, the Personnel of all town departments, to my secretaries, Mrs. Doris Ellingwood, Mrs. Joan Tenan, to Chamber of Commerce members and advertisers, to private individuals and to the press of Biddeford, Portland, out of state, and Canadian newspapers.

To J. Leo Farrington, a constable of the Town of Old Orchard Beach, in the County of York and the State of Maine.

GREETINGS:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of said Town of Old Orchard Beach, qualified to vote in town affairs, to assemble at the High School in said Old Orchard Beach on Monday, the Fourth day of March, A. D. 1957 at 9 o'clock in the forenoon, then and there to act on the following articles, to wit:

Article 1. To choose a Moderator to preside at said meeting.

Art. 2. To hear and act on the report of the Selectmen and other town officials.

Art. 3. To choose all necessary town officers for the ensuing year.

Art. 4. To see if the Town will vote to raise and appropriate the sum of \$50.00 to be used for decorating graves on Memorial Day, under the direction of the American Legion, said sum to be taken from Licenses Income.

Budget Committee so recommends.

Art. 5. To see if the Town will vote to raise and appropriate the sum of \$200.00 for defraying the expenses of the Memorial Day parade and exercises, under the direction of the Memorial Committee, said sum to be taken from Licenses Income.

Budget Committee so recommends.

Art. 6. To see what sum of money the Town will vote to raise and appropriate to defray the expense of Town Administration for the year 1957.

The Budget Committee recommends that \$16,750.00 be appropriated, that the salary of each Selectman be \$75.00, the salary of each assessor be \$75.00, and the salary of the Town Clerk be \$2,000.00 annually and paid from the appropriation for administration.

Art. 7. To see what sum the Town will vote to raise and appropriate for the hire of clerical assistance for the assessors.

Budget Committee recommends \$1,000.00.

Art. 8. To see what sum of money the Town will vote to raise and appropriate for the hire of an experienced Assistant Assessor from April 1st until date of commitment.

Budget Committee recommends \$1,500.00.

Art. 9. To see what sum of money the Town will vote to raise and appropriate for planting flowers and trees, in various sections of Town. Said sum to be expended with the approval of the Town Manager.

Budget Committee recommends \$300.00 from Parking Lot Income.

Art. 10. To see what sum of money the Town will vote to raise and appropriate for heating, lighting and general maintenance of the Town Hall.

Budget Committee recommends \$5,975.00

Art. 11. To see what sum of money the Town will vote to raise and appropriate for Civil Defense and Public Safety.

Budget Committee recommends \$1,000.00 and that unexpended balance be carried forward as a credit balance in the following year.

Art. 12. To see if the Town will vote to raise and appropriate the sum of \$186,905.00, for schools to be divided as follows: Common schools, \$101,200.00; high school, \$44,656.00; textbooks, \$3,563.00; repairs, \$4,500.00; supplies, \$4,959.00; maintenance (utilities, insurance, equipment), \$8,913.00; industrial arts, \$3,975.00; home economics, \$3,375.00; physical education, \$8,000.00; medical-health (school physician, dental hygienist, dentist, optometrist), \$864.00; school committee, \$200.00; supervision, \$2,700.00.

Budget Committee so recommends.

Art. 13. To see if the Town will vote to raise and appropriate the sum of \$2,500.00 for the purchase and erection of portable steel bleachers or grandstands for the high school athletic field.

Budget Committee makes no recommendation.

Art. 14. To see if the Town will vote to authorize the Superintending School Committee to appoint a school physician.

Budget Committee so recommends.

Art. 15. To see if the town will vote to authorize the Selectmen to appoint a committee of five members to act jointly with a study committee of the PTA to report findings and recommendations relative to sub-standard space requirements in the high school for general courses in Home Economics, Industrial Arts, and Physical Education.

Budget Committee so recommends.

Art. 16. To see what sum of money the Town will vote to raise and appropriate for the Public Works' Department, including highways and bridges, snow removal, surfacing, sewers and drains, sanitation, maintenance of Town dump, maintenance of Town Team, and maintenance of sidewalks.

Budget Committee recommends, highways and bridges, \$16,000; snow removal, \$10,000.00; surfacing, \$13,000.00; sewers and drains, \$7,500.00; sanitation, \$22,500.00; town dump, \$7,500.00; town team, \$3,450.00; sidewalks, \$2,500.00.

Art. 17. To see what sum of money the Town will vote to raise and appropriate for the purpose of paying valid outstanding indebtedness of the town.

Budget Committee recommends \$28,500.00 (\$27,000.00 from general taxation, and \$1,500.00 from parking lot income.)

Art. 18. To see what sum of money the Town will vote to raise and appropriate to pay interest on notes and bonds for the year 1957.

Budget Committee recommends \$10,000.00.

Art. 19. To see what sum of money the Town will vote to raise and appropriate for street lights.

Budget Committee recommends \$16,755.00.

Art. 20. To see what sum of money the Town will vote to raise and appropriate for lifeguard service for the year 1957.

Budget Committee recommends \$6,500.00 (Salaries \$4,900.00 and \$1,600.00 equipment.)

Art. 21. To see what sum of money the Town will vote to raise and appropriate to clean the streets and the beach.

Budget Committee recommends \$10,200.00.

Art. 22. To see what sum of money the Town will vote to raise and appropriate to maintain the Police Department for the year 1957, and the enforcement of parking meter regulations.

Budget Committee recommends \$30,000.00 for Police and \$850.00 for enforcement of parking meter regulations. The last mentioned sum to be taken from parking meter income.

Art. 23. To see what sum of money the Town will vote to raise and appropriate for the improvement of the Milliken Street parking lot.

Budget Committee recommends \$750.00 from parking meter income.

Art. 24. To see what sum of money the Town will vote to raise and appropriate to defray cost of installation, removal and repairs of parking meters.

Budget Committee recommends \$500.00 from parking meter income.

Art. 25. To see what sum of money the Town will vote to raise and appropriate for painting curbs, the purchase and installation of traffic signs, and the purchase of a new police car.

Budget Committee recommends \$450.00 for painting curbs; \$500.00 for traffic signs; \$800.00 for new police car. (Curbs and signs costs from parking meter income, and \$800.00 from general taxation.)

Art. 26. To see what sum of money the Town will vote to raise and appropriate for advertising purposes for the year 1957.

Budget Committee recommends \$11,000.00.

Art. 27. To see whether or not the Town will vote to raise and appropriate the sum of Six Hundred Dollars to be paid to the State of Maine Publicity Bureau to be expended and used for advertising the natural resources, advantages and attractions of the State of Maine, in accordance with the provisions of Chapter 91, Section 108 of the Revised Statutes of 1954.

Budget Committee so recommends. \$275.00 for advertising in "Maine Invites You", and \$325.00 for membership in the Maine Publicity Bureau for 1957.)

Art. 28. To see what sum of money the Town will vote to raise and appropriate for Contingent Expense.

Budget Committee recommends \$5,000.00.

Art. 29. To see what sum of money the Town will vote to raise and appropriate to pay the salary of the License Inspector, namely Mr. Fred I. Luce.

Budget Committee recommends \$1,000.00.

Art. 30. To see what sum of money the Town will vote to raise and appropriate for the salary and travel expense of the Health Officer.

Budget Committee recommends \$500.00 salary and \$100.00 travel expense.

Art. 31. To see what sum of money the Town will vote to raise and appropriate for Health Nursing Service and Immunization.

Budget Committee recommends \$4,776.00 for Health Nursing Service, and \$300.00 for Immunization.

Art. 23. To see what sum of money the Town will vote to raise and appropriate for Public Assistance and for Aid to Dependent Children.

Budget Committee recommends \$10,000.00 for Public Assistance and \$1,400.00 for Aid to Dependent Children.

Art. 33. To see what sum of money the Town will vote to raise and appropriate to assist the Library Association.

Budget Committee recommends \$7,000.00.

Art. 34. To see what sum of money the Town will vote to raise and appropriate for the Town's share of Social Security payments for the year 1957.

Budget Committee recommends \$3,000.00.

Art. 35. To see if the Town will vote to raise and appropriate \$375.00 to be paid to the Ocean Park Association for the Town's share of the cost of cleaning Temple Avenue and Ocean Park Beach.

Budget Committee so recommends.

Art. 36. To see what sum of money the Town will vote to raise and appropriate for State Aid Road Construction (in addition to the amounts regularly raised for the care of highways and bridges), under the provisions of Section 44, 49, or 50, Chap. 23 R. S. 1954 amended.

Budget Committee recommends \$3,730.00 to be used on Temple Ave.

Art. 37. To see what sum of money the Town will vote to raise and appropriate for Workmen's Compensation Insurance, and Liability Insurance on Town Hall and Comfort Station.

Budget Committee recommends \$2,200.00 for Workmen's Compensation, and \$150.00 for Liability Insurance.

Art. 38. To see if the Town will vote to authorize the Park Commission to operate the public parking area for hire during the season 1957, and to pay over to the Town Treasurer daily all receipts. Disbursements to be made by the Treasurer upon approved vouchers signed by a majority of the Park Commission and approved by the Board of Selectmen as prescribed in the Revised Statutes of 1954.

Art. 39. To see if the Town will vote to appropriate from Surplus the sum of \$4,621.66, to the Parking Lot Income account, so called.

Art. 40. To see if the Town will vote to authorize any unexpended balance in the Parking Lot Income account, so called, for the year 1957, to be carried over into the same account for the year 1958.

Art. 41. To see what sum of money the Town will vote to raise and appropriate for hydrant rental for the year 1957.

Budget Committee recommends \$32,124.00 (one new hydrant at Ocean Park.)

Art. 42. To see if the Town will vote to appropriate from Surplus the sum of \$3,810.00 for hydrant rental, to cover bill already rendered for additional charges for 1956, for which no provision had been made.

Budget Committee so recommends.

Art. 43. To see what sum of money the Town will vote to raise and appropriate to maintain the Fire Department for the year 1957.

Budget Committee recommends \$25,700.00.

Art. 44. To see if the Town will vote to raise and appropriate a sum of money to employ an assistant Fire Inspector for the ensuing year.

Art. 45. To see if the Town will vote to authorize the Selectmen and Town Treasurer to deposit an amount equal to the unexpended balance in the Fire Department account at the close of the 1957 fiscal year, in the Town of Old Orchard Beach Capital Reserve Fund, known as the Fire Department Major Equipment Account.

Art. 46. To see what sum of money the Town will vote to raise and appropriate for the purpose of having sewer line maps made.

Budget Committee recommends \$1,500.00.

Art. 47. To see what sum of money the Town will vote to raise and appropriate to complete the Colby Avenue sewer project. (Relaying sewer.)

Budget Committee recommends \$5,775.00.

Art. 48. To see if the Town will vote to raise and appropriate a sum of money to clean out septic tanks in the sections of Old Orchard Beach that are not serviced by sewer lines, when considered necessary after inspection and recommendation by the Health Officer.

Art. 49. To see if the Town will vote to raise and appropriate the sum of \$1,100.00 for the purchase of a trailer-type compressor and jack-hammer, with 25 foot hose, chisels, and equipment.

Budget Committee so recommends.

Art. 50. To see if the Town will vote to accept as Public Ways the following streets, as laid out by the Selectmen:

Weymouth Ave., 120 feet westerly to W. Grand Ave.

Connecticut Ave., 100 feet westerly from 10th St.

Tioga Ave., 150 feet easterly (continuation).

Casco Ave., 50 feet westerly (continuation).

Queen Ave., northeast side of Grove Ave., 200 feet.

Budget Committee recommends acceptance of all, except Queen Ave.

Art. 51. To see what sum of money the Town will vote to raise and appropriate to grade and gravel the following streets:

Budget Committee recommends \$1,200.00.

Art. 52. To see what sum of money the Town will vote to raise and appropriate for sidewalks in the following locations:

West Grand Ave., easterly side, Colby to Temple Ave., 130 feet,	\$260.00
Center Street, northerly side, 90 feet,	\$180.00
Francis Street, from Imperial to Brad- bury Street, 150 feet,	\$300.00

Budget Committee recommends \$740.00.

Art. 53. To see what sum of money the Town will vote to raise and appropriate to cover the brook on West Grand Avenue.

Budget Committee recommends the sum of \$3,500.00.

Art. 54. To see if the Town will vote to authorize the Selectmen to grant a 1% discount on taxes paid within one month from commitment.

Budget Committee so recommends.

Art. 55. To see if the Town will vote to raise and appropriate the sum of \$1,500.00 to carry out the purpose of Article 54.

Art. 56. To see if the Town will vote to raise and appropriate the sum of \$145.95 to reimburse Edgar Deprey for improperly assessed personal property taxes for the years 1955 and 1956.

Art. 57. To see what sum of money the town will vote to raise and appropriate for membership in the Maine Municipal Association.

Art. 58. To see if the Town will vote to amend Chapter 5 of the By-Laws of the Town of Old Orchard, enacted in 1925, as amended, by adding thereto the following section to be known as Section 4: "It shall be unlawful for any person to set, light, kindle or maintain any outdoor open fire of any kind or nature within the limits of the town without first obtaining a written permit therefor from the Chief Engineer of the Fire Department. The penalty for violation of this section shall be by fine not to exceed twenty-five (\$25.00) for each offense."

Art. 59. To see what action, if any, the Town will take to relocate the T-for-Turn Road, so called, in its proper location.

Art. 60. To see if the Town will vote to raise and appropriate the sum of \$600.00 for use by an appointed By-Laws Committee, to comprise three local attorneys and two laymen; the attorneys to receive \$100.00 each, and the balance of \$300.00 to be applied to cost of printing By-Laws.

Art. 61. To see if the Town will vote to construct a storm drain on the southwesterly side of Center Street, extending from Charles Avenue to Saco Ave., there connecting with the proposed State Highway drainage system. This project to include four catch basins, one on each of the following streets: Charles Avenue, Maple Avenue, Murphy Avenue and Michaud Avenue.

Budget Committee recommends the sum of \$2,000.00.

Art. 62. To see what sum of money the Town will vote to raise and appropriate for changing the existing 1,000 lights to 6,000 lumen lights on Center St., namely poles numbered J2, J5, J7, at a yearly increase of \$148.00.

Budget Committee does not recommend.

Art. 63. To see if the Town will vote to grade and gravel so much of Sunset Drive as has not been graded, and erect such retaining wall as is necessary, and how much it will appropriate therefor.

Art. 64. To see what sum, if any, the Town will vote to raise and appropriate to extend Eden Lane sewer as far as possible up to 500 feet, including man-holes, at an estimated cost of \$3,000.00.

Budget Committee so recommends.

Art. 65. To see if the Town will vote to sell a strip of land approximately 100 feet deep running from the Corner of Milliken Street and Walnut Street, along said Walnut Street approximately 1000 feet. Said sale to be made to one Joseph Glazier of 55 Walnut Street for a sum not to exceed \$5,000.00.

Art. 66. To see if the Town will vote to construct a traffic circle in the square between the Town hall and St. Margaret's Church and appropriate a sum of money for same.

Art. 67. To see what sum, if any, the Town will vote to raise and appropriate for the repair and grading of the following streets:

Central Avenue, from Seaview Avenue to Woodland Avenue.

Woodland Avenue, from Central Avenue to Hillside Avenue, est. cost \$200.00.

Park Avenue, from Central Avenue to Hillside Avenue.

Lake Avenue, from Central Avenue 100 yards easterly.

Smithwheel Road, upper end to Fenderson's, est. cost of \$1,000.00.

Art. 68. To see what sum of money the Town will vote to raise and appropriate to finish the sidewalk on the northeasterly side of Center Street, a distance of approximately 90 feet.

Art. 69. To see what sum of money the Town will vote to raise and appropriate for the installation of one street light on Lewis Avenue.

Art. 70. To see if the Town will vote to accept as Public Way—Cliff Avenue.

Art. 71. To see what sum, if any, the Town will vote to raise and appropriate to resurface Ocean Avenue, between Central Avenue and Somerset Avenue; and work on Seaview Avenue. (Grade and gravel.)

Budget Committee recommends \$2,500.00 for each Avenue.

Art. 72. To see what sum of money the Town will vote to raise and appropriate for the purchase of a bucket loader. (Sub-committee reported that it was possible to purchase same at cost of \$12,930.00, but that trade-in on the Walters truck of \$3,200.00, would make net cost of bucket loader \$9,730.00.)

Budget Committee recommended sum of \$9,730.00.

Art. 73. To see if the Town will vote to raise and appropriate the sum of \$682.00 to replace culvert on Walnut Street with two thirty inch drains.

Budget Committee recommends \$682.00.

Art. 74. To see if the Town will vote to raise and appropriate the sum of \$350.00 to construct a culvert from the southerly corner of the junction of Walnut and Milliken Street, across Milliken Street. (Catch basin included.)

Budget Committee recommends \$350.00.

Art. 75. To see what sum of money the Town will vote to raise and appropriate to replace tile pipe with cast iron in sewer on Main Avenue. (6th to 9th Sts.)

Budget Committee recommends \$950.00.

Art. 76. To see what sum of money the Town will vote to raise and appropriate for the construction of a sidewalk on Saco Avenue, on the side the schools are located on, from Fern Park Avenue to the High School. (Est. cost \$6,000.00.)

Art. 77. To see if the Town will vote to raise and appropriate the necessary funds to complete a sidewalk from Union Avenue to Goose Fare Brook.

Art. 78. To see if the Town will vote to raise and appropriate the sum of \$454.00 to construct a cement sidewalk on Union Avenue for a distance of 227 feet.

Budget Committee so recommends.

Art. 79. To see what sum of money the Town will vote to raise and appropriate for extending sewer on Balsam Lane for 200 feet.

Budget Committee recommends \$1,400.00.

Art. 80. To see what sum of money the Town will vote to raise and appropriate for extending sewer line from Pine to Balsam Lane for 300 feet.

Budget Committee recommends \$2,100.00.

Art. 81. To see what sum of money the Town will vote to raise and appropriate for Mosquito and Moth Control.

Budget Committee recommends \$2,400.00.

Art. 82. To see if the Town will vote to authorize the selectmen to install 10-cent locks at the Comfort Station in place of those now in use.

Budget Committee so recommends.

Art. 83. To see if the Town will vote that moving pictures may be shown on Sundays, in accordance with the Revised Statutes of Maine.

Art. 84. To see if the Town will vote to fix a date when taxes shall be due and payable, and to fix a rate of interest to be charged on taxes after said date.

Budget Committee recommends 6%.

Art. 85. To see if the Town will vote to authorize the selectmen and treasurer to sell and dispose of property acquired by tax process, on such terms as they deem advisable and for the best interest of the Town, and to execute quit-claim deeds for the same, or any action relative thereto.

Art. 86. To see if the Town will vote to authorize the selectmen to appoint a Budget Committee.

Art. 87. To see if the Town will vote to authorize the Budget Committee to act in an advisory capacity to the Board of Selectmen and Town Manager, and to meet with said Board and Manager at convenient intervals.

Art. 88. To see if the Town will vote to authorize the selectmen and Town treasurer to apply all unexpended balances at the end of the fiscal year of 1957 to Surplus Account, except those required by law, or by vote of the Town, to be carried forward to the next fiscal year.

Art. 89. To see if the Town will vote to authorize the selectmen to employ the State Auditing Department for the year 1957, and that a mid-year inspection of the Town's financial affairs be made by that Department.

Art. 90. To see if the Town will vote to go on Daylight Saving Time for the summer months.

Art. 91. To see if the town will vote to install signs at the railroad crossings at Union and Atlantic Aves. Two signs at each crossing; to be 3 ft. long by 2 ft. high, and be painted in white letters on a bright red background: SLOW BAD BUMP.
