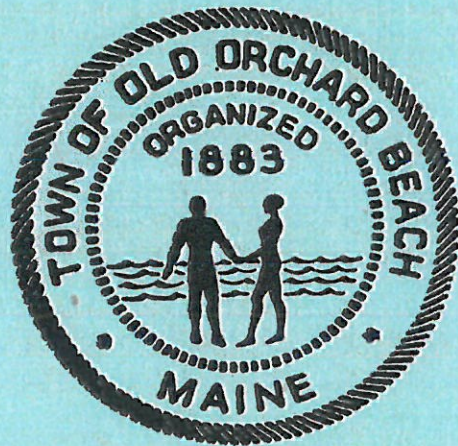

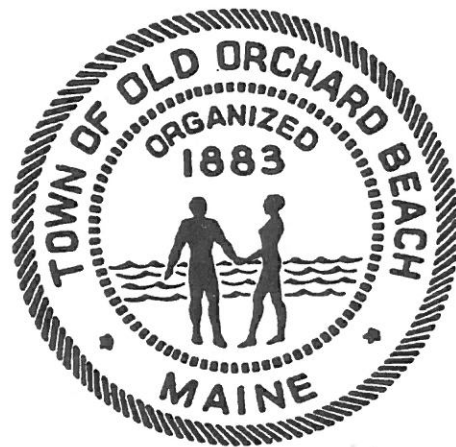

1968 PARK COMMISSION REPORT

The Park Commission was again formally authorized by the Council to operate a Public Parking Area within the undeveloped section of Veteran's Memorial Park. To placate local private parking-lot operators the daily parking fees were raised to \$1 commencing 1 July and reverting to our normal 50¢ fee on 11 August. Gross receipts reported by Manager E. M. Hickey were \$14,051.50. This amounted to an increase of slightly less than \$1,500 from the previous year when the 50¢ fee was maintained for the entire season. The Parking Lot payroll, authorized by the Chairman, amounted to \$4,629.63 or roughly 33% of total gross receipts.

In order to settle the controversy (between the Council and Commission,) over charges for vehicles at the Municipal Parking Lot, a member of the Commission wrote Mr. Richard B. Sanborn of the Maine Municipal Association who, after reviewing all the facts, stated that ". . . under Title 30, Section 3851 that the Park Commission does have the care and superintendency of the parks and it would be up to the Commission and not to the Town Council to determine charges for the use of the same."

The largest expenditure of the Commission was \$4,200 paid to LaMarre Tree Service of Biddeford for removal of diseased Elm trees and the pruning of various types of trees throughout the Town. No capital improvements in the Park were completed this year.

The Commission cleaned and maintained the basketball court at the Central Park Playground and provided the youngsters with basketballs and nets.

The Women's Civic Group was especially helpful with their beautification program throughout the Town. This included the planting of trees, care of flower boxes at key sites in the municipality and the maintenance of the islands at the Pine Park Rotary. The Town Manager and Public Works Foreman deserve a note of thanks for their interest and cooperation.

The Immunization Clinic was held each month Sept. through June. There were 275 children receiving DPT, Smallpox, Measles and Polio vaccine.

The Agency was certified for Medicare in July. This has been a constructive experience in that the whole program has been re-assessed. Have gone over weaknesses, especially in billing. The Board feels all patients should be billed or some attempt made to collect fees. This would remain on a sliding scale, according to a patient's means to pay.

The formation of an active Blood Donors bank has not developed as hoped. Our sincerest thanks to that small per-cent who have willingly co-operated. Yet more donors are needed and some dedicated person who can help in the organizing and maintaining such an effort. This is one of our major health needs in the community.

To the volunteers who have helped with the clinics and the Doctors for their co-operation my sincere thanks.

ASSESSORS REPORT

December 31, 1968

INTRODUCTION *

The so-called "pick-up for 1968 over the previous year in assessment values was 1.47% (\$12,661,850 to \$12,848,350). Discounting any "bookkeeping changes" (1964 a seven year average "pick-up" (1960-1968) comes out to 1.8%, therefore, our "growth" for 1968 was slightly below average.

During the same period (1960-1968) appropriations from property taxes, including the county tax, however, *exclusive* of appropriations from other revenues, (excise taxes, for example) averaged 9.46%.

In short, our appropriations from property tax revenue have been over five times the rate of our growth or net "pick-up".

This is why we must begin to seriously look at our revenue picture. Accordingly, this report will deal with certain assessing problems and my recommendations to resolve them.

However, before I begin, I would like to commend my two assistant assessors, Mr. Arnold H. Morin and Mr. Kenneth H. Cooper for their sincere dedication and complete cooperation.

*1968 tax rate .088 (at approximately 36% of the fair market value) or an estimated full value rate of 32.30 per thousand.

100% of Fair Market Value

The first function of an equitable tax system is to be able to inform a taxpayer in a clear and concise manner exactly on what basis his property is being assessed.

Our present system, since the last valuation (1950) is confusing, to say the least, and ridiculous in fact.

Disparate assessing practices and underassessment as well make it difficult for the average citizen to evaluate and compare the effects of assessment in different communities and further obscure the relative effect of flat rate property tax exemptions such as the \$3,500 veteran exemption.

My first recommendation would be that at the time the current revaluation by CLT is completed we take the figures at 100% of the market value so that an assessor could intelligently relate to a taxpayer exactly how they arrive at the amount of tax. This should not be done until 1970, when, hopefully, the revaluation will be completed, for to do so before would only compound the inequities which have been built into our tax system over the last 19 years.

Assessment Administration

Our community has committed itself to investing \$38,000 to equalize its assessment roll. In addition to this amount of money, the Town has already raised thousands of dollars to produce a complete set of tax maps, vital records for the functions of the Assessor's office. For a total sum then of over \$50,000 the town as a matter of policy—just plain horsesense—should institute a program that will protect this investment. The best way to do this is to reorganize the assessing department under a shared-time, professional, single assessor. The most likely neighbor who could join us in this endeavor in the future would be Saco.

The complexity of the Assessor's work is such that it requires continual training and special skills necessary to maintain maps, to develop sales ratio studies, to appraise new construction and to keep an eye on all the functions of his domain.

Assessing Motels

This coming year, particularly, because it appears an optimum level in new assessments must be reached and because of the number of new motels under construction, we should adopt a common schedule to ascertain the cost per square foot in order to determine a proper value.

In the past there has developed a noticeable lack of uniformity in determining actual cost per square foot regarding this type of construction.

Combining Single Assessor and Building Inspector

I would recommend that we look into the advantages of combining the position of a single Assessor with the position of Building Inspector. Such a move would reduce duplication of efforts—such as field work and records keeping. Further, both functions could utilize the services of a common clerk and economies to the Town could be realized.

Major Inequities

The major inequities in our present local tax system are threefold:

1. Low land valuation.
2. Renovations on real property which have never been disclosed or picked-up.
3. The nominal inflationary increments not accounted for.

It is hoped that the revaluation now going on (to be completed in 1970) will remedy the above weaknesses and others in our tax system for there is but one paramount criteria that we must continuously strive for—*Fairness*.

Our immediate goal is a home for our elderly people and low cost housing. A request was also made for middle income housing. This will encompass a lot of hard work and will require the help and support of every citizen of this community.

REPORT OF HEALTH OFFICER

The past year has not been without its rewards to me as Health Officer. I have been encouraged to see improvements in many areas of the town and yet the Camp Ground section has continued to deteriorate and is fast becoming an eye sore to the town. The narrow streets narrowed still further by heavy snow this year have dramatically demonstrated the need for immediate attention to this area. I have been in communication with our two U. S. Senators and our Congressman and I have met several times with members and clergy of each denomination here in town in the hope of organizing a committee to seek funds under our Workable Program through H.U.D. and to use these funds for rebuilding or renovating homes for the aged and handicapped. We can, by uniting our efforts, demonstrate to the Federal Government that we can help ourselves improve the living conditions in our town if we receive the necessary funds.

I am still concerned that the present dump is now reaching its saturation point and may some day soon prove to be too close to schools and homes, camps and trailer parks and if a heavy

rat population should occur, we would have real problems. Again I would urge that a committee be appointed to look into another dump area.

A most serious menace to our beautiful beach is the litter caused by thousands and thousands of beer cans, tonic cans, spray lotions etc. Although our street dept does a terrific job in placing waste cans every so many feet and then pick these trash cans up daily, one need but to stroll the beach on any given day at sunset and he will be appalled at the staggering amount of trash thrown about with complete disregard for the rights and safety of others. Our beautiful beach is being abused to the point where one day we will awaken to find the filth and litter which now adorns once beautiful Revere Beach in Mass. Stricter enforcement of existing rules on the beach is a must. But more so is the complete prohibition of drinking alcoholic beverages on our beach. This must stop or we encourage people to treat our beach, town and citizens with contempt. We must enforce "No drinking beer etc. on the beach" I would recommend that one or more neatly uniformed horse mounted officers patrol the beach in order to curb this flagrant abuse of littering. Once visitors get the message, they will cooperate and we will perpetuate the image of the "Cleanest Beach in the World."

I wish now to thank Chief Clark and his officers for their cooperation in every instance where the need was.

I thank Chief Louis Wharff who keeps me informed in many instances where I would not have occasion to be aware of the situation.

And again I thank Armand St. Hillaire and each of his Street Department workers for the tremendous cooperation I have received from them when I sought a crew and a truck to haul off accumulation which could have caused health problems.

**REPORT OF
 THE SUPERINTENDENT OF SCHOOLS**

To: The School Committee and Citizens of Old Orchard Beach:
 The Charles A. Loranger Junior High School was completed in March, 1968. Occupancy of the building by the students, transpired April 8, 1968. Both students and faculty were greatly relieved to have a place of their own. A dedication exercise was held May 8, 1968.

A beautification program for the schools was implemented with trees being planted around the High School. Plans currently call for more trees to be planted in front of all the schools along Saco Avenue.

Curriculum studies have been in progress throughout the entire year. Some areas of concern are: Health Education, Home Economics, and Industrial Arts for the seventh and eighth grades.

The Old Orchard Beach schools were selected as a training center for students attending Gorham State College, University of Maine and St. Francis College. All student teachers performed admirably under the supervision of excellent teachers of Old Orchard Beach.

During the past summer the custodians did a commendable job cleaning and painting the schools. The locker rooms in the High School, as well as eight classrooms were painted.

With the cost of education still escalating, the Town of Old Orchard Beach should seriously consider the possibility of a School Administrative District with Saco. According to current statistics from the Department of Education, an additional 10% in General Purpose Aid would be realized, as well as 22% of the unpaid principal and interest on bonded indebtedness pertaining to school construction since August 29, 1957.

The School Committee has applied to the Naval Department for Junior Naval R.O.T.C. Currently there are only a few in the entire United States.

A summer program in math and reading was held for all students who desired to attend. The funding of the program was made available through Title I funds. Teacher Aides were also instituted through Title I funds.

Old Orchard Beach should be proud of the members of the School Committee. They are very interested in the welfare of all students, as well as the community.

I wish to express my sincere appreciation to the members of the School Committee, Town Officials and citizens for their help during the past year.

PRINCIPAL'S REPORT

At the start of school in September, the high school time schedule returned to 8:00-2:00 after two years of operation on a shorter day. The school was able to re-establish its daily activity period and a fifty minute class period. With the return of the activity period, many school organizations have been able once again to come into operation: the Key Club, the Chess Club, the National Honor Society, and several others. The National Honor Society, as an active chapter, has furnished a Lounge room for the use of all students who are on the honor roll. Any encouragement of the learning process is good and should be encouraged.

The senior class of 1968 celebrated Arbor Day by planting 5 maple trees on the front lawn to replace the elms which have died. We hope to continue this planting program yearly, including both the front and back of the school. The Women's Civic League has also encouraged plantings at the school including furnishing trees and the shrubbery around the front edge.

The physical plant of the school is basically good. The Youth Corps under the direction of Mr. John McSweeney painted most of the classrooms this summer, the custodial staff performed the annual refinishing of the gymnasium floor, and most of the window shades in the front of the building have been replaced. The front drive has been widened and resurfaced, the class of 1967 donated a hurdle fence along T-for-Turn Road, and desks in all senior and junior home rooms have been replaced with new ones. Many of these desks were thirty years old and were literally falling apart.

Some thought, however, must be given to long-term improvements in the high school building. All the present toilets should be modernized, replacing plaster walls and asphalt floors with more permanent tiles and new fixtures. The first floor hallways and classrooms should have tiled floors, instead of the present painted cement. The cost of thrice-yearly painting of these floors is excessive considering custodial time and the paint itself.

Much credit should be given to the staff and faculty of the high school who have done so much to make this year successful.

Early in the school year the Iowa Tests of Basic Skills were administered to all the 6th and 7th graders. The Differential Aptitude Tests were administered to the 8th graders. I.Q. Tests were given to all grade 7 pupils.

Library:

The number of volumes in the new library is slowly being built-up. Presently, there are 557 books in the library.

Sports Program:

The sports program has been expanded, thereby, enabling more pupils to participate. For example, we presently have a 6th grade team, 7th grade team, and an 8th grade team participating in Basketball.

A "Pep Club" was organized for the purpose of creating more school spirit.

The Ski Club has proven quite popular, with 25 enrolled members. The Ski Club travels to the "Big A", in York Wednesday afternoons, conditions permitting.

Science:

The Science Department is making good use of the new Science Lab, and a Science Fair will be held in conjunction with the High School.

In closing, I wish to express my sincere appreciation to superintendent Howard Cushman, the superintending School Committee, the School Nurse, Teacher Aides, custodians and lastly the teachers for their cooperation and interest in our school.

Our hot lunches were prepared at the Loranger Junior High School, delivered to our building by Mr. Harold French, and served by Mrs. Helen Allen and Mrs. Elizabeth Regan.

During the cold months we reached a high of 181 pupils being served daily. In addition we had approximately 75 pupils bringing a cold lunch from home.

Milk was served in the classroom at recess time to approximately 286 children.

Mrs. Agnes Murphy, school nurse, visited our building every Monday and on many other occasions when necessary.

In the Fall of the year all pupils were weighed, measured,

and had their eyes and ears tested by the classroom teacher. Children who had difficulty on the visual and auditory testing were referred to the school nurse for further testing.

All Kindergarten pupils were examined by Dr. Stephen Polackwich. Dr. Donald Skilling examined all Kindergarten and first grade pupils. In the other grades children were examined if there was an apparent need in addition to all new pupils in the system. Both doctors were assisted by Mrs. Murphy.

Testing

Kuhlmann-Anderson Intelligence Tests were administered in first grades. Four reading tests were also given as part of the basic reading system.

Third grade pupils were given the Iowa Tests of Basic Skills.

All new pupils entering second and third grades took the Otis Intelligence Test.

All test results were recorded on the child's permanent school records.

Report Cards and Parent Teacher Conferences

Report cards were sent home four times during the school year.

Parent Teacher Conferences were held in the fall at the close of the first ranking period. All teachers were very pleased with the large turnout of parents and welcomed the opportunity to discuss school activities.

Parents are welcome to visit our classrooms at any time during the year to confer with teachers.

Fire Drills

Fire drills are practised frequently. Mr. Wharff is often on hand to observe the exit of the children and to check the buildings to see that safety precautions have been followed.

Banking

Each Tuesday was Banking Day at the Elementary School. Facilities for this service were provided by the local Saco and Biddeford Savings Institution. Many children participated each week.

Insurance

Optional insurance was available to all students. The Gilpatrick Insurance Agency supplied the school with forms which were distributed to the children by the teachers. Many parents took advantage of this opportunity to insure their child.

Field Trips

Mrs. Dorothy Wilson's first grade class visited Allgroves Greenhouse and each child was presented a plant by the owner, Mrs. Esther Gilbert.

Mrs. Kathleen Lee's first grade class visited the Elm's Nursing Home during the Christmas season. The children sang carols and presented the patients with gifts which were made at school.

Mrs. Mary Morsey, teacher aide, accompanied both groups.

Junior Red Cross and March of Dimes

Elementary School pupils contributed \$27.44 to the Junior Red Cross and \$68.31 to the March of Dimes.

Music, Art and Physical Education

Miss Alice Hartwell, music supervisor, visited each classroom weekly. Special music programs were held in the cafeteria during holiday seasons.

Art is taught by the classroom teacher. All pupils had an opportunity to participate in an art contest sponsored for the local area by the Biddeford Savings Bank.

Physical Education is also taught by the classroom teacher.

Grade Meetings

We continued to hold monthly grade meetings. As a result of these meetings by grades, the teachers had an opportunity to discuss curriculum at their level. They made sure new material was presented at approximately the same time and the same material was being covered in all subjects.

Library Books

The Elementary School has an additional 277 library books in the classrooms obtained under Title II funds. New filmstrips and records were also made available under this same fund.

We now have 30 sets of books in our circulating library which are available to all classes.

Television

Teachers again obtained guides for each program viewed on Maine's Educational Television Network. These guides are available to the school free of charge from the Education Department in Augusta. They recommend the programs to be viewed on each grade level, suggest material to be presented before the television lesson, and give suggested follow-up material.

Learning Services Hub

Teachers in the past year, on many occasions, have appreciated the help received from the Learning Services Hub. This organization works in the areas of social work, guidance counsel-

ing, and speech therapy to aid children showing problems of learning. This group and many of the teachers have worked diligently together and we believe many children have benefited from their services.

During the fall term 37 children were recommended for speech therapy by the classroom teachers. These children were tested by Miss Linda Collins, speech therapist, of the Learning Services Hub. Many of these children are now receiving individual help or working in small groups on Wednesday when Miss Collins visits our building.

Teacher Aides

This year all concerned were pleased to welcome two teacher aides to the Elementary School. They are Mrs. Esther Taylor and Mrs. Mary Morsey. They are performing tasks that are ancillary to instruction, thus providing the teacher with more time for planning and conducting the instructional activities of the classroom. Their duties consist of supervision of the playground, cafeteria, halls, and bus loading. They do clerical work, hot lunch and milk orders, correct papers, conduct small group drill, assist individual children with lessons and many other tasks which help the teacher.

The efficient services of both women are considered a real asset to our building.

Closing

In closing, I wish to express my sincere appreciation to Mr. Cushman and the School Committee for their cooperation throughout the year. I also wish to thank all of my teachers for their untiring efforts toward the betterment of our school. Mr. Stanley Podchalski is to be complimented for his efficient services as custodian in our building. All of the teachers wish to thank the parents for their interest and cooperation throughout the year.

This is due in part to the great amount of time required to perform the eye examinations on those pupils who may have shown some visual deficiencies by the school eye doctor. In conjunction with this the Audiometer tests are time consuming. However examinations were carried out last August and September on those who were to participate in football.

Physical examinations have been completed on all new pupils and the elementary grades. To be done are the high school students and also the "Tine Tests" that are given in the spring.

SCHOOL NURSING REPORT

January, 1968 found us still under the necessity for double sessions for the Jr. High and High School students but with the comfort of quite certainly having a new Jr. High School by Spring term. By mid-April this was accomplished and with the change over to normal daily schedules the incidence of colds and virus infections that had been quite severe improved considerably in both the Jr. High and High School groups.

Another problem that troubled us on a wide age level was pediculosis. Our modern age comforts and variety of health protections have still to wipe out head lice. This miserable condition was no respecter of the cleanest kept child and quite unfortunately, appeared to find that child more readily at times than the children who were less carefully kept in personal hygiene. It was no comfort to the mother who does a good job in caring for her children and home to find them infested from the slackness, by and large, of a few families who tolerate head lice. We did (and do) "wage war" in every way possible on this problem and at times have been both disgusted and discouraged. That the problem was small by comparison with the number of students didn't lessen the worry that congested areas and lack of average home facilities could add to the problem. We constantly checked the children involved and the contacts of these children and gave help and medication to fight this nuisance. That the State Dept. of Health has made this condition a reportable item for several years past has stressed the health aspect involved.

The T.B. Tine Test program was done during the Spring Term and the groups covered were the Kindergarten and the Seventh Grades plus new students on all grade levels who had not had a recent T.B. test. (Adults in the school system are required by law to have a T.B. test or chest x-ray once in two years so those due for a test were also checked). Follow up results were satisfactory on the few who tested positively.

Also through the Winter and Spring terms we had a series of class conferences through the excellent cooperation of teachers and principals in the Jr. High and High School on topics that have been of great concern in our State and elsewhere in the country. Drug and liquor problems in Maine have risen in number and most unfortunately, have been affecting an increasing number of young teenagers. The York County Pharmacists as a group have been working most thoroughly with our civil authorities in a total effort to protect and educate our youngsters

to the dangers of these problems. The School Nurse attended workshops in the Spring and Fall terms to gain all available information and literature to give to our teenagers to help them hopefully to make wise decisions regarding these questions.

Marijuana has come into use in Maine in the past couple of years as our news media has told us on several occasions so we need to educate the youngsters to potential danger. Boston area has risen to fifth place in the country as a drug traffic center and we are much too close in travel distance to that outlet. Marijuana does build a psychological dependency although it has been called non addictive, and it has been a pathway to other drug use.

Along with the dangers associated with drugs and liquor we have seen in the State of Maine for over a year a steady rise in the V.D. problem. During the fall term the Jr. High and High School faculties attended a two day workshop under the guidance of Dr. Philip Rice, a Family Life specialist from the Univ. of Maine. (The School Nurse and two other teachers from our School Union have continued study with Dr. Rice at the U. of Me. in Portland during the past college term semester.) If and when our curriculum should develop a course of instruction in Family Life and Sex Ed. we will have some basic good information to give our students in their job of becoming adults in today's world. Sex is flung at our children daily through T.V., movies, magazines etc. and clean decent information should be available for them and with recognition that it is the right, privilege and obligation of the parents to be the first teachers of their children in family life and sex ed. The schools may cooperate with interested parents in helping with this task and as teachers are often parents their aims are the same. To help their youngsters to develop into responsible adults.

After some years of School Nursing we have seen the aims and needs of the program change from basic hygiene and first aid teaching (although still very important) to a wider picture of social welfare needs. The whole child's needs cover physical, mental and emotional aspects and the answers may be food, clothing, medical care or contact with specialists for help on an emotional problem that has been hindering a child's progress in his studies.

We have many to thank for their help during 1968, — both individuals and agencies.

The Hub Learning Services, Saco, staff's care was valuable for a number of families whose children had learning difficulties from a number of causes.

The O. E. O. federal program through the Community Action workers helped solve a variety of needs, — medical and social action problems. The follow up on problems found during last summer's Head Start program has been valuable.

Several State and local service agencies including the State Depts. of Health and Welfare, and the Dept. of Ed. provided services for our children. Physical exams, cardiac care, transportation to school and home tutoring were supplied through a combined local and State level source.

Our community area service clubs, — Lions, Kiwanis and Elks, continued their help to children by covering various social and medical care needs.

Our school system services were continued as for many years with the cooperation of parents, teachers and students in carrying on our regular medical care programs of physical check ups and the vision programs on several grade levels, during the Fall and Winter terms. These covered children in the Kindergarten, 1st, 4th, 7th and 8th grades and students in the Freshmen and Junior classes in High School, plus new students on all grade levels. The athletic groups had medical checkups in late summer in preparation for Fall term participation. All defects were reported to parents by written note.

Our school lunch was again a wholesome addition to our health needs particularly in the winter months for a number of youngsters.

With thanks and appreciation to all individuals and groups who helped in many ways during 1968.

Dear Mr. Cushman:

In today's visually oriented world, vision care is an important part of any school health program, and it hardly seems

necessary to point out the intimate relationship that exists between vision and school achievement, vision and social development, vision and safety, vision and recreation, vision and health.

The controlled School Vision Testing Program assures the personnel involved of real value and benefits derived by the school population of Old Orchard Beach.

Vision problems are not static, they change and new problems appear as the child grows and develops through the adolescent years. The pressure of vision centered activities make it imperative to discover vision problems as early as possible. The program as instituted in the Old Orchard Beach school system is directed toward this fulfillment.

A brief outline of the method of operation may be informative.

1. Previous year's Vision Testing records are reviewed.
2. All sub-primary children are screened using the six point clinical procedure.
3. All children in Grades 1, 4, 7, are screened with the accepted School Vision Testing instrument, using the Massachusetts Vision Test Standards, which are the accepted school standards.
4. All intermediate grades-questionable cases and teacher referrals are sent to the school vision testing station for further attention.
5. Conference with the Industrial Arts Department on their Eye Safety Program.
6. Freshman and questionable cases from previous years are screened with the testing instrument.
7. All students in the Driver Training class at Old Orchard Beach High School are screened.
8. Notices of students requiring attention are sent to parents by Mrs. Agnes Murphy, R.N. and follow-ups and recommendations are noted and teachers advised.
9. Records are reviewed and filed upon completion.

The complete cooperation of all school personnel justifies the necessary time required to maintain this excellent school vision testing program; the assistance of Mrs. Agnes Murphy, R.N. in student preparation affords greater effectivity and lessens school time lost per student.

COMMENTS

Under Chapter 101, Private and Special Laws of 1967 the Town of Old Orchard Beach School District was created and the District was established on June 17, 1967.

Proceeds from bonds issued, fire insurance proceeds and investment earning totaled \$695,693.39. This amount financed construction expenditures of \$656,921.69 during the period June 17, 1967 to December 31, 1968.

The account balance was \$38,771.70 at the close of the period and was represented by a certificate of deposit and a demand deposit in the Canal National Bank, Old Orchard Beach, Maine.

School construction bonds outstanding at December 31, 1968 totaled \$520,000.00 and these obligations mature during the ensuing nineteen years with interest at $4\frac{1}{4}\%$.

SCOPE OF AUDIT

Minutes of the trustees meetings were reviewed for matter pertaining to financial affairs.

An analysis was made of receipts, deposits and negotiated checks. The cash balance was reconciled with statements furnished by the depository. Vouchers were examined as were paid bonds and coupons.

COMMENTS

SCOPE OF AUDIT

The system of internal control was reviewed as pertained to the handling of cash and other matters of financial concern. Cash accounts were verified by reconciliation of bank statements and count of cash.

An analysis was made of receipts and deposits as well as expenditures and negotiated checks. Vouchers, payrolls and canceled checks were examined on a selective basis. Letters of confirmation were used to verify the correctness of recorded assets and liabilities.

Revenue accruing to the municipality from various sources was reviewed and checked to pertinent records. Records of council meetings, as pertained to financial matters, were reviewed. Surety bond coverage was determined.

The cash records of the Edith Belle Libby Memorial Library were examined, the cash balance was reconciled and investments were verified.

OPERATIONAL RESULTS

The fiscal year's operations showed that a net unexpended departmental balance of \$56.99 was lapsed to surplus, per the following summary:

The overlay and unexpended balances in the welfare and contingent accounts less overdrafts in various other operating accounts, particularly in the highway, health and interest accounts were the major factors contributing to the amount lapsed to surplus.

GENERAL

During the preceding year a loan of \$11,650.00 was negotiated to assist in financing, together with anticipated federal funds, an "Auditorium Study." It is understood that this project has been abandoned due to lack of federal participation. An amount of \$4,000.00 was paid on this loan in the current year leaving an unpaid balance of \$7,650.00.

The audit showed that the year end accounts payable totaled \$75,348.52. Included in this amount were unpaid school department bills of \$22,644.00 for November and December, 1968, various other departmental bills totaled \$35,457.73 and a balance of \$8,135.00 on the county tax assessment. A tax anticipation loan of \$50,000.00 and withholding and social security tax deductions were unpaid at December 31, 1968.

A review of expenditures indicated that several purchases of materials and/or services exceeding \$500.00 had been made without requiring competitive bids. Attention is directed to charter provisions governing purchases or contracts.

It was noted that uncollected taxes and tax liens totaled \$209,705.24 at the close of the current year. It is recommended that the delinquent accounts be reviewed to determine their collectibility and administrative action be taken accordingly.

The Memorial Park produces a considerable amount of revenue. It is recommended that unused tickets be retained for audit purposes.
