TOWN MANAGER'S REPORT

To the Town Council and citizens of Old Orchard Beach, it is my privilege and honor to submit the following report:

Subsequent to my appointment in June, my office was deluged with phone calls and visits from citizens seeking help and resolution of problems. These calls and visits, although courteous and friendly, had the urgency of exhausted patience with the lack of response to their complaints, ranging from clogged sewer lines and pot-holed roads to criticism of ordinance indifference.

In order to organize an administrative structure, enabling Town Government to function with a sense of order and proper management, while, at the same time, acknowledging citizen requirements, it was necessary to devote many hours beyond the normal daily work schedule just to respond to citizen needs, analyze prevelant conditions and formulate plans for improvement. The almost immediate arrival of the "Tourist Season" brought new demands on our day-to-day operations. But, time had to be found to correct many physical inadequacies and complete suspended work projects.

Examples of projects and actions undertaken and completed are:

- Total re-construction of the tide gates system on New Salt Road and re-surfacing of storm injured street; (these projects enabled the Town to meet Federal Disaster inspections and qualify for payment of Federal Disaster Funds).
- Replacement of broken sewer lines leading to some beach front motels, which had been handicapped for years, and whose business was threatened unless conditions and "lines" were corrected. Our efforts enabled them to again function normally.
- The completion and filing of the Town's application to H.U.D. for a grant of \$1,250,000 for a major sewer project involving the separation of storm and sanitary sewers plus the building of a secondary treatment plant. The application still has a high priority even though funding was delayed because Southern Maine Regional Planning Commission was not certified for sewer and water projects and the "freeze" on H.U.D. sewer and water funds by the President.
- The problem of non-payment of back taxes is well known and, unfortunately, prevelant for many years. I personally visited many delinquent tax payers and, in my duties as Tax Collector, was successful in collecting over \$75,000.000 in back taxes.
- Re-certification of our community nursing services. Substantial complaince with all statuatory requirements and conditions were necessary before recommendation to the Social Security Administration was made by the State Department of Health and Welfare. Reinforcement and assistance to our town public health nursing services as well as to our advisory council laid the groundwork for the subsequent certification given to the community. Our public health nurses are acknowledged and commended for their efficient services. In addition, the advisory board and its devotion

to the nursing staff and the community health needs resulted in complete coordination of all efforts.

 The enforcement of our zoning ordinance and the re-inforcement of the Planning Board's efforts to administer the sub-division law #4956 has resulted in curtailment of most violations which had been practiced indiscriminately by those who disdained laws and ordinances.

Although there are many more major actions undertaken which contribute to progress, perhaps examples of other types of actions will help define the broad areas of daily demands on the Town Manager's office.

- An inspection of the Town Hall's physical condition produced evidence of urgent repair needs to prevent ice and water from crippling our ability to function during the winter of 1972. The Board of Registration was without adequate quarters, so action was taken to restore a room on the second floor providing much needed working space.
- The "Oil Spill" necessitated urgent actions to dispell rumors in Canada that our beach was ruined. Linkages with Coast Guard officials and proper vital communications with all news media enabled us to negate stories which might have had a disastrous effect on the Town's economy.
- The preparation of roads and our Public Works Crew for winter services required short and long range analysis and planning so that efficient operation could be achieved.
- Centralized buying of all equipment; supplies and materials was instituted resulting in significant savings to taxpayers.
- Even the neon signs on Rt. 1 and Cascade Road as well as on Ocean Park Road were broken and needed immediate re-wiring.

Although the above information defines a few specific actions, it is not just this type of activity which occupies time and energy. There are matters of a significant nature which require continuing attention and positive resolutions. The community's future is of vital concern since many areas of neglect are surfacing, and corrective strategy, plans and action are demanded.

1973 requires the following considerations:

- Examination of the Town Charter and the Council's recommendations for revision.
 This document, as it now exists, does not provide for efficient and coordinated community administration, nor for continuity of government. Without this . . . federal aid is questionable. Boards and Commissions are isolated appendages, and services to the citizens become polarized and ineffective.
- A new personnel policy to define the administration's relationship with the family of municipal employees while, at the same time, making clear what they may expect from the Town they serve.

- Analysis and revision of our zoning ordinance. This vital document, necessary to the
 community's growth, is in need of revision and updating. The removal of conflicting
 requirements and a simple definition of zones and districts and their requirements is
 necessary to eliminate many of the confusing conditions which exist in its present
 enforcement.
- Relocation of the Town Dump . . .
 - Although this matter has been considered and discussed before many Town Councils in the past, no action had been taken. The specific relocation to a land area that is suitable must have the approval of the Soil and Conservation Commission as well as the Environmental Protection Agency. The urgency for relocating our town dump is acute, and the combined efforts of all, Town Council, the Planning Board and citizens, is necessary to make this change a suitable one.
- The Assessor's office requires assistance in the total revision of the Town's tax maps.
 Although the appointment of Mr. Emery has produced many significant improvements in this office, assistance and input by the Town Manager, the Board of Assessment Review and the Town Council is necessary in order to achieve the required level of efficient operation needed.
- The resurfacing and reconstruction of selected town roads is a project for 1973 which must be accomplished.
- The shortage of remaining open space requires the consideration of the Council for land acquisition and for determining future needs for community facilities and/or recreation for the citizens.

Old Orchard Beach, as we all know, is a potential gem in the family of Maine's communities. The natural resource of our beach and ocean stands out as a singular community treasure. The protection of this treasure requires the interest, concern and support of every sincere and dedicated citizen.

The Park Commission and her many friends were shocked and saddened by the death of Edith E. Gallant on March 25, 1972. She was in the first of her second three year term on the Park Commission and had for many years been interested and active in Town Affairs.

Mr. Ernest Gallant was offered the appointment to fill the term as Park Commissioner, but could not accept as he found it impossible to give the proper time and attention to the position. Subsequently, Mr. Reny was appointed to fill the unexpired term. In spite of rather poor weather, the parking lot took in \$18,332.50 in parking fees. The

payroll, all for local residents, amounted to over \$6,000.00.

A new matal pole and light was installed at the lower end of the park, and an additional area of over 8,000 square feet was paved. The four trees planted in the center strip last year were removed because they did not survive. However, they will be replaced by Lamarre's tree service. Also a shade tree was donated and planted by the local Cub Scout pack.

Many trees throughout the town were removed or trimmed, but only where it was ab-

solutely necessary.

1972 Yearly Report

The Old Orchard Beach Planning Board was very active again this year with twenty-five official meetings besides the many sessions with the Southern Maine Regional Planning Commission.

After many hours of deliberation and assistance from SMRPC, the Old Orchard Beach Planning Board accepted the new subdivision code in accordance with our State

Statute: Title 30, M.R.S.A., Chapter 454, Section 4956 on May 6, 1972.

This new subdivision code evolved from the State's 105th Legislature and was created for the purpose of helping the communities to plan for better future growth. However, in order to have a successful program, we need the assistance and cooperation of the townspeople. Therefore, we urge any individual contemplating changes in a structure or a new building to contact the proper authorities at the Town Hall for pertinent information.

A large subdivision of single homes was approved on Fern Park Avenue as well as other small subdivisions in town.

A public hearing was held for an amendment to our Zoning Ordinance referring to the 500 ft. notification which was required prior to a hearing by the Zoning Board of Appeals. The approved change is to notify abuttors in conjunction with posting in our local newspaper. This will help to inform all interested parties and expedite processing of each appeal.

Discussion on traffic flow and international signs with the State Highway Commission did not materialize, however, we have hopes of achieving this along with no park-

ing on State Roads.

The Planning Board has recommended the utilization of the large parcel of land owned by the town on Milliken Street for a combination recreation and parking area. This parking area along with Heath Street Parking would greatly assist in enforcing the no parking ordinance on narrow side streets and on East and West Grand Avenue for better traffic flow.

The Planning Board feels there is a great need for a Business Manager to assist the Town Manager in informing and explaining ordinance procedures, enforcing all Town ordinances and assisting all existing and future Boards to perform their tasks.

I wish to thank the following Planning Board members for their devoted time and cooperation during the past year: Mrs. Henry Lemire, George Cooper, Frederick Ahearn, Jeffrey Thompson. This Board will continue to do its best to make this town a better place to live.

As instructed by the 1972 Chairman of the Zoning Board of Appeals, Charles E. Day, Sr., I am hereby submitting the 1972 Annual Report of the Old Orchard Beach Zoning Board of Appeals as follows:

The members of the Zoning Board of Appeals this year were Charles E. Day, Sr., Chairman, Clarence Roberts, Sumner Johnson, Raymond J. Begin, Ann E. Pennell and Richard E. Sweeney, Alternate Member. John

Menard was appointed to the Board upon the resignation of Ann E. (Pennell) Provencal.

The Board handled thirty-seven (37) appeals during 1972. After being informed by Code Enforcement Officer, Robert McNally, that an error had been made pertaining to a decision made on an appeal heard in 1971, the Board recinded its 1971 action for denial and granted the

appeal.

The number of appeals granted in 1972 was twenty-four (24); nine (9) of those appeals were granted with stipulations. Eight (8) appeals were denied, two (2) withdrawn, one (1) tabled until 1973 at the request of the appellant and two (2) were tabled pending court cases not yet decided. The appeals varied in that twenty-two (22) pertained to nonconformance of the building, use or premises, three (3) were Special Exceptions and twelve (12) involved only space and bulk requirements.

A change in the Zoning Ordinance Section IV. BOARD OF APPEALS, B. Appeal Procedure, paragraph 2. pertaining to procedure for appeals involving the use of building or premises was approved, after public hearing, by the Planning Board as recommended by the Board and the Assessor. The proposed amendment was subsequently approved for posting, by the Town Council. The Board currently awaits the final action of the Town Council making the amendment a legal provision of the Zoning Ordinance.

ANNUAL REPORT FOR 1972 OLD ORCHARD BEACH PUBLIC SAFETY COMMISSION

The Public Safety Commissioners during the year 1972 were Chairman Thomas Lee, Sr., Charles E. Huot, Chairman from June through December 31, Robert Winslow and Victor Beausoleil. Chairman Thomas Lee resigned on May 17. Having been appointed to the Commission by the Town Council on June 1, to fill the unexpired term of Mr. Lee, Victor Beausoleil attended his first meeting on June 6.

The Old Orchard Beach Public Safety Commission held eight (8) formal meetings,

the Minutes for which were filed with the Town Clerk.

In addition to handling various personnel, financial and law enforcement matters which occured during the year, the Public Safety Commission initiated plans for the writing of a Police and Fire Department Rules and Regulations booklet, provided that the Town Council would appoint the Town Attorney or an attorney of the Commission's choice, to either write the booklet or check it for legalities prior to printing. They proposed the printing of the booklet as a 1973 project.

The Commission increased the probation period for the Police and Fire Department

from six (6) months to one (1) year, made a study of the Fire Department work and vacation schedules and gave the Police Chief the authority to continue the policy of orientation for the new summer Special Police crew.

Having purchased two (2) new file cabinets for the Police Department, the Commission authorized the Fire Chief to purchase the National Fire Protection Association Industrial Safety Library which includes various up-to-date codes. Approval for schooling and books was granted to the Fire Chief and firemen. The courses, Fire Protection and Industrial Fire Hazards, were offered at the Southern Maine Vocational Technical Institute. The Commission informed the Police Chief that funds were available for the purchase of reference material for the Police Department and that he was to indicate his choices before the end of the year.

Late in November, the Public Safety Commission had the initial meeting to negotiate with the newly organized Police Union, Local 1828, Council 74 of the American Federation of State, County and Municipal Employees, AFL-CIO and made arrangements for subsequent negotiation sessions.

Now, we are 8.

On July 1, 1972, Old Orchard Beach was joined with Arundel and they together became known as Union 8. Together they hired a new Superintendent, a new Secretary / Bookkeeper (Mrs. Susanne Brousseau), equipped a new office at the Loranger Junior High School, and got down to the business of operating the schools. Old Orchard Beach contributes 85.4 percent of the total cost of running the Central Office, a figure that is based on the number of teachers in each town. However, the Superintendent's office is as far as the Union goes. Otherwise, each town runs its own schools as it sees best.

TWO NEW PROGRAMS

There were two, major, new programs introduced during 1972, both during the fall. One was the Learning Disabilities Program. This program is designed especially for the student (grades K-6) who has the mental ability to succeed in the classroom, but who, for some reason or other, is unable to keep up with his classmates. Such a learning disabled student might have an undetected sight or hearing problem, an emotional problem, or some other difficulty that actually prevents him from learning as well as he otherwise could.

The Learning Disability program takes such a student, finds out what is causing his inability to learn, and gives him the special help that he needs. And, it really works. One student gained two years in reading in just two weeks. Many other students have also made remarkable progress as a result of this program.

The program is 100 percent funded under the Federal Government's Title I program. Mrs. Patricia Maguadda is the program's teacher-coordinator and Miss Patricia Sirhakis is the teacher-associate.

The other new program also comes as a result of the vision and educational commitment of your School Committee. It is a real opportunity for our mentally and physically handicapped children of any age (through 20 years old) to go to a school outside of town that can meet their needs. Many of our handicapped children of school age (5-17) have gone to other, special schools for a number of years. Now, even those of preschool age and those past high school age (through age 20) can take advantage of this new educational opportunity. Your School Committee wants all children in Old Orchard Beach to have a fair opportunity for a meaningful education. People with questions about this program should contact the Superintendent of Schools at the earliest possible time.

NEW SCHOOL PLANS

While we recognize that Old Orchard Beach has a number of pressing problems, all of which will cost money to solve, we must also face the fact that our school can no longer absorb additional students without our overall, educational program being hurt. We're already feeling the squeeze particilarly in the elementary grades.

At the request of your School Committee, our Town Council has appointed a Building Committee. This Committee has begun to formulate plans for new school facilities. There is simply no room for more classes. Also, we obviously cannot add anything to our present curriculum withouthaving the space for it.

Examples of what our students are up against are:

Kindergarten classed that are twice as big as they should be -

A Learning Disabilities Program that can only help half as many children as need help -

No program at all for our mentally retarded students -

No cafeteria at Jameson —

No library at Loranger -

Physical education for just grades 7, 8, 9, and 10 -

There is little need to go on with the list. The point is that going much further with a limited program is very unwise from an educational standpoint.

It's unwise from a financial point-of-view, as well. Spending money on an educational program that is out of space and can't, therefore, do the job it should is something like spending money to run a car at 5 miles to the gallon because the engine is out of tune and can't do its job. Both are penny-wise and pound-foolish.

The citizens of Old Orchard Beach may feel assured, however, that their School Department will do the very best it can with what it has to work with. We're committed to not only working as hard as we can for your children, but as intelligently as we can, as well.

The need for more space became alarmingly apparent this fall when we began the Learning Disabilities program. The only way we could make room for the students who need this extra help was to move the Nurse's office to a stairway landing, move our health equipment to other parts of the building, and use the one-time health room for the students. The room holds just 11 children at a time, and we've got 47 children in the program.

There are, altogether, a great number of kindergarten, first, and second grade students who don't stand much of a chance in our classrooms: They just can't learn fast enough. These youngsters are behind the rest of the class to begin with, and, as time goes on, they just fall further and further behind-slowing down the rest of the class in the meantime. This is a situation that just isn't fair to anyone.

We're looking hard for some way to help these children. The new school that we are looking forward to will certainly give us the room we need, but these children need the help right now. If they fall too far behind during their first two or three years of school, they may never catch up. This is a waste of time, money, and human resources that Old Orchard Beach can scarcely afford. Our highest priority at the elementary level, therefore, is to help the child who is unable to help himself.

"It's just a matter of time" is the way a number of Old Orchard Beach citizens feel about the Elementary buildings. These wooden structures have outdated wiring, old furnaces and other hazards to safety. We hope that the Community will be able to support the new school building that is being proposed by its Building Committee. This will not only help us to do a better job of educating, but avert a possible tragedy, as well.

Our 36 students who are enrolled in the Learning Disabilities Program got their extra help out in the corridor. That's not much of a place to learn, and it's an obvious ty problem, as well.

Many people have suggested that it's time to add on to Jameson School. The Building Committee is very much aware of this possiblity and is giving it due consideration as a part of its overall planning.

Our two more important needs are a program for our children who cannot keep up with their classmates, and more space.

There were three major changes during 1972: (1) Our library was made into a classroom (the books went over to the High School Library); (2) 20 of our students in grades 5 and 6 who had fallen way behind their classmates were given a chance to catch up through the Learning Disabilities Program; (3) the Superintendent of Schools moved into the rooms used for the Nurse's Office and the Alumni Association's Conference room. (The Nurse now sees her patients in the little walkway between the lobby and the teacher's room.)

It was the need for another eighth grade classroom that forced us to close out our library. Next year, when we expect another 21 students to be with us, out classes will be bigger than ever — there's no choice. We're using a storage room for our Learning Disabilities classes, and the Cafeteria for study halls; there's simply no other place to

go.

Our highest priorities at the Junior High School are the same as in the lower grades: a program for our students who can't keep up with their classmates, and more space. Additional space would mean a great deal to our students. At the present time we are offering only a basic educational program — the 3 R's, so to speak. Our only other offering is Industrial Arts for the boys — and they have to share the High School facilities to get that.

It's not that we're interested in adding a lot of frills, or any, for that matter; we just want to give our students a fighting chance when they get into the world and have to compete with people who are better prepared. And, we can't leave it all up to the

High School.

Specifically, we'd like to offer our students a realistic opportunity to look into the careers that are available in Maine. A solid, practical, career education program would go a long, long way toward giving our maturing students a head start in life. Then, the mathematics, reading, social studies, and science that they study would take on far more meaning and they'd learn these basic subjects much better than they do, now. And, that would mean getting more education for the money.

As far as space is concerned, the High School is relatively well off. We have been able to operate on an open-campus plan, which permits students to leave the building during their free periods instead of tying up rooms for study hall. Students may stay in school, if they wish, during free periods, and there is a study room and the library available for them to study in.

Open-campus works like this: Only sophomores, juniors, and seniors may participate. The student's marks must remain satisfactory or he is automatically removed from open-campus privileges during the next marking period. This demands that the student learn to make wise use of his time, which is a crucial part of anyone's education. Each student is assigned a teacher-advisor during his freshman year, a teacher who will watch the student's progress throughout high school. The teacher-advisor works closely with the student, his parents, and the guidance counselor, in hopes of providing the student with as much cooperation and help as is possible during his high school career. We're very much aware that our students will soon be out in the world. Therefore, we've made a special effort to provide as much vocational education as possible. There are three parts to our program: (1) Co-operative education, which permits about 20 students to spent part of their school day out on a job in which he is interested, (2) the Business Education/Secretarial program, which has about 80 students enrolled, and (3) the program at the Biddeford Regional Vocational High School, to which we sent 16 Juniors and Seniors.

Perhaps our greatest need of a better library. We expect our students to take more and more of the responsibility for their education onto themselves — to go beyond what they have presented to them in the classroom. We owe them at least a basic opportunity to use a good library/resourse area. Our present library is too small to do the job that is needed, particularly since we have to use it for the Junior High as well. Our plans are to expand the library as much as possible by using space already available and to include study aids other than books and magazines.

SCHOOL NURSE

From January and through the winter we had the usual run of cold infections. They ranged from the nuisance level to the severe virus degree. Some children came to school who were obviously sick and should have been kept home. They just added to their own misery and spread more illness to other, students and adults.

Another problem that has had a high number of victims has been a mounting rate of head lice. For past year, this problem has caused considerable distress mo a number of families. The School Department helped with the medicated-supplied necessary to clean up head lice, and the cooperation from families generally was good, although we feel that there was a degree of "don't care" attitude from a few families. This problem has been a reportable condition to the State Department of Health for several years and it was on their advice that our School Department gave us permission to stock the medication to help on this problem.

In April a siege of measles broke out sharply among the younger age children, although we in recent years had clinics that gave us a good degree of immunization for measles protection. Upon the advice of the State Department of Health, we held a clinic for the children who lived in the most congested area of Town, and who had no record of measles protection. Fifty-two children were immunized who had not yet become ill.

Fall Term: The regular program of health examinations was started in August when Dr. Donald Skilling, our School Doctor, checked the football players. In September the examinations were continued with checkups for all students that were involved in sports in both the Junior and Senior High School levels. Medical checks were also given to the Kindergarten classes and grades 4, 8, and 11. Over 400 medical checks were done at school which includeed new students on all grade levels besides the groups already listed. The general physical health was quite good, but a number of needs were apparent.

Nutritional needs were helped through our lunch program, and a variety of social and economic difficulties were aided though local and state agencies and clinics. The

parents were notified of the apparent needs of the children, and conferences were held to discuss and plan for the needed help.

Our school vision program was administered by Dr. Stephen Polackwich. Dr. Polackwich personally examined the Kindergarten classes and tested Grades 1, 4, 7, and 9. Total vision tests', 657.

A TB Tine Test program for adults on the school staff was done in late spring. The State Department for TB Control had advised us to discontinue doing TB tests on the school children for the past year but testing for adults was to be carried on. There were no signs of reaction to the TB tests in adults tested in 1972.

In November of 1972 we observed Diabetes Detection Week by sending home by each student, Kindergarten through Grade 8, a pamphlet about diabetes detection and a Testape for each child to have a urine test done at home. Some 1300 test kits were sent to the homes.

During the month of December, audiomater tests were given by the School Nurse to the children at the Elementary School. Parents were notified of any apparent hearing difficulties.

Our several health programs covered through the past year were very time consuming, but very necessary per State law or individual or family needs. We are helped by fine cooperation from our teachers, our aides, and numbers of parents, plus organizations and clinics services both local and fron the State level. Our School Liaison Officer, Mr. John Tilton, and the York County Counseling Service have been most helpful to us in working with our school youngsters.

We closed for Christmas vacation on a very nice note. The Junior High students through their Student Council planned and carried out a Christmas Project. The Students brought in dried and canned goods sufficient to make four, fine, food boxes that helped to make a merrier Christmas for others. The Nurse gladly helped on the distribution of these boxes.

CONCLUSION

As your Superintendent, my overall impression is that Old Orchard Beach is a community that supports its schools, and respects the overall efforts being made by its teachers, administrators, and the School Committee.

The focus of this report has been on the action that I feel is desperately needed for our children and that I believe the town will support, once all of the facts and figures are known and understood. This report, however, is just a general summary of our conditions and needs. Phone calls or personal visits to my office or to any of your schools are always most welcome. We'll always answer your specific questions about your schools, or find the answers for you.

I'd like to thank the members of the Superintending School Committee, School Department Personnel, town officials, and all of the many other townspeople who have done so much to make my first few months as your Superintendent a pleasure and a success.

FIRE DEPARTMENT Annual Report 1972

To the members of the Town Council, Town Manager and the Citizens of Old Orchard Beach, Maine:

The following is a report of the Old Orchard Beach Fire Department for the year 1972.

A total of 254 calls were answered during 1972.

New Equipment: To have better communications with surrounding areas the chief purchased a 4 frequency portable radio which enables him to be in contact with O.O.B. Fire, Biddeford and Saco Fire, Scarboro Fire, O.O.B. Police and State Fire frequency.

An additional 100 feet of 5" hose was purchased making a total of 800 ft. now in use in the department. Acquired from the Civil Defense was a 52 GMC troop carrier. The men of the Fire Department constructed a tank on this truck and sanded and prepared the truck to be painted. The students at Biddeford Vocational School painted the vehicle, the town furnished the materials. This truck is equipped with a booster, a 1½" hose, 10 Indian tanks and a 250 gal. per minute pump. Total cost of this truck was \$747.55. Batteries for Eng. 1, Eng. 2, Tank 1, and Ladder truck were purchased plus two snow treads for Tank 3.

Repairs on Vehicles:

Eng. 1, - valve job done on right bank of engine, replaced master brake cylinder, tune up done, changed carburetor.

Eng. 2, - replaced discharge valve seals and electric pump. Tune up and cleaned carburetor.

Tank 1, - Repaired left front brakes.

Tank 3, – Tune ups, carburetor cleaned.

All repairs done on the vehicles were done by the drivers.

Schools and Training:

Chief Smith, Deputy Roy and Driver Guerin attended the Spring Semester on Fire Department Management at S.M.V.T.I. in South Portland. Deputy Roy, Drivers LaPorte, Guerin and Merrill attended the Fall Semester on Fire Prevention at S.M.V.T.I. Drivers Guerin and Merrill attended a second course on Dangerous Materials.

Fire fighting drills and rescue operations are held by the fire department twice a month during the complete year.

REPORT OF THE POLICE DEPARTMENT

Police Department and its projected services for the Town of Old Orchard Beach, written by Chief Richard Lumb, who assumed office on April 16, 1973.

The Old Orchard Beach Police Department will be instituting programs that offer the citizens of this Town additional services, along with its law enforcement responsibilities.

We, as a police service, expect to establish a program of juvenile services which will provide a counseling service to parents and to youths who have problems. The York County Counseling Service of Biddeford will be available for assistance in training personnel and evaluations for recommendation to the Court and the Department. We hope, through the Office of the Chief of Police to spend considerable time at all levels of the school system, to provide social training in the function of Law Enforcement, and its role in the community. This program of studies will be offered to students who are interested, when facilities become available. The Policewoman, in addition to her duties with the Department, will play a major role in the application and implementation of this program.

The Police Department hopes to present to the Town's citizens, programs of training and education for community betterment. The training for the officers of the Department has been accelerated for one objective, a well trained, efficient Department.

In brief summary the members of the Old Orchard Beach Police Department are dedicated to the citizens of Old Orchard Beach, the law enforcement that we are sworn to uphold, and of providing services that are supportive of other community programs. The Police cannot satisfactorily solve each individual complaint, in all instances, nor can they escape the constant criticism by people, who through their own personal reasons, would like to be left entirely alone to act and conduct themselves as they please ignoring laws which the majority of the citizens obey.

The citizens of the Town should join the Police Department in its efforts to make Old Orchard Beach the resort and yearly residential place it should be. A definite participation by the citizens in supporting the Department, is vital and should not be left to chance. The voices usually heard are those who are vocal and full of criticism and, if left unanswered, do cause seeds of doubt and raise questions in the minds of the majority of the citizens who are not apprised of the true situations:

I as Chief of Police have given my maximum effort and will continue to do so. Your support and participation will be necessary for the unification of Town Government and the Town social Institution. Support and participation, hand in hand, with trained professional police service will make Old Orchard Beach a community to be respected.

PUBLIC HEALTH NURSING SERVICE ANNUAL REPORT YEAR 1972

In the past year the Old Orchard Beach Public Health Nursing Service has undergone many changes.

On May 15, 1972 Mrs. Helen Curry retired from our nursing agency after serving as town nurse for thirteen years. Needless to say, Mrs. Curry's retirement was accepted with sadness by the many Old Orchard Beach residents who had received endless devotion from her services to the community.

The purpose of the Public Health Nursing Service is to provide preventive, curative, and rehabilitative nursing care and other therapeutic services to patients in the home and to promote health for the individual, family, and community as a whole. This is accomplished through community health supervision, referral of individuals to other services in our area, care and follow-up of patients with communicable disease, preschool immunization clinics, physical therapy services, and bedside nursing care.

With the recent outbreak of numerous measles cases in New Hampshire, I strongly urge all parents to have their children immunized against measles at their private physician or at the regular immunization clinics.

The agency was recertified for another year for Medicare thus enabling Medicare recipients to receive skilled nursing care and physical therapy in the home.

The Medical Advisory Board continued to serve in an advisory capacity to the nursing agency. Two new members were added to the board: Michael Magaudda, M.D. and Dwight McLeod, Health Officer. Other active members include Mrs. Yola Painchaud, R.N., chairman, Mrs. Rita Dancoes, secretary, Mrs. Carolyn Anton, R.N., Herbert Hopkins, M.S., and Louis DeAngeles.

Many hours have also been spent with the newly appointed Health Officer Dwight McLeod in an effort to promote community health by identifying health needs of the community, setting goals, and implementing various ways to correct specific health hazards.

To Louis Sarelas, Town Manager, members of the Advisory Board, Doctors, town secretaries, and all other volunteers who have so kindly given me support and assistance, I give my sincere thanks.

REPORT OF THE HEALTH OFFICER OF THE TOWN OF OLD ORCHARD BEACH, MAINE

Honorable Louis Sarelas Town Manager Old Orchard Beach, Maine 04064

Dear Mr. Sarelas:

This report of the Old Orchard Beach Health Officer has meant (traditionally) a response to be printed in a booklet and left at that. It is my intention to make this report an informational sheet for the people of the town and cite how the town has measured up to itself, i.e. the health and personal as well as ecological condition of its members and its natural assets.

Since assuming duties as a full-time Health Officer, I feel several tangible accomplishments can be seen. Being available 24 hours a day allows me to make the following brief report.

First, every complaint relevant to the duties of this office have been investigated as have the complaints or comments which deal ostensively with other departments. We have dealt with all of them.

Concerning communicable diseases, those cases reported include:

-rubella	(5)
-chicken pox	(12)
-measles	(74)
-scarlatina	(1)
-ring worm	(1)
-heapatitis	(8)

In addition to the above, there were several cases of "pediculus capitis" (head lice) Each case has been fully scrutinized and acted upon. It would be an appropriate time for me to commend publicly, Mrs. Agnes Murphy (School Nurse) and Mrs. Clair Souliere (Town Nurse) for their outstanding dedication to the town and its people.

Since the Saco Treatment Plant is now operational, OOB's Bear Brook Pumping Station has made pollution in the area and in Goose Fare Brook almost negligible. The 2 pumps which have been installed most certainly affect the efficient disposal of any related waste. I intend to request another survey this Spring in order to determine just how the pollution factor was reduced and by how much.

Also, the reservoir on School Street has been cleaned of junked automobiles and a culvert has been installed so that a stagnant brook will, once again, flow freely and join Little River as a clean and sparkling body of water.

I have recommended the dump be moved. This is a very simple matter if the town would take the interest and finally decide to make a positive move. I hope OOB will soon make the necessary preparations for securing a new dumping site.

I have suggested and will move toward allowing private firms engaged in waste removal from septic tanks, etc. to discard their waste into the treatment plant system.

We are working on immunication clinics for pre-school youngsters and will be formulating an adult education course for mothers in order that they may have a defined knowledge of health as well as personal hygiene. I have been in continual contact with Dr. Ledley of the State Department of Health and Welfare and his advice has been invaluable. I will continue seeking the advice of those persons who are in the capacity to offer us professional guidance and at no cost to the town.


Certain problem areas of the town have been the Smithwheel Road and School Street areas. We are attempting to define the health-related problems and seek solutions.

Much has been done to promote better health in our community and more concern for the the environment. Much more will be done in the coming years, I am certain. I would like to thank the town officials for their cooperation and express my appreciation to Norman Guerette, the President of the Chamber of Commerce, for his assistance.

An old Arabian proverb says "He who has health has hope, and he who has hope has everything." God willing, this maxim will apply to Old Orchard Beach.








But too few of our younger generations know of the roles this community has played in the annals of history. One of these roles was in "Aviation Pioneering".









SCOPE OF AUDIT

The system of internal control was reviewed as it pertained to the handling of cash and other matters of financial concern. Cash accounts were verified by reconciliation of bank statements furnished by the depository and/or bank confirmation.

An analysis was made of receipts and deposits as well as disbursements and bank charges. Vouchers, payrolls and cancelled checks were examined on a selective basis. Letters of confirmation were used on a test basis to verify the correctness of recorded assets and liabilities.

Revenue accruing to the municipality from various sources was reviewed and checked to pertinent records. Records of council meetings, as they pertained to financial matters, were reviewed. Surety bond coverage was determined.

The cash records of the Edith Belle Libby Memorial Library were examined, the cash balance was reconciled and investments were verified.

The current year's operations showed a net gain of \$68,939.06 which was accounted for as follows:

The overlay, supplemental taxes and unexpended balances in the interest, town poor, tree care, health insurance and social security accounts, less tax abatements and an overdraft in the public works department account were the major factors contributing to the net unexpended departmental balance lapsed. The records did not indicate that authority had been granted by the legislative body allowing overdrafts in appropriation accounts.

* * * * *

The following comments pertain to the accompanying financial statements:

ASSETS . . . The general fund cash balance which included general, capital improvement, federal revenue sharing and petty cash, totaled \$137,996.14 at December 31, 1972. The bank balances used in reconciling this amount were confirmed by the depository. Petty cash was counted.

Accounts receivable amounting to \$14,627.36 at the close of the year consisted principally of funds due from the U.S. Office of Emergency Preparedness.

Taxes receivable totaling \$179,893.01 consisted principally of current year accounts of \$173,412.96. The remaining balance of \$6,480.05 was for prior years dating from 1965. Tax liens and tax acquired property amounted to \$43,104.17 and \$492.13 respectively.

Expenditures totaling \$89,390.78, which were in excess of amounts appropriated are being shown on the balance sheet as deferred charges pending further financial activity.

LIABILITIES, RESERVES AND SURPLUS . . . Accounts payable totaled \$72,870.71 at the year end. Included in this amount were unpaid school department bills of \$16,203.86 for December of 1972, a balance of \$12,448.50 due on county tax assessment and various other departmental bills totaling \$44,218.35. A tax anticipation note of \$100,000.00 and agency funds totaling \$14,838.76 were also outstanding at December 31, 1972.

Unexpended departmental balances of \$68,772.43 were carried forward to the ensuing year in accordance with legal requirements and/or customary practice. Federal revenue sharing funds of \$81,009.40 and excise taxes of \$7,205.31 are reserved for future allocation. The capital improvement fund (garage and pumping station) balance amounted to \$19,825.04 at the close of the year.

The unappropriated surplus amounted to \$71,693.19, an increase of \$15,746.82 for the year. This change resulted principally from the net unexpended departmental balance lapsed and actual revenue over estimated less the transfer to reduce the current year tax levy.

Appropriated surplus, established for tax losses, amounted to \$13,467.41.

DEBT FUND . . . The debt fund, incorporated in the balance sheet as a separate fund, shows various purpose outstanding bonds of \$512,000.00, due to mature during the ensuing thirteen years, and an equipment note of \$102,468.75, to be fully paid by July 15, 1978.

GENERAL

State revenue sharing funds of \$34,614.12 were applied to reduce the 1972 tax levy.

With reference to funds deposited in banks attention is directed to the amounts on deposit as they pertain to bank insurance coverage.

Monthly trial balances of the general ledger and periodic reconciliations of accounts receivable and accounts payable with control accounts would aid materially in keeping audit costs at a minimum.
