There will be a Town Council workshop on Wednesday, February 28th, at 6:00 PM in the Town Council Chambers to discuss the proposed public bathroom locations at the beach entrances on Ocean Avenue and Brown Street.

Chair: Shawn O'Neill

Chair O'Neill opened the workshop at 6:00pm

Town Manager Asanza presented a PowerPoint that gave an overview of the proposed locations and layouts of the proposed restrooms.

Shifra Strum – Brown Avenue – Why can't the Union Street bathrooms be connected to the town sewer? Town Manager Asanza – not on town land, can't connect. Shifra Strum – can they purchase the land? – Town Manager Asanza it is an option. Chairman O'Neill opened the floor to public input.

Sherri Tripp - 6 Union Ave – thanked Council for the issue being brought to Town – would like to see them on Union Ave instead of Ocean – Commercial businesses along Union Ave – presented picture on proposed location – no businesses on Ocean Ave – lifeguard stand at end of Union Avenue and tourists walk down from the campground to Union Ave entrance – 2 parking spots for Lifeguards and public works – handicap spot on Ocean Ave disappeared – lifeguard parking sign that no one uses – presented map that shows potential traffic flow – if on Ocean Ave, people would cut through Crystal Ave – Vice Chair Blow – handicap spot on Ocean Ave though to be changed back – Town Manager Asanza will follow up

Marie Gagne – 8 Ocean Ave – Ocean Ave mostly residential – water at end of Ocean during rain events – residential area – Ocean Ave does not have friendly beach access – Union and Atlantic have the most businesses – First Street? Plenty of land there.

Justine Wood – Aquarius Motel – bathrooms on the middle of Brown Street – will block parking spaces at both motels at the end of the road – Chairman O'Neill – two bathrooms approved this year – didn't realize it was blocking spots – Justine Wood – short street, don't want to see blocked spots – agree it is needed on road.

Roger Teachout – Skylark Inn owner – health officials trace diseases through public restrooms – toilet plume, flushed toilet sends plume of bacteria into air, stays for 90 minutes – OOB is known for beaches – drug issues in public restrooms, fornication issues.

Joe Capone – 3 Brown St – 30 years – better places than in the entry to the

beach – disturb birds – birds have more of a right to be on the beach than the people – easement town owns goes from the beach across to railroad tracks – anywhere along the street –

Jeffrey Murphy – Breakers Condo Association on Ocean Ave – residents sent in emails – bottom of the street is underwater during rain – blocking one of the parking spaces – would hire council to represent condo association if needed.

Shifra Strum – no question that there is a need for restrooms – identify people urinating on the street all the time – proposals lack creativity – a structure built over railroad tracks to easily get to Milliken Street – families and children in the rentals on the street between the motels and small rentals – tourism is a big industry in the town – need to solve problems of bathrooms in town and need to be sensitive to tourism in town – don't know what the solution is but if this is the best solution, it may be the wrong engineering firm to use –

Ron Parent – Breakers Owner – Ocean Ave is a beautiful entrance to the beach – would not like to see public facility looking out from deck – not why they purchased place in the first place – doesn't believe it will reduce bacteria levels in the ocean – concern on property values dropping – increase in public drinking and not respecting dunes – would like to see funds used to policing of beach at pre-covid levels – parties happening on beach –

Donna Saxby – Skylark Inn – 2 Brown Street – not an easy job to find a location for a public toilet – people come for the beach – appreciate what the town does to maintain the beach – bathroom at the entrance of beach is not as appealing for people to come to beach – cars dropping off people to change at restrooms and get ready for the beach – no room for cars dropping off people – limited parking on Brown Street – 1 spot for each rented room – no room for people parking to use bathrooms – didn't hear height of bathrooms – Town Manager Asanza – can find out – Donna Saxby – visibility issues – grandparents/parents stay on porch and watch kids playing on beach, safety issue –

Patty – Breakers on the Sea owner – would block her parking space, does not want children in danger there – safety issue with cars at end of street

Shifra Strum –Doesn't know how public restrooms are maintained currently – would like to know how they are maintained currently? How do they arrive? Where would they park? How long? How frequently and how it is monitored? Chairman O'Neill – hired a company to maintain trashcans on the beach, every hour –

Alex Wojcik – Breakers by the Sea owner - would lose access to parking – lots of kids going up and down the street all hours of the day and night – open hours and seasonally? – Town Manager Asanza – summer months only, locked at night, exterior lighting, police chief recommended cameras – Alex Wojcik – light interfere? – Town Manager Asanza – lighting designed not to interfere – Alex Wojcik – handicap sign on Ocean Ave – lifeguard sign up currently, only users were visitors and were ticketed – lifeguard stand on Union Avenue – Vice Chair Blow – handicap sign will be there before summer – apologize for not following up after previous discussion – Alex Wojcik – thanked council for adding blue mat for entrance – storm issues cover mats

Vice Chair Blow – speaking for himself, not the entire council – read all emails – does not support Ocean Ave bathroom or on Brown – apologize if it came across that it was a foregone conclusion that these were the locations – would like to check out Union – small impact, foot traffic already high on Union – very valid concerns presented – don't want to see them on Union and Brown – maybe 1 unit on Union at this point as a pilot - opinion as single Councilor -

Town Manager Asanza – whatever areas are proposed, abutters will always receive notices to be clear and transparent on the process –

Shifra Strum – ADA-compliant suites – handicap parking and 3 rooms with no stairs – have beach wheelchair through Rec department – wouldn't be able to use if the bathroom is there.

Chairman O'Neill – thanked residents for their time and feedback – Chairman O'Neill – doesn't support Brown Street or Ocean Avenue based on input – Union is a good spot – would like to see facility close to the beach, the intent was to reduce walking from the beach.

Chairman O'Neill closed the workshop at 6:54 pm
