INTRODUCTION

What is a Comprehensive Plan?

A comprehensive plan is a planning document intended to be a guide for communities when making policy and land use decisions over a 10 year period. The comprehensive planning process is an opportunity for a community to take inventory of past and current trends and data and plan for the future of the community. The process of comprehensive planning is often the start of further consideration of matters related to the well-being of a community such as land use, preservation of natural resources, economic development, housing, municipal department functions, how to serve residents, business owners and visitors, and other important topics. The comprehensive plan can help facilitate those discussions and offer a direction as well as recommendations for further planning and policy work.

Why is it important?

The comprehensive plan is an important planning document because it guides policy decisions, zoning decisions, municipal investments, and overall well-being of a community. The comprehensive plan consists of inventory chapters covering topics such as the economy, transportation, recreation, housing, and population. The inventory chapters provide a detailed overview of each topic which is important for long range planning decisions. A majority of the inventory chapters include associated goals, strategies, and policies that will dictate how the Plan is implemented. The inventory process is a critical foundation that sets the stage for the community's vision of the future. The goals, policies, and strategies provide the direction and action steps to achieve the vision.

Lastly, a Comprehensive Plan, approved as consistent by the State makes municipalities eligible for State grants and loans, and allows municipalities to legally enact a zoning ordinances.
